



Setting Up and Pairing your COUL Ergonomic Keyboard


- Slide the Power Switch (A) to the right for the ON position and check the Power LED Indicator (B) status.
- Once the power is ON, hold down the COUL Key together with one of the Bluetooth keys (F7 or F8 or F9) for approximately 3 seconds to pair with your PC, Mac or other device.

Device Layout




- A. Power switch

Check Battery Remaining



- Press and hold the COUL key (F) whilst pressing the Delete key (H) to check how much Battery life is remaining.
- Check the number of times the Power LED indicator (B) flashes to indicate the Battery charge that is remaining.

Recharging the Battery



- Use the USB Cable provided to charge your COUL Ergonomic Keyboard.
- Check the LED indicator (B) for charging status, which will be red during charging.

Safety Guidelines

It is important to achieve maximum safety when using the COUL Ergonomic Keyboard, so we suggest that you use the following guidelines:

1. Taking the device apart will void the warranty, so do not attempt to do this by yourself.
2. Do not attempt to operate the device under abnormal current load conditions.
3. Do not attempt to disassemble the COUL Ergonomic Keyboard. There are no user serviceable parts inside.
4. Do not expose the COUL Ergonomic Keyboard to direct sunlight.
5. Never expose this device to too high or too low temperature.
6. The suitable temperature for the product is 0°C to 35°C.
7. Keep the device and accessories away from a damp or wet environment.
8. Never expose this device to fire, dust, oil, moisture or smoke.

Comfort & Ergonomics

When using the COUL Ergonomic Keyboard, it is important to find a comfortable posture and take frequent breaks in order to ensure optimum comfort and avoid injury. For information about ergonomics and safety, visit www.coul.com/ergonomics.

Maintenance, Cleaning and Usage

The COUL Ergonomic Keyboard requires little maintenance, but we suggest that once a month, you disconnect the USB cable, power off the device and clean it using a soft cloth to minimize the build up of dirt. Do not use soap, detergents or chemicals to clean the device.
