Dual metering socket

1 Function

1.1 Description

1、Manual power-off function: press the button to switch on and off;

2、Child lock function: After the child lock is turned on, the manual power-off function is disabled (set by the mobile APP);


3、Remote power-off function (operated by mobile APP);

4、Power-off recovery function: After power-off and power-on, restore the state before power-off (set by mobile APP);

5、Metering function: separately collect 2 output voltages, currents, active power.

2、1st indicator light


3、1st button

4、2nd single-phase two-pole ground socket hole


5、2nd indicator light

3.1 Installation requirements


1、Installing the cassette requires the US standard dedicated cassette

2、Can't be installed outdoors


3.2 Installation steps

1、Cut off the mains power;


2、The fire line L, the neutral line N and the ground line E respectively correspond to the corresponding fire line, neutral line and ground line of the inner wall of the wall, and attention should be paid to insulation, and no exposed copper wire is outside.;




3、Fix the socket to the cassette on the indoor wall with screws, pay attention to the installation direction;



4、Attach the decorative bone cover to the socket with a screw lock;



5、The product can be installed by assembling the decorative cover to the decorative cover frame through 4 hooks.
