The charger must be checked regularly for conditions such as damage to the cord, plug, casing and other components that may result in the risk of fire, electric shock or injury to persons. The charger must not be cleaned with liquids. The Toniebox must be disconnected from the charger before cleaning. The charger is not a toy and should therefore only be used by adults. This is under the full responsibility of the parents. When connecting it to the outlet, please ensure that the plug is close enough and easy to reach. The charging station is a passive component and is only to be used with the Toniebox. As with all electric products, precautions should be observed during handling and use to prevent electric shock. The AC adapter may become warm during normal use. Always allow adequate ventilation to the AC adapter and use care when handling the charger.
