


Charging Instructions

1. To charge your helmet, connect the USB cable into the port located on back interior of your helmet.




Pairing Your Helmet

1. Turn on your helmet by sliding the power switch to the ON position.
2. Turn on Bluetooth on your smartphone.
3. On the Bluetooth settings screen, connect to the item that corresponds with your helmet. A sound will play when connected to your Bluetooth® compatible device.

When wearing your helmet always:

- Fasten the chin strap buckle
- Make sure it sits firmly and leveled on your head
- Increase or decrease the chin strap for a precise fit
