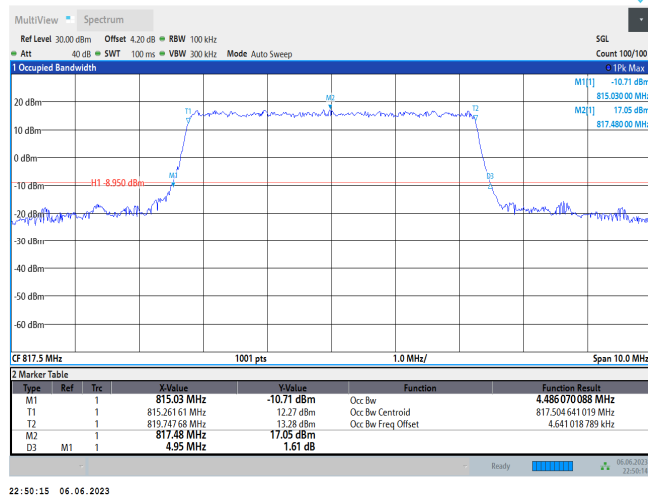

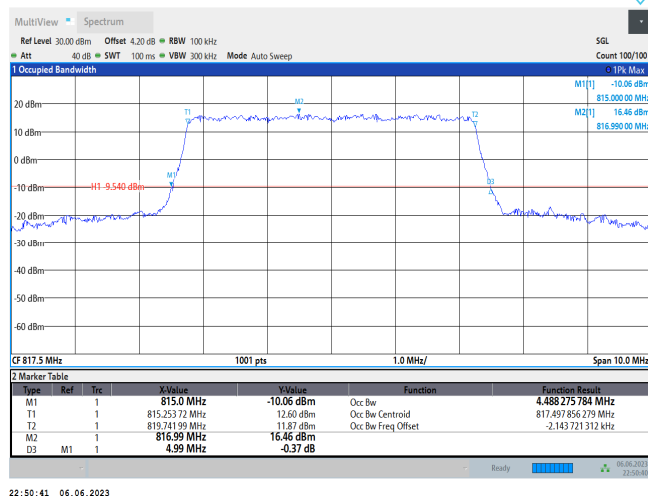

Band18(815-824)-5MHz-16QAM-23875-25RB#0



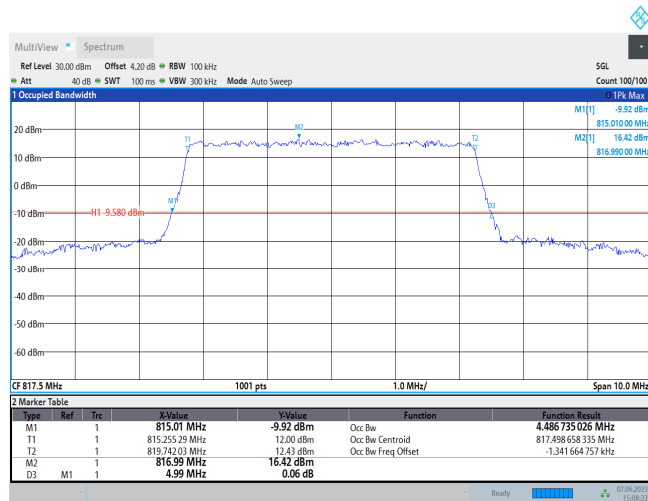
