Test Graph EDR ANT1 2402 2Mbps Higher Band Emissions

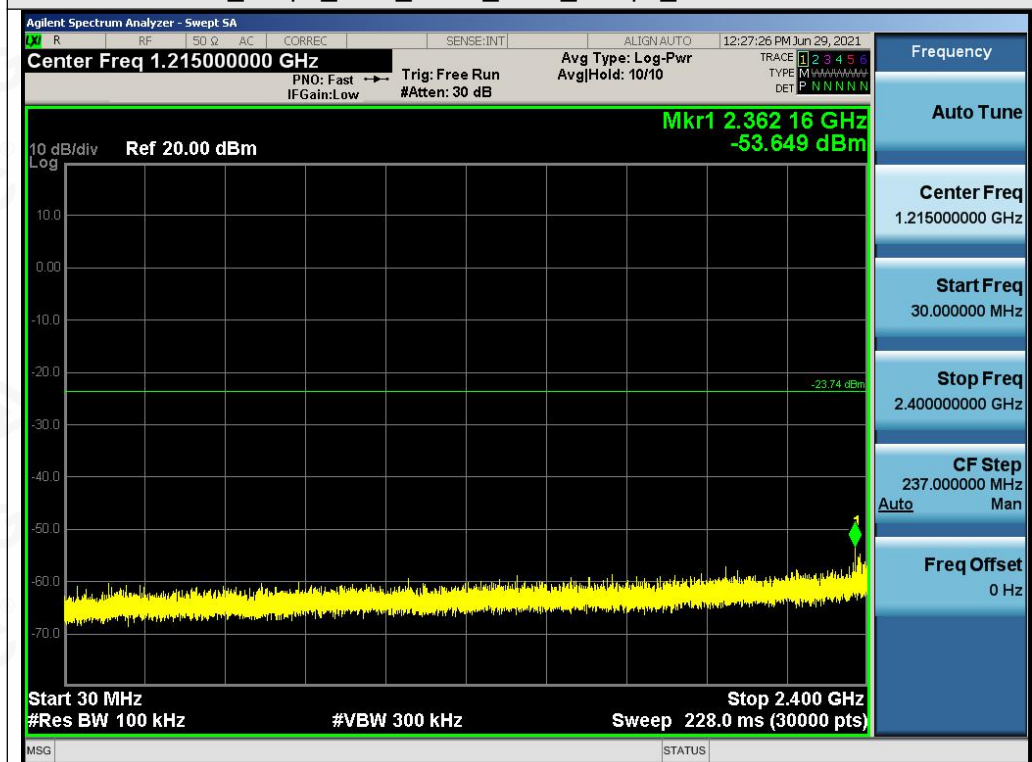

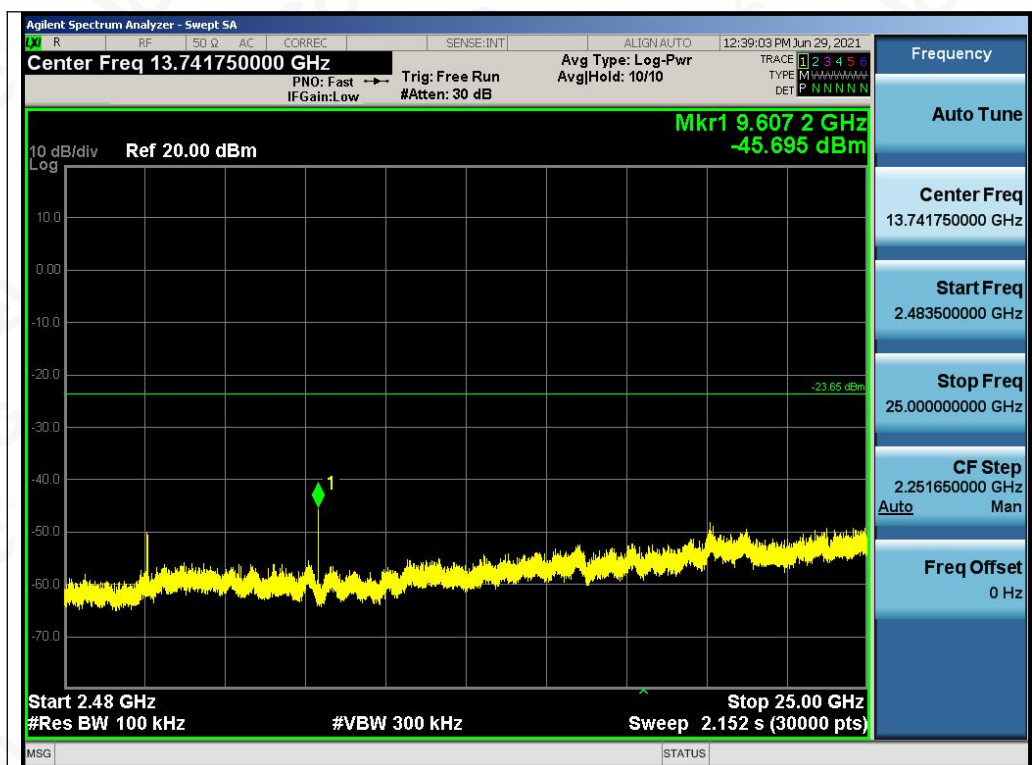

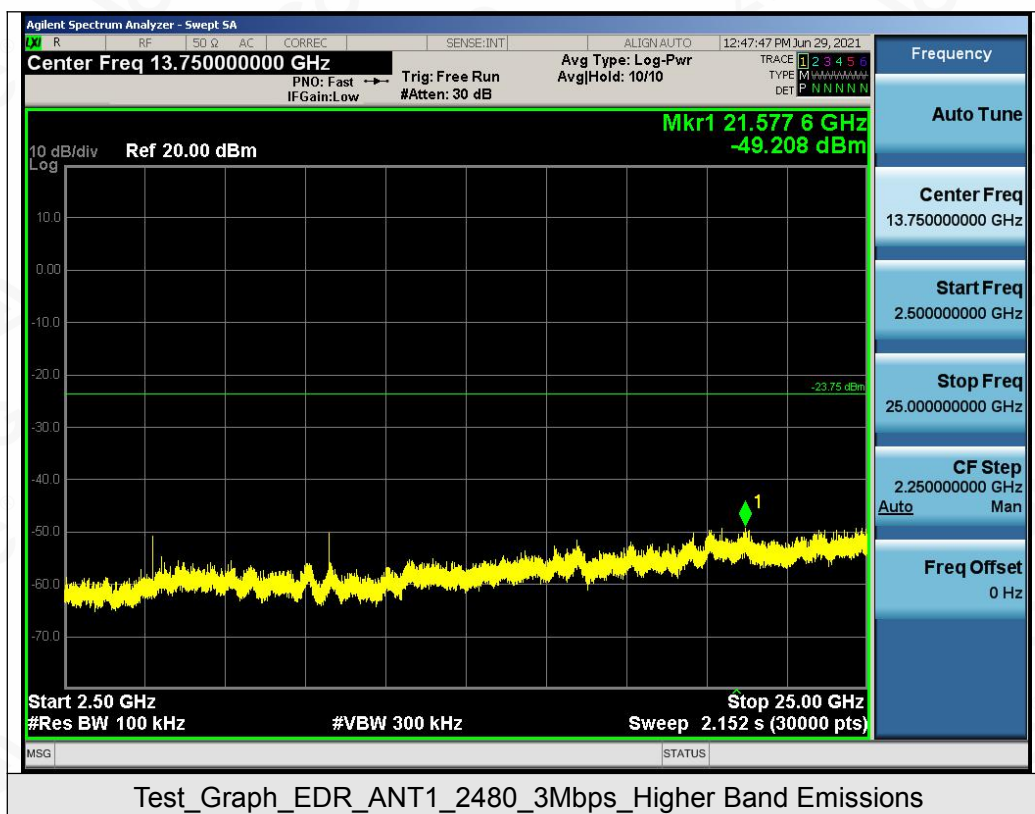

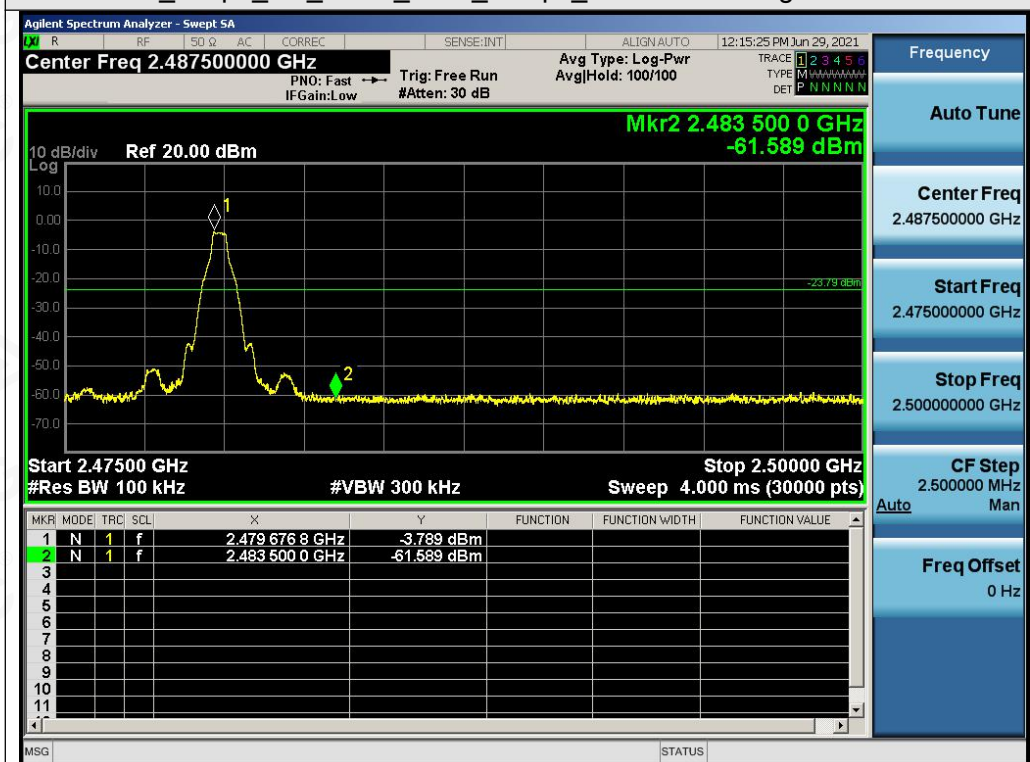

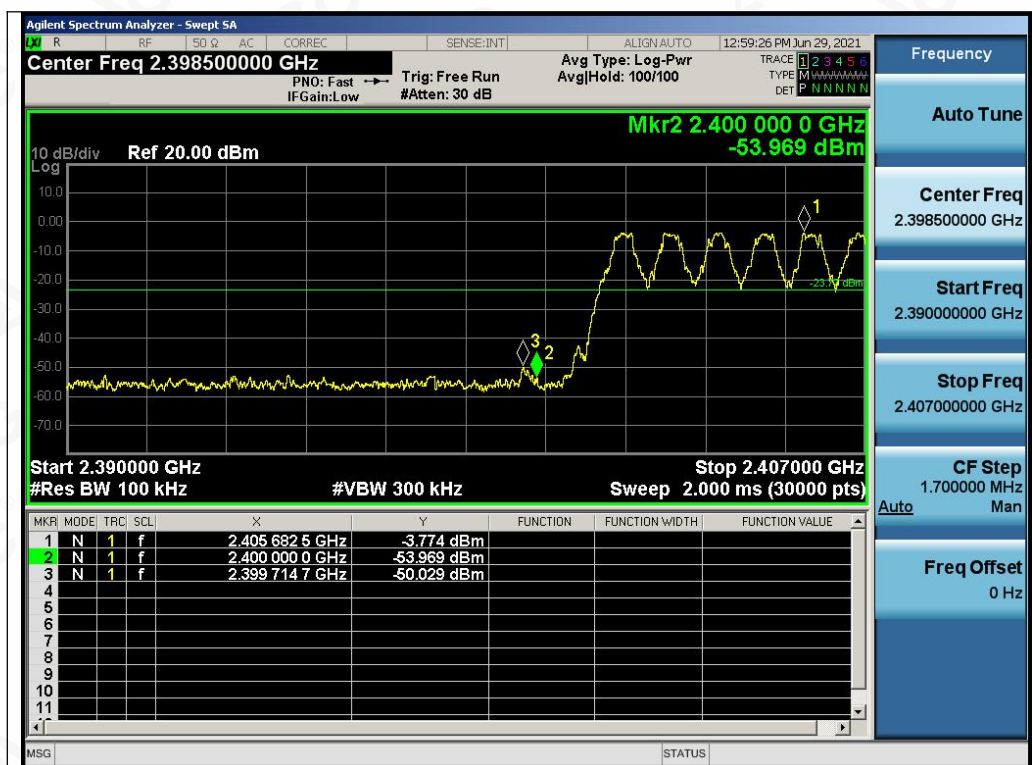

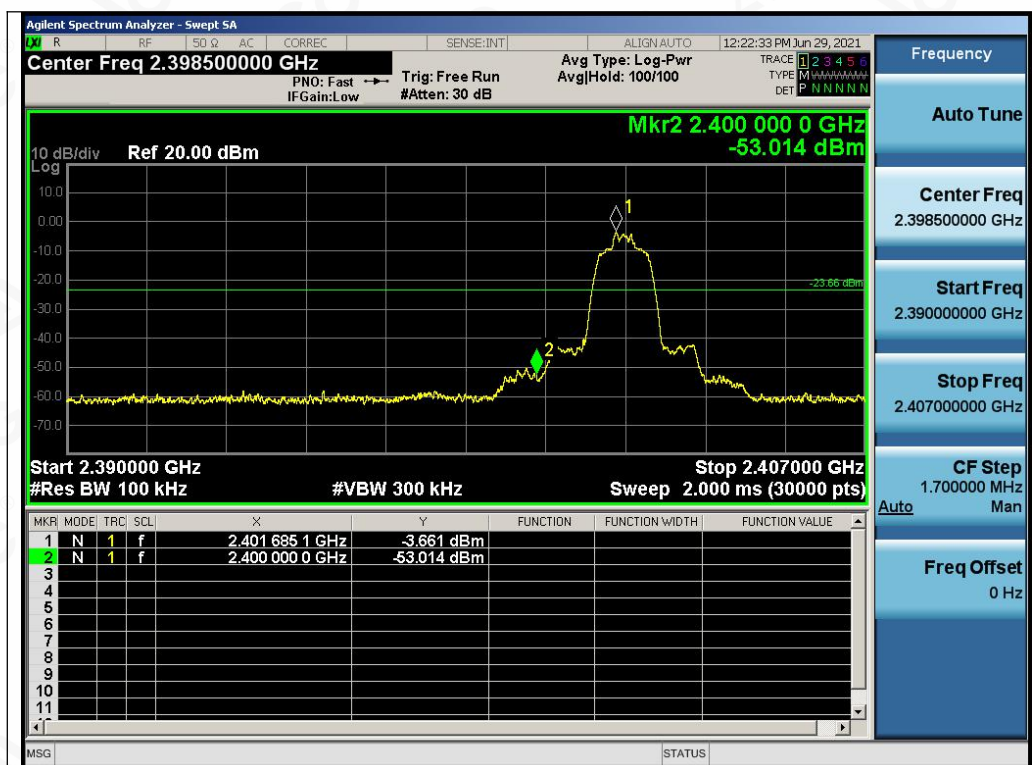
