

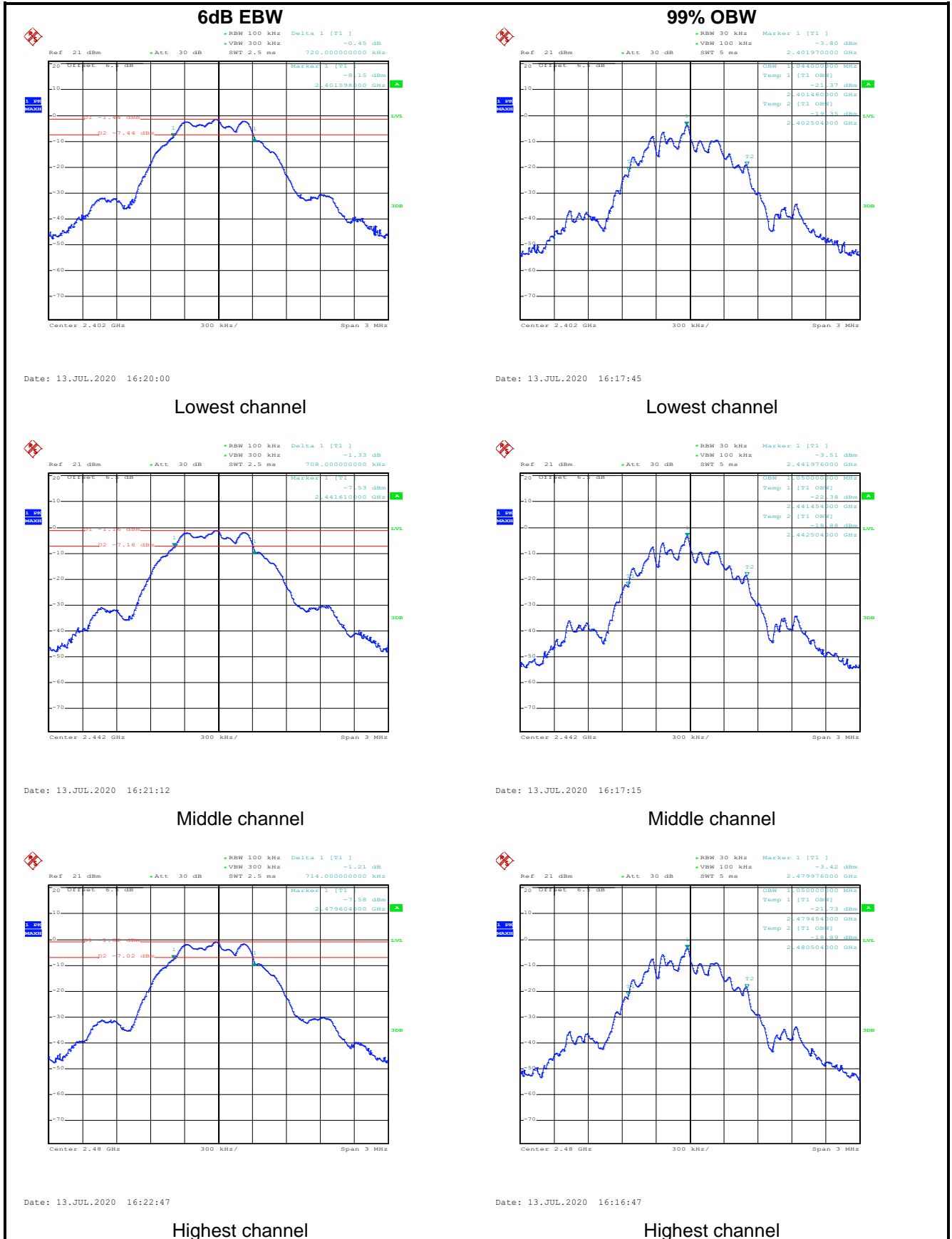



Test plot as follows:



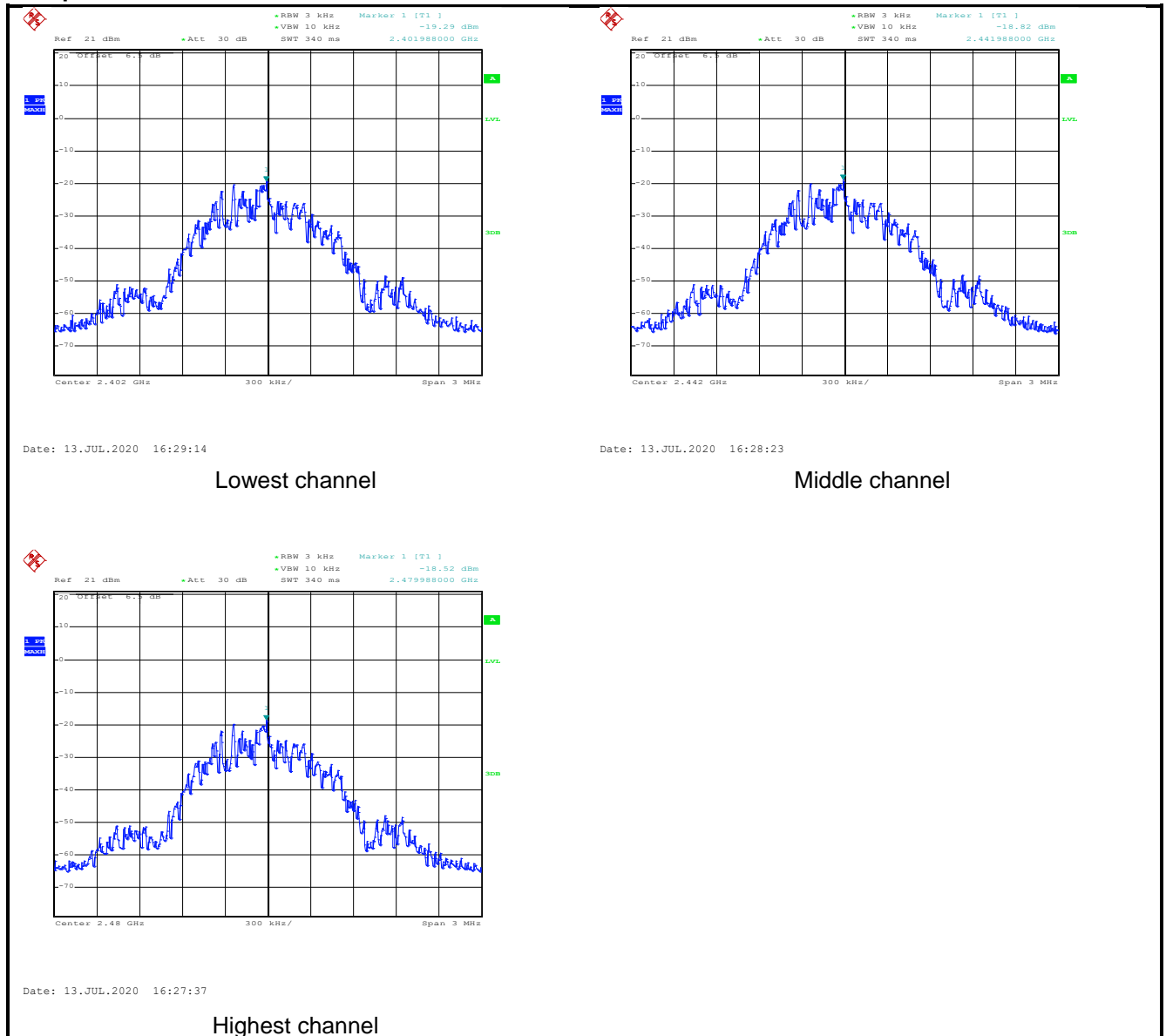
