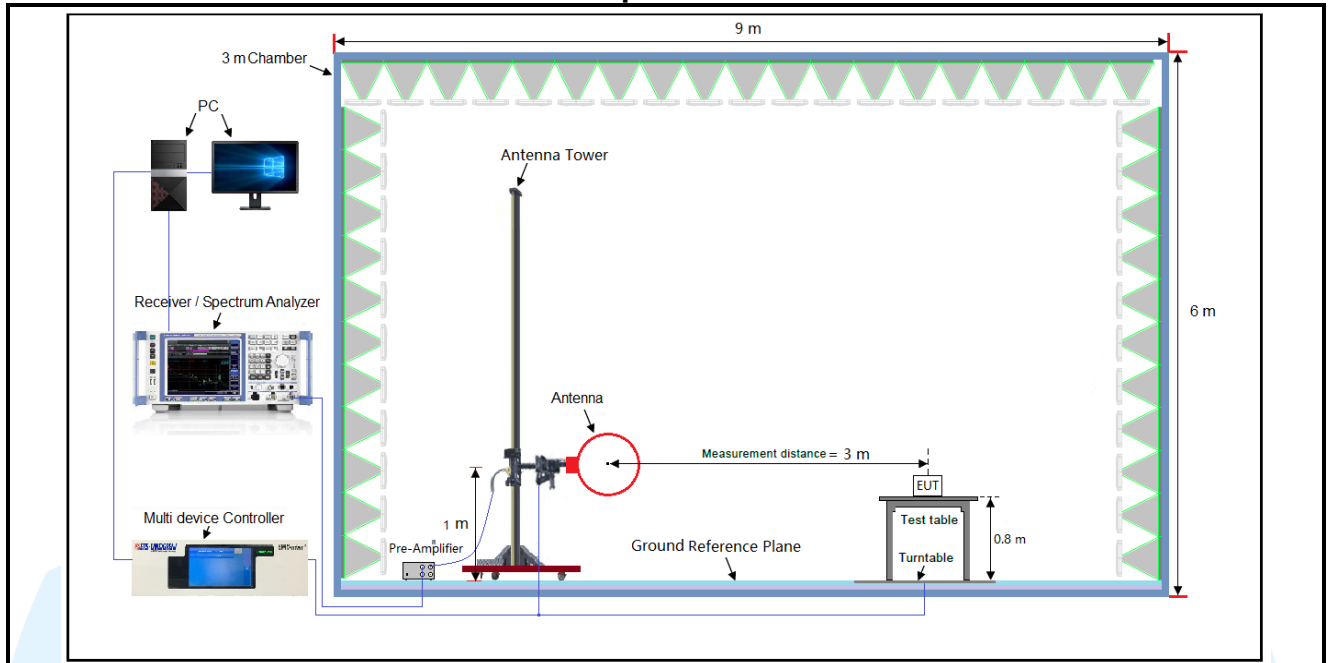


Figure 1. Below 30MHz

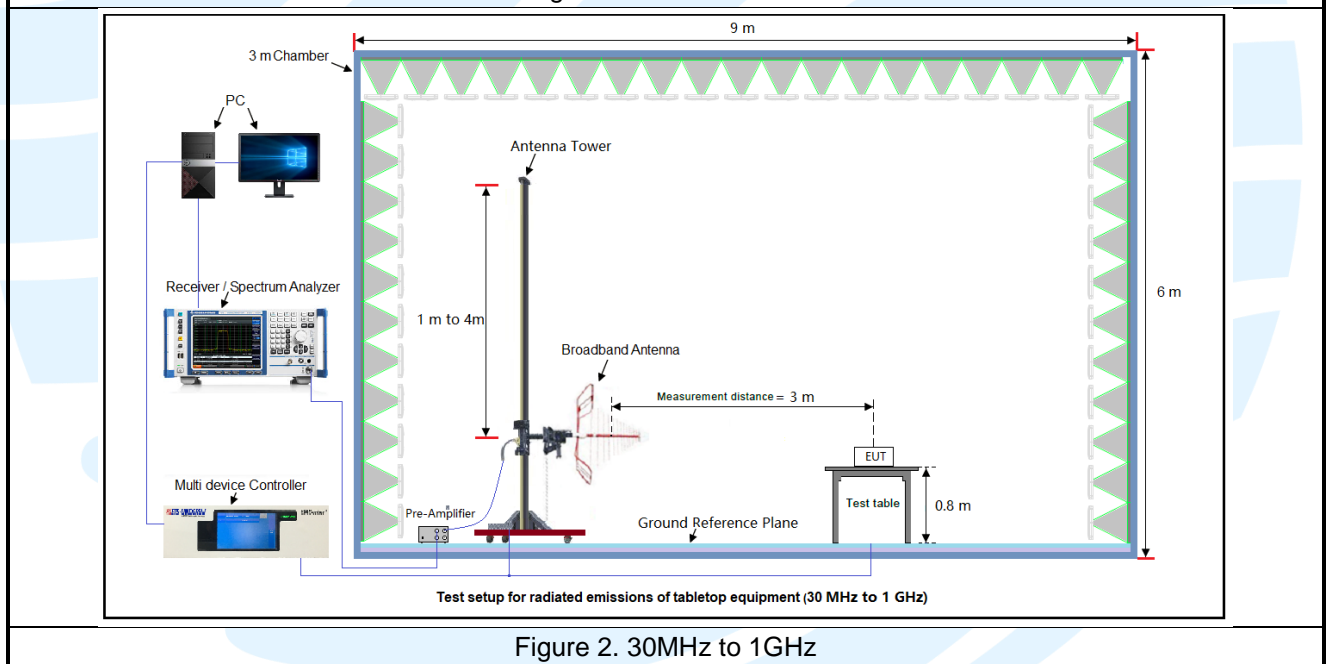
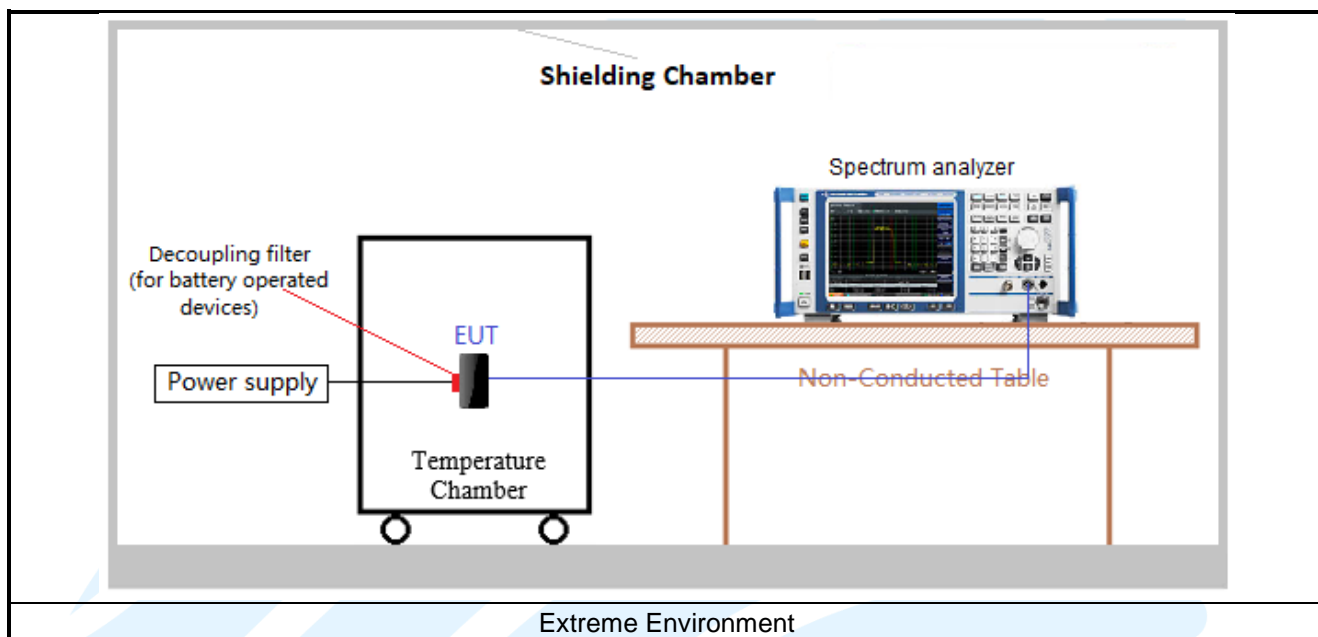


Figure 2. 30MHz to 1GHz

The diagram illustrates the experimental setup for EMI testing within a Shielding Room. On the left, a measurement system is placed on a table, consisting of a PC, a Receiver, and a Pulse Limiter. This system is connected to LISN 1 (Line Impedance Stabilization Network) via a Ground Reference Plane. LISN 1 is connected to the AC Mains. The test setup includes a Test table with two EUT/AE (Equipment Under Test/Accessory Equipment) units and a PSU (Power Supply Unit). The EUT/AE units are separated by 10 cm, and the PSU is 10 cm from the second EUT/AE. The Test table is elevated 40 cm from the floor, with insulation ≤ 0.15 m. LISN 2 is connected to the AC Mains and the PSU. The distance from LISN 1 to the first EUT/AE is 80 cm, and from LISN 2 to the PSU is 80 cm.

The diagram illustrates a Shielding Chamber setup. A Spectrum analyzer is connected to an EUT (Equipment Under Test) via a cable. Both are placed on a Non-Conducted Table. The entire setup is enclosed within a Shielding Chamber, which is situated on a Normal Environment floor.



4.6 SYSTEM TEST CONFIGURATION

For emissions testing, the equipment under test (EUT) setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing. During testing, radiated emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario. It was powered by a 3.8Vdc battery. Only the worst case data were recorded in this test report.

All readings are extrapolated back to the equivalent three meter reading using inverse scaling with distance. Analyzer resolution is 100 kHz or greater for frequencies below 1000 MHz. The resolution is 1 MHz or greater for frequencies above 1000 MHz. The spurious emissions more than 20 dB below the permissible value are not reported.

Radiated emission measurement were performed from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

5.2 ANTENNA REQUIREMENT

Standard Requirement
15.203 requirement: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.
EUT Antenna: This product has a permanent antenna, fulfill the requirement of this section.

5.3 20DB BANDWIDTH

Test Requirement: FCC 47 CFR Part 15 Subpart C Section 15.215 (c)

Test Method: ANSI C63.10

Limit: Operation within the band 13.110 MHz to 14.010 MHz

Requirement : Intentional radiators operating under the alternative provisions to the general emission limits, as contained in §§15.217 through 15.257 and in subpart E of this part, must be designed to ensure that 20dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equip compliance with the 20dB attenuation specification may base on measurement at the intentional radiator's antenna output terminal unless the intentional radiator uses a permanently attached antenna, in which case compliance shall be. Demonstrated by measuring the radiated emissions.

Test Procedure: Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
Use the following spectrum analyzer settings:

- The spectrum analyzer center frequency is set to the nominal EUT channel center frequency
- Span = approximately 2 to 5 times the OBW
- RBW = 1% to 5% of the OBW
- VBW $\geq 3 \times$ RBW
- Sweep = auto;
- Detector function = peak
- Trace = max hold
- All the trace to stabilize, use the marker-to-peak function to set the marker to the peak of the emission, use the marker-delta function to measure and record the 20dB down bandwidth of the emission.

Note: The cable loss and attenuator loss were offset into measure device as an amplitude offset.

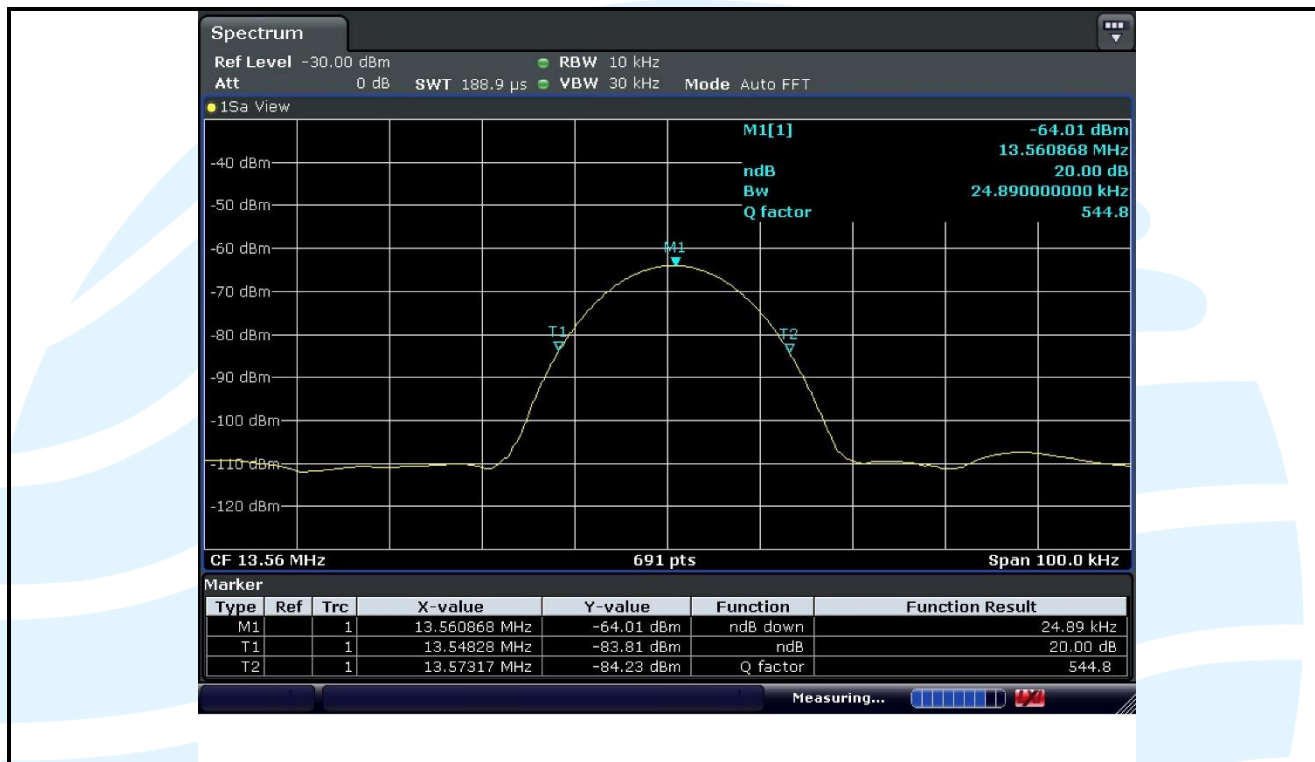

- The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rota table table was turned from 0 degrees to 360 degrees to find the maximum

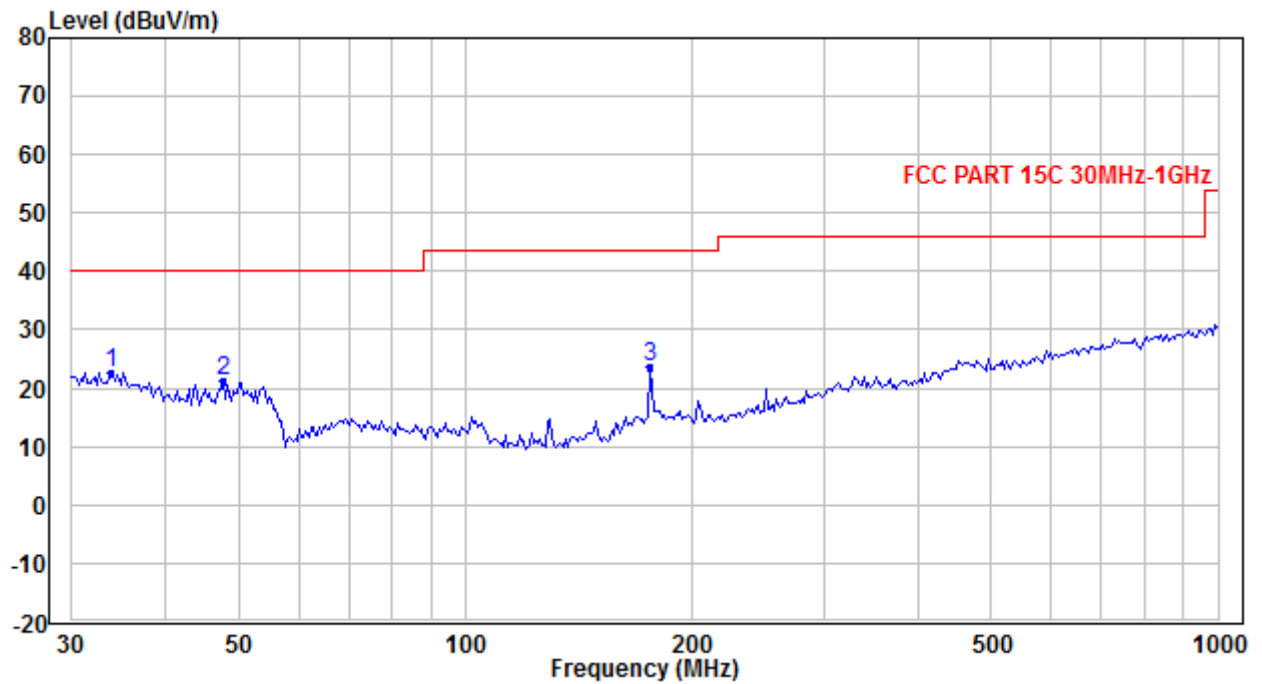

5.6 FREQUENCY TOLERANCE

Test Method: ANSI C63.10-2013

Limits:

The frequency tolerance of the carrier signal shall be maintained within $\pm 0.01\%$ of the operating frequency over a temperature variation of -20 degrees to $+50$ degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

Test Procedures:

- 1) The EUT was placed inside the environmental test chamber and powered by nominal DC voltage.
- 2) Turn the EUT on and couple its output to a spectrum analyzer.
- 3) Turn the EUT off and set the chamber to the highest temperature specified.
- 4) Allow sufficient time (approximately 30 min) for the temperature of the chamber to stabilize, turn the EUT on and measure the operating frequency after 2, 5, and 10 minutes.
- 5) Repeat step c) and d) with the temperature chamber set to the lowest temperature.
- 6) The test chamber was allowed to stabilize at $+20$ degree C for a minimum of 30 minutes. The supply voltage was then adjusted on the EUT from 85% to 115% and the frequency record.

The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
- 9) The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane,
- 10) The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.
- 11) In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.10 on conducted measurement.

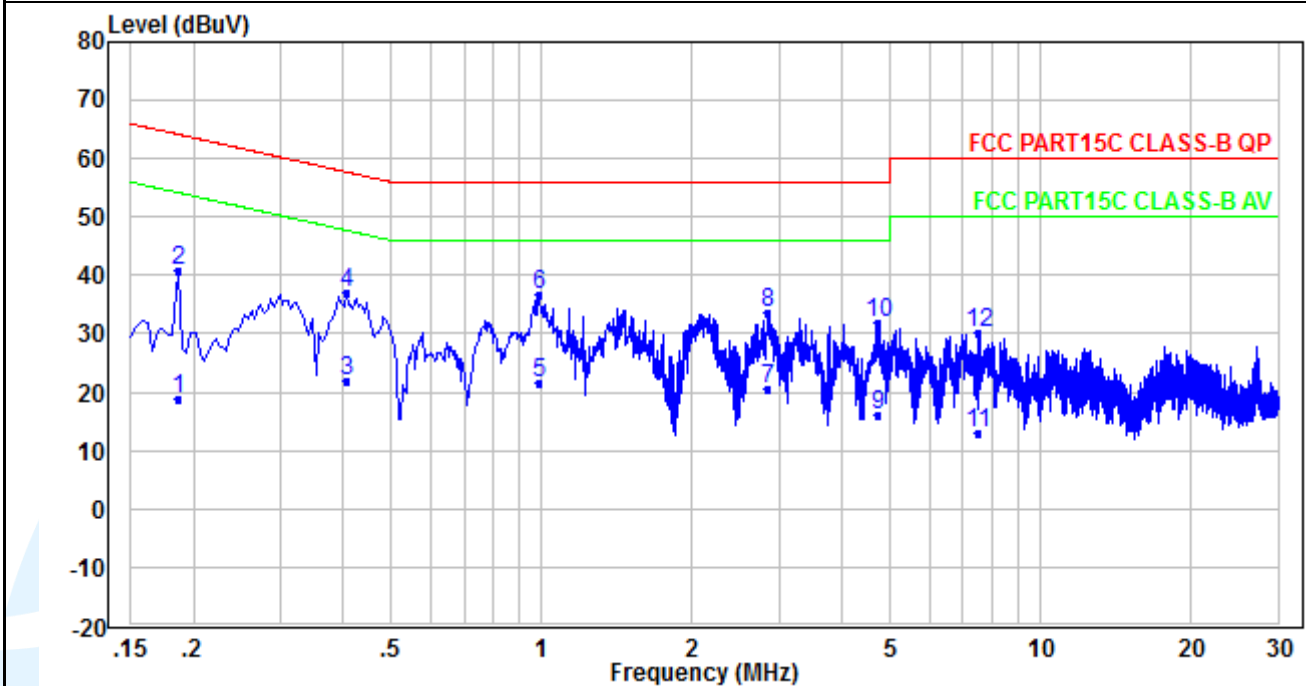

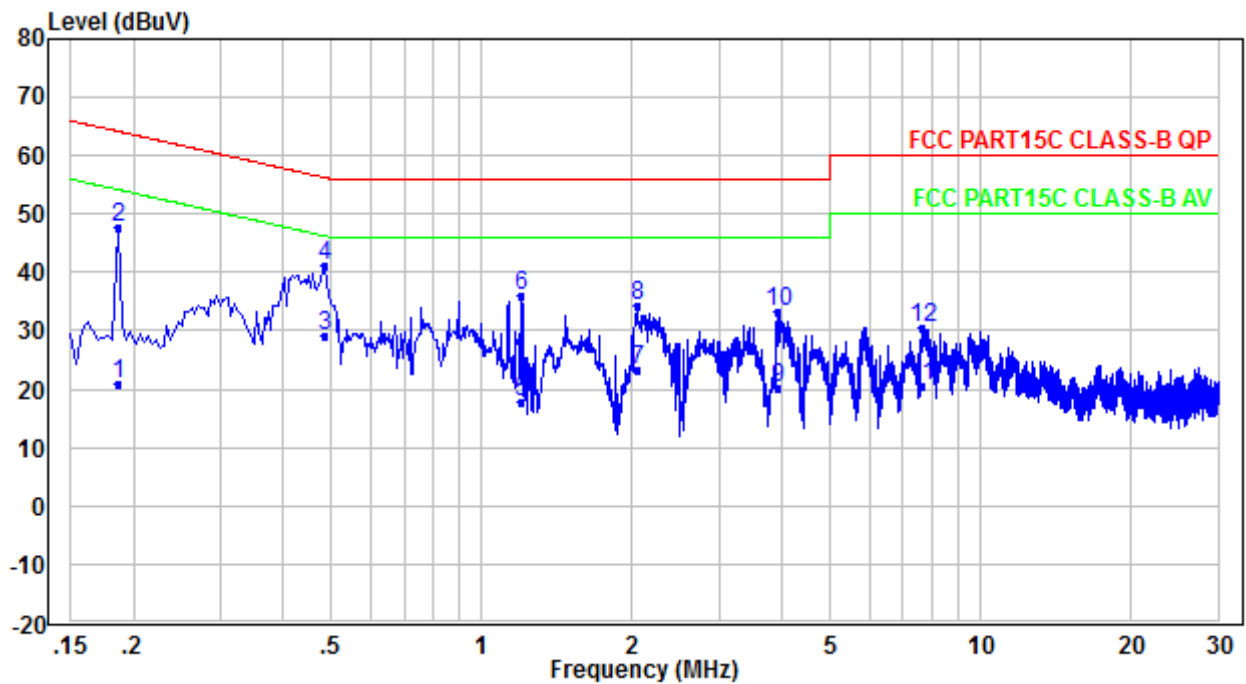
