#### **PART I: SAFETY AND HANDLING INFORMATION**

**Caution!** Before using the Watch, please read the following instructions which contain important safety and regulatory information. Please keep these instructions in a safe place so that you can refer to them when needed. Provide these instructions when passing on the Product.

##### **I. Safety and handling instructions**

###### **A. Protection of the user's health**

As a general recommendation, the Watch is not intended for use where the failure of the device could lead to death, personal injury, or severe environmental damage.

If you have any questions concerning your Watch, its batteries and/or accessories' chemical contents, do not hesitate to contact us via our website at [tagheuer.com](http://tagheuer.com) or by mail at the following address: TAG HEUER - Branch of LVMH Swiss Manufactures SA - 6A RUE LOUIS-JOSEPH CHEVRELOT - 2300 LA CHAUX-DE-FONDS - SWITZERLAND (Phone: +41 (0)32 919 8000).

Your Watch and its built-in applications are not medical devices. They are not designed or intended for use in the diagnosis of disease or other conditions, or in the cure, mitigation, treatment, or prevention of disease.

Before starting or modifying any exercise program using the Watch, consult your physician. Be careful and attentive exercising. Stop immediately if you experience pain, faintness, dizziness, exhaustion, or shortness of breath. By exercising, you assume all inherent risks, including any potential injuries. If you have any medical condition that you believe could be affected by the Watch (for example, seizures, blackouts, eyestrain, or headaches), consult with your physician prior to using the Watch.

Some individuals may experience skin reactions to materials used in jewelry, watches, and other wearables that are in prolonged

contact with their skin. This can be due to allergies, environmental factors, extended exposure to irritants like soap, sweat, or other causes. You may be more likely to experience irritation from any wearable device if you have allergies or other sensitivities. If you have known skin sensitivities, please take special care when wearing the Watch. You may be more likely to experience irritation from the Watch if you wear it too tightly. Periodically remove the Watch to allow your skin to breathe. Keeping the Watch bands clean and dry will reduce the possibility of skin irritation. The materials used in the Watch and the Watch bands meet the standards set for jewelry by the U.S. Consumer Product Safety Commission, applicable European regulations, and other international standards. If you experience redness, swelling, itchiness, or any other irritation or discomfort on your skin around, or beneath, your Watch, please remove the Watch and consult your physician before resuming wear. Continued use, even after symptoms subside, may result in renewed or increased irritation.

Prolonged contact of the skin with abnormally warm surfaces may cause injury (or discomfort). Remove your Watch from your wrist if it becomes uncomfortably warm.

You should pay specific attention if you have a medical condition that reduces your ability to detect heat on your skin.

The Watch contains components which may interfere with electronic medical devices. If you use an electronic medical device, please refer to section 3a below.

###### **B. Main characteristics of your Watch**

The Watch features Wi-Fi, Bluetooth, GPS, NFC, and a heart rate sensor. It also includes a PPG sensor for heart rate monitoring and SpO2 measurement for blood oxygen levels. Additionally, an ambient light sensor and inter-modularity allow users to customize the Watch by changing parts such as the strap with additional accessories.

It is not intended to be used as a medical device. Your Watch is paired with TAG Heuer Connected Application. This application is available on compatible smartphones running Android 11.0+ with supported Google Mobile Services (excluding Go edition and phones without Google Play) or iOS 17.0+. This compatibility might change in the future, please refer to the Application page on the App Store or Google Play store to check the minimum version required. Please note that certain smartphones running Android with preloaded Chinese set up may not be compatible. Supported features and apps may vary between platforms and

countries with compatibility subject to change and may be only available in certain languages. If you are unsure of your device's compatibility, or for further information please contact us at the following link [tagheuer.com/contact/](http://tagheuer.com/contact/).

The Watch requires the use of the charging accessories provided with it (Please refer to product packaging). The accessories provided with your Watch contain a USB cable and a charging dock. You will find below further details on the use of the Watch and its charging accessories.

## 1. Performance and handling

For optimal performance of the heart rate sensor, your Watch and strap must be snugly fitted to the wrist. If you want to measure your heart rate while practicing sports, wearing your Watch with a steel bracelet may not be an optimal choice, as it can be difficult to tighten properly. During swimming activities, the heart rate monitor is disabled as the water interrupts its detection.

To disable the Watch's radio (Bluetooth, Wi-Fi), please follow the following stages:

- If your screen is dimmed, touch the screen to wake up the Watch,
- Go to the Settings,
- Scroll down and select either Wi-Fi or Bluetooth menu,
- Tap the small icon (toggle) next to either Wi-Fi or Bluetooth to turn it off or disable it.

Please note that actual battery life may vary depending on many factors including apps used, number of notifications, device settings, number of charged cycles, screen brightness, Wi-Fi usages. Lithium batteries, like the one contained in the TAG Heuer Connected Watch, should maintain a minimum voltage level to ensure safe operating conditions. The battery contains an internal protection circuit that will prevent charging if the battery voltage drops to unsafe levels. To ensure that this does not happen, recharge the watch every 12 months, and charge to above 80% before storing for an extended period of time.

## C. Important safety precautions

Please note that failure to comply with the following guidelines may cause malfunctions or be hazardous to the user and/or exclude or reduce the benefit from the International Limited Guarantee.

### 1. Using the Watch and its accessories safely

#### a. Keeping your Watch safe

##### (i) General

Do not use or store the Watch and its accessories in dusty, dirty areas as its components may be damaged.

Do not attempt to open the Watch's casing. Non-expert handling of the Watch may cause damages to your Watch and will void the International Limited Guarantee.

Do not drop or knock the Watch. Do not place heavy objects on it.

Do not use sharp objects on the screen. Do not use excessive force on the screen. Rough handling may damage the internal circuits.

Do not use harsh chemicals, cleaning solvents or strong detergents to clean the Watch. Do not test the pressure on your Watch in case of any doubt, please contact the customer care team.

If the Watch or any of its accessories are not working properly, take them to your nearest qualified service center.

##### (ii) Exposure to liquid

The Watch is water resistant to 50m/5ATM. You may, for example, wear and use the Watch for shallow-water activities such as swimming or in the rain. However, it should not be used for activities involving submersion below shallow depth or high-velocity water such as scuba diving, water-skiing.

Be sure to clean and rinse your Watch it with fresh water after it has been in salt-water or chlorinated water and dry it thoroughly with a nonabrasive, lint-free cloth.

If you perspire with your Watch or your Watch gets wet while wearing it (even with fresh water), always dry it carefully before placing it on its charging dock. Be aware that straps other than metal, rubber or fabric (such as leather) and any charging accessories are not water-resistant and may result in aesthetic damage if they come into contact with water, as they are not designed for it.

The following must also be avoided as it could damage your Watch (it could notably affect the water resistance and cause cosmetic issues):

- Exposing the Watch to soap, detergent, acids or acidic foods, and any liquids other than water, such as perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents;
- Dropping the Watch or subjecting it to impacts.
- Exposing the Watch to pressurized water or high velocity water, for example, diving, and surfing.
- Wearing the Watch in the sauna or steam room.

Please note that the touch screen and other features may get deactivated temporarily while the Watch is wet. If the Watch or your hands are wet, dry them thoroughly before handling the Watch.

Be sure to carefully follow those instructions when using your

Watch, as any use in contradiction with those instructions would void the International Limited Guarantee.

### **(iii) Using buttons, digital crown, connectors, and ports**

Never apply excessive pressure to a button on the Watch, or force a charging connector into a port, because this may cause damage that is not covered under the International Limited Guarantee. If the connector and port do not join with reasonable ease, they probably do not match. Check for obstructions and make sure that the connector matches the port and that you have positioned the connector correctly in relation to the port.

Certain usage patterns can contribute to the fraying or breaking of cables. The cable attached to a charging unit, like any other metal wire or cable, is subject to becoming weak or brittle if repeatedly bent in the same spot. Aim for gentle curves instead of angles in the cable. Regularly inspect the cable and connector for any kinks, breaks, bends, or other damage. Should you find any such damage, discontinue use of the cable.

## **b. Safety of people around you**

### **(i) Protection of children**

The Watch and its accessories present a **choking hazard** to children and must therefore be kept away from children.

### **(ii) Driving and engaging in activity safely**

Do not use your Watch while driving.

You assume full responsibility for the use of the GPS of the Watch and the risks derives therefrom.

Radio frequency signals might affect improperly installed or inadequately shielded electronic systems in motor vehicles. Check with the manufacturer or its representative regarding your vehicle. If any equipment has been added to your vehicle, you should also consult the manufacturer of that equipment for information on radio frequency signals.

Do not use your Watch while engaging in any activity that requires your full attention. Inattention to vehicular traffic or other pedestrian hazards could result in serious injury, death or property loss.

In general, always use common sense when using your Watch.

## **2. Electrical Safety**

### **a. Accessories**

Use only the accessories provided in the packaging (TAG Heuer charging dock and cable). Using any accessories not specifically designed for your Watch may invalidate any warranty or guarantee (including the International Limited Guarantee) applicable to your device and could render the Watch inoperative or unsafe.

### **b. Charging accessories**

Your Watch is provided with the following charging accessories: USB cable, charging dock.

To charge the Watch, use only charging accessories provided by TAG Heuer.

When a charger is not in use, disconnect it from the power source.

It is important to keep the Watch and the accessories provided therewith in a well-ventilated area when charging.

Use only the accessories provided by TAG Heuer as we cannot ensure that third party accessories will not damage your Watch. Before using any charging accessory, ensure that the power source voltage matches that of the approved charging accessories.

Do not overload power outlet, extension cords or convenience receptacles because this might result in a risk of fire or electric shock. To reduce the risk of damage to the cord or the wall charger, pull the wall charger rather than the cord when you disconnect the charging accessory from the power outlet or convenience receptacle.

Using damaged Watch charging accessories, or charging when moisture is present, or handling accessories with wet hands, can cause fire, electric shock, injury, or damage to the user or the Watch or other property. Be sure the Watch (including the charging pins on the back of your Watch) and the charging accessories are dry before charging. When you use the charging accessories to charge the Watch, make sure that the USB plug is fully inserted into the adapter before you plug the adapter into a power outlet. The Watch should not be charged next to certain pieces of furniture that could easily catch fire in case of an overheated battery (e.g. sofas, bookshelves, etc.). Avoid prolonged skin contact with the connector when the cable is plugged into a power source because it may cause discomfort or injury. Sleeping or sitting on the connector should be avoided.

In addition to the above:

- Do not expose the charger to water while in use; this may cause the charger and the Watch to fail.
- Carefully insert the USB cable into the charger base, forcing the cable in the wrong direction will damage the charger.
- It is not recommended to charge the Watch in a place where there is direct sunlight on the Watch, as this may cause overheating.
- Always use a USB power source to charge your Watch.
- The Watch face will display a charging symbol that shows the current battery charge percentage.

- It is recommended to remove the Watch from the charger once it is fully-charged.
- Actual battery life may vary depending on many factors including apps used, number of notifications, device settings, number of charged cycles, screen brightness, Wi-Fi usages.
- Please refer to the FAQ section of TAG Heuer's website: [faq.tagheuer.com](http://faq.tagheuer.com)
- The charger contains a small magnet to ensure proper alignment and attachment of the Watch to the charger.

#### c. Battery safety

Your Watch contains a built-in lithium-ion polymer battery that is only replaceable by TAG Heuer. Do not attempt to replace your product's battery (for information on the recycling of the battery, please refer to section Maintenance and Disposal (paragraph D-4), below).

In any event:

- Do not expose the Watch to fire or other external heat sources, such as hot plates, stove tops, space heaters or ovens, as this could cause fire or explosion.
- Do not dispose the Watch in a fire.
- Never place the Watch on a charger that is damaged in any way.
- Do not leave the Watch in hot or cold places.
- Store the Watch in a way that the contacts cannot be short-circuited by other metallic objects such as needles or paper clips.
- If the Watch becomes unusually warm, deformed or mechanically damaged, do not continue to use it but dispose of the item in an environmentally friendly manner.

### 3. Interaction with the environment

#### a. Interference with electronic equipment and magnetic characteristics

Like any radio-transmitting device, your Watch may interfere with other electronics.

Turn off your device on airplanes or in areas where required (e.g., hospitals, gas stations).

In any case, make sure you are using your device where it is authorized for use and in an authorized manner.

In particular, your Watch may interfere with pacemakers, defibrillators, or other medical devices. Maintain a safe distance of separation between your medical device and the Watch and accessories. Consult your physician and medical device manufacturer for information specific to your medical device. Stop using the Watch and its accessories if you suspect they are interfering with your pacemaker, defibrillator, or any other medical device.

Keep key cards and credit cards away from the Watch and its accessories.

#### b. Dangerous areas

Charging or using the Watch in areas with potentially explosive atmospheres, such as those with flammable chemicals, vapors, or fine particles (e.g., grain, dust, metal powders), can be dangerous. Obey all signs and instructions.

#### c. Geolocation performance

The geolocation function Global Navigation Satellite System (GNSS), such as the Global Positioning Service (GPS), may experience performance issues in case of use near any device using terrestrial broadband network.

#### d. Operating and storage temperatures

The Watch shall not be operated or stored at temperatures below -20 °C (-4 °F) and above 50 °C (122 °F) and shall not be charged at temperatures below 0 °C (32 °F) and above 45 °C (113 °F).

The Watch can be damaged and battery life shortened if stored or operated outside of these temperature ranges. Avoid exposing the Watch to dramatic changes in temperature or humidity. If the interior temperature of the Watch exceeds normal operating temperatures (for example, in a hot car or in direct sunlight for extended periods of time), you may experience the following as it attempts to regulate its temperature:

- Charging may slow or stop;
- The display may dim;
- Some data transfer may be paused or delayed.

The Watch and its accessories will become warm when plugged into a power source. For example, while the Watch is charging or while its accessories are plugged into a power source, do not sleep on them or place them under a blanket, or your body. Always use common sense when charging your Watch.

### D. Maintenance and disposal

#### 1. Cleaning

Clean the Watch with the cloth. Remove the rubber or textile strap before cleaning it with water and a bit of soap. We recommend to rinse it before placing it back on the Watch charging dock. Clean the Watch head if it comes in contact with anything that may cause stains, or other damage, such as dirt or sand, makeup, ink, soap, detergent, acids or acidic foods, or comes in contact with liquids other than fresh water, including those that may lead to skin irritation such as: sweat, salt water, soapy water, pool water, perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents. Please be aware that exposing the Watch to any liquids other than water will void the TAG Heuer

International Limited Guarantee. See the section dedicated to Exposure to liquid above for details.

Discoloration of the charging surface of the Watch charging dock and of the stainless-steel components of your Watch (notably the charging pins on its back or metal bracelets) may occur after regular use. This may result from corrosion caused by some perspiration or dust accumulating on the components.

Cleaning the charging surface of the charging dock and the stainless-steel components of your Watch may reduce, or prevent, such discoloration, and will help to prevent damage to your charger and your Watch. To do so, wipe the charging surface of your charger and the stainless-steel components of your Watch with a damp, nonabrasive cloth, and dry them thoroughly with a nonabrasive, lint-free cloth.

When cleaning the charging dock, always disconnect the cable from the power source.

If your Watch gets wet or exposed to sweat, clean it and carefully wipe the charging pins on the back before charging.

Do not use cleaning products when cleaning your Watch or the charging surface of the charging dock.

Follow below actions recommended for your Watch:

- Do not clean the Watch while it is charging.
- Do not dry the Watch or the bands using any external heat source (for example, a hair dryer).
- Do not use cleaning products or compressed air when cleaning your Watch.
- Do not clean with cosmetic or cleaning products such as wet wipes.
- Do not use any corrosive or abrasive cleaning agents.
- Keep the Watch clean and dry. Dry the Watch thoroughly if exposed to water.

## 2. Repairing

Do not attempt to repair the Watch by yourself. Always contact a TAG Heuer Customer Care Center if you need repairing assistance. The list and contact details of those centers can be found at [tagheuer.com/service/repair-center.html](http://tagheuer.com/service/repair-center.html)

## 3. Built-in battery precautions and information

Your Watch is equipped with a built-in lithium-ion polymer rechargeable battery that is not replaceable or removable by the user. Attempting to replace or remove the battery yourself, or tampering with the Watch in any way, will void the warranty and may pose a safety hazard. For any issues or handling related to the battery, please contact the TAG Heuer Care.

## 4. Electronic or electric equipment and battery disposal



**Your Watch, its accessories and its battery contain hazardous substances. They must not be disposed of as unsorted household waste.**

They are subject to specific local regulations. In particular, as the Watch and its accessories were placed on the market after 13 August 2005, they are subject, in the European Union, to Directive 2012/19/EU on waste electrical and electronic equipment (WEEE); in addition, the battery contained in your Watch is subject to Directive 2006/66/EC on batteries and accumulators and waste batteries and accumulators. The above-mentioned crossed-out wheeled bin symbols indicate that the Watch, its battery and its accessories are subject to these regulations.

The correct disposal of your old equipment, batteries or accumulators will help to prevent potential negative consequences for the environment, animal and human health. By recycling, reusing the materials or other forms of utilizing old devices, you are making an important contribution to protecting our environment.

For more detailed information about disposal of your used electric or electronic equipment, batteries and accumulators, please contact:

Consumers are, depending on the domestic legislation, encouraged or obliged by law to return electrical and electronic devices at the end of their service lives to the public collecting points set up for this purpose or to the point of sale. Specific modalities are defined by the national laws of each country.

## Exposure to Radio Frequency Energy and Specific Absorption Rate Information

This device is a radio transmitter and receiver that uses an internal antenna to send and receive low levels of radio frequency (RF) energy for data communications. The device emits RF energy below the published limits when operating in its maximum output power mode and when used with TAG Heuer authorized accessories. To comply with RF exposure compliance requirements, the device should not be used in other configurations.

This device must not be co-located or operated in conjunction with any other transmitter or antenna.

The Watch meets the EU, US and Canada requirements for exposure to radio waves. It is designed and manufactured not to exceed the emission limits for exposure to RF energy set by the Federal Communications Commission (FCC) of the US Government, Industry Canada (IC) of the Canadian Government, the French Government and recommended by the Council of the European Union when used as directed in these Instructions, to ensure the safety of all persons, regardless of age or condition.

**The exposure standard for radio electrical devices uses a unit of measurement known as the Specific Absorption Rate (SAR).** Tests for SAR are conducted using standard operating positions with the device transmitting at its highest certified power level in all tested frequency bands.

Please note that:

- In the United States and Canada, the allowable SAR limits are the following: 1.6 W/kg (averaged over any 1 gram of tissue) for the head, neck and trunk; 2.0 W/kg (averaged over any 10 grams of tissue) for limbs;
- In the EU, the recommended SAR limits are the following: 1.6 W/kg (averaged over any 10 grams of tissue) for the head and trunk; 2.0 W/kg (averaged over any 10 grams of tissue) for limbs (these are legal requirements in France).

The SAR limit recommended by the ICNIRP (International Commission for protection against non-ionizing radiation) is 2 W/kg.

Additionally, the SAR limit that applies to residents of countries / regions that have adopted the SAR limit recommended by the IEEE (Institute of Electrical and Electronics Engineers), including the US, is 1.6 W/kg averaged over one (1) gram of human tissue.

For SAR values for your Watch, see Part III: Regulatory Information.

## **PART II: INTERNATIONAL LIMITED GUARANTEE**

Your Watch (the "Product") and its accessories are covered by an International Limited Guarantee (the "Guarantee") granted by TAG Heuer, branch of LVMH Swiss Manufactures SA, having its registered office at 6a rue Louis Joseph Chevrolet, 2300 La Chaux-de-Fonds, Switzerland, against any manufacturing defect, subject to the conditions below. For the purposes of the Guarantee, "accessories" mean accessories included in the packaging of your Product (e.g., charging dock, USB cable and straps). Accessories are not water-resistant except rubber straps, textile straps and steel bracelets. The Guarantee is valid for two years from the date of purchase for your Product and one year from the date of purchase

for its accessories. Conditions, limitations and exclusions apply to both the Product and its accessories.

### **What is covered?**

Under the Guarantee, TAG Heuer undertakes to repair, free of charge, any problem with the functions of your Product or its accessories that result from a manufacturing defect. TAG Heuer may alternatively, at its own discretion, decide to replace or refund your Product or its accessories. This Guarantee is only honored in official TAG Heuer Service Centers (list and contact details can be found on [tagheuer.com/service/repair-center.html](http://tagheuer.com/service/repair-center.html)).

The Guarantee covers any function defect arising during normal use of the Product and its accessories in accordance with the Product's and accessories' technical specifications and user manuals, as well as any non-arguable quality defects on the cosmetics or mechanical functions that obviously result from a component quality problem or Product mis-assembly by TAG Heuer. This could be, for instance power on/off issues, charging issues, display malfunction, impossibility to use the Product functions or applications due to a manufacturing defect.

### **What is not covered?**

The Guarantee does not cover:

- Damage resulting from services provided anywhere other than at an official TAG Heuer Service Center;
- Function defects which do not arise during normal use of the Product and its accessories in accordance with their technical specifications and user manuals;
- Quality defects in the cosmetics or mechanical functions that do not obviously result from a component quality problem or Product mis-assembly;
- Screen;
- Batteries, unless failure has occurred due to a defect in materials or workmanship;
- Damage to the case or hardware due to moisture that might have entered your Product as a result of improper handling;
- Improper or inadequate use of your Product or its accessories, notably:
  - The Product has been opened by you or an unauthorized person;
  - The Product has been connected to accessories not approved by TAG Heuer;
  - The Product has been damaged or used in a way that contradicts recommended usage guidelines, such as improper plugging, exposure to excessive voltage or electrical discharges, significant shocks, drops, or abnormal mechanical

stress leading to damage to the product's housing or electronic components;

- The product has been aesthetically or functionally damaged due to misuse of a non-charging accessory during assembly or any engraving not performed by TAG Heuer;
- The Product has been abnormally exposed to liquids (water or others), cosmetic products or other chemical substances (presence of corrosion, humidity) or extreme environmental or climatic conditions, in a manner not consistent with the usage instructions (including the Safety and Handling Information);
- An attempt has been made to modify the Product's software.
- Normal wear and aging of your product and its accessories due to regular use, including:
  - Any surface wear due to normal use, such as scratches on the case, strap, crystal, or buckle, dust intrusion, surface degradation, or color changes from sun exposure or contact with chemicals;
  - Reduction in battery performance due to normal aging.

#### **Additional information about TAG Heuer specific material**

Some Products feature a thin gold or titanium carbide coating, which is sensitive to friction on hard, rough surfaces and may wear over time. The guarantee does not cover damage to this coating due to impact or mishandling.

#### **Additional information about operating systems and software applications**

TAG Heuer is not responsible if operating system updates, device pairing, or mobile phone software updates cause malfunctions in the Product or its applications. As permitted by law, TAG Heuer does not guarantee uninterrupted or error-free operation of the product.

Software applications developed and made available to you by TAG Heuer for use with the Product are not covered by the Guarantee. Your use of software applications shall be subject to your acceptance of the dedicated terms and conditions and privacy policies of those applications without prejudice to your statutory rights.

Third-party software applications are not covered by the guarantee, and TAG Heuer is not liable for their use or any damage they may cause to the Watch. You should review third-party terms and conditions before using their software.

#### **Additional information about sensors and intended use**
