Caution! Before first using the BIG BANG e, please read the following instructions which contain important safety and regulatory information. Please keep these instructions in a safe place so that you can refer to them when needed.

SAFETY INSTRUCTIONS

MAIN CHARACTERISTICS OF YOUR BIG BANG e WATCH

The BIG BANG e is a luxury watch which includes Wi-Fi, Bluetooth® and contactless payment functions. It is not intended to be used as a medical device or a fitness tracker.

Wear OS by Google works with phones running Android 6.0+ (excluding Go edition) or iOS 12.0+. Supported features may vary between platforms and countries. Wear OS by Google is a trademark of Google LLC.

The BIG BANG e requires the use of the charging accessories provided with it. The accessories provided with your BIG BANG e contain a micro USB cable, a charging cradle, and a wall plug. You will find further details on electrical safety recommendations concerning the use of the charging accessories below.

You can disable the watch Bluetooth®, Wi-Fi, and contactless payment functions by following the steps below:

If your screen is dim, touch the screen to wake up the watch;

- Swipe down from the top of the screen;
- Find the Settings icon (⚙️), then touch to select;
- Go to "Connectivity", touch Wi-Fi/Bluetooth®/NFC settings, depending on which you want to turn off;
- If Wi-Fi/Bluetooth®/NFC is set to Automatic, tap the toggle switch next to either Wi-Fi/Bluetooth®/NFC to turn it off or disable it.

IMPORTANT SAFETY PRECAUTIONS

Please note that failure to comply with the following guidelines may cause malfunctions or be hazardous to the user and/or void or reduce the entitlement under the warranty and/or US Limited Warranty.

a) Using the BIG BANG e and its accessories safely

Keeping your BIG BANG e safe

(i) General

Do not use or store the BIG BANG e in dusty, dirty areas as its components may be damaged.

Do not store the BIG BANG e in warm areas or under direct sunlight. High temperatures can shorten the life of electronic devices, damage batteries, cause them to become inoperative, and warp or melt certain plastics.

Do not store the BIG BANG e in cold areas. When the BIG BANG e subsequently warms up to its normal temperature, moisture can form inside the BIG BANG e, which may damage the electronic circuits.

Do not attempt to open the BIG BANG e's casing. Non-expert handling of the BIG BANG e may cause damage to your BIG BANG e, and may void the warranty and/or US Limited Warranty.

Do not drop or knock the BIG BANG e.

Do not place heavy objects on it.

Do not use sharp objects on the screen.

Do not use excessive force on the screen. Rough handling may damage the internal circuits.

Do not use harsh chemicals, cleaning solvents or strong detergents to clean the BIG BANG e.

While listening to your device with headphones, make sure you have set the volume to a reasonable level in order to avoid damage to your ears.

If the BIG BANG e or any of its accessories are not working properly, take them to your nearest HUBLOT store. The personnel there will assist you, and if necessary and possible, arrange for the BIG BANG e to be repaired.

In addition to the above, please refer to your instructions and warranty manual for information on the cables, charging cradle, wall plugs and battery electrical safety.

(ii) Exposure to liquid

Try to minimize exposing the BIG BANG **e** to these substances: soap, detergent, acids or acidic foods, and any liquids other than fresh water, such as salt water, soapy water, pool water, perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents.

The BIG BANG **e** has a water resistance rating of IP68 under IEC standard 60529.

If your BIG BANG **e** has a leather strap, be aware that these straps are not water resistant.

The following may affect the water resistance of the BIG BANG **e** and should be avoided:

- Submerging the BIG BANG **e** watch in water for long periods of time;
- Dropping the BIG BANG **e** or subjecting it to impacts;
- Exposing the BIG BANG **e** to pressurized water or high velocity water, for example, water skiing, wake boarding, surfing, jet skiing, etc.
- Wearing the BIG BANG **e** in a hot or humid environment, such as a sauna or steam room.

(iii) Using buttons, Digital Crown, connectors, and ports

Never apply excessive pressure to a button on the BIG BANG **e**, or force a charging connector into a port, because this may cause damage that is not covered under the warranty and/or US Limited Warranty. If the connector and port do not join with reasonable ease, they probably do not match. Check for obstructions, and make sure that the connector matches the port and that you have positioned the connector correctly in relation to the port.

Certain usage patterns can contribute to the fraying or breaking of cables. When attached to a charging unit, the cable, like any other metal wire or cable, is subject to becoming weak or brittle if repeatedly bent in the same spot. Aim for gentle curves instead of angles in the cable. Regularly inspect the cable and connector for any kinks, breaks, bends, or other damage. Should you find any such damage, discontinue use of the cable.

Discoloration of the accessories (cable, plugs) after regular use is normal. Dirt, debris, and exposure to moisture may cause discoloration. If your accessories become warm during use or if the BIG BANG **e** does not charge or sync, disconnect the cable from the power adapter and clean the accessories with a non-abrasive, dry, lint-free cloth. Do not use liquids or cleaning products when cleaning the accessories.

Discoloration of the charging surface of the BIG BANG **e** charging accessories may occur after regular use. Cleaning the charging surface may reduce, or prevent, such discoloration, and will help to prevent damage to your charger and the BIG BANG **e**. To clean the charging surface, disconnect the charger from both the BIG BANG **e** and the power adapter and wipe with a damp, nonabrasive cloth. Dry with a non-abrasive, lint-free cloth before resuming charging. Do not use cleaning products when cleaning the charging surface.

b) User health protection

As a general recommendation, the BIG BANG e is not intended for use where the failure of the device could lead to death, personal injury, or severe environmental damage.

The BIG BANG e and the included BIG BANG e apps are not medical devices. They are not designed or intended for use in the diagnosis of disease or other conditions, or in the cure, mitigation, treatment, or prevention of disease. Before starting or modifying any exercise program using the BIG BANG e, consult your physician. Be careful and attentive while exercising. Stop exercising immediately if you feel pain, faint, dizzy, exhausted, or short of breath. By exercising, you assume all associated inherent risks including any injury that may result from such activity. If you have any medical condition that you believe could be affected by the BIG BANG e (for example, seizures, blackouts, eyestrain, or headaches), consult your physician prior to using the BIG BANG e.

Some people may experience reactions to certain materials used in jewelry, watches, and other wearable items that are in prolonged contact with their skin. This can be due to allergies, environmental factors, extended exposure to irritants like soap, sweat, or other causes. You may be more likely to experience irritation from any wearable device if you have allergies or other sensitivities. If you have known skin sensitivities, please take special care when wearing the BIG BANG e. You may be more likely to experience irritation from the BIG BANG e if you wear it too tightly. Remove the BIG BANG e periodically to allow your skin to breathe.

Keeping the BIG BANG e straps clean and dry will reduce the possibility of skin irritation. If you experience redness, swelling, itchiness, or any other irritation or discomfort on your skin around, or beneath, your BIG BANG e, please remove the BIG BANG e and consult your physician before resuming wear. Continued use, even after symptoms subside, may result in renewed or increased irritation.

The materials used in the BIG BANG e and the BIG BANG e straps meet the standards set for jewelry by the U.S. Consumer Product Safety Commission, applicable European regulations, and other international standards.

During software updates and other limited circumstances, the BIG BANG e may overheat, causing the exterior portions of the watch to feel warmer than usual to the touch. In this event, do not hesitate to remove the BIG BANG e from your wrist for a brief moment to avoid irritation.

If you use an electronic medical device, please refer to the "Interaction with the environment" section below.

c) Integrity of people in the surroundings

(i) Protection of children

Keep the BIG BANG e and its accessories out of the reach of children. In particular, some BIG BANG e straps may present a choking hazard to small children. Keep these straps away from small children.

(ii) Walking and driving safely

Do not use your BIG BANG e while driving.

The BIG BANG e generates, uses, and can radiate radio frequency signals. Radio frequency signals might affect improperly installed or inadequately shielded electronic systems in motor vehicles. Check with the manufacturer or its representative regarding your vehicle. If any equipment has been added to your vehicle, you should also consult the manufacturer of that equipment for information on radio frequency signals.

Do not use your BIG BANG e while walking or engaging in any activity that requires your full attention. Inattention to vehicular traffic or other pedestrian hazards could result in serious injury, death or property loss.

ELECTRICAL SAFETY

a) Accessories

Use only those accessories approved by HUBLOT. Using any accessories not approved by HUBLOT for use with your BIG BANG e might invalidate any approval or warranty and/or US Limited Warranty applicable to your device and/or might result in the BIG BANG e becoming inoperative and/or dangerous.

b) Charging accessories

Your BIG BANG e is provided with the following charging accessories: micro-USB cable, charging cradle and wall plug. Use only approved charging accessories.

When a charger is not in use, disconnect it from the power source.

It is important to keep the BIG BANG e and the accessories provided therewith in a well-ventilated area when charging.

Use the charging accessories provided with the BIG BANG e or any other HUBLOT approved charging accessories only from the type of power source indicated on the label. Before you use any power supply, verify that the mains (AC) voltage is in accordance with the voltage printed on the power supply.

Do not overload power outlet, extension cords or convenience receptacles because this might result in a risk of fire or electric shock. To reduce the risk of damage to the cord or the wall charger, pull on the wall charger rather than the cord when you disconnect the charging accessory from the power outlet or power source.

Using damaged BIG BANG e charging accessories, or charging when moisture is present, can cause fire, electric shock, injury, or damage to the user or the BIG BANG e or other property. Be sure the BIG BANG e and the charging accessories are dry before charging. When you use the charging accessories to charge the BIG BANG e, make sure that the USB plug is fully inserted into the adapter before you plug the adapter into a power outlet. Avoid charging the BIG BANG e in direct sunlight. Do not wear the BIG BANG e while it is charging.

Avoid prolonged skin contact with the connector when the cable is plugged into a power source because it may cause discomfort or injury. Sleeping or sitting on the connector should be avoided.

In addition to the above:

- Do not expose the charger to water while in use; this may cause the charger and the BIG BANG e to fail;
- Carefully insert the USB cable into the charger base, forcing the cable in the wrong direction will damage the charger;
- It is recommended to charge the BIG BANG e in a cool place, in order to prevent overheating of the BIG BANG e;
- It is not recommended to charge the watch in a place where there is direct sunlight on the BIG BANG e, as this may cause overheating;
- When the BIG BANG e is placed on the charger, and the charger is plugged into a wall, a charging screen will be displayed on the face of the BIG BANG e, indicating the percentage of battery already charged;
- It is recommended to remove the BIG BANG e from the charger once it is fully-charged;
- If the BIG BANG e fails to charge, check that the wall plug is fully inserted into the wall outlet, the USB cable is firmly attached to the charger, and the watch is properly placed on the charger;
- If the BIG BANG e still does not charge, make sure that the watch is correctly oriented on the charger and make sure the back of the BIG BANG e is clean;
- The charger contains a small magnet to ensure proper alignment and attachment of the BIG BANG e to the charger. Please keep the charger away from metal.

c) Battery safety

Your BIG BANG e contains a built-in battery that is not replaceable. Do not attempt to replace your product's battery (for information on the recycling of the battery, please refer to the "Maintenance and disposal" section below).

In any event:

- Do not expose the battery to fire or other external heat sources, such as hot plates, stove tops, space heaters or ovens, as this could cause fire or explosion;
- Do not dispose of batteries in a fire;
- Never use any charger or battery that is damaged in any way. Use the battery only for its intended purposes. Do not short-circuit the battery;
- Do not leave the battery in hot or cold places.

INTERACTION WITH THE ENVIRONMENT

a) Interference with electronic equipment and magnetic characteristics

Your BIG BANG e, like any radio-transmitting equipment, may interfere with other electronic devices.

Switch off your device on airplanes or any place where it is requested (hospitals, gas stations, etc.).

In any case, make sure you are using your device where it is authorized for use and in an authorized manner.

In particular, your BIG BANG e may interfere with pacemakers, defibrillators, or other medical devices. Maintain a safe distance of separation between your medical device and the BIG BANG e and accessories. Consult your physician and medical device manufacturer for information specific to your medical device. Stop using the BIG BANG e and its accessories if you suspect they are interfering with your pacemaker, defibrillator, or any other medical device.

Keep key cards and credit cards away from the BIG BANG e and its accessories.

b) Dangerous areas

Charging or using the BIG BANG e in any area with a potentially explosive atmosphere, such as in areas where the air contains high levels of flammable chemicals, vapors, or particles (such as grain, dust, or metal powders), may be hazardous.

Obey all signs and instructions.

c) Operating and storage temperatures

The normal operating temperature of the BIG BANG e is from 0 to 40° C (32 to 104° F).

The BIG BANG e can be damaged and battery life shortened if stored or operated outside of these temperature ranges. Avoid exposing the BIG BANG e to dramatic changes in temperature or humidity. If the interior temperature of the BIG BANG e exceeds normal operating temperatures (for example, in a hot car or in direct sunlight for extended periods of time), you may experience the following as it attempts to regulate its temperature:

- Charging may slow or stop;
- The display may dim;
- Some data transfer may be paused or delayed;

The BIG BANG e and its accessories comply with applicable surface temperature standards and limits. However, even within these limits, sustained contact with warm surfaces for long periods of time may cause discomfort or injury.

The BIG BANG e and its accessories will become warm when plugged into a power source. Use common sense to avoid situations where your skin is in contact with the BIG BANG e and/or its accessories for long periods of time when they are plugged in. For example, while the BIG BANG e is charging or while its accessories are plugged into a power source, do not sleep on them or place them under a blanket, pillow, or your body. Take special care if you have a physical condition that affects your ability to detect heat against the body. Remove the BIG BANG e if it becomes uncomfortably warm.

MAINTENANCE AND DISPOSAL

a) Cleaning and repair

Keep the BIG BANG e clean and dry. Dry the BIG BANG e thoroughly if exposed to fresh water. Clean the BIG BANG e if it comes in contact with anything that may cause stains, or other damage, such as dirt or sand, makeup, ink, soap, detergent, acids or acidic foods, or comes in contact with liquids other than fresh water, including those that may lead to skin irritation such as: sweat, salt water, soapy water, pool water, perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents. The BIG BANG e may vary or fade over time.

The following things are not recommended in the care of your BIG BANG e:

- Do not clean the BIG BANG e while it is charging;
- Do not dry the BIG BANG e or the straps using any external heat source (for example, a hair dryer);
- Do not use cleaning products or compressed air when cleaning your BIG BANG e.

b) Built-in battery: precautions and information

- Your BIG BANG e features a built-in rechargeable battery, which is not replaceable or removable by the user;
- Do not attempt to replace or remove your BIG BANG e's battery yourself;
- Tampering with your product, or attempting to open it, will void the warranty and/or US Limited Warranty and may result in a safety hazard;
- For any handling of the battery please contact your HUBLOT store or to call our Customer Service Centers at the phone numbers that can be found at the end of this booklet.

c) Electronic or electric equipment and battery disposal

Your BIG BANG e, its accessories and its battery contain hazardous substances. They must not be disposed of as unsorted household waste. They are subject to specific local regulations. In particular, as the BIG BANG e and its accessories were placed on the market after 13 August 2005, they are subject, in the European Union, to Directive 2012/19/EU on waste electrical and electronic equipment (WEEE);

In addition, the battery contained in your BIG BANG e is subject to Directive 2006/66/EC on batteries and accumulators and waste batteries and accumulators. The crossed-out wheeled bin symbols below indicate that the BIG BANG e, its battery and its accessories are subject to these regulations.

The above-mentioned equipment and battery must be collected separately.

The correct disposal of your old equipment, batteries or accumulators will help to prevent potential negative consequences for the environment, animal and human health.

By recycling, reusing the materials or other forms of utilizing old devices, you are making an important contribution to protecting our environment.

Do not dispose of the above-mentioned equipment in a fire.

- HUBLOT will not honor the warranty for your BIG BANG e sold without a valid warranty card properly electronically activated or filled out and signed by a HUBLOT store;
- The serial number engraved on the case is perfectly legible and no part of the original case back or original serial number has been removed, modified, falsified, altered, replaced, erased, defaced or made illegible.

Failure to abide by any of the above conditions renders all rights resulting from the BIG BANG e international limited warranty null and void.

What is not covered?

Damage resulting from service provided anywhere other than at an official HUBLOT Customer Service Center is not covered and shall void the warranty. The international limited warranty also does not cover straps, crystals and batteries, or any damage to the case or hardware due to moisture that might have entered your BIG BANG e as a result of improper handling.

More generally, it does not apply if there has been improper or inadequate use of your BIG BANG e:

- Product has been opened by the user or by unauthorized person;
- Product has been connected to non-recommended accessories such as other battery type or charger;
- Product has been voluntarily degraded or used out of the recommended rules for product start-up or usage such as wrong plug-in or product has been exposed to extra voltage or electric discharges, important shocks, drop or abnormal mechanical stress leading to major degradation of product housing, electronic components;
- Product has been abnormally exposed to water or other chemical substances (presence of corrosion, humidity);
- Product has been exposed to high temperature (greater than 40° C/104° F) or other extreme environmental conditions;
- An attempt to modify product software has been performed.

If one or the above mentioned items are observed, then the BIG BANG e will not be covered by the international limited warranty. The normal wear and aging of your BIG BANG e due to normal usage is not covered by warranty. This is especially the case for

- Any material surface degradation due to normal usage of product, scratches on case, rubber, crystal, dust intrusion or degraded surfaces, change of color of parts due to exposure to solar radiation or contact with any chemical substance;
- Damage of autonomy performance due to battery normal aging.

Disclaimer of warranty for software

For purposes of this Software section, "Software" means any software application (and all associated content and functionality) that may be accessed using or that may otherwise interoperate with the BIG BANG e.

Third-Party Software. "Third-Party Software" refers to Software that has been developed by, or is provided to you for use with the BIG BANG e by, any person other than HUBLOT.

Please note that HUBLOT shall not be held responsible where updates to the operating systems of the BIG BANG e or pairing of the BIG BANG e with specific mobile phone models would incur dysfunction or malfunctioning of the BIG BANG e.

Third-Party Software is provided subject to, and in accordance with, the applicable third party's terms and conditions. Any warranty that is provided in connection with such Third-Party Software is provided solely by such third party(ies) and not by HUBLOT.

Accordingly, you acknowledge that HUBLOT shall not be liable with regards to the use and/or exploitation of such third parties application and/or software. We strongly encourage you to read carefully third parties' terms and conditions.

HUBLOT Software. HUBLOT may from time to time provide or make available certain Software to users in connection with the BIG BANG e ("HUBLOT Software").

General conditions and limitations

This international limited warranty gives you specific legal rights and you may also have other rights under local laws which vary from country to country. HUBLOT and its stores shall have sole discretion to decide to repair or replace any HUBLOT timepiece under this international limited warranty. To the extent permitted by the local law, HUBLOT shall not be liable for any incidental, special, punitive or consequential damages.

This international limited warranty may be transferred with the BIG BANG e.

We recommend that you bring your BIG BANG e to the nearest HUBLOT store. This list of HUBLOT stores worldwide can be found at the end of this booklet. This warranty does not affect your legal rights as a consumer.

Please check that this booklet contains a card electronically activated or completed, dated and signed – otherwise you will not be covered by the international limited warranty services outlined above.

Additionally, in order to be covered by this international limited warranty, the following administrative conditions shall be met when returning the product:

To the extent permitted by local legislations, the product shall be returned with its original battery and charger to a HUBLOT store.

Specific additional terms of warranties applicable to Australia and New Zealand

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. In addition to your rights above, HUBLOT goods come with warranties that cannot be excluded under the Australian Consumer Law or under New Zealand Law.

If your HUBLOT goods are defective, you are entitled to a replacement or refund for a major failure or may be entitled to recover costs for an amount for the reduction in the product's value and in some cases compensation for loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure. In Australia, please go to your nearest HUBLOT store in Australia for any warranty inquiries. You may also call our Customer Service Center at the phone numbers that can be found at the end of this booklet for more information or for any question on this warranty.

Specific additional terms of warranties applicable to Austria

This international limited warranty is in addition to the statutory warranty of the seller which may not be excluded.

HUBLOT shall not be liable for any incidental, special, punitive or consequential damages, except for damages to persons and claims under Austrian Product Liability Law. The product shall be returned with its original battery and charger to a HUBLOT store.

Specific additional terms of warranties applicable to Belgium

The international limited warranty set out above is in addition to other rights and remedies available to you under mandatory Belgian law. In particular, you may have a right to resort to HUBLOT obligations under applicable Belgian law governing the sale of consumer goods, which are not affected by the terms of this international limited warranty.

Specific additional terms of warranties applicable to Brazil

This international limited warranty is in addition to the mandatory rules and warranties provided in the Brazilian Consumer Defence Code – CDC (Law No. 8078/90, as amended). We strongly recommend you consult the provisions of the CDC.

HUBLOT and its official Customer Service Centers, to the extent permitted by Brazilian law, shall have sole discretion to decide to elect one of the three alternatives repair, replace or refund your BIG BANG Ⓢ under the international limited warranty. Also, to the extent permitted by Brazilian law, HUBLOT shall not be liable for any incidental, special, punitive or consequential damages.

Specific additional terms of warranties applicable to the Czech Republic

This international limited warranty is provided at the discretion of HUBLOT and gives you specific legal rights which may be exercised in addition to other rights and remedies available to consumers under the laws of the Czech Republic governing sale of consumer goods. National rights and remedies are not affected by this international limited warranty.

In regard to Czech legislation in particular, see your options below.

If a defect in your BIG BANG e occurs within six months from the date of purchase, the law presumes that the BIG BANG e was defective on the date of purchase and therefore not compliant with the contract. Depending on the nature of the defect, the non-conformity with the contract can be substantial or non-substantial.

In case of substantial non-conformity with the contract you can claim one of the following rights:

- a) to have your BIG BANG e replaced with a defect-free product,
- b) to have your BIG BANG e repaired,
- c) to claim a proportionate discount from the purchase price, or
- d) to withdraw from the contract.

In case of non-substantial non-conformity with the contract you can claim one of the following rights:

- a) to have the defect in your BIG BANG e eliminated, or
- b) to claim a proportionate discount from the purchase price.

Furthermore, Czech law provides for a statutory warranty against any defect occurring in your BIG BANG e within twenty-four months from the original date of purchase. If the defect occurs within this timeframe you can claim a replacement for your defective BIG BANG e, if it is not disproportionate in regard to the nature of the defect.

If the defect relates only to a part of the BIG BANG e you can only claim replacement of this part. In case such replacement or repair is not possible, you can withdraw from the contract. If, however, the replacement of the BIG BANG e or its part is disproportionate to the nature of the defect, in particular where the defect can be repaired or removed without undue delay, you have the right to have your BIG BANG e repaired free of charge.

You can also claim a replacement or repair of your defective BIG BANG e or its part in case of recurring defects which prevent you from proper usage of the BIG BANG e. If the defect occurs repeatedly (i.e. more than three times), you can withdraw from the contract and ask for a refund of the purchase price in exchange for the defective BIG BANG e.

If you wish not to claim your rights as described above, you can ask for a proportionate discount from the purchase price. You can also claim a discount in case the seller is not able to provide you with a defect-free BIG BANG e, replace its defective part or repair the product. The discount is also available to you if the seller fails to provide a remedy for your claim within a reasonable time or where such a remedy would cause substantial difficulties to you.

Your claims under Czech law can be raised with the seller from whom you bought the BIG BANG e within the statutory time limits as stated above. If you want to exercise your rights, you have to notify the seller without undue delay from when the defect occurred, describe the nature of the

defect and provide a proof of purchase (i.e. purchase receipt for the BIG BANG e).

Specific additional terms of warranties applicable to the mainland China

Your BIG BANG e comes with warranties that cannot be excluded under the Consumer Protection Law. In addition:

- If any quality defects occur to your BIG BANG e within seven days after purchase, you may choose to return the product, or request seller to replace or repair the product at your discretion. Where you chose to return the product with quality defect, HUBLOT should refund the purchase price;
- If any quality defect occurs within 15 days after the purchase, you may request HUBLOT to replace or repair the products at your discretion. Where you choose to replace the BIG BANG e with quality defects, HUBLOT should replace it with the same type and specifications free of charge;
- Within one year after the purchase, if the BIG BANG e is not fit for its intended use after two rounds of repair, after you present relevant repair records, HUBLOT shall replace it with a product of the same type and specifications free of charge, or refund purchase price after deduction of any depreciation cost.

Specific additional terms of warranties applicable to Denmark

This international limited warranty is in addition to other rights and remedies available to you under Danish law, which may not be excluded, such as the rights provided under the Consumer Sales Act (Forbrugeraftaleloven) and the Sales of Goods Act (Købeloven). For instance, under the Danish Sales of Goods Act, you may be entitled to claim defects within a time period of two years from the delivery date, provided that you give notice thereof within reasonable time after you discovered the defect.

Specific additional terms of warranties applicable to France

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. With respect to the above-mentioned international limited warranty, *"when the buyer asks the seller to carry out repairs covered by his commercial warranty upon the acquisition and the reparation of a movable asset, the period of any resultant shutdown of seven days or longer shall be added to the unexpired term of the warranty. The said period shall run from the time when the buyer requests assistance or the time when the product in question is taken out of service pending repair, should this be subsequent to the request for assistance"* (article L217-16 of the French Consumer Code).

Notwithstanding anything to the contrary in this warranty, in addition to the limited international warranty, HUBLOT is liable for the French legal (i) warranty of conformity described in articles L217-4 to L217-13 of the French Consumer Code, and (ii) warranty against hidden defects in the conditions set out in articles 1641 to 1648 and 2232 of the French Civil Code.

With respect to the warranty against hidden defects, according to article 1641 of the French Civil Code "the seller is bound to a warranty against hidden defects in the thing sold that render it unfit for its intended use, or that so impair its use that the buyer would not have bought it, or would only have given a lesser price for it if he had known of the defects", and to the first paragraph of article 1648 of the same Code "an action resulting from redhibitory defects must be brought by the buyer within two years from the discovery of the defect". With respect to the warranty of conformity, according to articles L217-4 and L217-5 of the French Consumer Code "the seller shall deliver a product which conforms to the contract and is held liable for any lack of conformity which exists upon delivery. He is also held liable for any lack of conformity caused by the packaging or the assembly instructions, or the installation if he assumed responsibility therefor or had it carried out under his responsibility" and "the product conforms the contract:

1. If it is suitable for the purpose usually associated with such a product and, if applicable: correspond to the description given by the seller and has the features that the seller presented to the buyer in the form of a sample or model;
2. If it has the features that a buyer might reasonably expect to have considering the public statements made by the seller, the producer or his representative, including advertising and labeling;
3. Or if it has the features defined by mutual agreement between the parties or be suitable for any special requirement of the buyer which was made known to the seller and which the latter agreed to". In addition, an "action resulting from a lack of conformity lapses two years after delivery of the product" (article L217-12 of the French Consumer Code).

Specific additional terms of warranties applicable to Germany

The conditions of the international limited warranty do not apply to rights granted under statutory warranty and consumer protection laws. This international limited warranty is in addition to other rights and remedies available to you under the laws of Germany, which cannot be excluded. Nothing in this international limited warranty purports to limit, modify, take away from, disclaim, exclude or suspend any mandatory warranty requirements provided or non-excludable statutory rights you may have under the laws of Germany, in particular the statutory warranty and consumer protection rights under Sec. 434 ff., 474 ff. German Civil Code (Bürgerliches Gesetzbuch, BGB).

Irrespective of the rights granted under the international limited warranty, if your BIG BANG e is defective and does not conform to contract at the time of delivery, you are entitled by Sec. 434 ff. 474 ff. BGB, at your choice, to a replacement or to have the BIG BANG e repaired. If we are not able to replace or repair your defective BIG BANG e or refuse to do so, you may be entitled to revoke the purchase agreement, reduce the purchase price or demand damages or reimbursement of futile expenditure.

In addition to the conditions set forth in this warranty form above, the international limited warranty does not apply in the events of a lack of fitness for a particular purpose and uninterrupted or error-

free operation. The statutory warranty and consumer protection rights, in particular Sec. 434 ff. 474 ff. BGB, are not limited, modified, taken away, disclaimed, excluded or suspended thereby. HUBLOT shall not be liable for any incidental, special, punitive or consequential damages arising out of or in connection with the international limited warranty. In this respect, HUBLOT shall only be liable on the merits of willful misconduct (Vorsatz) or gross negligence (grobe Fahrlässigkeit). The aforesaid limitation of liability shall not apply in case of damages to the life, the body or the health of a person; the same applies to compulsory liability according to the German Product Liability Act (Produkthaftungsgesetz).

Specific additional terms of warranties applicable to Grand-Duchy of Luxembourg

This international limited warranty is without prejudice to your rights and remedies available to you in accordance with the Luxembourg legal warranty of conformity described in articles L212-1 to L-212-7 of the Luxembourg Consumer Code and warranty against hidden defects in the conditions set out in articles 1641 to 1649 of the Luxembourg Civil Code.

With respect to the warranty of conformity, a professional must deliver a product which conforms to the contract and is held liable for any lack of conformity which exists upon delivery, even unknown to him. He is also liable for any lack of conformity caused by the packaging, the assembly instructions or the installation if such installation formed part of the contract or took place under his responsibility. To invoke the professional's legal warranty of conformity, the consumer must, by any means, inform the latter of the default in conformity within a delay of two years as of the delivery of the product.

With respect to the warranty against hidden defects, articles 1641 and following of the Luxembourg Civil Code state that "a seller is bound by a warranty against hidden defects in the thing sold that renders it unfit for its intended use, or that so impairs such use that the buyer would not have bought it, or would only have given a lesser price for it if he had known of the defects". In accordance with article 1648 of the Luxembourg Civil Code, the buyer must inform the seller of the hidden defects within a brief delay as of the moment the defect was discovered or should have been discovered.

Specific additional terms of warranties applicable to Hong Kong special administrative region of the people's Republic of China

This international limited warranty is in addition to other rights and remedies available to you under Hong Kong law (in particular, the Sale of Goods Ordinance (Cap. 26 The Laws of Hong Kong)).

Specific additional terms of warranties applicable to Israel

These specific additional terms applicable to the State of Israel (the "Israeli Specific Terms") shall supplement the provisions of the international limited warranty and be incorporated in the same to constitute an integral part thereof. The purpose of these Israeli Specific Terms is to meet the requirements of the Consumer Protection Law, 1981 and the Consumer Protection Regulations (Warranty and Service After Sale), 2006, which cannot be excluded.

Notwithstanding anything to the contrary in the international limited warranty:

1. This international limited warranty is provided by on behalf of HUBLOT SA.
2. The international limited warranty shall commence from the date of receiving the purchased BIG BANG e.
3. During the first year of warranty:
 - 3.1 Notwithstanding anything stated in the international limited warranty, the international limited warranty shall cover any function defect (including damages to batteries) arising during normal use of the product in accordance with its technical specifications, user manuals, as well as any non-arguable quality defects on the cosmetics or mechanical functions that are obviously coming from a component quality problem or watch mis-assembly.
 - 3.2 In order for the international limited warranty to be honored, you are only required to present the duly electronically activated (or duly signed, if no electronic activation system is available) international limited warranty or a proof of purchase. As the warranty is individual to the product, you will be asked the serial number of your HUBLOT BIG BANG e (engraved on the case back) in order to link it with the warranty.
 - 3.3 To the extent that in the course of the repair it was necessary to replace the BIG BANG e – in whole or in part – then this replacement shall be free of charge.
 - 3.4 You will receive a written notice regarding repair or replacement that has been done with respect to your product.
 - 3.5 Repairing a malfunction in the BIG BANG e shall bring it back to its condition as it was prior to the occurrence of the malfunction and if such repair involves the replacement of any components, such components will be replaced with new and original components.

- 3.6 Repair will be performed within ten (10) days from the day on which the BIG BANG e was delivered to a HUBLOT Customer Service Center or within 2 weeks from the date on which the product was delivered to HUBLOT authorized retailer. Saturdays and holidays will not be counted as part of the periods detailed herein.

5. The international limited warranty is provided in HUBLOT Customer Service Center, which details can be found on <http://hublot.com>.
6. **ADDITIONAL LIMITED WARRANTY** - After the end of the first year of warranty, the Israeli Specific Terms other than Section 3 remain applicable to your HUBLOT BIG BANG e (excluding the accessories) for one additional year. For the avoidance of doubt, the duly electronically activated (or duly signed, if no electronic activation system is available) international warranty card will still have to be enclosed with your HUBLOT BIG BANG e when it is sent for repair.

Specific additional terms of warranties applicable to Italy "Garanzia legale del venditore"

This international limited warranty is in addition to the statutory warranty which may not be excluded, pursuant to articles 128ff of the Italian Consumer Code.

In the case of a lack of conformity, you shall be entitled to have the HUBLOT goods brought into conformity free of charge by repair or replacement or to have an appropriate reduction made in the price or the contract rescinded with regard to those goods, in accordance with what provided under Art. 130 of the Italian Consumer Code.

At your discretion, you may request HUBLOT to repair or replace the HUBLOT goods, free of charge in either case, unless the remedy requested is impossible or disproportionate.

One of the remedies shall be considered disproportionate if it imposes costs on HUBLOT which, in comparison with the other remedy, are unreasonable, taking into account:

The value the HUBLOT goods would have if there were no lack of conformity;

The significance of the lack of conformity, and whether the alternative remedy could be completed without significant inconvenience to you.

The repairs or replacements shall be completed within a reasonable time and without any significant inconvenience to you, taking account of the nature of the HUBLOT goods and the purpose for which you required the HUBLOT goods.

The costs above mentioned refer to costs that are essential to make the HUBLOT goods conform, in particular with reference to the costs incurred for delivery, labour and materials.

At your discretion, you may require an appropriate reduction of the price or have the contract rescinded in one of the following situations:

Repair or replacement are impossible or disproportionate;

If HUBLOT has not completed the remedy within a reasonable time or replaced the HUBLOT goods within the appropriate time;

The replacement or repair carried out previously caused significant inconvenience to you.

When determining the amount of the reduction or the sum to be refunded the use of the HUBLOT goods is taken into account.

After reporting the lack of conformity, HUBLOT may offer you any other available remedy, with the following effects:

If you have already requested a specific remedy HUBLOT is obliged to implement it, with the necessary consequences within a reasonable time frame, unless you accept an alternative remedy;

If you have not already requested a specific remedy, you shall accept the offer or reject it by choosing another remedy pursuant to what above.

If the non-conformity is of only minor importance, for which it is impossible or disproportionate to complete the remedies of repair or replacement, you are not entitled to rescind the contract.

HUBLOT shall be held liable where the lack of conformity becomes apparent within two years of delivery of the HUBLOT goods.

You lose your consumer's rights if you do not inform HUBLOT Customer Service of the lack of conformity by no later than two months after the date on which you discovered it. This notification shall not be required if HUBLOT has acknowledged the existence of the lack of conformity, or has concealed it.

Except where proven otherwise, it shall be assumed that the defects arising by six months after the delivery of the HUBLOT goods already existed on that date, unless this presumption is incompatible with the nature of the HUBLOT goods or the nature of the lack of conformity.


Actions intended to enforce the lack of conformity not hidden by HUBLOT with fraud shall in any event lapse after twenty-six months from delivery of the HUBLOT goods. Consumers who have been summoned to perform the contract may in any event enforce their rights provided that the lack of conformity was notified within two months from discovery thereof, and prior to the expiry of the period referred to in the foregoing sentence.

Specific additional terms of warranties applicable to Lebanon

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. Notwithstanding anything to the contrary in this warranty, in addition to the international limited warranty, HUBLOT is liable for the warranty of conformity and warranty against hidden defects described respectively in articles 28 and 29 of the Lebanese Consumer Protection Law ("CPL"). Pursuant to article 28 of the CPL, HUBLOT warrants the quality of the products and their conformity to the description that such supplier has announced. According to article 29 of the CPL, HUBLOT warrants hidden defects that concretely damage the products or make such products unsuitable for its proper use as resulting from their nature or from the provisions of the contract taking into consideration that this warranty shall neither cover faults that slightly damage the products or the use of such products, nor faults customarily permissible.

Specific additional terms of warranties applicable to Macau

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded.


To be eligible under this warranty, any defects/lack of conformity of the BIG BANG  must be claimed from/ notified to HUBLOT Customer Service Center within a period of 30 days from the date on which you detected such defects/lack of conformity.

This manufacturer's warranty: (i) is independent of any warranty that may be provided by the seller, for which he carries sole responsibility; (ii) does not affect your statutory rights towards the seller, the manufacturer or the distributor.

Specific additional terms of warranties applicable to the Netherlands

This international limited warranty gives you specific legal rights, which may be exercised in addition to other rights under Dutch law governing the sale of consumer goods which rights are not affected by this international limited warranty.

This international limited warranty is provided by HUBLOT having its main establishment at HUBLOT SA — HEADQUARTERS & MANUFACTURE — Ch. de la Vuarpillière 33 — 1260 NYON — SWITZERLAND

This warranty can be enforced in the countries where the BIG BANG  is distributed, including the Netherlands.

Specific additional terms of warranties applicable to Norway

In addition to the rights set out in the international limited warranty, you can complain based on the provisions in the Norwegian Consumer Purchase Act. The Act contains provisions regulating consumers' rights regarding, amongst other things, rectification, delivery of substitute goods, cancellation and right to damages. Provided that certain conditions in the Norwegian Consumer Protection Act are fulfilled, claims can be set forth up to five years after the purchase.

Specific additional terms of warranties applicable to Philippines

This international limited warranty is in addition to the implied warranties in accordance with the laws of the Philippines.

Specific additional terms of warranties applicable to Poland

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. This international limited warranty does not preclude, limit or suspend your rights vis-à-vis the seller of your product resulting from the provisions on the implied warranty against defects set out in articles 556 to 576 of the Polish Civil Code.

Specific additional terms of warranties applicable to Portugal

This international limited warranty of two years (applicable in the same terms to your BIG BANG e and its accessories), is a voluntary warranty and does not supersede the consumers' rights provided by the Consumers' Protection Law (Law no. 24/96 of 31 July, as amended), which may not be excluded.

Under the legal mandatory warranty, the period for claiming defects of non-conformity related to purchases made by consumers in Portugal is of 2 years from the date of delivery, pursuant to Decree-Law no. 67/2003 of 8 April (as amended).

This manufacturer's warranty is independent of any warranty that may be provided by the seller, for which he carries sole responsibility.

Specific additional terms of warranties applicable to Republic of Korea

For any issues in relation to consumer protection and related disputes that are not addressed in this international limited warranty, the Framework Act on Consumers would apply.

Specific additional terms of warranties applicable to Russia

This international limited warranty is in addition to other rights and remedies available to you under the Russian legislation in the sphere of the Consumers' Rights' protection. BIG BANG e comes with a warranty which is provided in addition to the rights mentioned above.

1. In case of any defect being revealed in your BIG BANG e, you are entitled to the rights provided to you by the Russian legislation in the sphere of the Consumers' Rights' protection, as well as by this international limited warranty. The terms and conditions for granting of the warranty for device and accessories are described in the section "What is covered" whereby you are entitled to make claims related to defects of the device and of the accessories to it. Please note that the period of validity of the warranty is different for the device itself and for its accessories.
2. The absence of a properly completed warranty card does not release HUBLOT from its warranty obligations. Nevertheless, in order to receive full benefit within the shortest possible time from this international limited warranty the following conditions must be met:

- The warranty card you received with your BIG BANG e should be enclosed to your BIG BANG e when returned to a HUBLOT store for repair;
 - The serial number engraved on the case is perfectly legible and no part of the original case back or original serial number has been removed, modified, falsified, altered, replaced, erased, defaced or made illegible.
3. The useful life of the watch is two years.
 4. In accordance with the Russian legislation BIG BANG e falls within the category of technically sophisticated products.
 5. The representative of the manufacturer in Russia, authorized to address your claims is OOO MERCURY CLASSIC, tax identification number 7715516170, main registration number 1047796230460, 117405, Kirpichnye Vyemki street, 2, Building 1, floor 2, indoor space X, room 8, office 11, MOSCOW, RUSSIA You may also call our Customer Service Center at the phone numbers that can be found at the end of this booklet for more information or for any question on this warranty.

Specific additional terms of warranties applicable to Singapore

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. Nothing in this international limited warranty purports to limit, modify, take away from, disclaim, exclude or suspend any mandatory warranty requirements provided or non-excludable statutory rights you may have under the laws of Singapore.

If your HUBLOT goods are defective and do not conform to contract at the time of delivery, you are entitled to a replacement, refund or to have the goods repaired.

Where the HUBLOT goods are found to be defective within six months from the time of delivery, it is presumed that the goods failed to conform to contract at the time of delivery and you may be entitled to a replacement, refund or to have the goods repaired.

In Singapore, please go to your nearest HUBLOT store in Singapore for any warranty inquiries. You may also call our Customer Service Center at the phone numbers that can be found at the end of this booklet for more information or for any question on this warranty.

Specific additional terms of warranties applicable to Spain

Under this limited two-year warranty, HUBLOT undertakes to carry out any of the following actions, which will be chosen by you, as a consequence of any problem with the functions defect arising during the normal use of the BIG BANG e: (i) repair, free of charge, the BIG BANG e (ii) replace the BIG BANG e for a new device which meets the same conditions than the one acquired; (iii) agree a reduction of the price of the BIG BANG e and (iv) the reimbursement of the price as a result of the refund of the BIG BANG e.

Specific additional terms of warranties applicable to Sweden

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded, such as the rights provided under the Consumer Sales Act (Konsumentköplag (1990:932)). As an example, the Consumer Sales Act may allow you to file a product complaint within three years after receiving a product.

Specific additional terms of warranties applicable to Turkey

This international limited warranty is in addition to other rights and remedies available to you under local law, which may not be excluded. Under Turkish laws, the warranty period is 2 years as from the delivery date of the BIG BANG e and the expected life span of the product is 5 years. The fullest extent of the goods including all parts is within the scope of warranty. In case the BIG BANG e is evaluated as defective, the consumer can use one of the rights granted in Article 11 of the Law Regarding Protection of Consumers numbered 6502:

- cancellation of the contract,
- discount in the sales price in proportion to the defect,
- free-of-charge repair,
- replacement of the defective BIG BANG e with a new one.

The seller is liable to perform such request preferred by the consumer. If free-of-charge repair or replacement of the defective BIG BANG e leads to disproportionate difficulties for the seller, the consumer can cancel the agreement or request a discount in the sales price in proportion to the defect. In determining what is disproportionate, the value of the BIG BANG e free from the defects, severity of the defect and whether or not the exercise of other optional rights would constitute a problem for the consumer shall be taken into account. In case the right of replacement of the BIG BANG e with a new one is chosen, it is required to satisfy such request within thirty business days at most as from directing it to the seller, manufacturer or the importer. Otherwise, the consumer is free to use other optional rights.

In case the consumer chooses the right of free of charge repair, the seller is liable to repair or to have repaired the BIG BANG e without demanding the cost of labor, the price of replaced parts or any other costs under whatsoever name. You may use the right of free of charge repair or replacement of the BIG BANG e with a new one against the manufacturer or importer as well. The seller, manufacturer and the importer are severally responsible for performing such rights within this paragraph. The manufacturer or the importer shall not be held liable where they can prove that the defect occurred after they released the BIG BANG e into the market. In case the right of free of charge repair is used by the consumer, you can request for refund of the purchase price, deduction from the purchase price in the rate of the defect or, if possible, replacement of the BIG BANG e with a new one from the seller in the events that;

- the BIG BANG e is broken down again within the warranty period,
- maximum period for the repair is exceeded,
- it is determined that repair of the BIG BANG e is not possible, through a report issued by authorized technical station, seller, manufacturer or importer. The seller cannot reject the request of the consumer. If such claim is not satisfied, the seller, manufacturer and the importer are severally responsible.

The repair period of the BIG BANG e is maximum 20 business days. Otherwise, you are free to use other granted optional rights. This period begins as of the notification date of the fault to the authorized service station or the seller within the warranty period, and the delivery date of the BIG BANG e to the authorized service station without the warranty period. In case the fault is not repaired within 10 business day, the seller or the importer shall be liable to assign another BIG BANG e having similar features for the use of the consumer until the repair is finished. In case the BIG BANG e is broken down within the warranty period, the period in repair shall be added to warranty period.

In case you choose the rights of cancellation of the contract or discount in the sales price in proportion to the defect, all paid amount or the discounted amount in the sales price shall be refunded to you immediately.

All costs generated from the use of optional rights shall be fulfilled by the party performing such rights of the consumer. You may also request for the compensation in accordance with the provisions of the Turkish Code of Obligations dated January 11, 2011 and numbered 6098 together with one of these optional rights.

The faults arising from the improper use of the goods against the facts indicated in guidelines for use are out of the warranty scope.

You may apply to Consumer Board or Consumer Court where your residential place is located or where the purchase transaction has been performed for the disagreements arising from your warranty rights.

Specific additional terms of warranties applicable to the United Arab Emirates

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. If your HUBLOT goods are defective, you are entitled to choose between repair, replacement or a refund. If you suffer loss or damage as a result of the defective goods, you may also be entitled to compensation.

These rights apply regardless of whether the warranty stamp is completed – subject to proof of purchase. In United Arab Emirates, please go to your nearest HUBLOT store in Dubai UAE for any warranty inquiries. You may also call our Customer Service Center at the phone numbers that can be found at the end of this booklet for more information or for any question on this warranty.

The serial number engraved on the case is perfectly legible and no part of the original case back or original serial number has been removed, modified, falsified, altered, replaced, erased, defaced or made illegible.

Specific additional terms of warranties applicable to the United Kingdom

This international limited warranty is in addition to other rights and remedies available to you under law, which may not be excluded. In addition to your rights above, HUBLOT goods come with implied terms that cannot be excluded under the UK Consumer Rights Act 2015.

United States limited warranty

What is covered?

This United States Limited Warranty ("US Limited Warranty") applies to the BIG BANG e sold within the United States and its territories at HUBLOT stores. Under this US Limited Warranty, HUBLOT agrees to repair, free of charge, any problem with the functions of your BIG BANG e that result from defects in materials and workmanship and arise within the two-year period commencing on the date of purchase, and its accessories for a period of one year from the date of purchase, subject to the conditions below.

For the purposes of this international limited warranty, accessories include charging accessories that are included in the original packaging of your BIG BANG e or sold at HUBLOT stores (i.e. charging cradle, micro USB cable, wall plug). For the avoidance of doubt, accessories do not include, and HUBLOT expressly disclaims any guarantee or warranty with respect to, accessories sold by third parties.

Limited conditions apply to both BIG BANG e and accessories.

All accessories are not water resistant.

What is not covered?

This US Limited Warranty does not apply to damage resulting from service provided anywhere other than at a HUBLOT Store, which shall void this US Limited Warranty.

This US Limited Warranty does not cover any software, straps, crystals and batteries, or any damage to the case or hardware due to moisture that might have entered the BIG BANG e as a result of improper handling. More generally, it does not apply if there has been improper or inadequate use of the BIG BANG e such as where:

- The product has been dismantled by the user or by unauthorized person;
- The product has been connected to non-recommended accessories such as other battery type or charger;
- The product has been voluntarily damaged or used out of the recommended rules for product start-up or usage such as wrong plug-in;

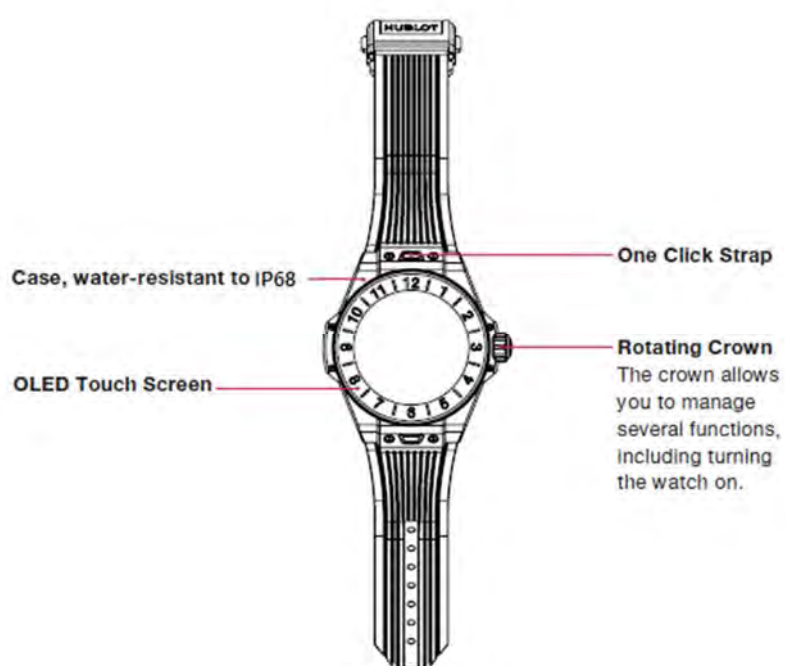

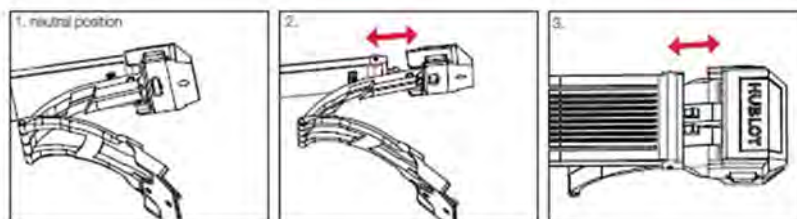
