Diagram of Measurement Configuration for Radiation Test (Below 1GHz)

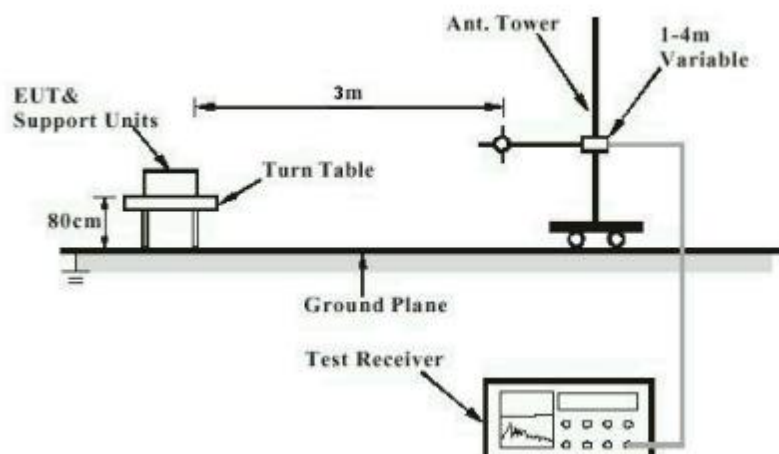


Diagram of Measurement Configuration for Radiation Test (Above 1GHz)

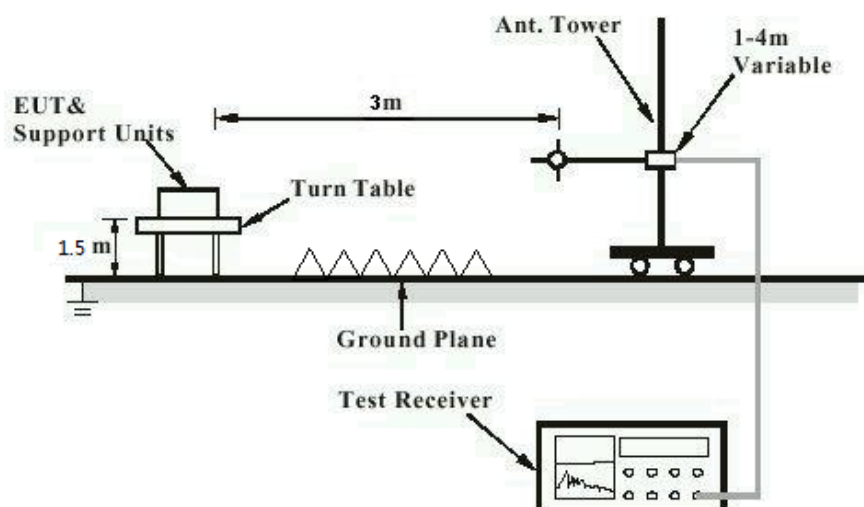


Diagram of Measurement Configuration for Conducted Transmitter Measurement

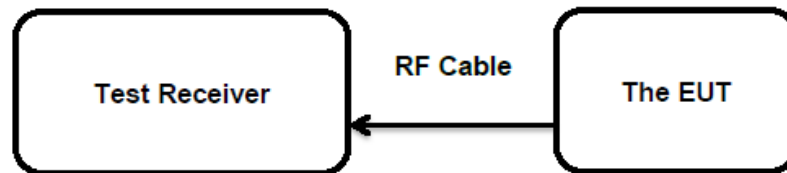
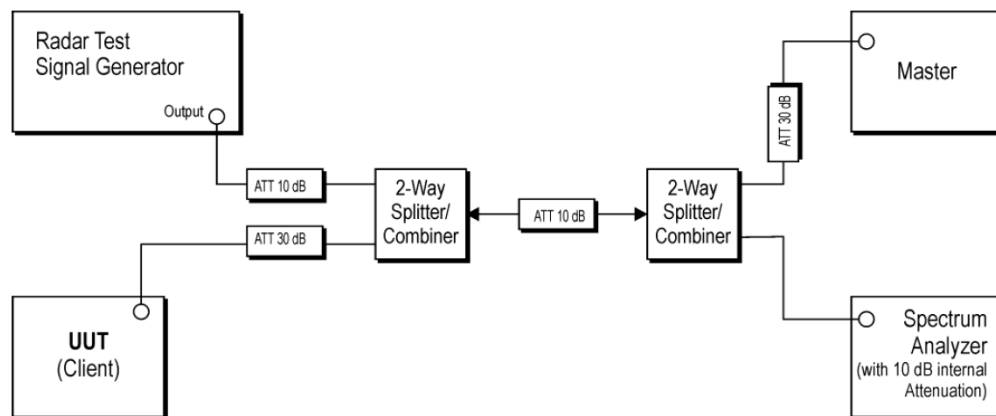


Diagram of Measurement Configuration for Dynamic Frequency Selection (DFS)
