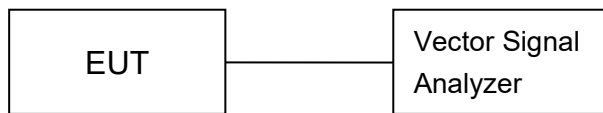

4. Set the spectrum analyzer to start measurement.
5. Record the values.



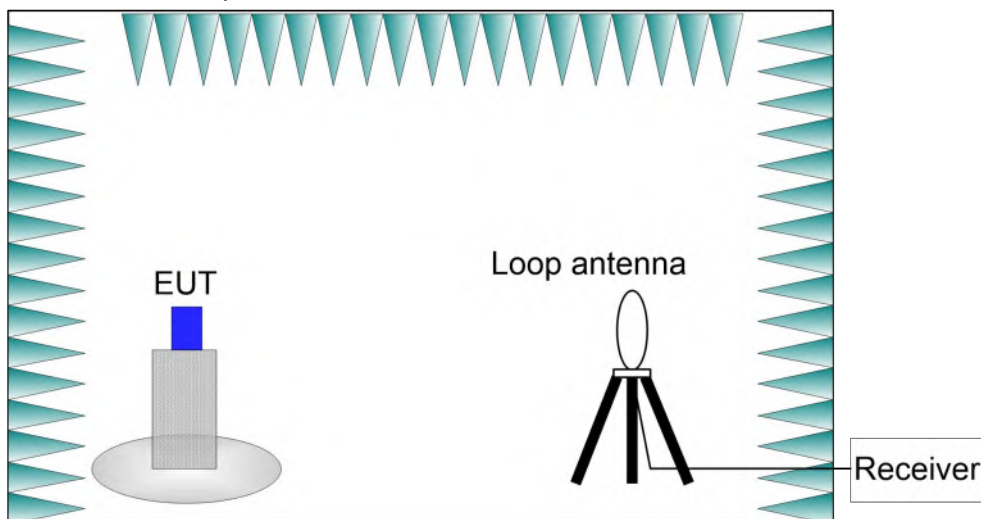
2) Radiated Measurements

Test setup:

9kHz-30MHz:

The EUT are measured in a anechoic chamber. The EUT is placed on a non-conductive stand of 80cm high, and at a measurement distance of 3m from the receiving antenna. The center of the receiving loop antenna is 1.0 meter above the ground. The test setup refers to figure below.

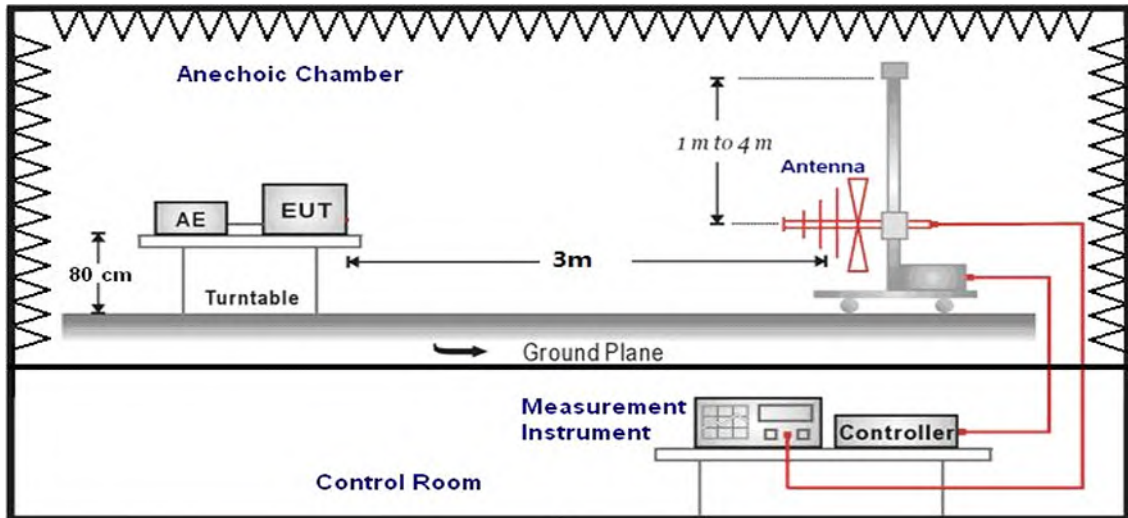
Detected emissions were maximized at each frequency by rotating the EUT and adjusting the receiver antenna polarization.



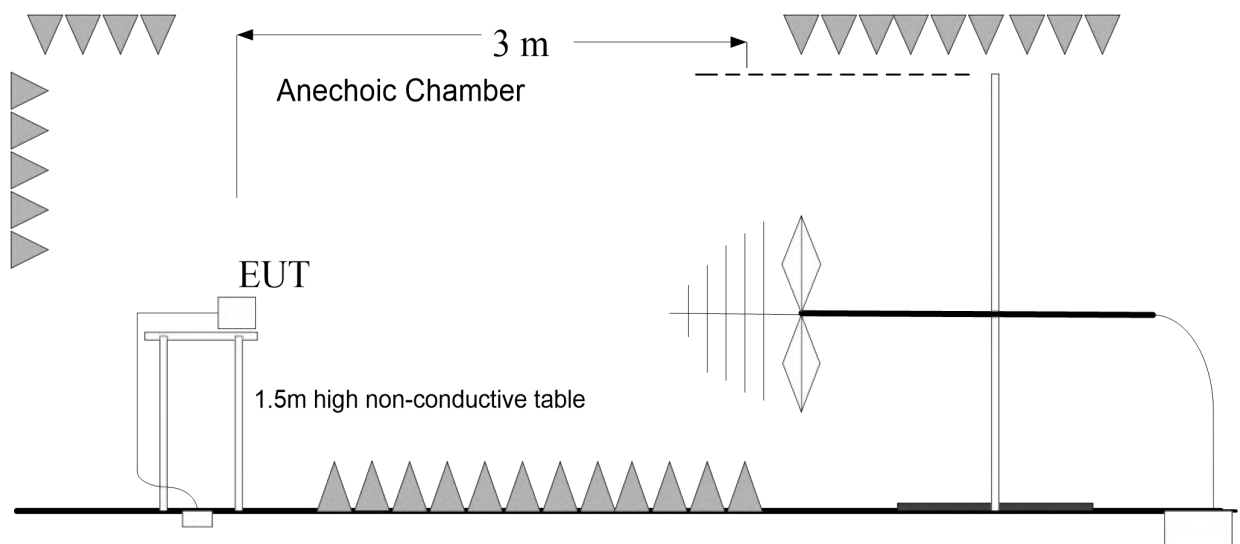

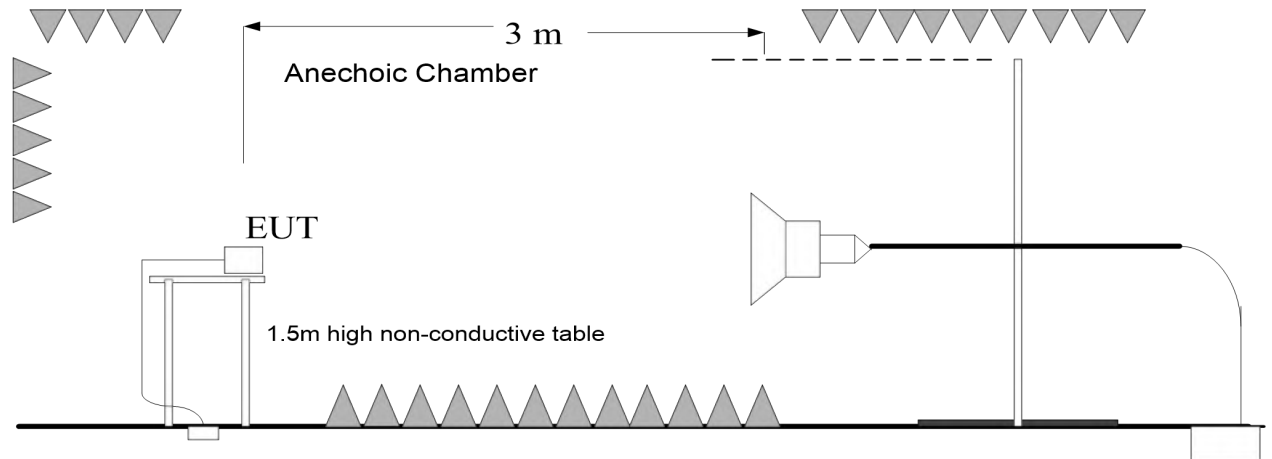

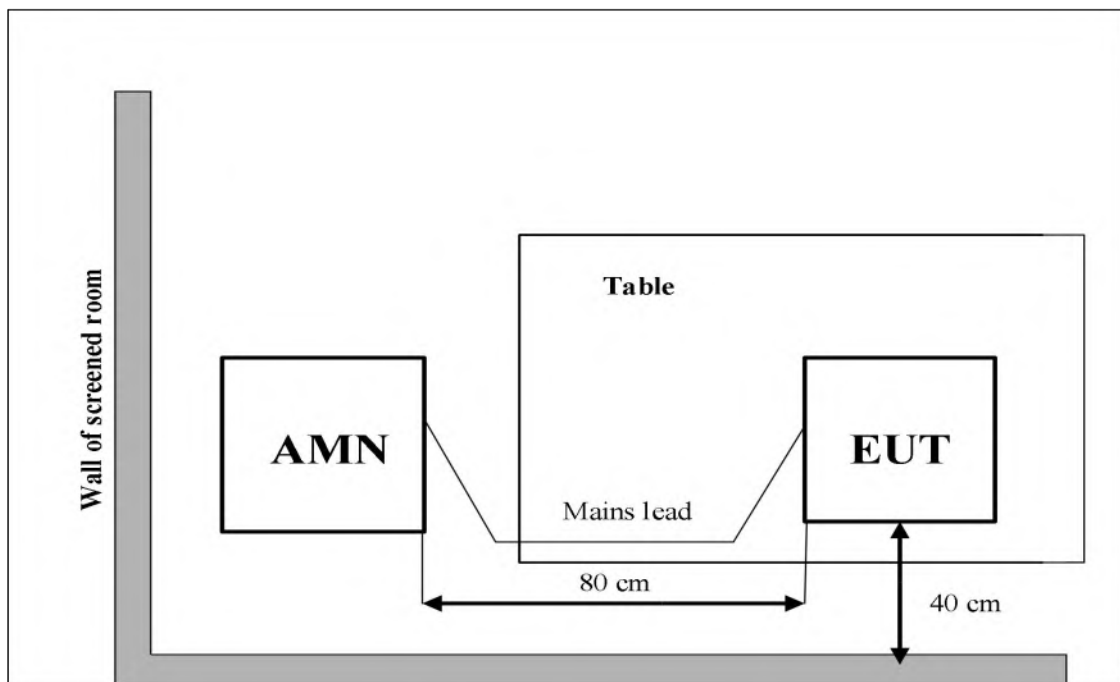

For WLAN, the EUT is working under test mode. The EUT is commanded to operate at maximum transmitting power.



**A.0 Antenna requirement****Measurement Limit:**

Standard	Requirement
FCC CRF Part 15.203	An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

Conclusion: The Directional gains of antenna used for transmitting: Antenna 1:-1.90dBi; Antenna 2:-0.05dBi; Directional gain:2.1dBi.

The RF transmitter uses an integrate antenna without connector.

A.1 Maximum Output Power

Measurement of method: See ANSI C63.10-2013-Clause 11.9.2.3.2.

Method AVGPM-G is a measurement using a gated RF average power meter.

Alternatively, measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Because the measurement is made only during the ON time of the transmitter, no duty cycle correction factor is required.

Note: The data rate 1Mbps (11b mode), 6Mbps (11g mode), MCS0 (11n mode), MCS0 (VHT mode), MCS0 (11ax mode) and MCS0 (11be mode) are selected as the Worst-Case. The Full RU of 802.11ax and 802.11be is the type with maximum outpower level. Between SISO and MIMO, the MIMO of 11n, VHT, 11ax and 11be is the worst type. Antenna 2 is selected as the worst condition (SISO). The following cases and test graphs are performed with this condition.

The EUT was programmed to be in continuously transmitting mode and the transmit duty cycle is not less than 98%.

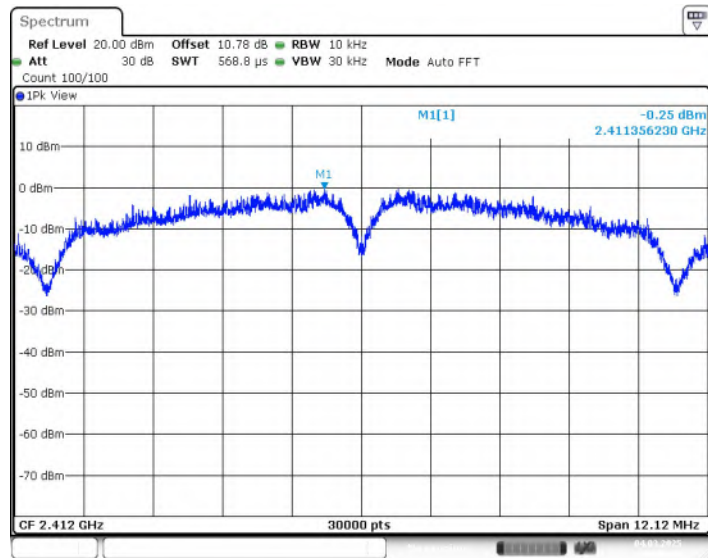


Fig.1 Power Spectral Density (802.11b, CH1)

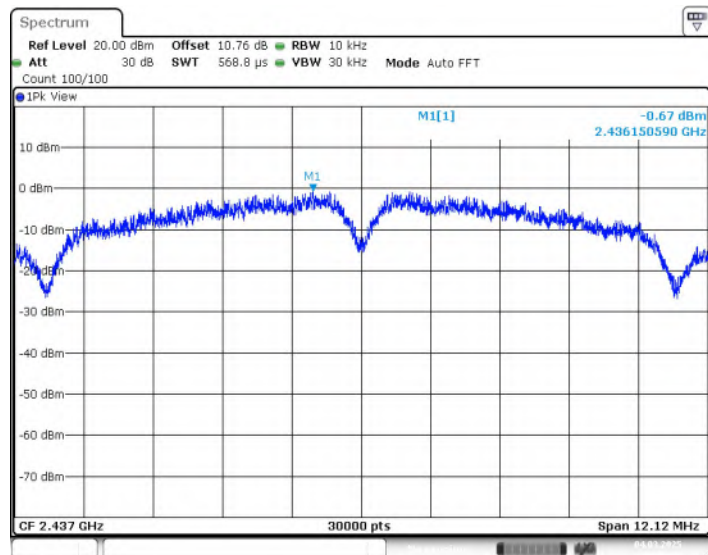


Fig.2 Power Spectral Density (802.11b, CH6)

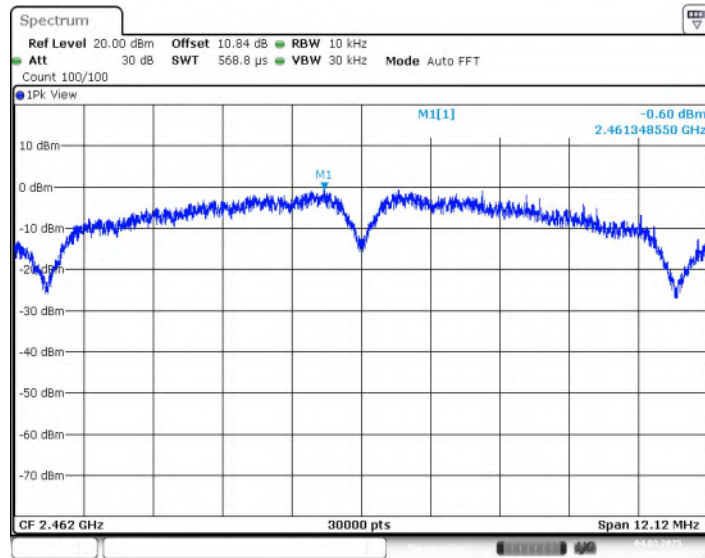


Fig.3 Power Spectral Density (802.11b, CH11)

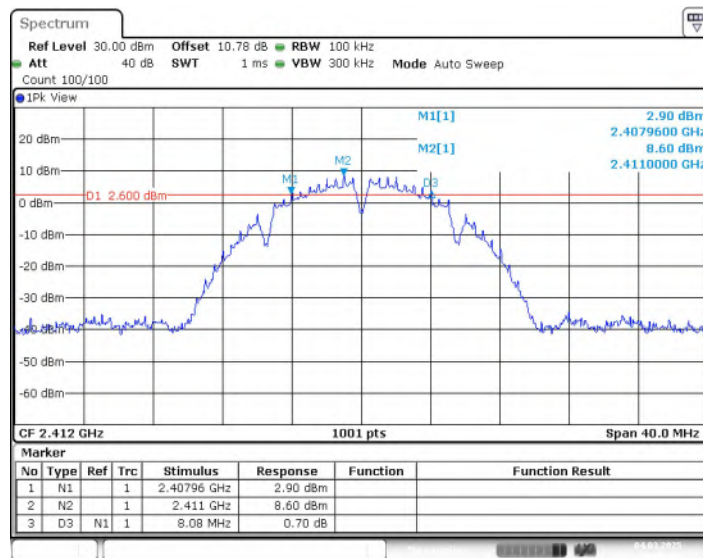


Fig.4 6dB Bandwidth (802.11b, CH1)

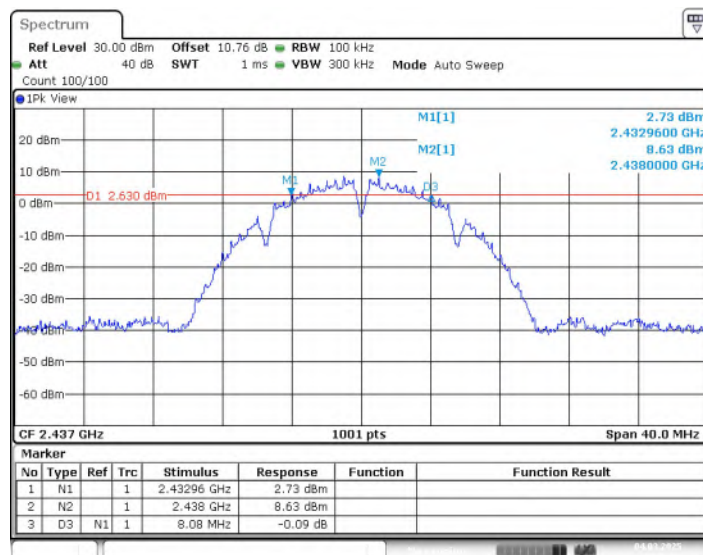


Fig.5 6dB Bandwidth (802.11b, CH6)

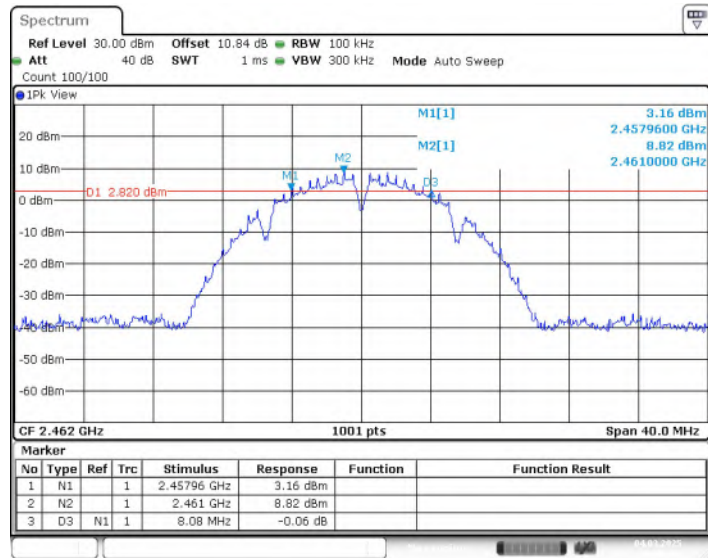


Fig.6 6dB Bandwidth (802.11b, CH11)

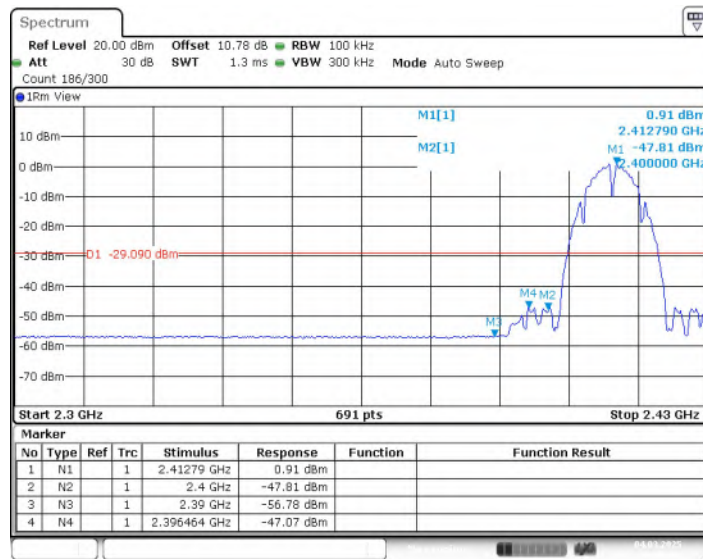


Fig.7 Band Edges (802.11b, CH1)

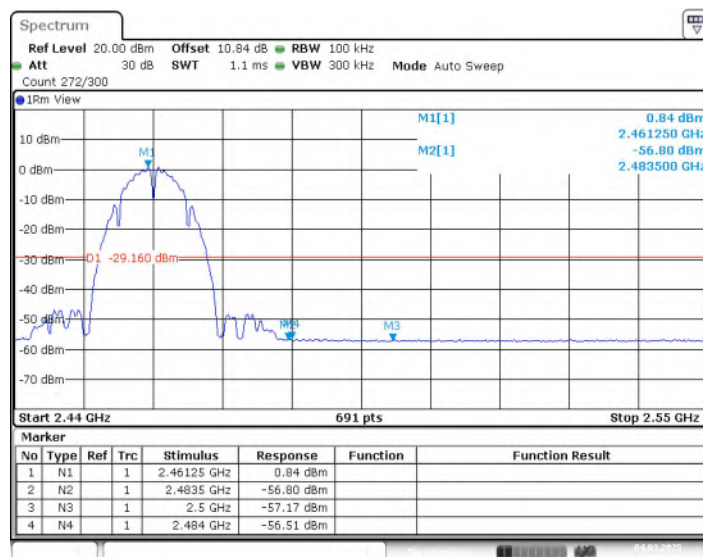


Fig.8 Band Edges (802.11b, CH11)

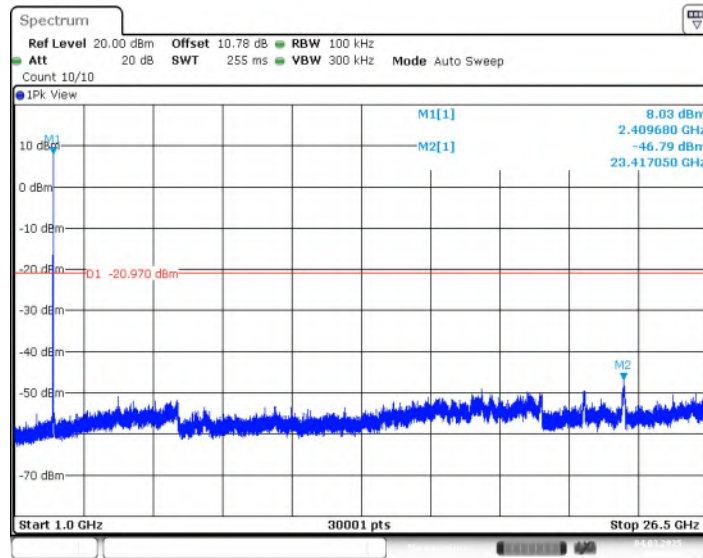


Fig.9 Conducted Spurious Emission (1GHz-26.5GHz, 802.11b, CH1)

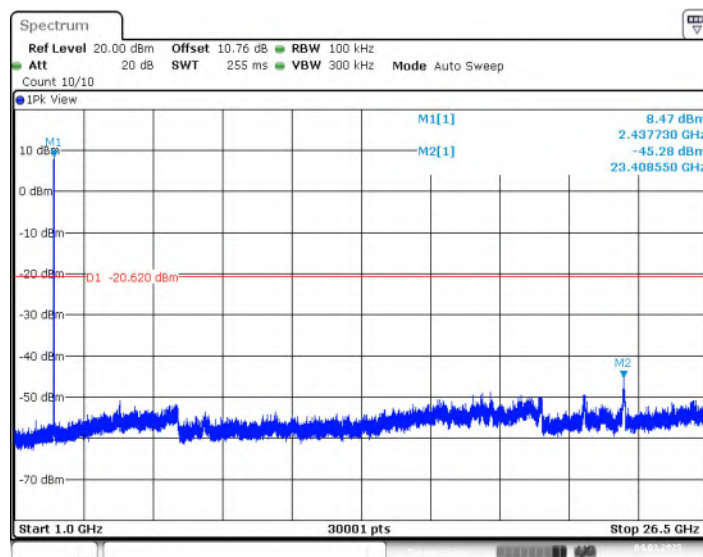


Fig.10 Conducted Spurious Emission (1GHz-26.5GHz, 802.11b, CH6)

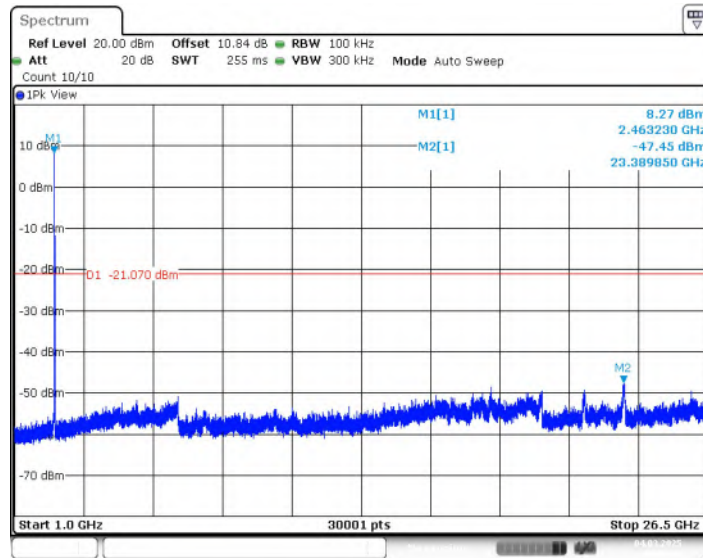


Fig.11 Conducted Spurious Emission (1GHz-26.5GHz, 802.11b, CH1)

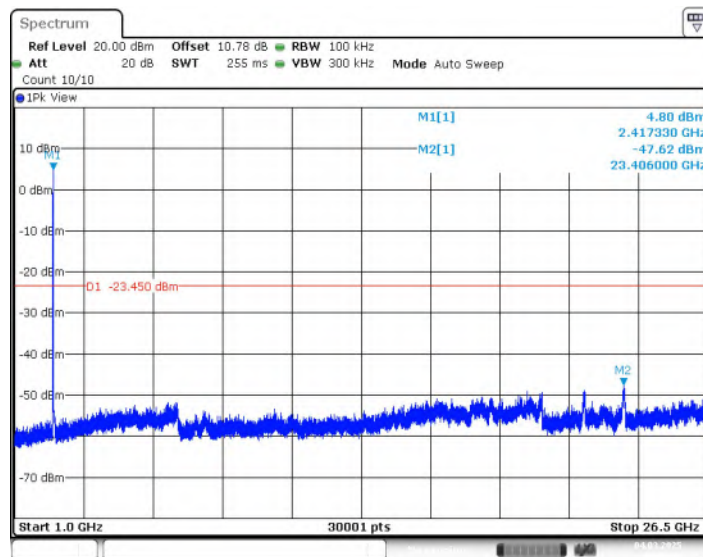


Fig.12 Conducted Spurious Emission (1GHz-26.5GHz, 802.11g, CH1)

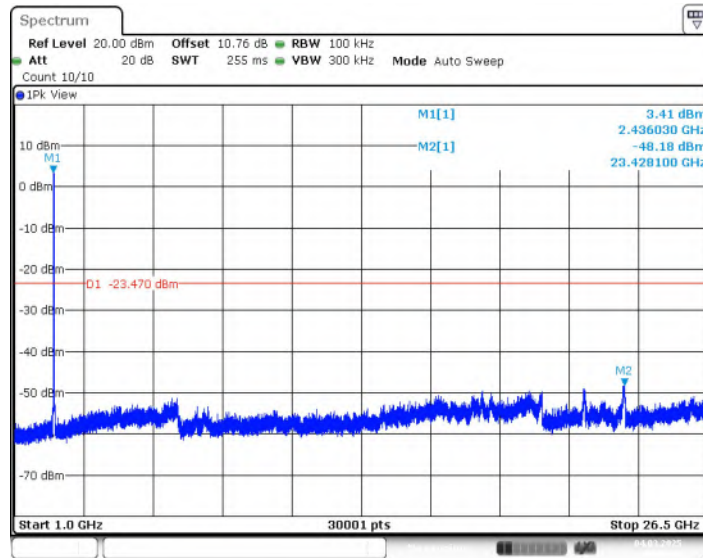


Fig.13 Conducted Spurious Emission (1GHz-26.5GHz, 802.11g, CH6)

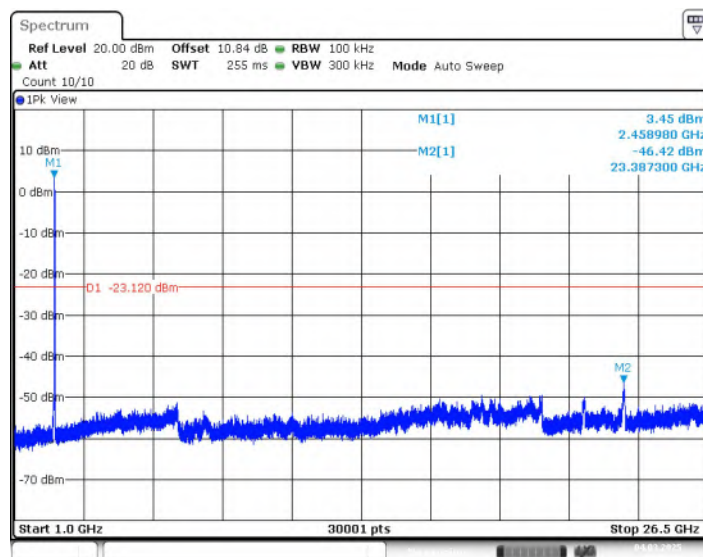


Fig.14 Conducted Spurious Emission (1GHz-26.5GHz, 802.11g, CH11)

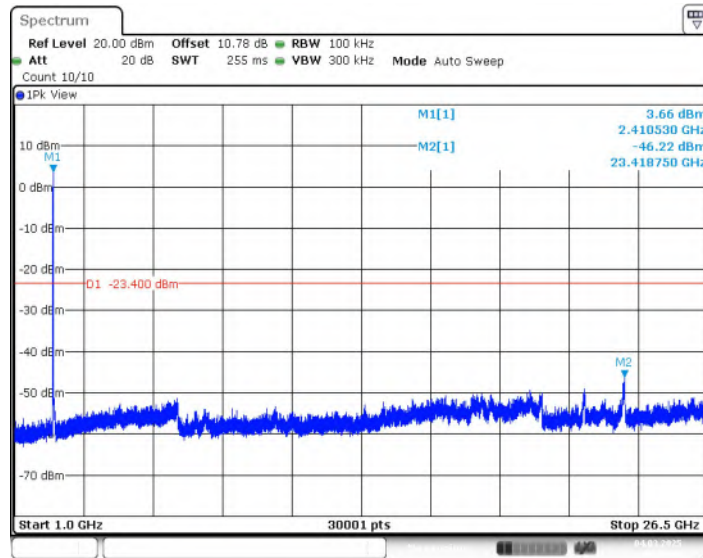


Fig.15 Conducted Spurious Emission (1GHz-26.5GHz, 802.11n-HT20, CH1)

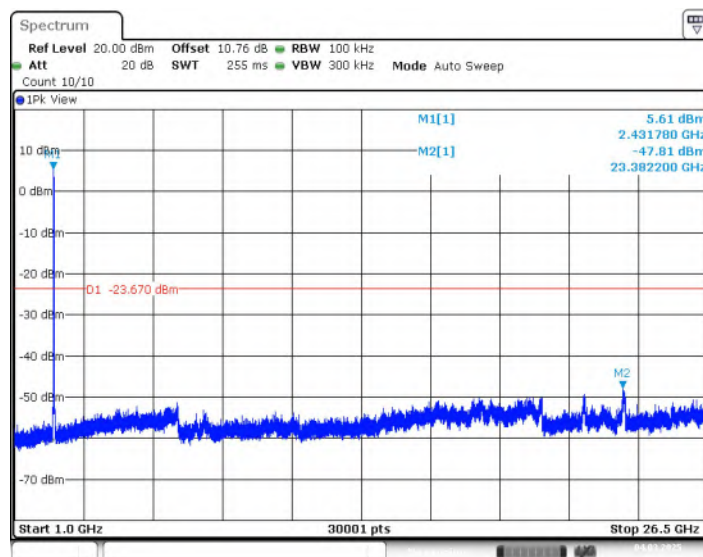


Fig.16 Conducted Spurious Emission (1GHz-26.5GHz, 802.11n-HT20, CH6)

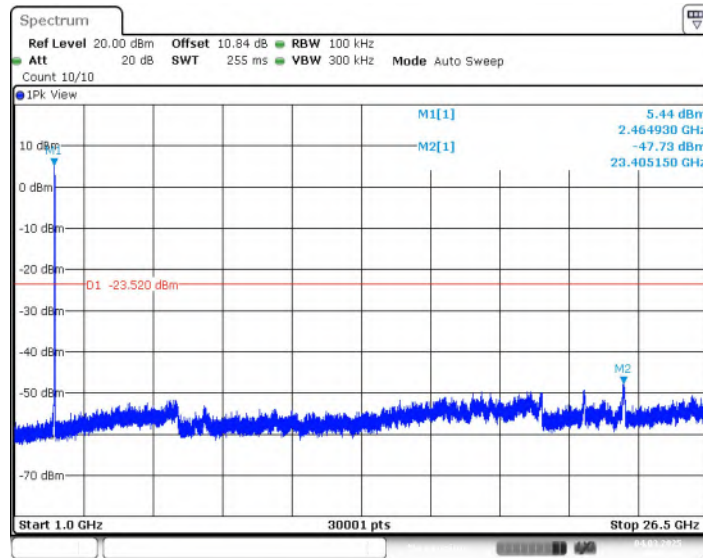


Fig.17 Conducted Spurious Emission (1GHz-26.5GHz, 802.11n-HT20, CH11)

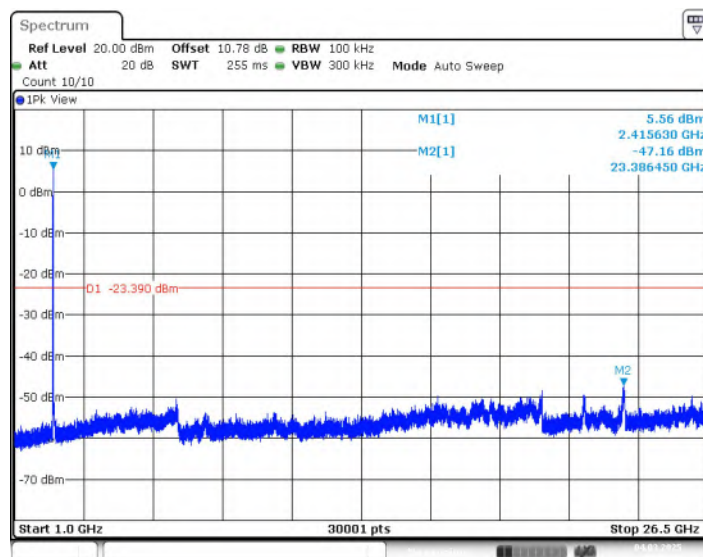


Fig.18 Conducted Spurious Emission (1GHz-26.5GHz, 802.11-VHT20, CH1)

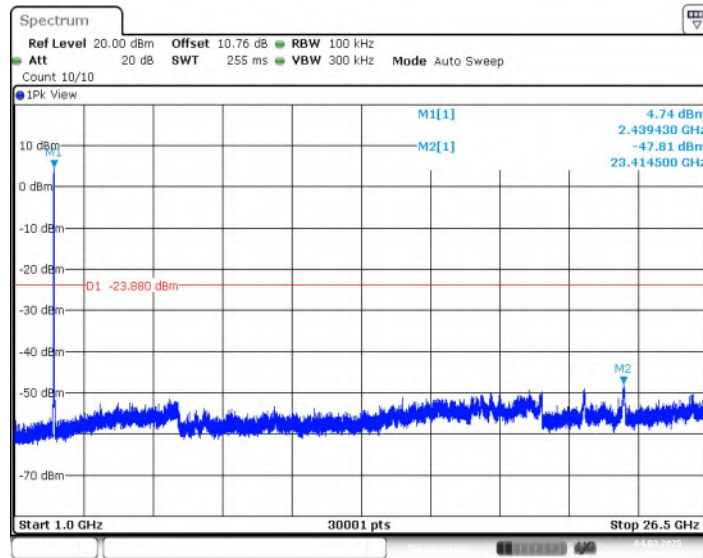


Fig.19 Conducted Spurious Emission (1GHz-26.5GHz, 802.11-VHT20, CH6)

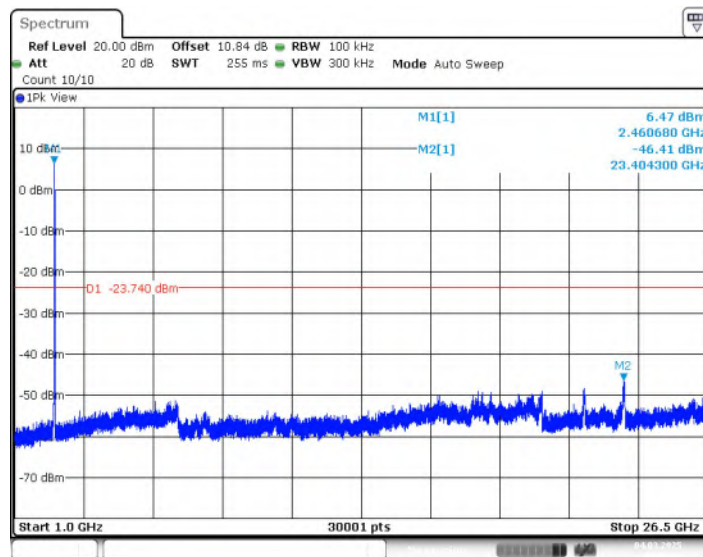


Fig.20 Conducted Spurious Emission (1GHz-26.5GHz, 802.11-VHT20, CH11)

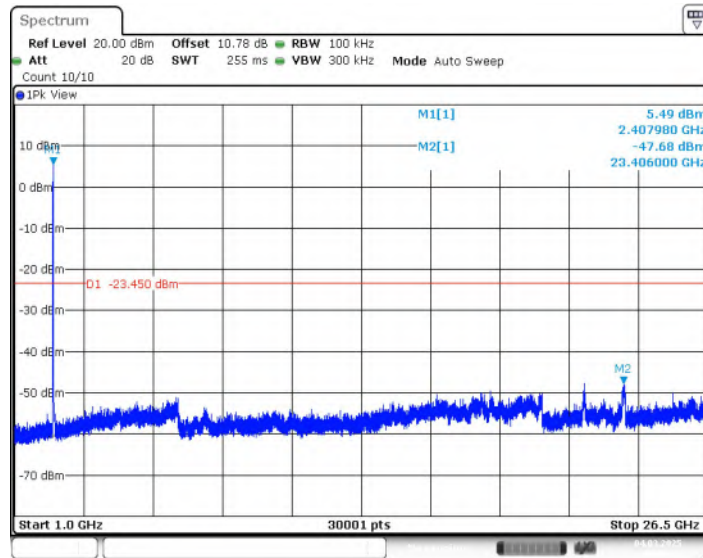


Fig.21 Conducted Spurious Emission (1GHz-26.5GHz, 802.11ax-HE20, CH1)

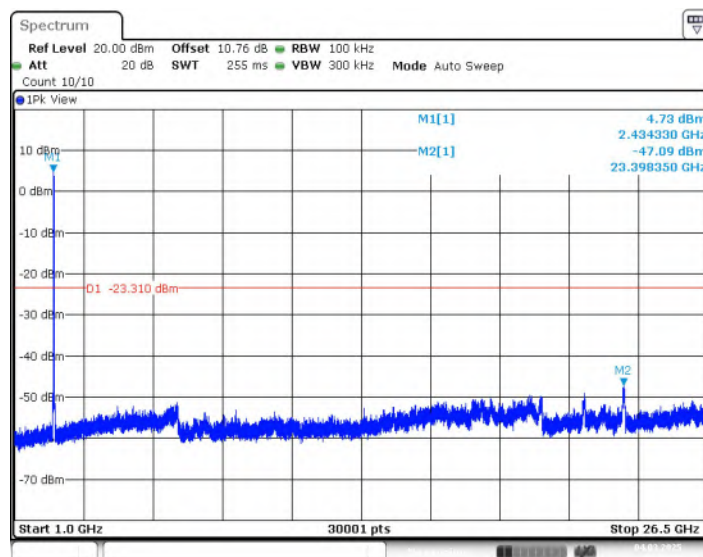


Fig.22 Conducted Spurious Emission (1GHz-26.5GHz, 802.11ax-HE20, CH6)

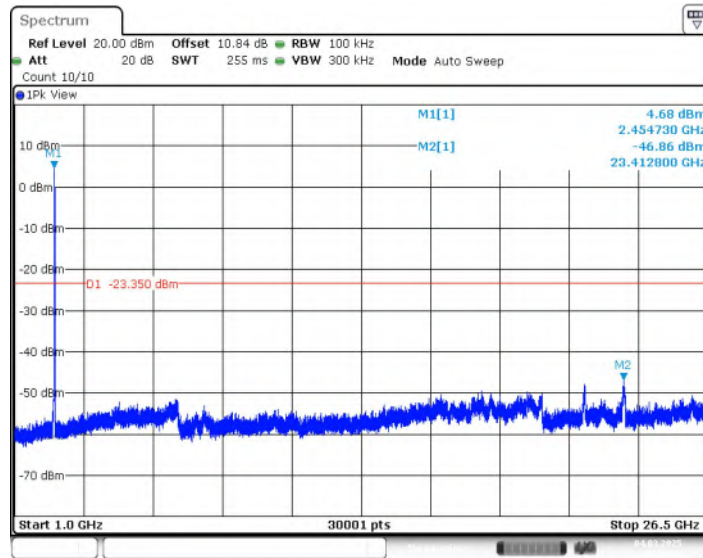


Fig.23 Conducted Spurious Emission (1GHz-26.5GHz, 802.11ax-HE20, CH11)

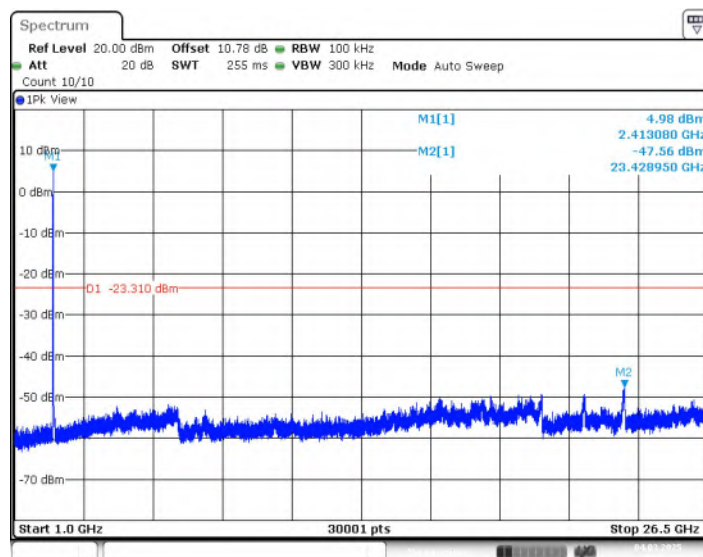


Fig.24 Conducted Spurious Emission (1GHz-26.5GHz, 802.11be-EHT20, CH1)

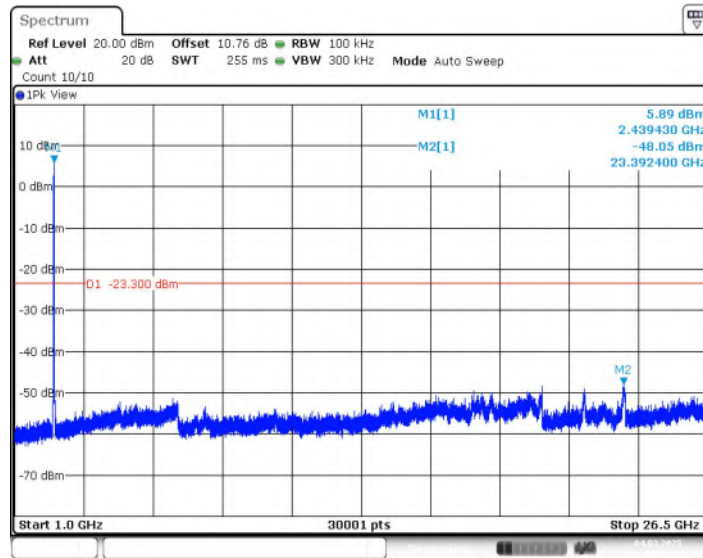


Fig.25 Conducted Spurious Emission (1GHz-26.5GHz, 802.11be-EHT20, CH6)

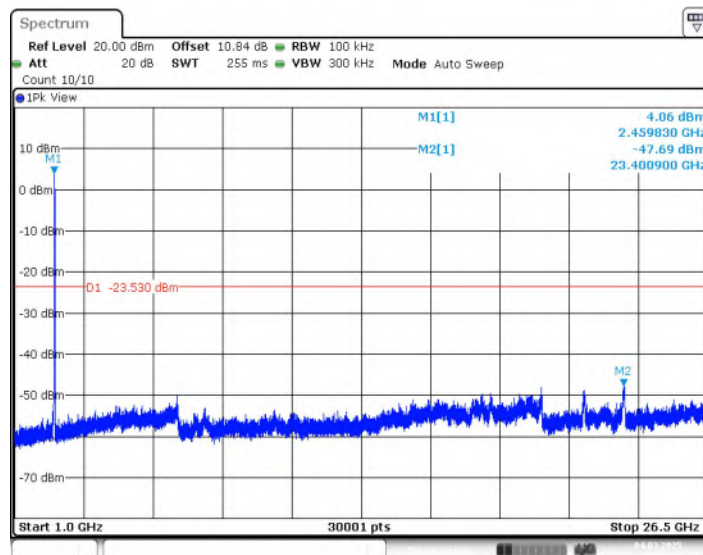


Fig.26 Conducted Spurious Emission (1GHz-26.5GHz, 802.11be-EHT20, CH11)

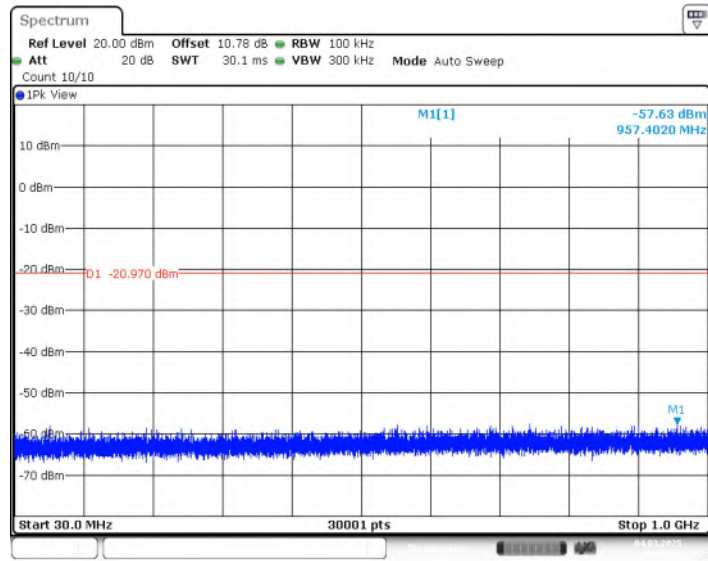


Fig.27 Conducted Spurious Emission (All Channels, 30MHz -1GHz)

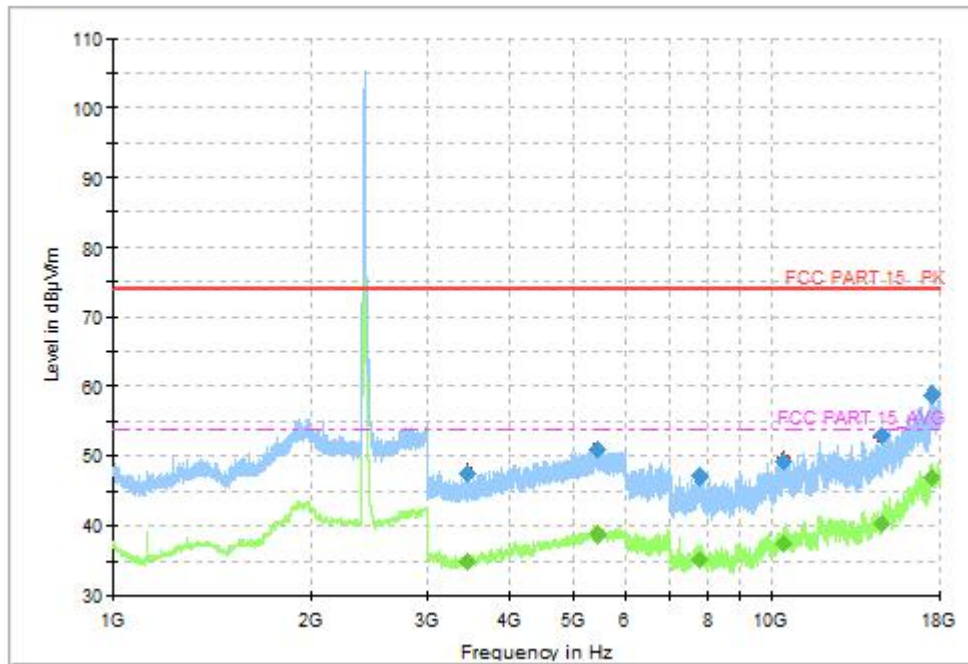


Fig.28 Radiated Spurious Emission (802.11n-HT20, CH1, 1GHz-18GHz, MIMO)

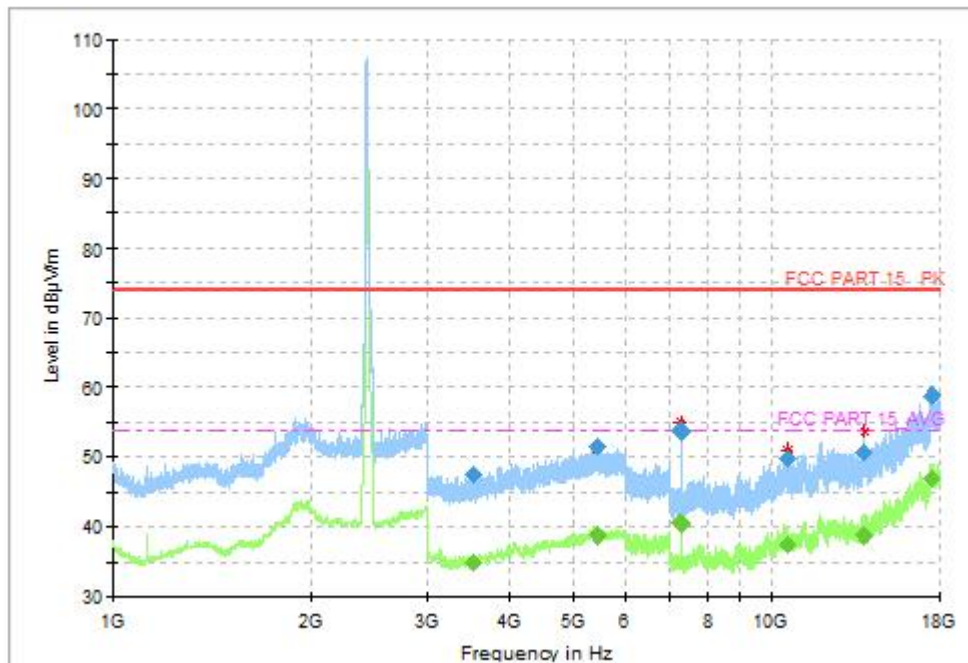


Fig.29 Radiated Spurious Emission (802.11n-HT20, CH6, 1GHz-18GHz, MIMO)

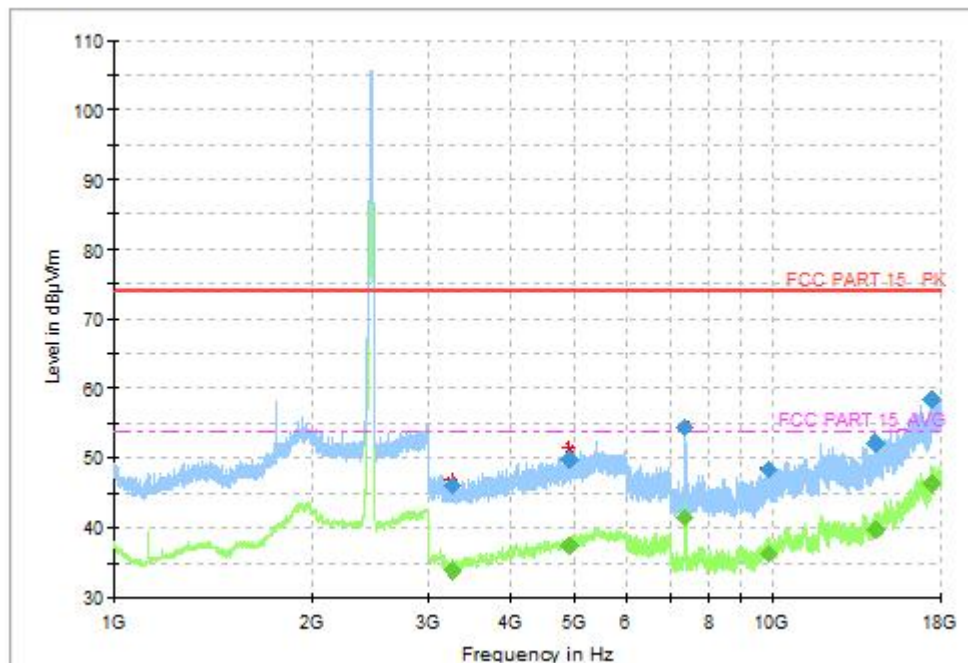


Fig.30 Radiated Spurious Emission (802.11n-HT20, CH11, 1GHz-18GHz, MIMO)

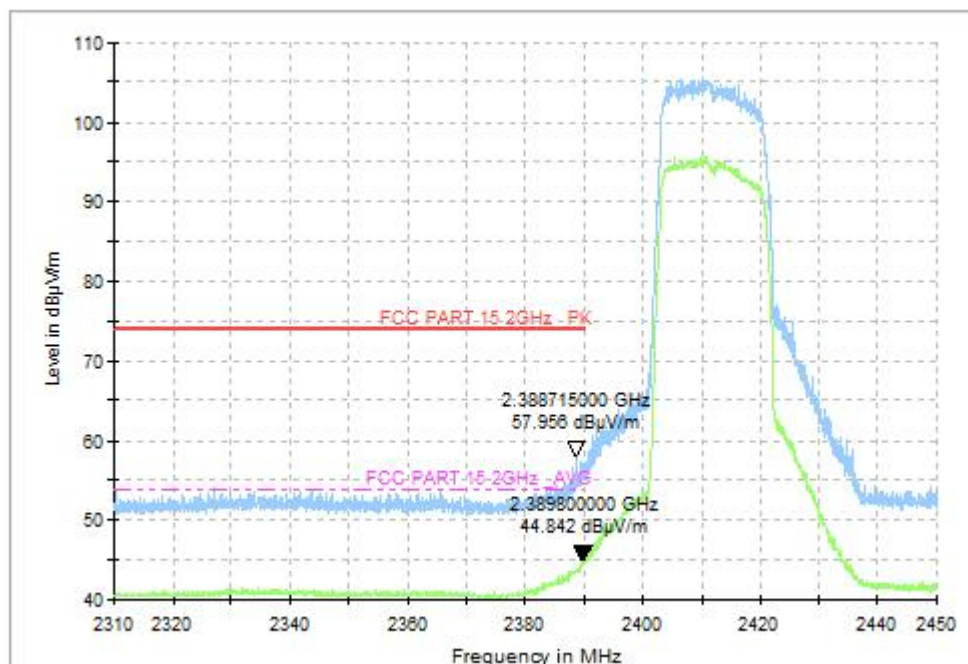


Fig.31 Radiated Restricted Band (802.11n-HT20, CH1, 2.38GHz~2.45GHz, MIMO)

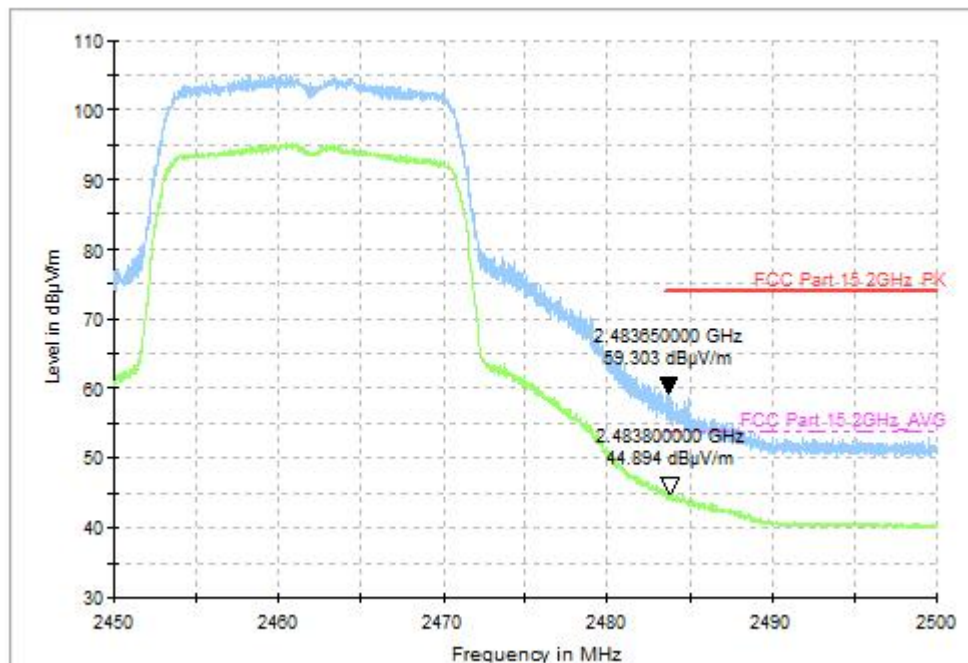


Fig.32 Radiated Restricted Band (802.11n-HT20, CH11, 2.45GHz~2.50GHz, MIMO)

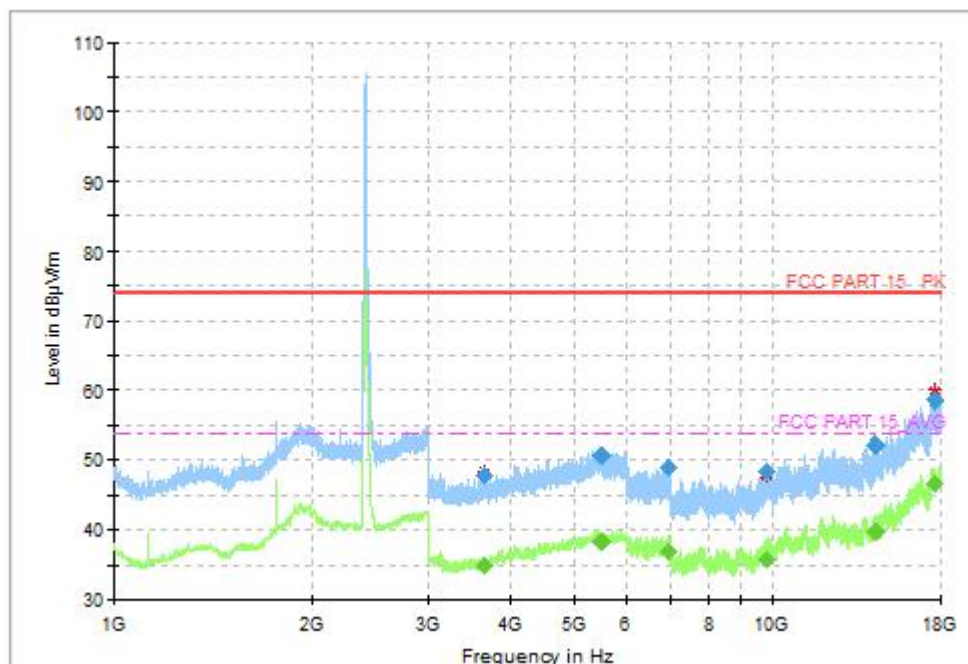


Fig.33 Radiated Spurious Emission (802.11-VHT20, CH1, 1GHz~18GHz, MIMO)

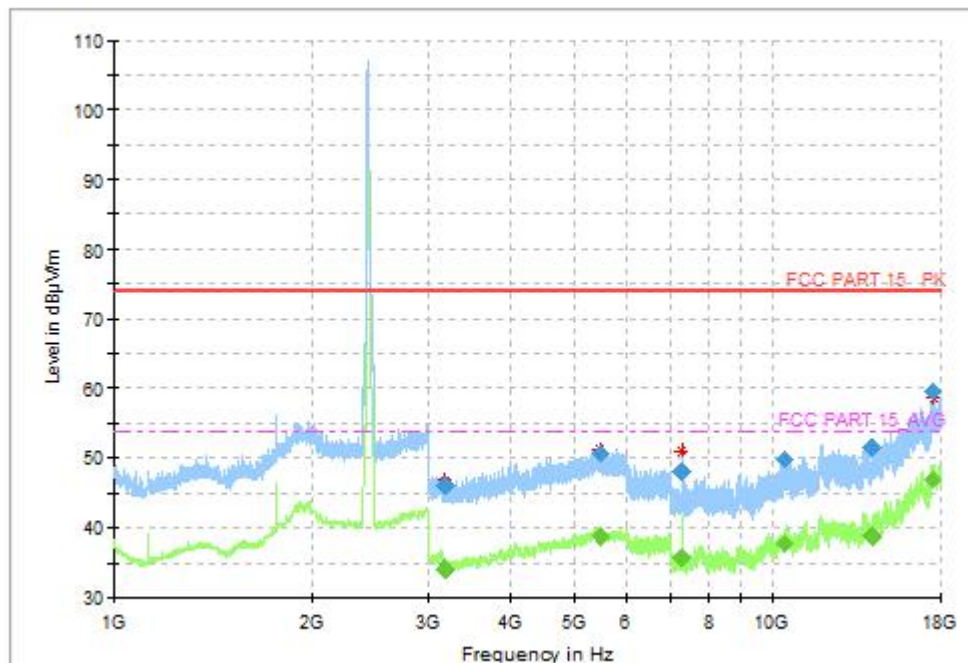


Fig.34 Radiated Spurious Emission (802.11-VHT20, CH6, 1GHz-18GHz, MIMO)

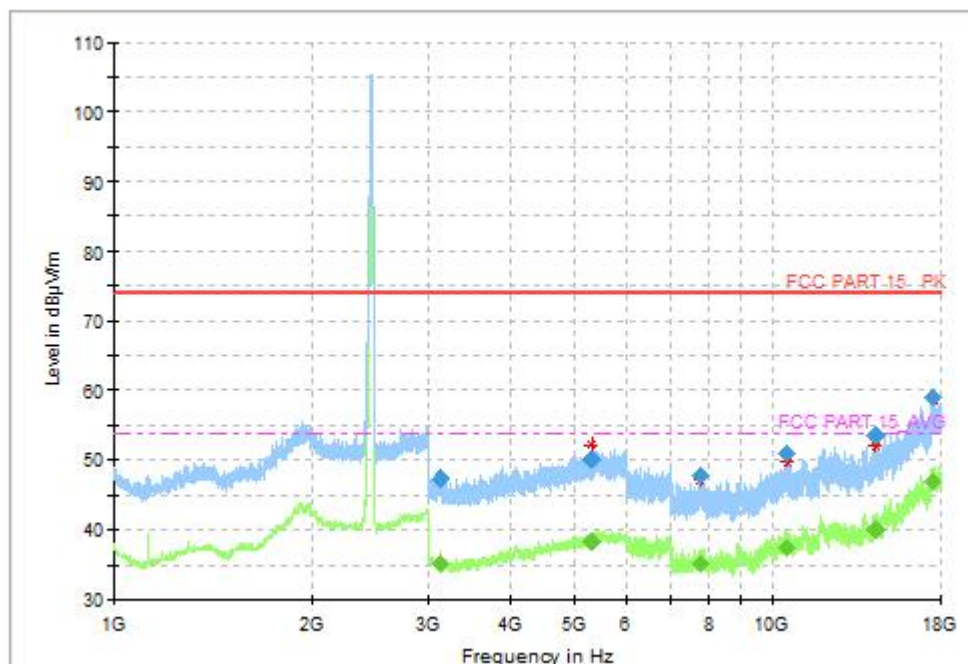


Fig.35 Radiated Spurious Emission (802.11-VHT20, CH11, 1GHz-18GHz, MIMO)

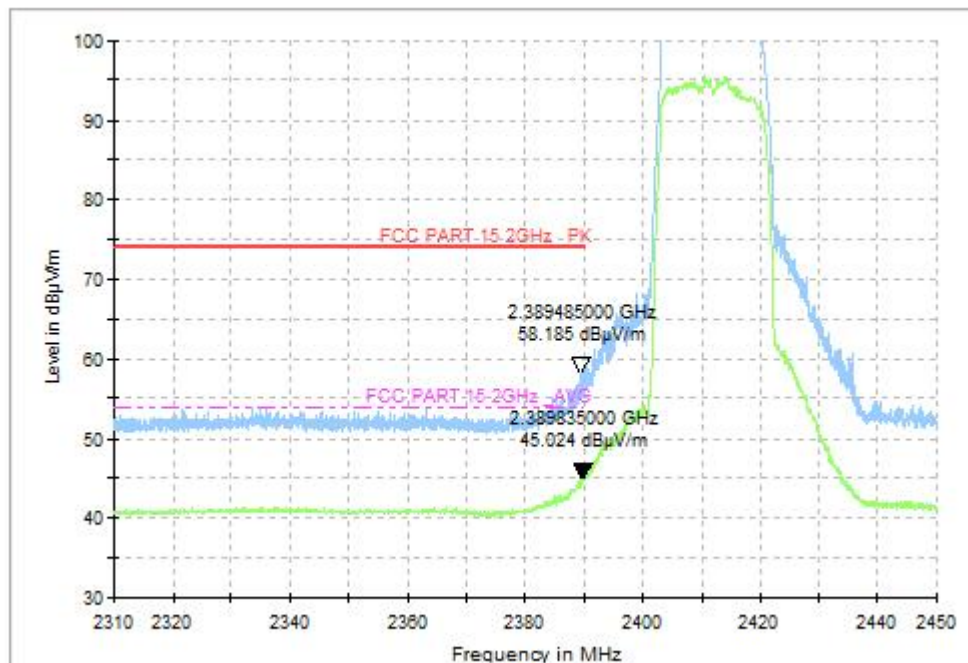


Fig.36 Radiated Restricted Band (802.11-VHT20, CH1, 2.38GHz~2.45GHz, MIMO)

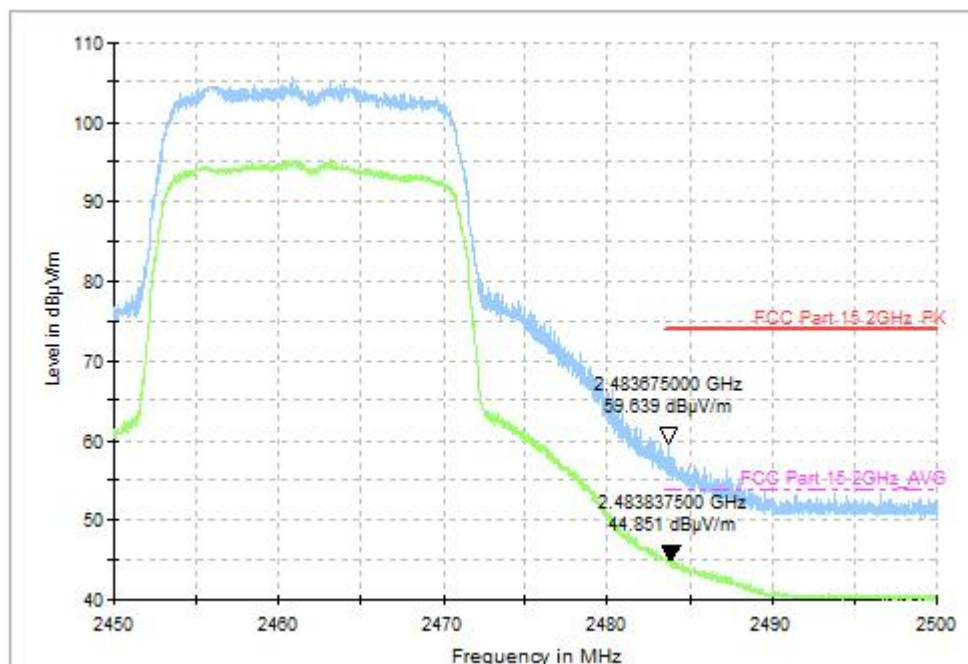


Fig.37 Radiated Restricted Band (802.11-VHT20, CH1, 2.45GHz~2.50GHz, MIMO)

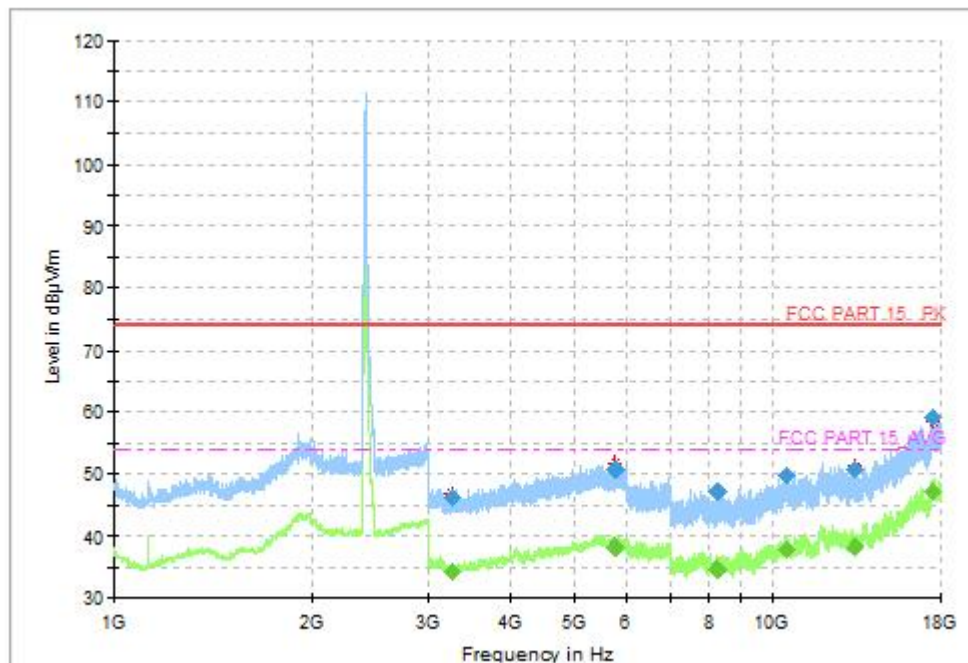


Fig.38 Radiated Spurious Emission (802.11ax-HE20, CH1, 1GHz-18GHz, MIMO)

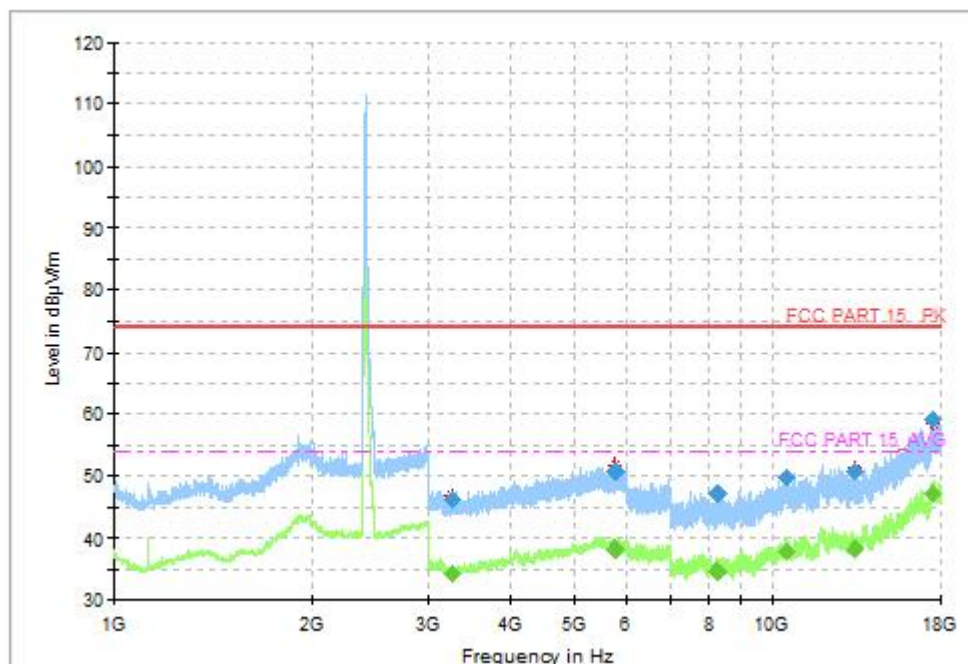


Fig.39 Radiated Spurious Emission (802.11ax-HE20, CH6, 1GHz-18GHz, MIMO)

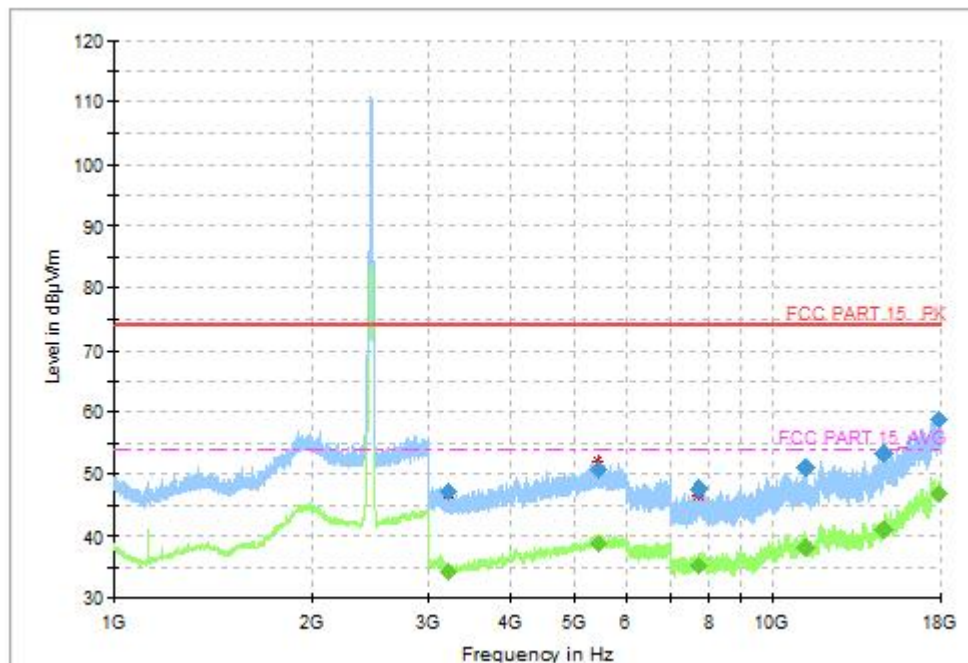


Fig.40 Radiated Spurious Emission (802.11ax-HE20, CH11, 1GHz-18GHz, MIMO)

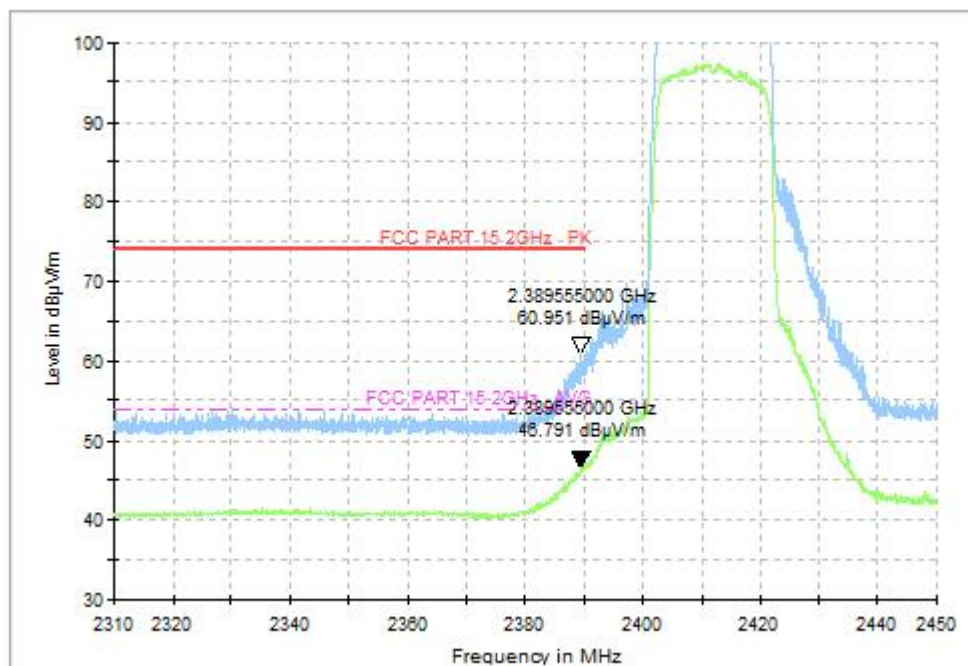


Fig.41 Radiated Restricted Band (802.11ax-HE20, CH1, 2.38GHz~2.45GHz, MIMO)

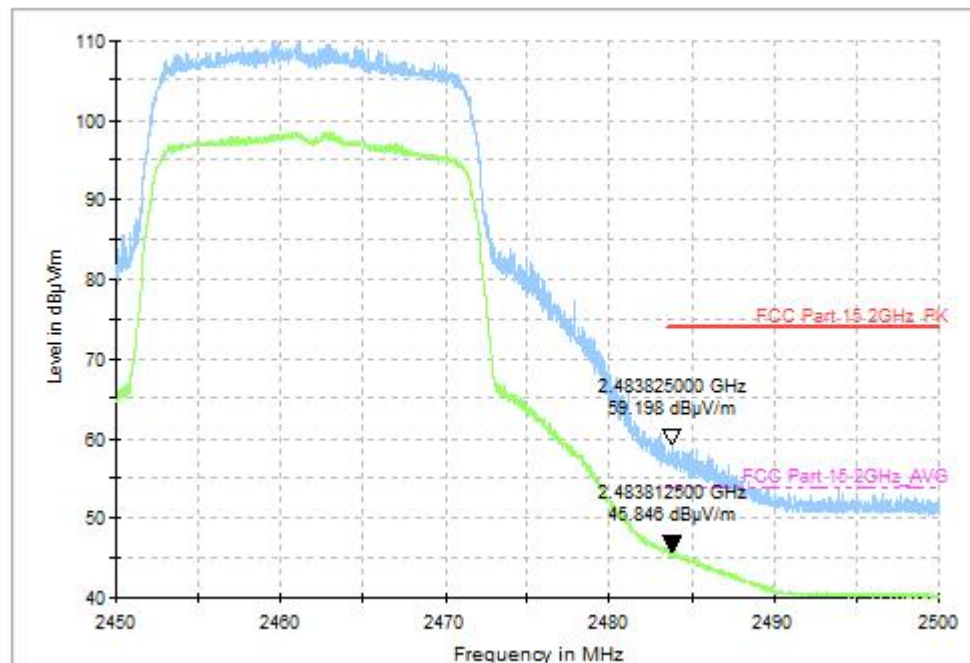


Fig.42 Radiated Restricted Band (802.11ax-HE20, CH11, 2.45GHz~2.50GHz, MIMO)

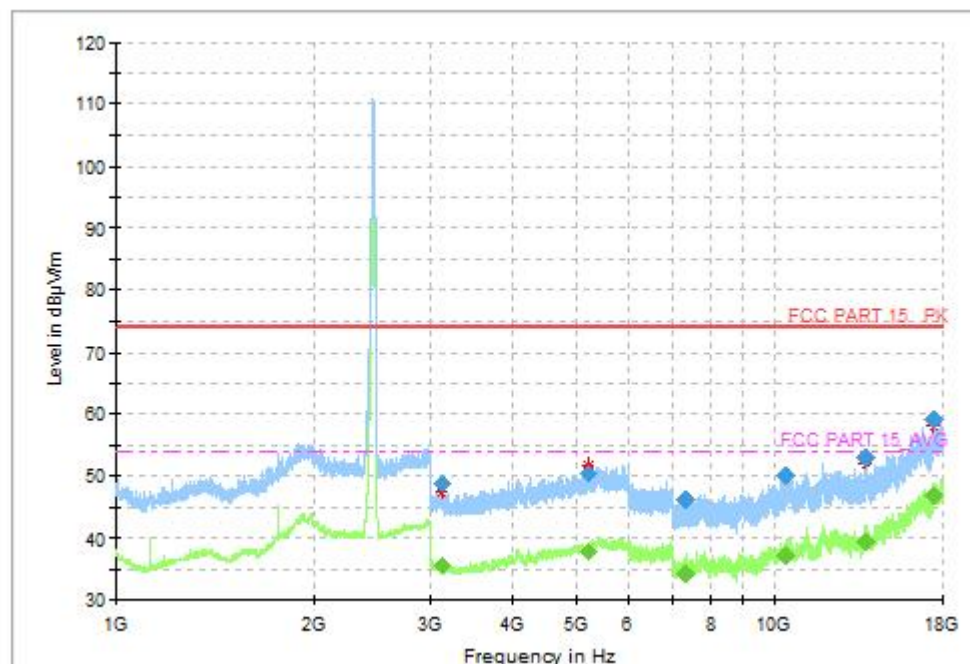


Fig.43 Radiated Spurious Emission (802.11be-EHT20, CH1, 1GHz-18GHz, MIMO)

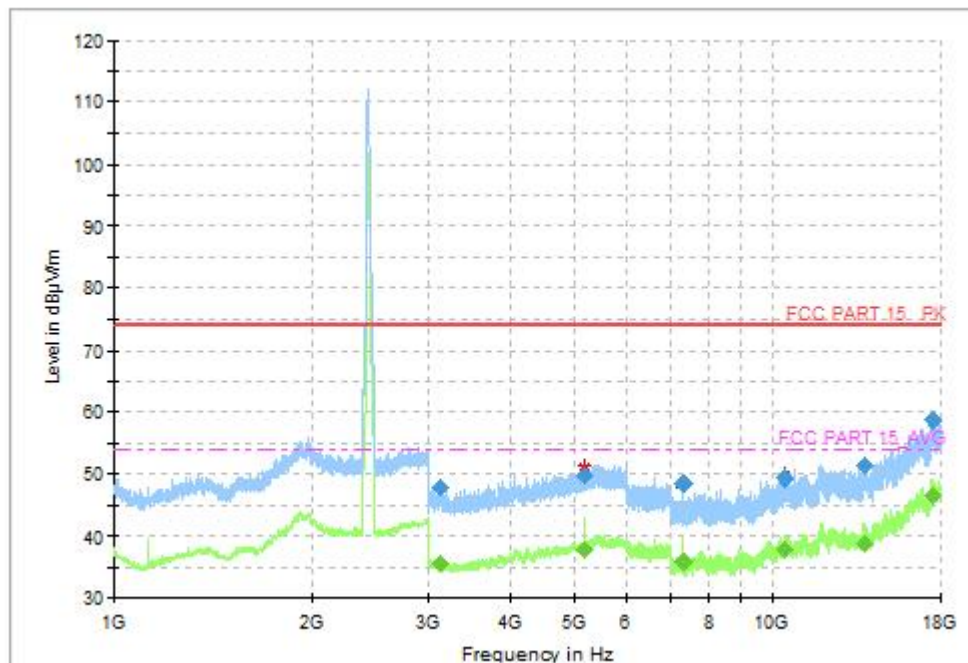


Fig.44 Radiated Spurious Emission (802.11be-EHT20, CH6, 1GHz-18GHz, MIMO)

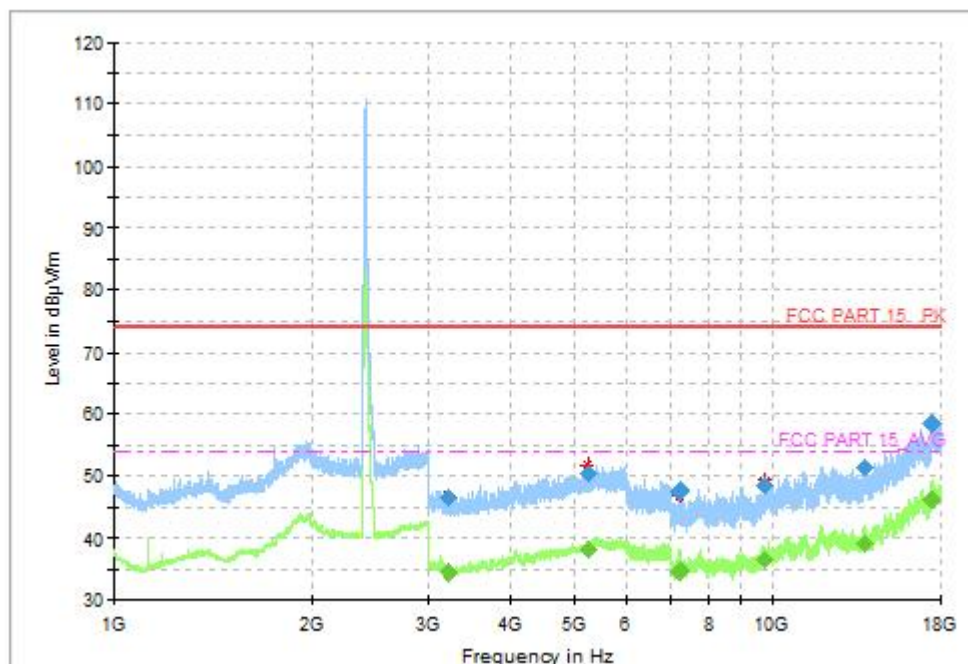


Fig.45 Radiated Spurious Emission (802.11be-EHT20, CH11, 1GHz-18GHz, MIMO)

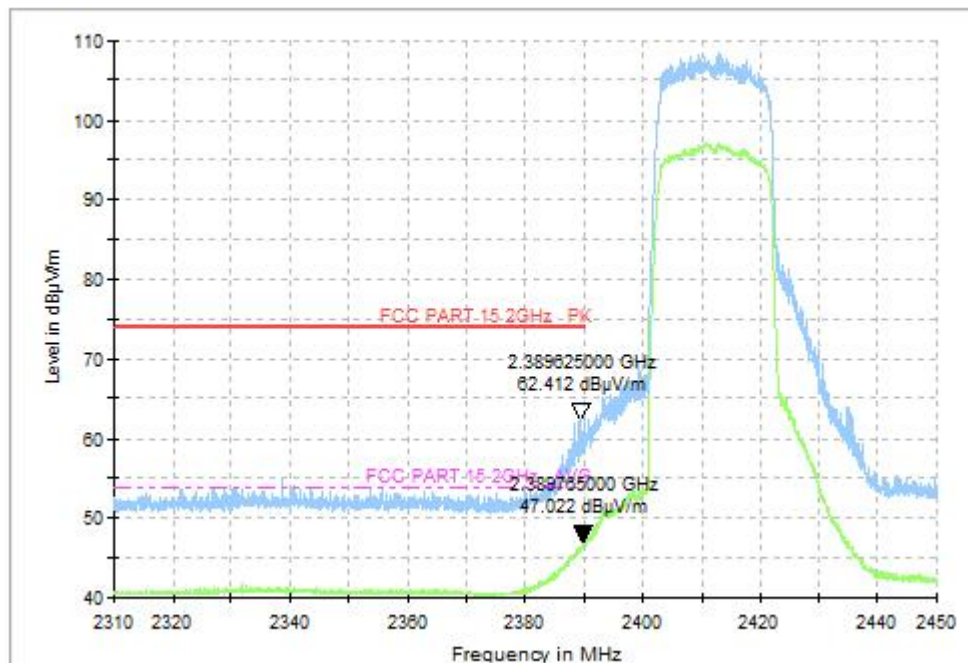


Fig.46 Radiated Restricted Band (802.11be-EHT20, CH1, 2.38GHz~2.45GHz, MIMO)

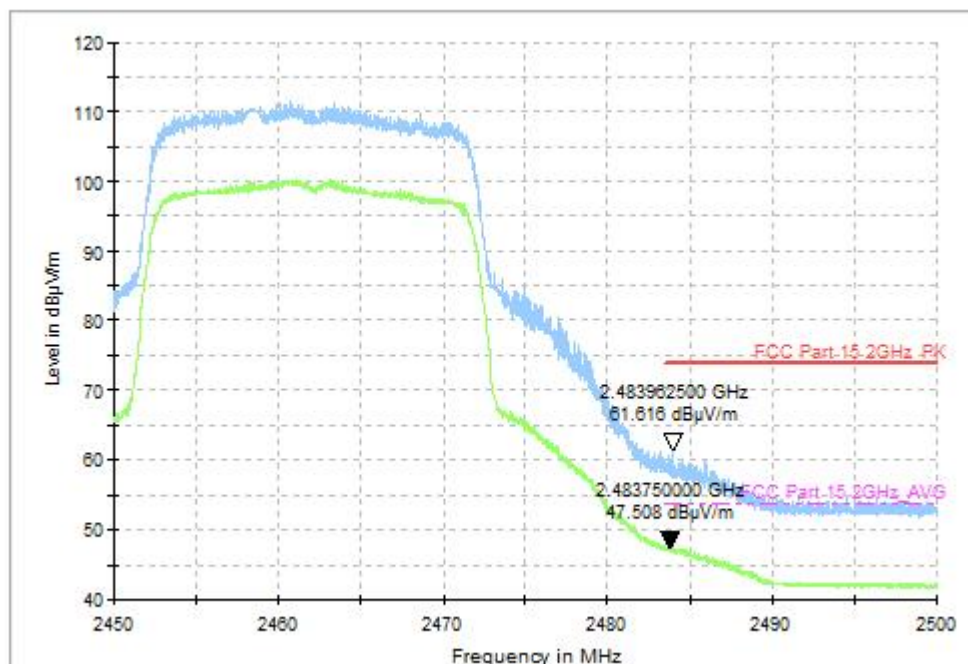


Fig.47 Radiated Restricted Band (802.11be-EHT20, CH11, 2.45GHz~2.50GHz, MIMO)

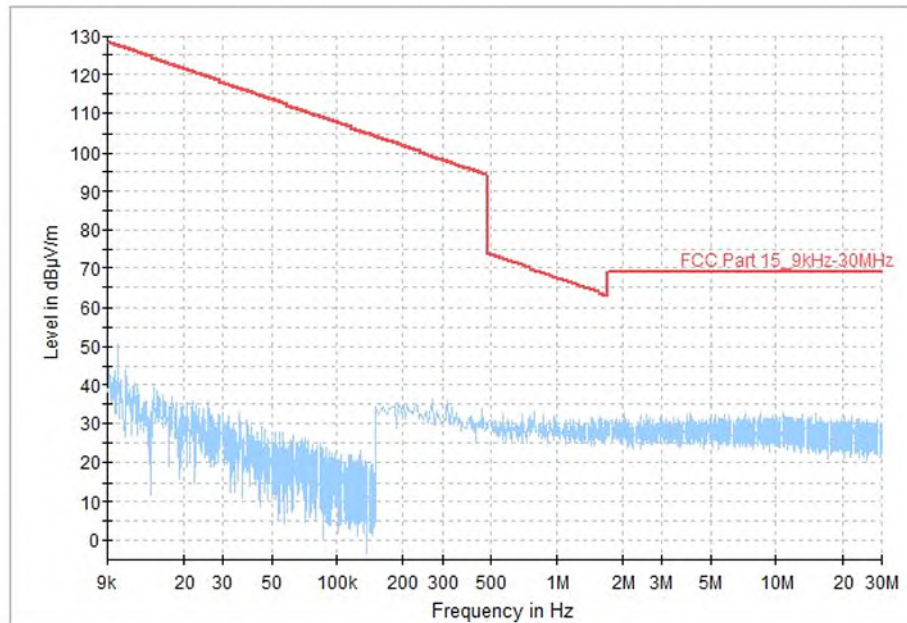


Fig.48 Radiated Spurious Emission (All Channels, 9kHz-30MHz, MIMO)

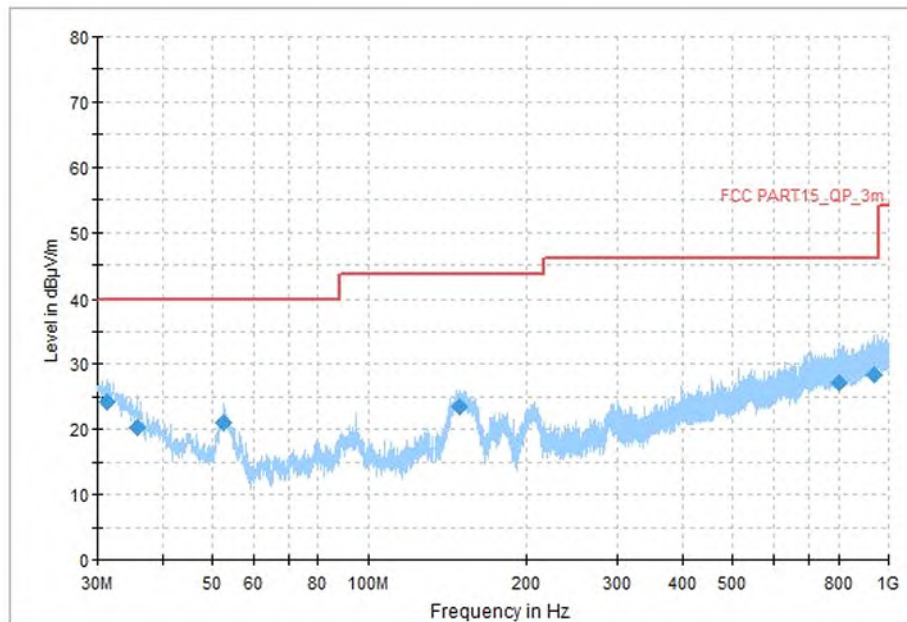


Fig.49 Radiated Spurious Emission (All Channels, 30MHz-1GHz, MIMO)

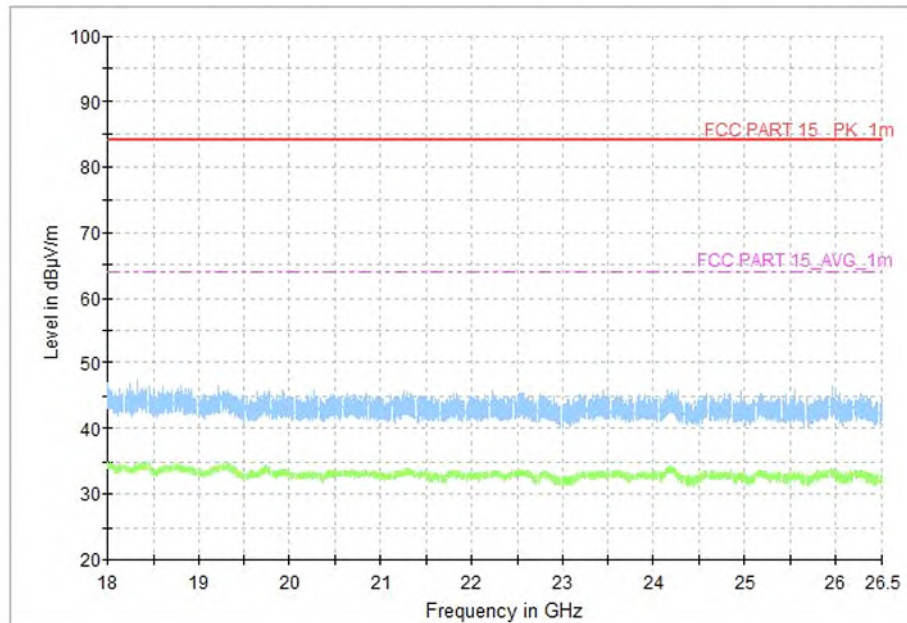


Fig.50 Radiated Spurious Emission (All Channels, 18GHz-26.5GHz, MIMO)

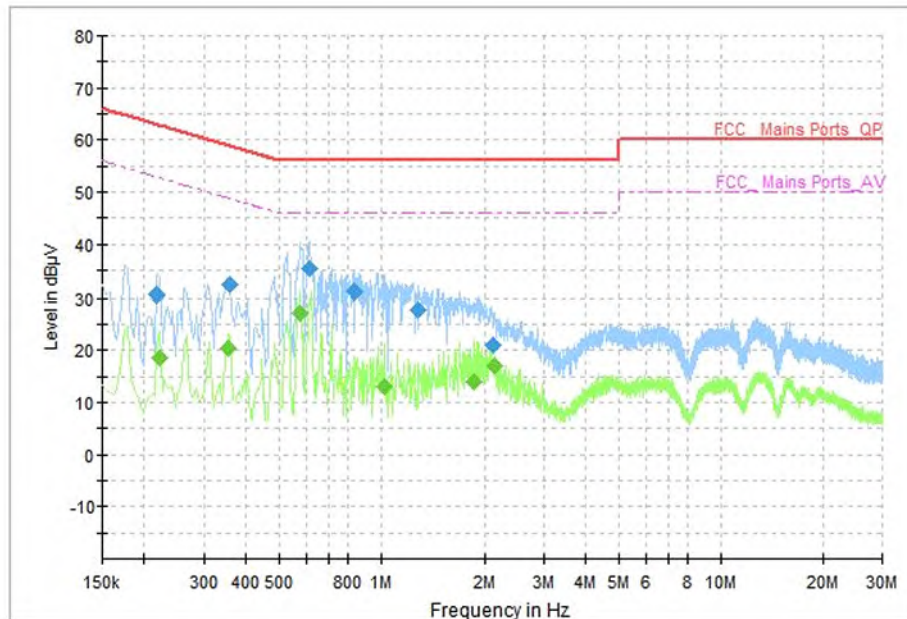


Fig.51 AC Power line Conducted Emission (Traffic)

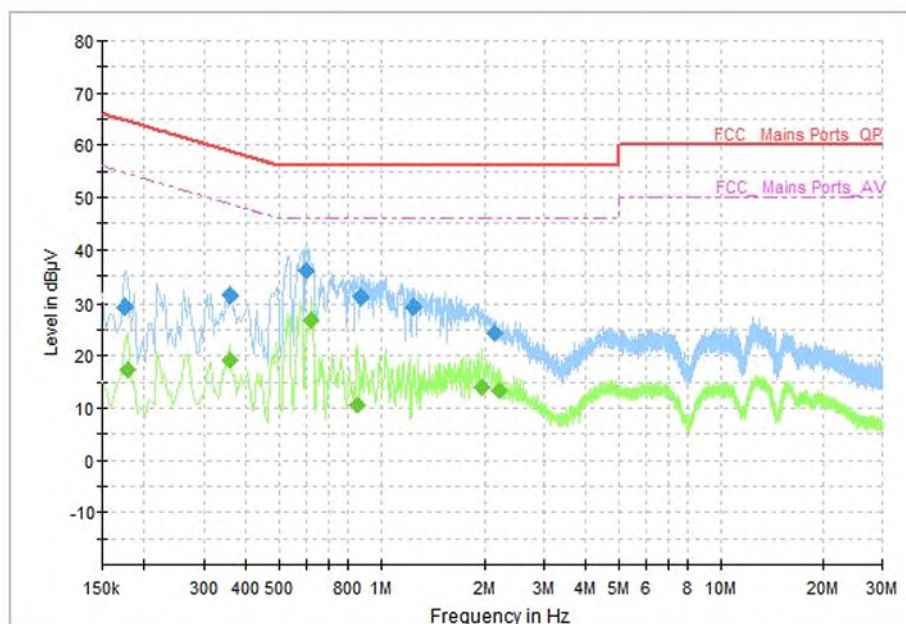


Fig.52 AC Power line Conducted Emission (Idle)
