

# V2\_HPB\_Advanced V1.05 Instruction For Use

One: V2 Bracelet picture preview



TWO: APP Connection


The first step to find the APP icon



The second step is the first interface, equipment search interface



Find the third interface device, click on the device name to establish a connection



Fourth interface, function testing interface, click the test step by step, click the gray box, and the APP to hand control loop to the relevant test, OK, if the test result of the box will turn green, if the test is not passed, will not change color, prompt error.



THREE: The function of hand ring show, when there is no connection APP, may also directly bring a gunner ring into the various functions, click on the touch location swappable interface, as long as the touch key, can enter the function, click the switch interface, no longer need to long press exit is the function again.

Function 1: The default interface, display bluetooth connection symbol, power indicator, date/time, etc



Function 2: Meter interface, display meter state, steps. Long press to send data after connect mobile phone APP



Function 3: Distance interface, display mobile distance, route. Long press into the function



Function 4: Heart rate testing interface, display heart rate, heart rate speed. Long press into the function



Function 5: Blood pressure testing interface, display blood pressure, blood pressure size. Long press into the function



Function 6: Mobile phone connection



Function 7: Shutdown interface, long press to turn it off



Function 8: Long time after activation patterns automatically connect APP into automatic mode



Function 9: Music playback interface, connection control music playback after phone



Operating considerations

1 : Please unexperienced operator ring when fully charged, when only one battery, please charge in time, avoid overdischarge.



2 : Long press to enter after the functional test, at any time can be long press exit function test, but click no longer work.



3 : Touch speed is recommended that you not too much too fast , can guarantee not appear abnormal situation unknown .
