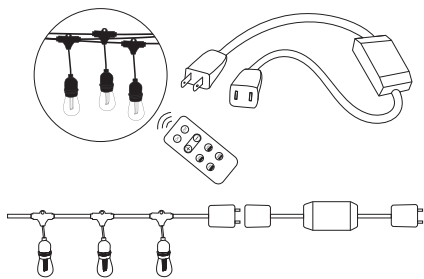

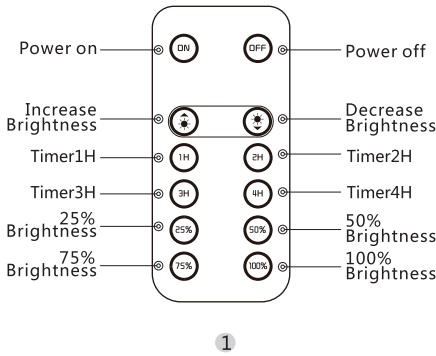

REMOTE CONTROLLER



Please calculate the total power of the bulb before use. The maximum output power is 360W. If you accidentally overload, connected a light bulb with a total output power of more than 360W, the dimmer will flash once and then immediately turn off. This indicates that it is overloaded, so please reduce the number of bulbs and re-run.
For example
If each bulb is 1.5W and there are 15 bulbs on each string, the total power of each string is 1.5*15=22.5W. At this time, only up to 16 strings can be connected.

General problem
If your dimmer is not working properly, please test the dimmer with an incandescent bulb alone. Please send us an email with any questions, we will try our best to solve the problem quickly for you, or give you a refund directly and you don't need to return the goods to us.
Most of the non-working conditions are compatibility issues, because there are no uniform standards for light bulbs on the market.

Incompatible Type: Not suitable for all low-voltage LED bulbs. Including: christmas tree lights, led cabinet lights, led strips light, LED lights with drive power or adapters.

Common incompatibility problems: cannot dim or brighten, unable to achieve the function

- * The dimming kit operates with 120V AC power only. Do not use with any other power supply type.
- * When using the remote control for the first time,check that the battery is in place and remote any plastic protection sleeves that may be alongside the battery.
- * Disconnect power at source prior to connecting cord set, installing light bulbs into sockets and etc.
- * Do not operate light string with any open sockets.
- * For outdoor string light, do not connect cord set to light strings during rain or other inclement weather conditions.
- * Do not overload sockets or light string. Do not exceed the maximum number of connected strings or total feet (and sockets) as listed.
