

## **Enbrighten VIBE Spectrum Tape Lights – Manual – 85822**

### **Overview**

1. This product is our company's latest design product. It adopts the control method of infrared remote control plus WiFi graffiti.
2. It can quickly and conveniently realize full-color adjustment and brightness adjustment, and can meet the application needs of our customers.

### **INSTALLING BATTERY (REMOTE)**

1. Simultaneously push in the tab as you pull out the battery drawer.
2. Place a new CR2025 battery in the drawer with (+) side of the battery facing up (see diagram on back of remote).
3. Push the battery drawer into the remote until it snaps into place.

### **TEST YOUR TAPE LIGHTS**

Test your tape lights before you begin installation.

1. Fully extend the tape light.
2. Connect the power adapter to a 120VAC 60Hz wall outlet.
3. Press the ON/OFF button on the in-line controller to ensure tape lights work properly.

**CAUTION:** Do not plug in the tape light until it is removed from the reel and fully extended, as it can get hot and damage the product.

### **SETUP**

Remotely operate your smart tape lights with the easy-to-use Enbrighten app. Follow the available instructions and resources to set up your smart device.

## INSTALLATION

- **CAUTION:** Do not connect the power supply while installing the tape lights.
1. Determine the best placement for your tape lights, making sure to adhere to the following:
    - Remove any nails, metal or other conductive objects from the installation surface before attaching tape lights, as it could cause the lights to short circuit.
    - Do not stick the tape lights to a glass surface.
    - Avoid installing lights near heat sources or potentially dangerous sources, such as sharp objects, candles, liquids, corrosive chemicals, etc.
    - Select a location within reach of the nearest wall outlet.
  2. Clean the mounting surface.
  3. Connect the tape lights to the in-line controller.
  4. Remove the adhesive backing from the back of the tape lights, then firmly press the tape lights onto a flat surface.
  5. Avoid bending the tape lights where the LEDs and circuits are located, as it could cause damage. If bending the tape lights is required for your chosen location, bend the lights in a loose loop (see Fig. 1).
  6. Connect the power adapter to the in-line controller and plug it into a 120VAC 60Hz wall outlet.

## MANUAL OPERATION

**ON:** Press the button once.

**OFF:** Press the button twice.

**Change-color mode:** Press and release the button to advance through a variety of preset color combinations and effects. Additional options are available through the Enbrighten app.

**Pairing mode:** Press button for 10 seconds for app pairing mode.

## REMOTE CONTROL OPERATION

The remote control uses infrared (IR) technology to communicate with the tape lights. When using the remote control, point it at the tape lights' IR receiver on the in-line controller, making sure there are no obstructions in the signal path.

Use the included IR remote to cycle through the various modes, adjust brightness settings and more. Avoid any extra IR interference by pointing the remote at the in-controller.

1. ON/OFF: Press to activate or deactivate lights
2. White Select: Press to select warm white (3000K) or cool white (4000K)
3. Modes: Press to change modes
4. Directional Modes: Press to change direction of active mode
5. MusicSync: Press for lights to react to sound
6. Single Color: Press repeatedly to advance through color options
7. Multicolor Modes: Press to select preset multicolor modes
8. Set Mode: Press and hold to enter SET mode.
9. Increase/Decrease:
  - a. In static mode, press to adjust brightness level of single color
  - b. In dynamic mode, press to adjust light speed
  - c. In SET mode, press to increase or decrease the number of ICs

### WiFi CONTROL OPERATION

1. First connection: Long press button to enter the network configuration mode, click button to switching mode, connect the power controller and light strip, the light flashes and enters the network distribution mode, open the Tuya app.
2. Automatically identify devices and add them. You can confirm whether to add the device by clicking the Add option.
3. Add a device Enter the WiFi name and password to connect to the device and proceed to the next step (WIFI can only use 2.4g, other devices may not be recognized and may not be connected).
4. Enter the WiFi name and password to directly proceed to the next step of adding the device, wait a few seconds and then add it successfully.
5. After adding successfully, click Finish to proceed to the next step.
6. After clicking Finish, you can adjust the color, brightness, dynamic mode, dynamic mode speed and timing function of the light strip according to your direct preferences.

## TROUBLESHOOTING

Cannot pair to the Enbrighten app	<ul style="list-style-type: none"><li>• Confirm the tape lights are powered.</li><li>• Enable Bluetooth on your smartphone.</li><li>• Position the tape lights and smartphone within 6ft. of the Wi-Fi router.</li><li>• Ensure your smartphone is connected to a 2.4GHz Wi-Fi network – 5GHz not supported.</li><li>• Verify your Wi-Fi network name and password.</li><li>• Try manual setup mode – see app for details.</li></ul>
Device offline	<ul style="list-style-type: none"><li>• Confirm the tape lights are powered.</li><li>• Verify your Wi-Fi is working.</li><li>• Remove the tape lights from the app and pair it again.</li></ul>
Remote not working	<ul style="list-style-type: none"><li>• Battery may be installed incorrectly. Reinstall battery.</li><li>• Battery may need to be replaced. Install new CR2025 battery.</li></ul>
