## 4 Test Standards and Limits

### 4.1 FCC Radiofrequency radiation exposure limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$[(\text{max power of channel})/(\text{min test separation distance})] \cdot [\sqrt{f}(\text{GHz})] \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion.

For 2.4G band device, the limit of worse case is

$$P_{\max} \leq 3.0 \cdot D_{\min} / \sqrt{f} = 3.0 \cdot 5 / \sqrt{2.480} = 9.525 \text{ mW}$$



## 5 Measurement and Calculation

### 5.1 Maximum transmit power

The Power Data is based on the RF Test Report SHEM191101886701.

**Test Data:**

### 5.2 RF Exposure Calculation

The Max Conducted Peak Output Power is 0.51mW. The best case gain of the antenna is 1.5dBi.

1.41dBi logarithmic terms convert to numeric result is nearly 1.32

According to the formula. calculate the EIRP test result:

$$\text{EIRP} = P \times G = 0.51 \text{ mW} \times 1.41 = 0.72\text{mW} < 9.525\text{mW}$$

So the SAR report is not required.
