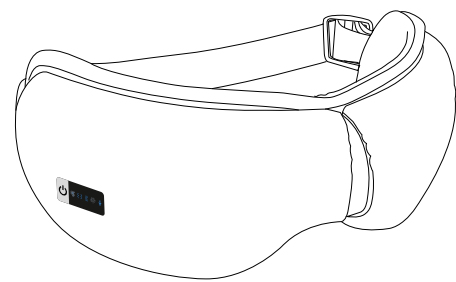

3. CONTRAINDICATIONS:

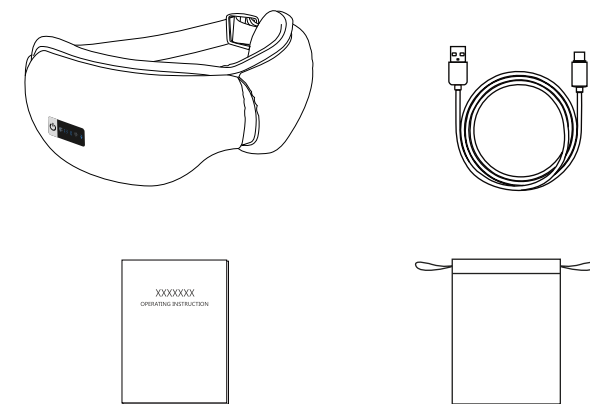
Disables eye injuries or inflammation.

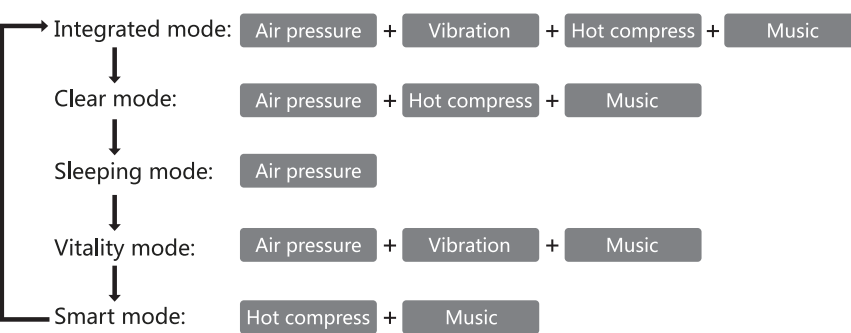

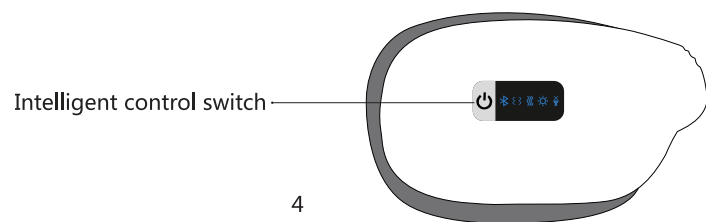

ONE KEY CONTROL LOOP



NAME AND FUNCTION OF EACH PART

1. One-click operation
- (1) Long press the key for 3 seconds to start the integrated mode (air pressure + vibration + hot compress + music)
- (2) Press the key again to start clear mode (air pressure + hot compress + music)
- (3) Continue to press the key to start sleeping mode (air pressure)
- (4) Continue to press the key to start vitality mode (air pressure + vibration + music)
- (5) Continue to press the key to start smart mode (hot compress + music)
- (6) Press the button for 3 seconds to turn off the machine function
- (7) Open the Bluetooth of your mobile phone and search the Bluetooth name: YBY. The devices will automatically connect.



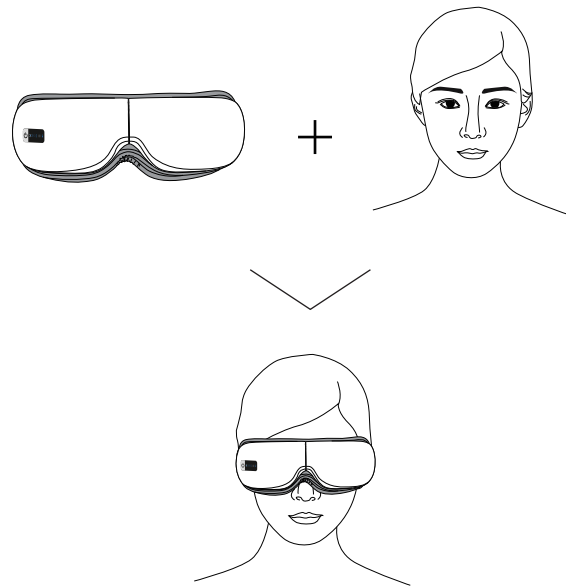

Bluetooth Air pressure Hot compress vibration Music pause/play

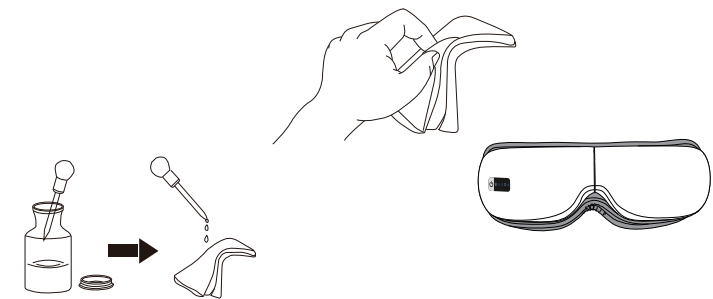

COMMON FAILURES AND SOLUTIONS

Unable to boot:

1. If the battery power is too low, please charge immediately
2. Host protection (with electricity) connect the charger, charge, and allow the host to automatically remove the protection (charge for 5 seconds)
3. The battery is not charged and the charger is damaged
4. The pressure intensity is too weak

Note: all maintenance work must be done by our authorized maintenance personnel

COMMON FAILURES AND SOLUTIONS

| The fault | Possible cause of failure | The solution |
|--------------------------|---|---|
| Unable to boot | Low battery | Please charge immediately |
| | Motherboard protection (with electricity) | Connect the charger to charge, and allow the host to automatically remove protection (5 seconds after charging) |
| | The battery is not charged | Replace charger |
| | In charge | Unplug charger |
| The pressure is too weak | Low power | charging |
| Eye patch not hot | Low power | charging |
| | Model is wrong | Tune to the corresponding pattern |
