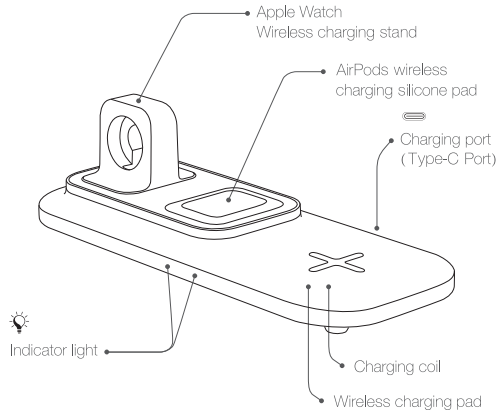

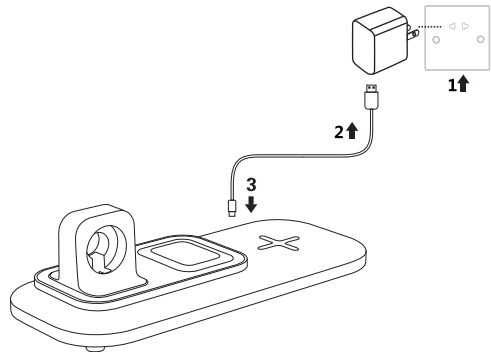

How to Work

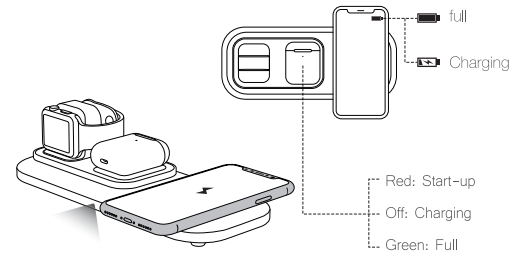
1. Connect a charging to the wireless charging.



Highly recommended to use Q.C 3.0/2.0 charging (9V/2A) and type-c cable with DT-X3 for fast charging. A lower power source may result in longer charging time, charging errors or lower charging efficiency performance.

2.Place a mobile phone & AirPods & Apple Watch on the charger.

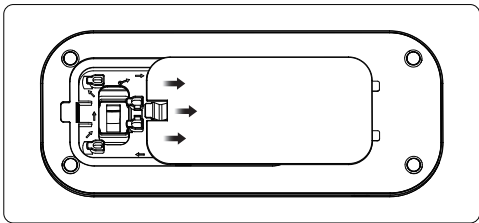
Check the charging icon displayed on the mobile phone's screen for the charging status.
Check the light of AirPods for the charging status.



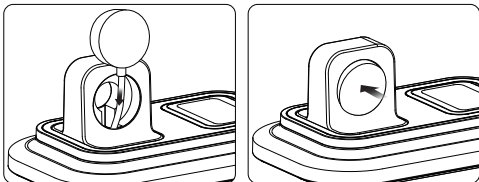
Indicator light identification:

Flashing white	1. Not charging properly due to a general error 2. Low power input (less than 9V/2A)

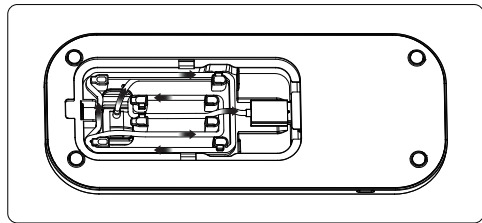
3. DT-X3 Easy Setup



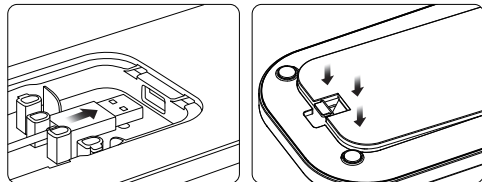
1 open the Bottom Cover.

3 install iWatch charging well.

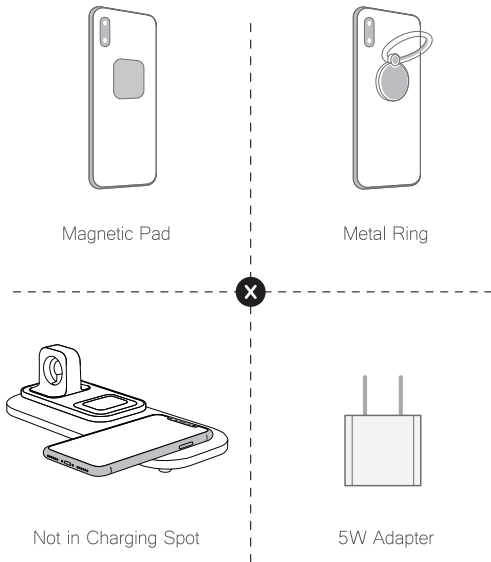
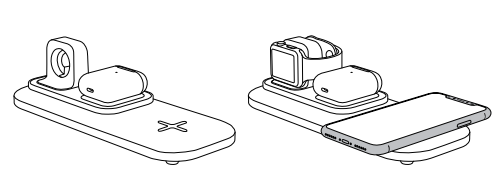
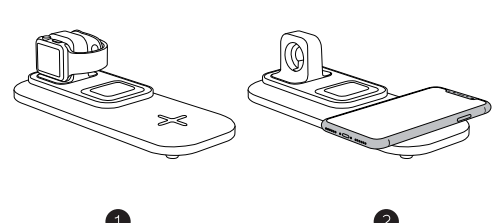


4 wrap the cable as picture shows.
