2 YEARS LIMITED WARRANTY

1. For a period of 2 years from the date of purchase if this Product is determined to be defective, ROCKsteady will repair or replace the Product, at its option, at no charge. After this 2 year period, you must pay for the replacement unit. This warranty does not cover costs incurred in connection with the removal and re-installation of radios, speakers or accessories, nor does it cover any other contingent expenses.
2. To obtain warranty service, you must take the Product, or deliver the Product freight prepaid, in either its original packaging or packaging affording an equal degree of protection, to any Factory ROCKsteady Service facility or to a Fulfillment Center. See below for additional information.

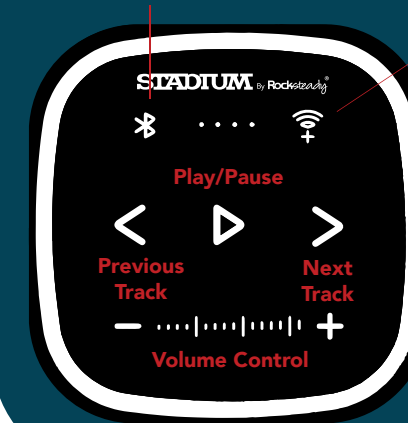

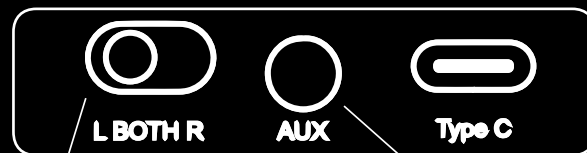

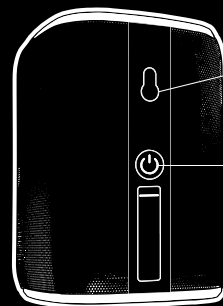
