




What's in the box


Description



Power Port	DC 5V±10%
Power on/off	Press the button for 3 seconds to turn on/off the camera
Status light	<ul style="list-style-type: none">Red light solids on: the camera network is abnormalRed light blinks: awaiting WiFi connection, or currently connecting (faster blinking)Blue light solids on: camera running correctly
SD card slot	Support local SD Card storage (Max.128G)
Reset	Press and hold on for 5 seconds to reset the camera
Charging indicator	<ul style="list-style-type: none">Red indicator solids on: battery is chargingBlue indicator solids on: charging completed
Battery capacity	6400mAh (Two 18650 lithium-ion batteries)

Add device

Log in the CloudEdge, select "Add Device", and add the smart camera to the App according to the screen tips(Make the smart camera close to the router when configuring).

FAQ

Download

Q : The device can't be previewed properly?
A : Check whether the network is normal, you can place the camera close to the router, and if not, it's recommended to reset the device and add it again.

Download App(iOS/Android)

Add device

Q : Why is it still in the list of device after resetting?
A : The reset device only resets the network configuration of the camera, but cannot change the configuration on the App, remove the camera, and must be deleted by the App.

Power on/off

Q : How to cut the camera a network to another router?
A : First remove and reset the device on the App and then configure the device again by the App.

Status light

Q : Why doesn't the device identify the SD card?
A : It is recommended to plug in SD card after power cut. Confirm whether the SD card is normally available and the format is FAT32. And the SD card can't be identified when the environment is not good.

SD card slot

Q : Why can't the notifications work in my cellphone App?
A : Please confirm that the App has been running on the phone, and the relevant reminder function has been opened; Message notifications and authority confirmation in the mobile phone system have been opened.

Reset

NOTE:If you need to re-select the WiFi network, please press and hold the "RESET" button for 5 seconds, the device will restart, and the indicator will be flashing red.

Functions

Remote wake-up

The camera will be in sleep mode to save power, you can have a preview in App.

Full duplex audio

You can send and hear the voice in your App from the camera.

PIR

When the camera detects someone stepping by, it sends an alarm message to your cellphone.

Low battery alarm

When the battery power is lower than your set, the App will send a notification to your mobile phone.

Record

Using SD card or opening CloudStorage Service, to keep recording for every moment.

Day & night

Powerful night vision means no interruptions, even in complete darkness.
