Carrier Frequency Separation_DH5_2402



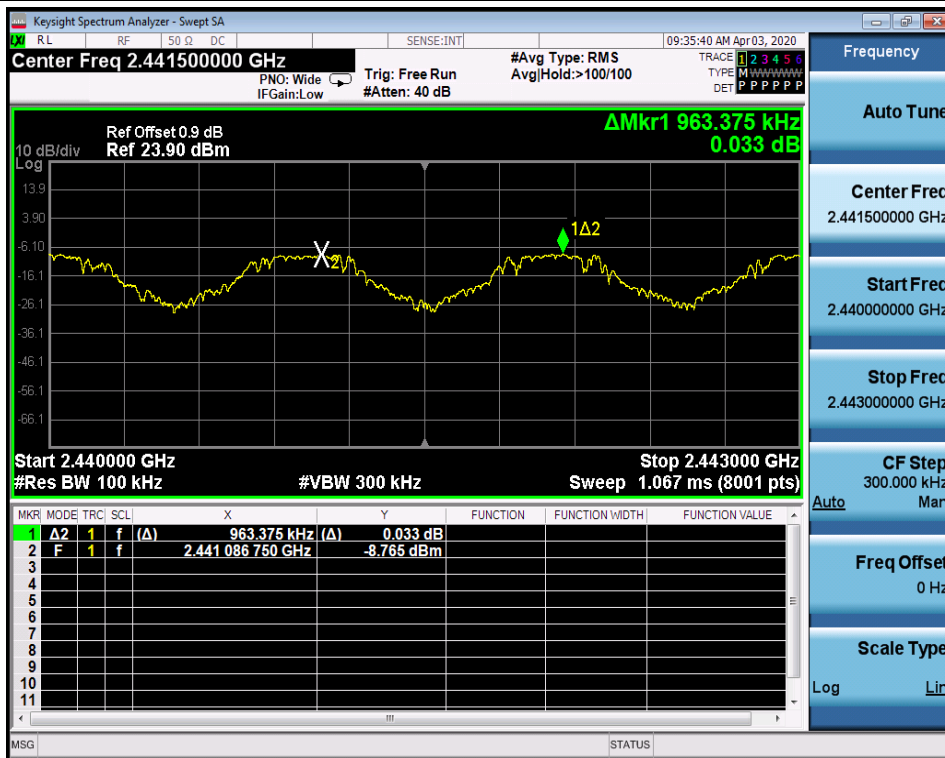
