The only difference between them is:

No external or internal difference, aesthetic or electrical, is present between the models in the main Trumpet unit. The models differ only for the provided transducers and licenses, that are exclusively software-related. The family representative is “Trumpet REM & AUD Wireless” because it is provided with the most comprehensive set of transducers and licenses.

The customer can buy a license or a different set of transducers after buying a specific model. For example, if he buys a Trumpet REM that is provided with a wired probe, he can buy a wireless probe afterwards and use the software to instruct the device to use the wireless probe instead of the wired one.

According to RSP 100, Issue 12, Clause 9.3:

Multiple versions of a product design are permitted to be certified under a single family certification service with one ISED Certification Number provided that all the product variants within a family certification meet the following conditions:

Clause	Response
a. the enclosure and general appearance of all product versions in a family certification shall be identical except for enclosure colour and/or minor external cosmetic differences	There is no difference in the main device between models of the same family: it is exactly the same device except for the label on the back (see below)
b. two or more versions of a product with one printed circuit board (PCB) design with different frequency bands/technologies enabled by software	The only change that can be enabled by the software is to enable or not the Bluetooth communication for the wireless probe, for all the models
c. a new version of a certified product which may have minor PCB modifications to improve existing frequency bands/technologies and/or add non-RF features	First radio certification
d. all the product versions within the family certification shall be identical or have differences permitted under Class I and III permissive changes	All the products within the family certification are identical.


