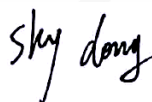

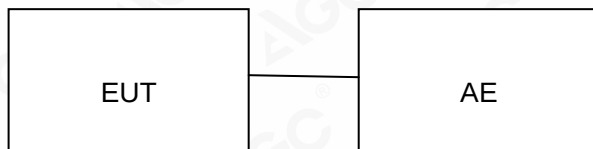

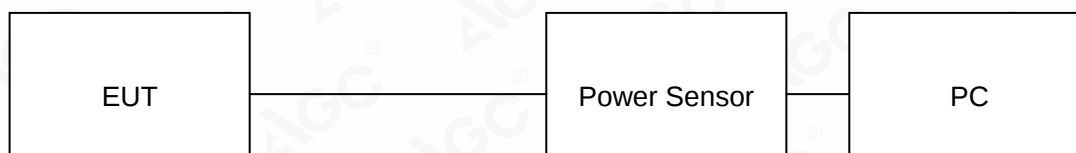

4. Record the maximum power from the software.

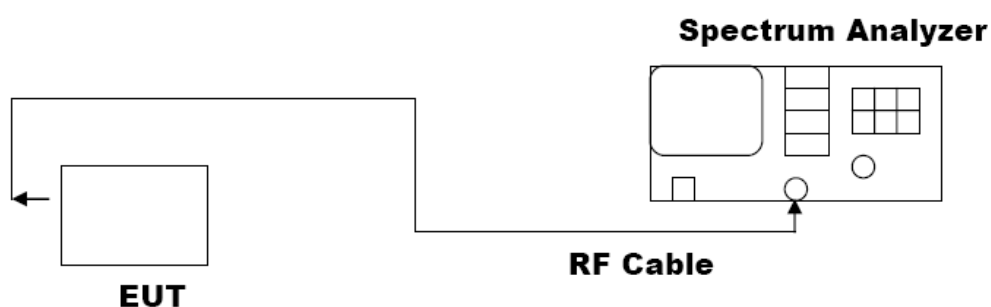

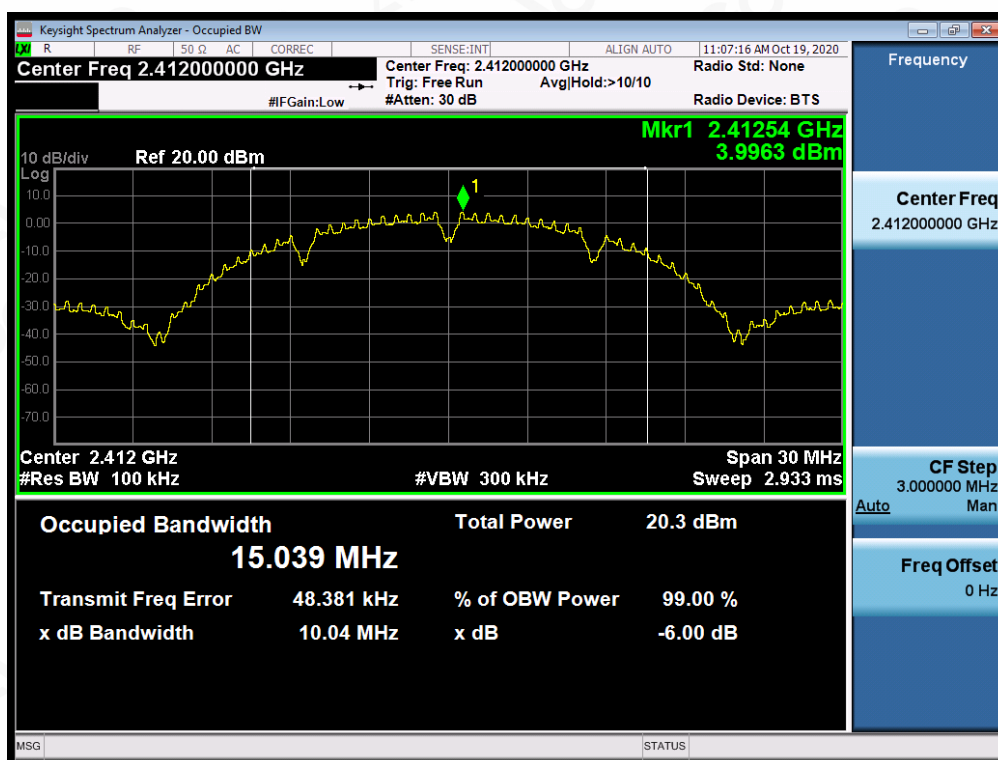

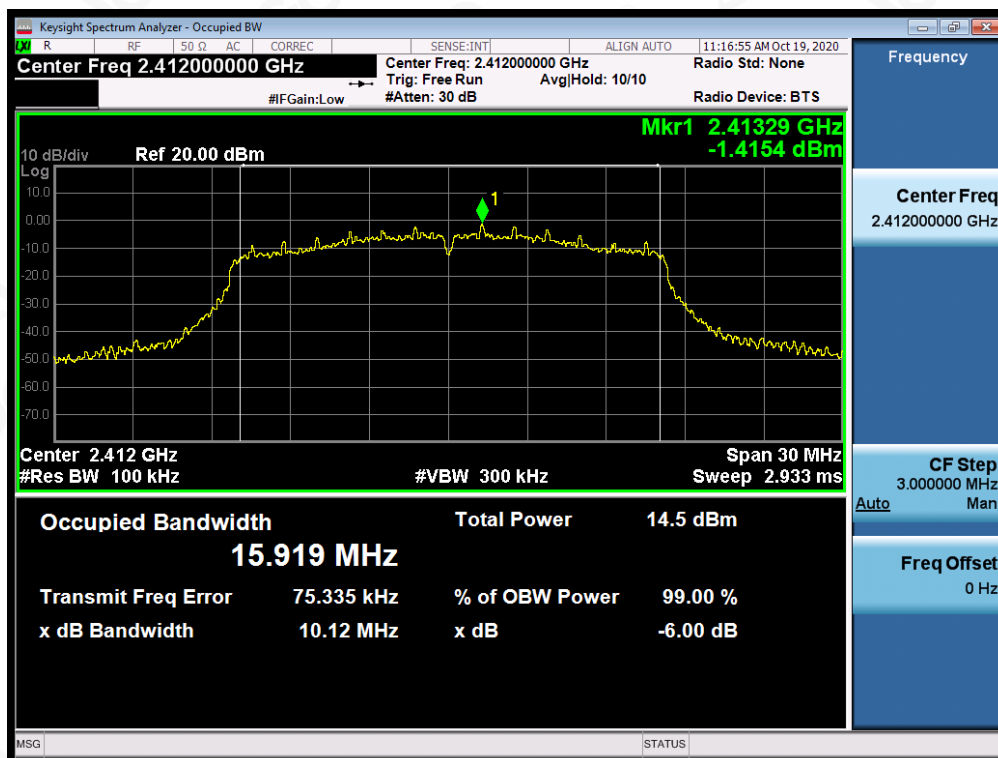


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

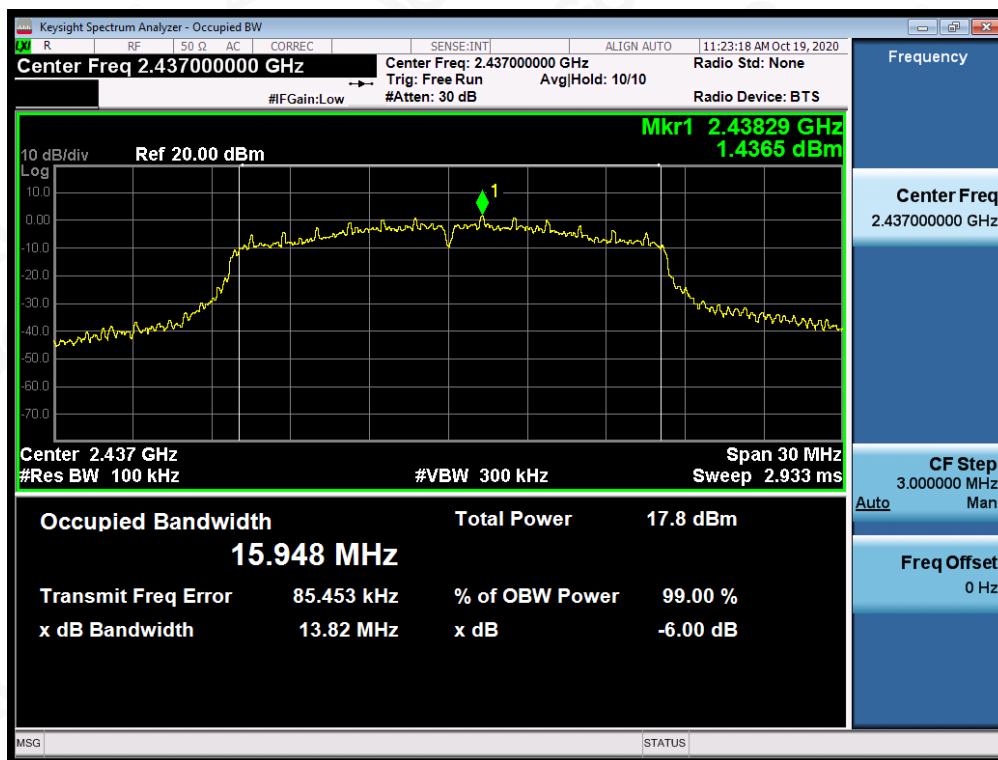

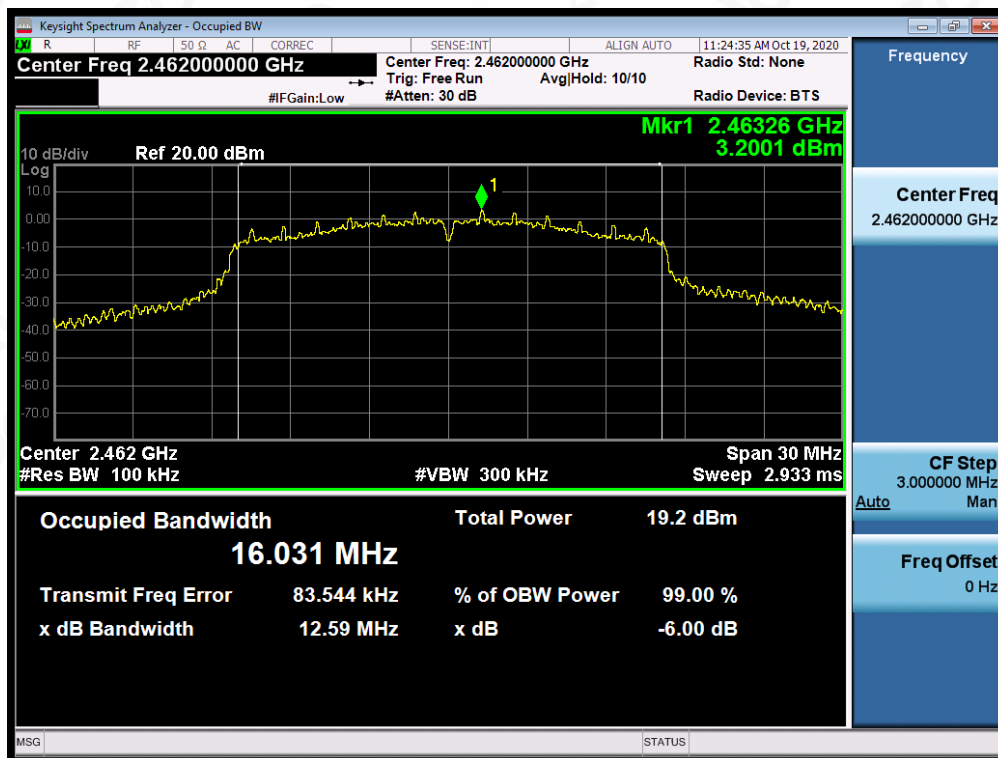

TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL



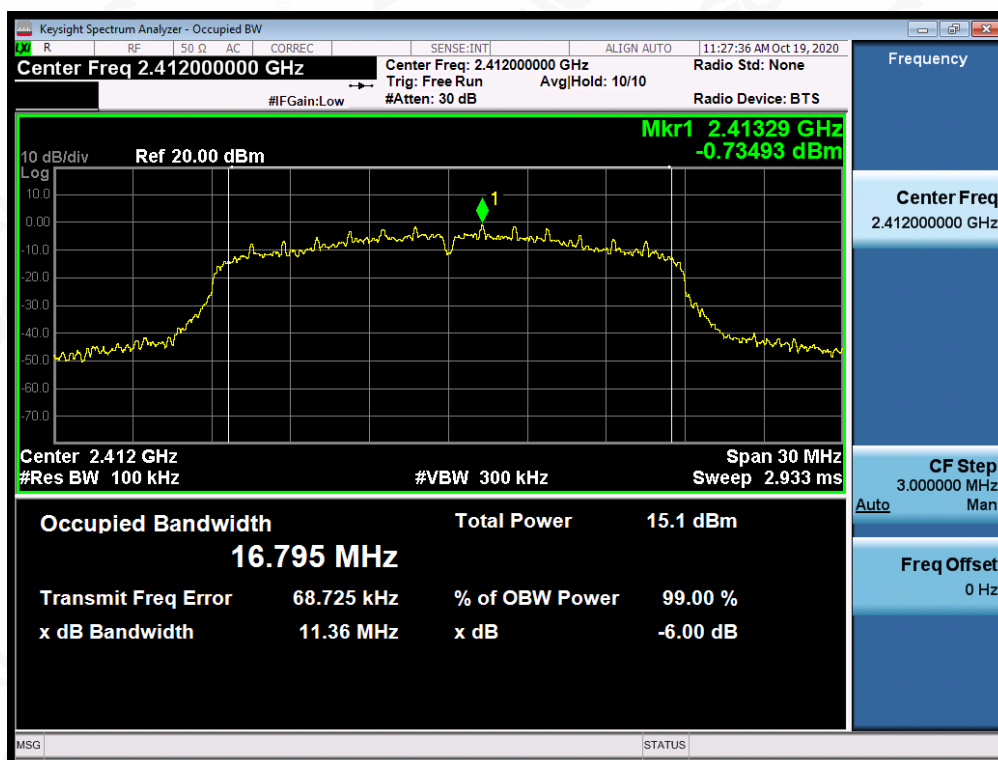

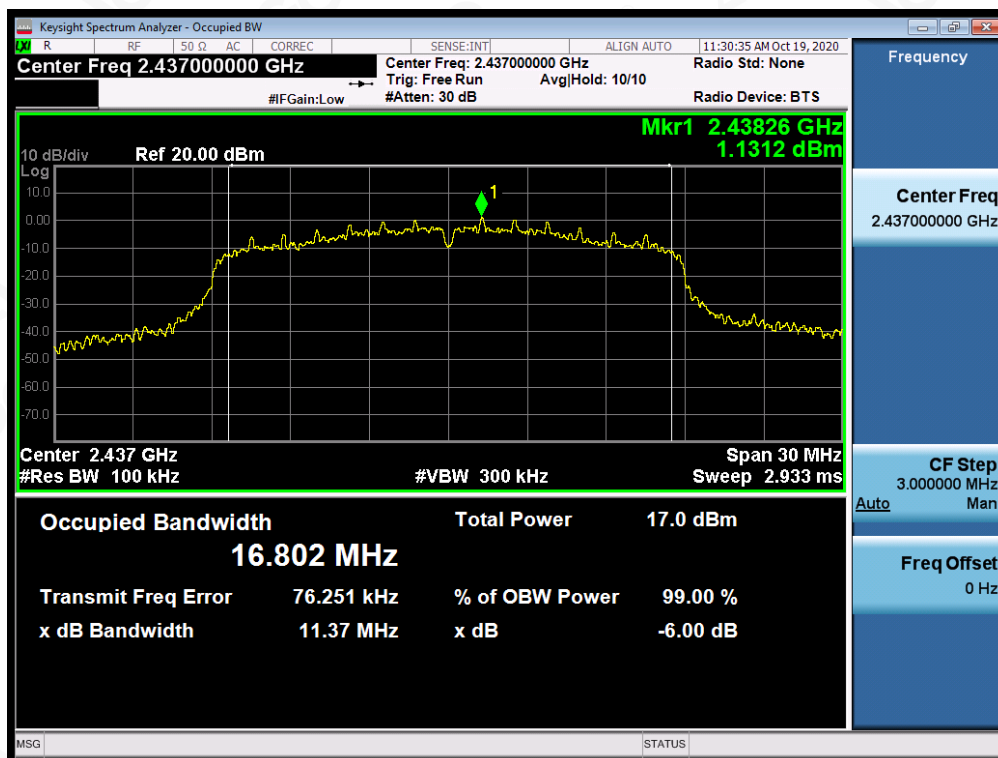

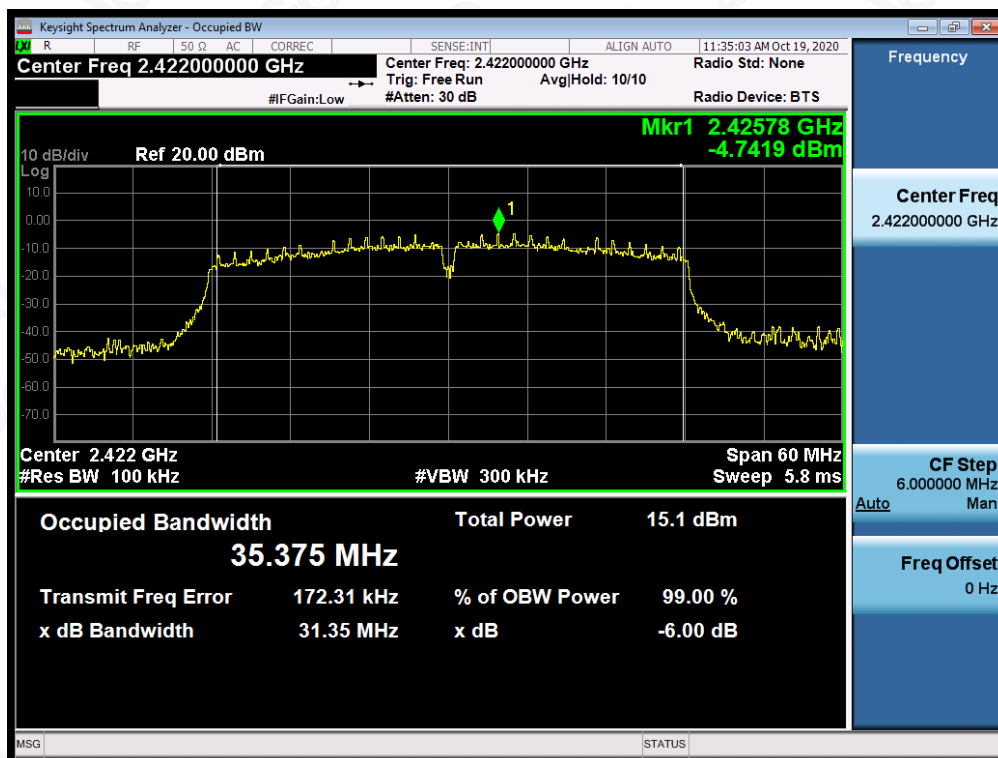


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL
