6dB Bandwidth_11B_2412_Ant1



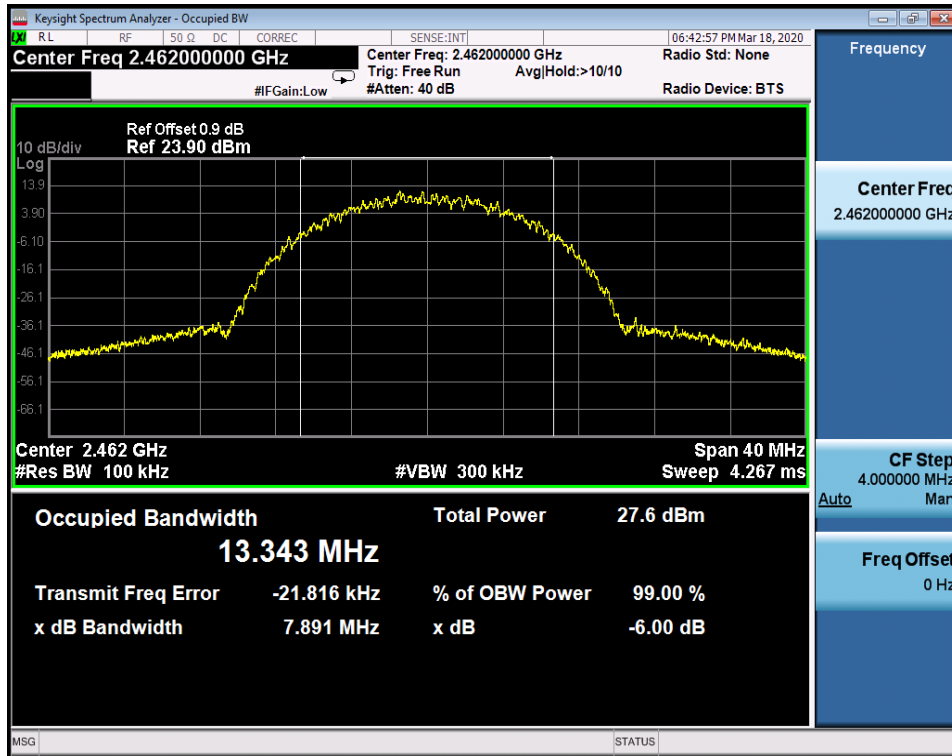

Maximum peak conducted output power_11B_2442_Ant1



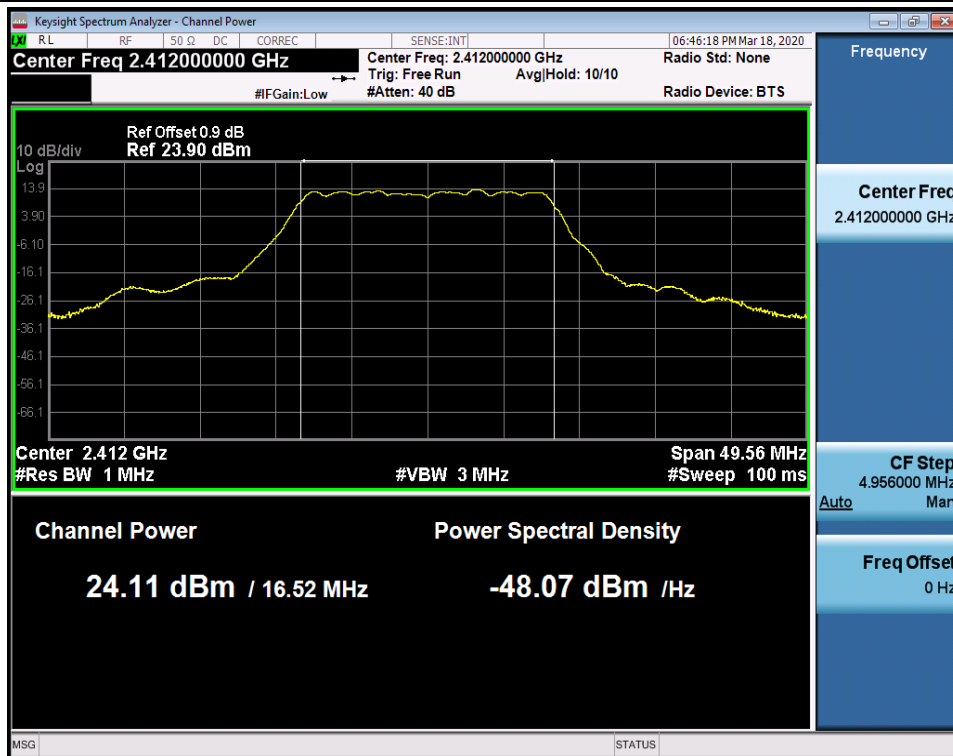

Maximum Peak power spectral density_11B_2412_Ant1



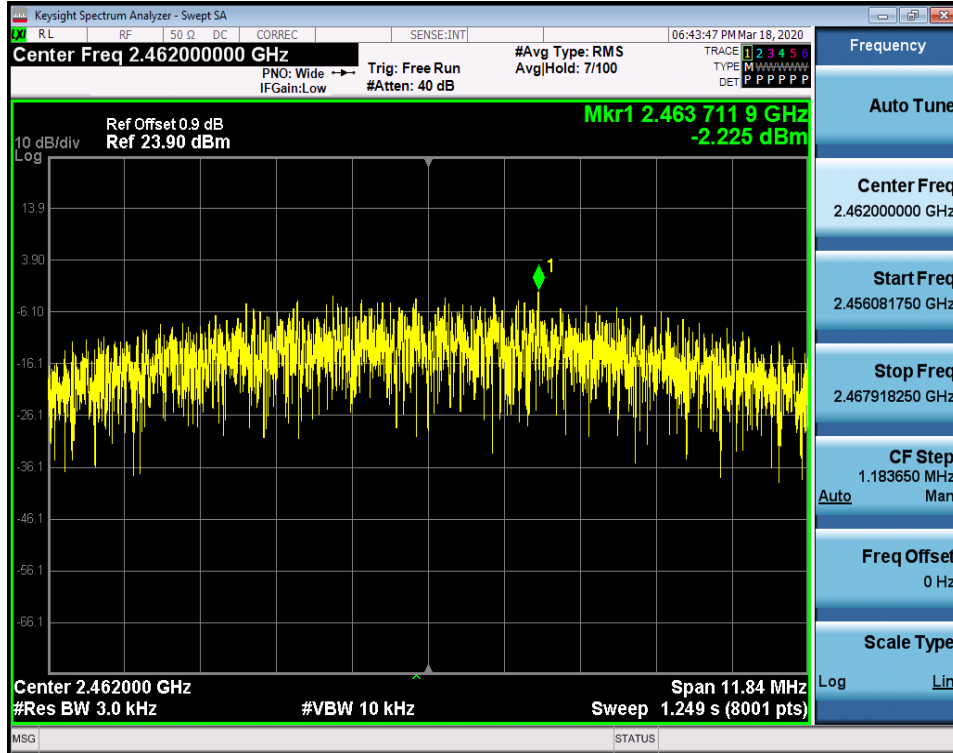
