To connect the lamp to the bridge, follow the instructions in the related mobile app.

Factory-reset:

Switch the lamp OFF and ON six times (6x) with intervals of 0.5-1 seconds. The lamp will blink to indicate it is factory-reset. It can then be connected to a bridge again.
