



#### 常见问题处理

- 3.如果是音响没有混响,可能是混响开关已关闭,请打开混
- 4.如果麦克风有噪音,可能是因为环境噪音,信号干扰,话 简靠喇叭太近等,请重新调试表的方向。
- 5.如果蓝牙播放中断,可能是因为蓝牙距离太远,或是手机 和扩音器之间有障碍物,影响信号的传输,请靠近连接的手
- 6.如果蓝牙无法连接,可能是因为距离太远,有障碍物,或 是被其他手机连接,请靠近手机避开障碍物,断开连接的手
- 7.如果无法充电,检查充电器是否正常,音响充电时候,充 电口的红色指示灯是否亮起。





## Frequently asked questions

- 1. If the indicator light does not turn on, please check whether the audio power is sufficient, or to connect the audio to 5V/IA power supply for charging, charging time is about 3 to 4 hours.

  2. There is no sound in the microphone. The power supply is not
- on, the mode is not correct, or the volume is not adjusted. Please adjust the volume of the microphone. If the stereo does not have reverb, the reverb switch may be off.
- please turn on the reverb switch.
- 4. If the microphone is noisy, it may be due to ambient noise, signal interference, microphone too close to the speaker, etc. please re-adjust the direction of the microphone.
- S. If Bluetooth playback is interrupted, it may be because the Bluetooth is too far away, or there is an obstacle between the phone and the loudspeaker, affecting the signal transmission, please close to the connected phone, avoid the obstacle.

  6. If Bluetooth can not be connected, it may be because the distance is too far, there are obstacles, or by other phones connected, please close to the phone to avoid obstacles, disconnect the phone
