

RF Exposure Evaluation**Limit**

The criteria listed in the following table shall be used to evaluate the environment impact of human exposure to radio frequency (RF) radiation as specified in 1.1310 & 2.1091

Note: f = frequency in MHz

Evaluation Method

Transmission formula: $P_d = (P_{out} \cdot G) / (4 \cdot \pi \cdot R^2)$

Where

P_d = power density in mW/cm², P_{out} = output power to antenna in mW, G = gain of antenna in linear scale;

$\pi = 3.1416$, R = distance between observation point and center of the radiator in cm

Remark:

1. Output power including tune up tolerance;
2. The maximum 2.4G antenna gain is 4.23dBi
3. The exposure safety distance is 20cm.

Simulation Transmission

EUT can only work in 2.4GWIFI+BLE mode

The formula of calculated the Simulation Transmission MPE is:

CPD1/LPD1+CPD2/LPD2+.....etc.<1

CPD=Calculation Maximum Power Denisty
