## User Guide

1 Unzip the zipper and put the battery into the battery holder.



2 Download the APP (attached picture) scan the QR code and enter the APP Store or Google Play to download the application, register through in-app rules, set up emergency contact, and ensure the normal use of the product by activating Bluetooth, GPS positioning, system reminder and other functions.



3 Activate &Bind the device. It gives a prompt sound after pressing the device, then APP can be used to search for binding..



If the product keep pressing for more than 60 seconds and still disconnect. It turns off automatically
