1.7 Description of Test Modes

Bluetooth operates in the unlicensed ISM Band at 2.4GHz. With basic data rate feature, the data rates can be up to 1 Mb/s by modulating the RF carrier using GFSK techniques. The EUT works in the X-axis, Y-axis, Z-axis. The following operating modes were applied for the related test items. All test modes were tested, only the result of the worst case was recorded in the report.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was determined to be TX(3Mbps-High Channel).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was determined to be TX(3Mbps-High Channel).

Pre-test AC conducted emission at charge from Low Channel mode, recorded worst case.

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/60Hz, recorded worst case.



2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10-2013, FCC CFR PART 15C 15.207, 15.209 and 15.247.

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT was operated in the normal operating mode for Hopping Numbers and Dwell Time test and a continuous transmits mode for other tests.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

2.3 General Test Procedures

2.3.1 Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.1.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane below 1GHz and 1.5 m above ground plane above 1GHz. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.4 of ANSI C63.10-2013

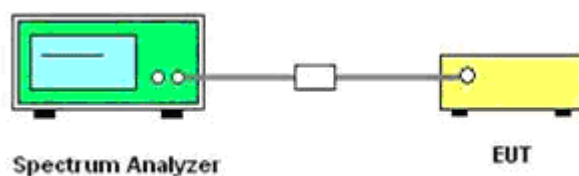
6. MEASUREMENT RESULTS

6.1. Frequency Separation and 20 dB Bandwidth

6.1.1 Limit

According to §15.247(a), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

6.1.2 Block Diagram of Test Setup



6.1.3 Test Procedure

Frequency separation test procedure :

- 1). Place the EUT on the table and set it in transmitting mode.
- 2). Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- 3). Set center frequency of Spectrum Analyzer = middle of hopping channel.
- 4). Set the Spectrum Analyzer as RBW = 100 kHz, VBW = 300 kHz, Span = wide enough to capture the peaks of two adjacent channels, Sweep = auto.
- 5). Max hold, mark 2 peaks of hopping channel and record the 2 peaks frequency.

20dB bandwidth test procedure :

- 1). Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel.
- 2). RBW $\geq 1\%$ of the 20 dB bandwidth, VBW $\geq$ RBW.
- 3). Detector function = peak.
- 4). Trace = max hold.

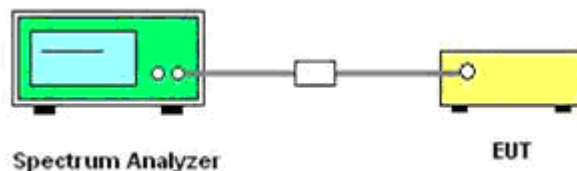

6.2. Peak Power

6.2.1 Block Diagram of Test Setup



6.2.2 Limit

According to §15.247(b)(1), For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400–2483.5 MHz band: 0.125 watts.

6.2.3 Test Procedure

The transmitter output is connected to the spectrum.

6.2.4. Test Procedures

- 1) Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.
- 2) RBW > 20 dB bandwidth of the emission being measured.
- 3) VBW $\geq$ RBW.
- 4) Sweep: Auto.
- 5) Detector function: Peak.
- 6) Trace: Max hold.

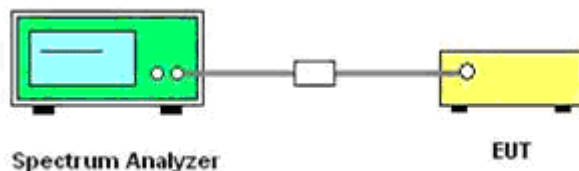


6.3. Time of Occupancy (Dwell Time)

6.3.1 Limit

According to §15.247(a)(1), Frequency hopping systems operating in the 2400MHz- 2483.5 MHz bands. The average time of occupancy on any channels shall not greater than 0.4 s within a period 0.4 s multiplied by the number of hopping channels employed.

6.3.2 Block Diagram of Test Setup



6.3.3 Test Procedure

- 1). Place the EUT on the table and set it in transmitting mode.
- 2). Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- 3). Set center frequency of Spectrum Analyzer = operating frequency.
- 4). Set the Spectrum Analyzer as RBW=1MHz, VBW=3MHz, Span = 0Hz, Sweep = auto.
- 5). Repeat above procedures until all frequency measured was complete.

6.3.4 Test Results

The Dwell Time=Burst Width*Total Hops. The detailed calculations are showed as follows:

The duration for dwell time calculation: $0.4[s] \times \text{hopping number} = 0.4[s] \times 79[\text{ch}] = 31.6[s \cdot \text{ch}]$;

The burst width [ms/hop/ch], which is directly measured, refers to the duration on one channel hop.

The hops per second for all channels: The selected EUT Conf uses a slot type of 5-Tx&1-Rx and a hopping rate of 1600 [ch*hop/s] for all channels. So the final hopping rate for all channels is $1600/6=266.67 [\text{ch} \cdot \text{hop/s}]$

The hops per second on one channel: $266.67 [\text{ch} \cdot \text{hops/s}] / 79 [\text{ch}] = 3.38 [\text{hop/s}]$;

The total hops for all channels within the dwell time calculation duration: $3.38 [\text{hop/s}] \times 31.6[s \cdot \text{ch}] = 106.67 [\text{hop} \cdot \text{ch}]$;

The dwell time for all channels hopping: $106.67 [\text{hop} \cdot \text{ch}] \times \text{Burst Width} [\text{ms/hop/ch}]$.

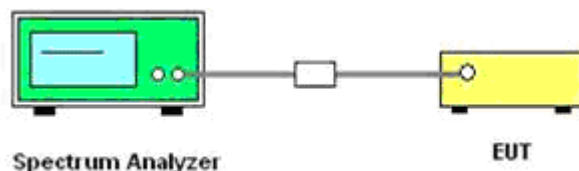


6.4. Number of Hopping Frequency

6.4.1 Limit

According to §15.247(a)(1), Frequency hopping systems operating in the band 2400-2483.5 MHz shall use at least 15 hopping channels.

6.4.2 Block Diagram of Test Setup



6.4.3 Test Procedure

- 1). Place the EUT on the table and set it in transmitting mode.
- 2). Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- 3). Set Spectrum Analyzer Start=2400MHz, Stop = 2483.5MHz, Sweep = auto.
- 4). Set the Spectrum Analyzer as RBW=100KHz, VBW=300KHz.
- 5). Max hold, view and count how many channel in the band.

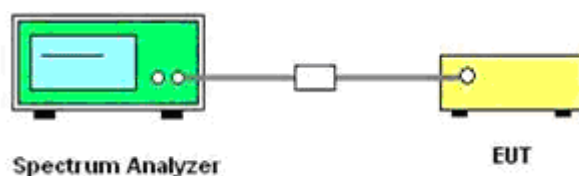


6.5. Band Edges Measurements and Conducted Spurious Emissions Test

6.5.1 Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required.

6.5.2 Block Diagram of Test Setup



6.5.3 Test Procedure

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

The transmitter output is connected to the spectrum analyzer. The resolution bandwidth is set to 100 KHz. The video bandwidth is set to 300 KHz.

Measurements are made over the 30 MHz to 25GHz range with the transmitter set to the lowest, middle, and highest channels

6.6.3. Test Procedures

1) Sequence of testing 9 kHz to 30 MHz

Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- If the EUT is a floor standing device, it is placed on the ground.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

Premeasurement:

- The turntable rotates from 0 °to 315 °using 45 °steps.
- The antenna height is 1.0 meter.
- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Final measurement:

- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0 ° to 360 °) and by rotating the elevation axes (0 °to 360 °).
- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

- The antenna is polarized vertical and horizontal.
- The antenna height changes from 1 to 4 meter.
- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ($\pm 45^\circ$) and antenna movement between 1 and 4 meter.
- The final measurement will be done with QP detector with an EMI receiver.
- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

Premeasurement:

- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height scan range is 1 meter to 4 meter.
- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

Final measurement:

- The final measurement will be performed with minimum the six highest peaks.

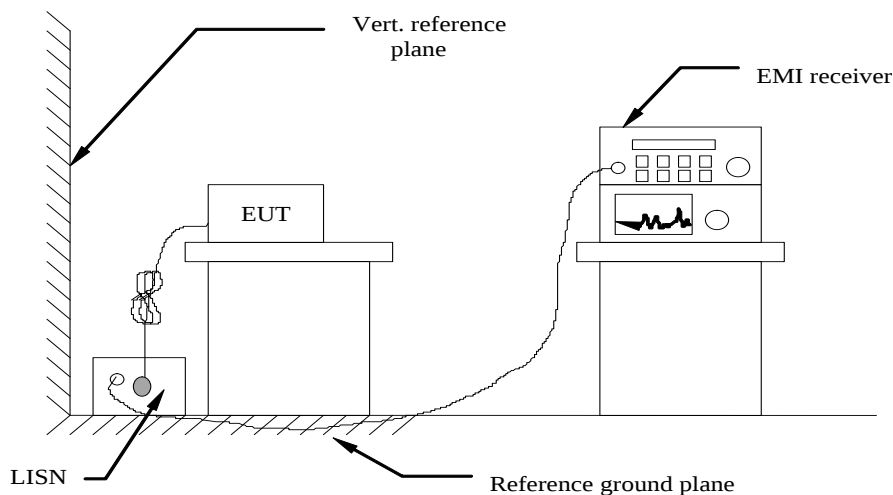
6.7.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 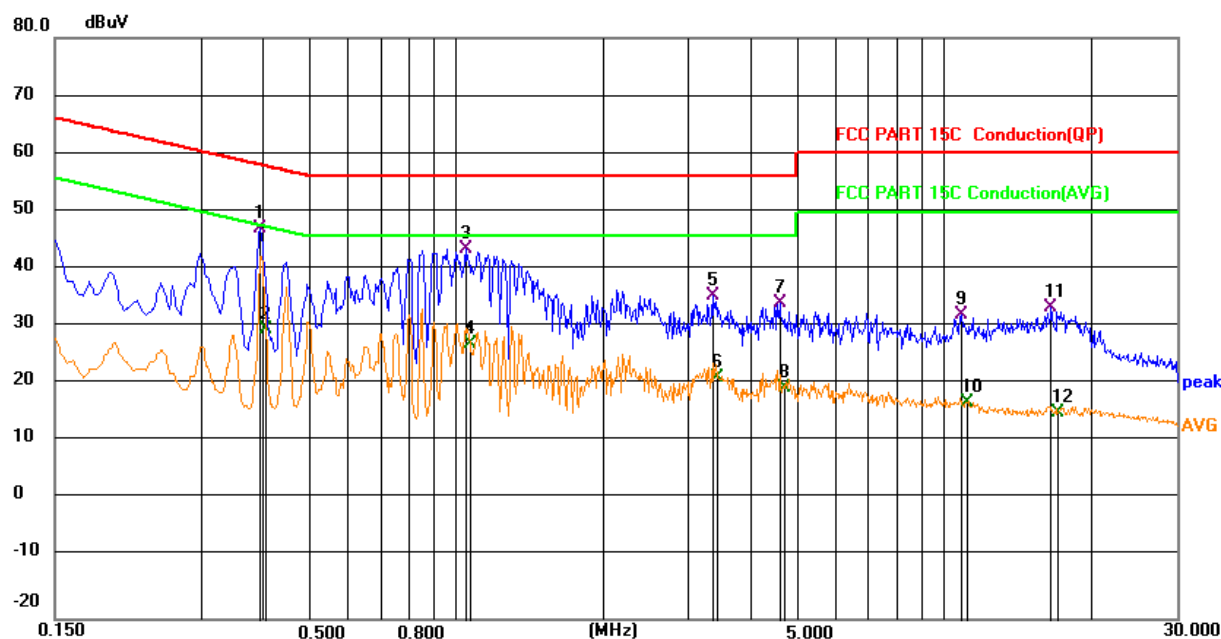

**AC Conducted Emission @ AC 120V/60Hz (worst case)**

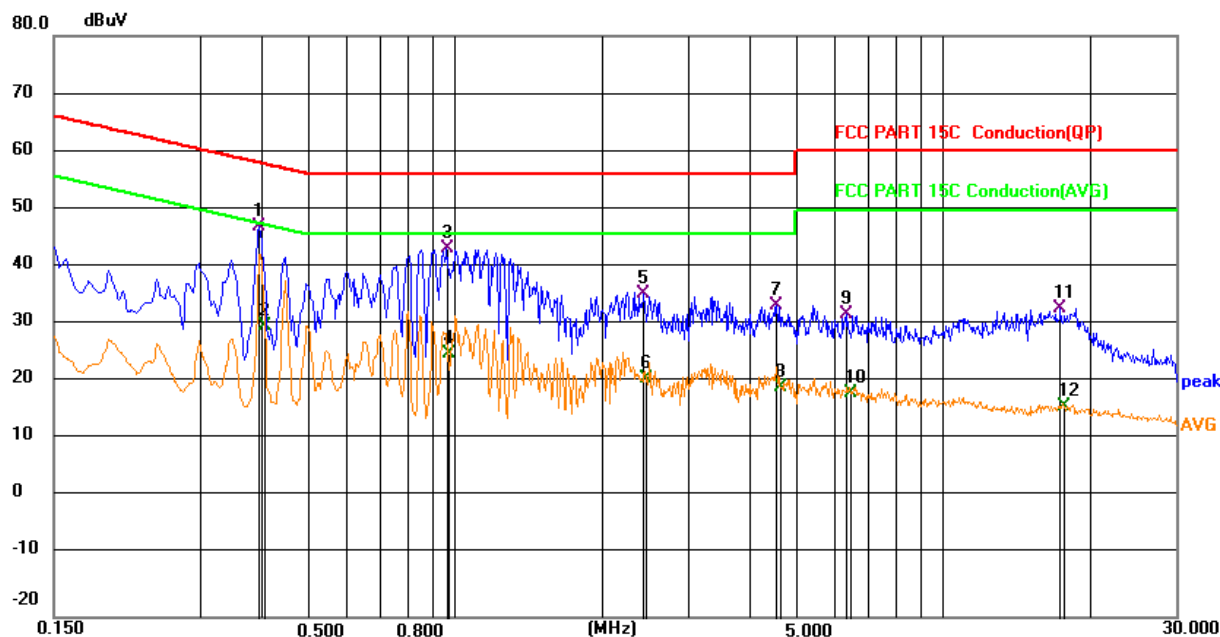

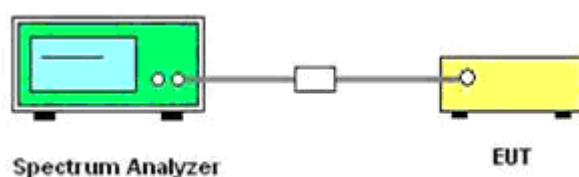


6.8. Emissions in Restricted Bands

6.8.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

6.8.4. Test Procedures

According to KDB 412172 section 1.1 Field Strength Approach (linear terms):

$$\text{eirp} = p_t \times g_t = (E \times d)^2 / 30$$

Where:

p_t = transmitter output power in watts,

g_t = numeric gain of the transmitting antenna (unitless),

E = electric field strength in V/m,

d = measurement distance in meters (m).

$$\text{erp} = \text{eirp} / 1.64 = (E \times d)^2 / (30 \times 1.64)$$

Where all terms are as previously defined.

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Middle Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/T for Peak detector.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.
6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).
7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)



8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
10. Compare the resultant electric field strength level to the applicable regulatory limit.
11. Perform radiated spurious emission test duress until all measured frequencies were complete.

However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.



6.9. Pseudorandom Frequency Hopping Sequence

6.9.1 Standard Applicable

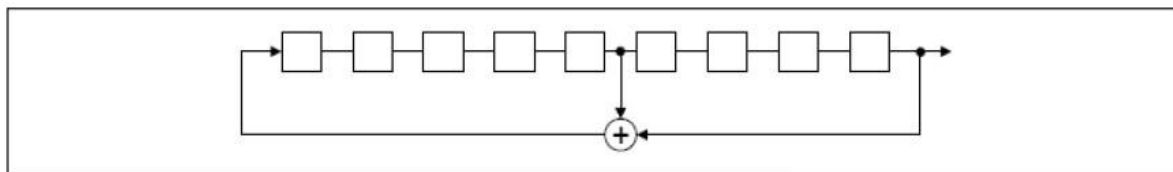
For 47 CFR Part 15C sections 15.247 (a) (1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hop-ping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hop-ping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

6.9.2 EUT Pseudorandom Frequency Hopping Sequence Requirement

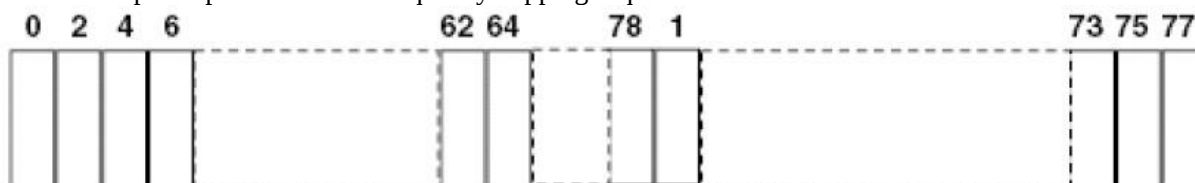
The pseudorandom frequency hopping sequence may be generated in a nine-stage shift register whose 5th first stage. The sequence begins with the first one of 9 consecutive ones, for example: the shift register is initialized with nine ones.

- Number of shift register stages:9
- Length of pseudo-random sequence:29-1=511 bits
- Longest sequence of zeros:8(non-inverted signal)

An example of pseudorandom frequency hopping sequence as follows:



Each frequency used equally one the average by each transmitter.

The system receiver have input bandwidths that match the hopping channel bandwidths of their corresponding transmitter and shift frequencies in synchronization with the transmitted signals.



6.10. Antenna Requirement

6.10.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

6.10.2 Antenna Connected Construction

6.10.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

6.10.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 0dBi(Max), and the antenna is an PCB Antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.
