1 Assessment

4 RF Exposure Limits and FCC Basic Rules

FCC

4.1.1 § 2.1093(c)(1)

Evaluation of compliance with the exposure limits in § 1.1310 of this chapter, and preparation of an EA if the limits are exceeded, is necessary for portable devices having single RF sources with more than an available maximum time-averaged power of 1 mW, more than the ERP listed in Table 1 to § 1.1307(b)(3)(i)(C), or more than the Pth in the following formula, whichever is greater. The following formula shall only be used in conjunction with portable devices not exempt by § 1.1307(b)(3)(i)(C) at distances from 0.5 centimeters to 20 centimeters and frequencies from 0.3 GHz to 6 GHz.

$$P_{th}(\text{mW}) = ERP_{20\text{ cm}}(\text{mW}) = \begin{cases} 2040f & 0.3\text{ GHz} \leq f < 1.5\text{ GHz} \\ 3060 & 1.5\text{ GHz} \leq f \leq 6\text{ GHz} \end{cases}$$

4.1.2 § 2.1093(c)(2)

For multiple mobile or portable RF sources within a device operating in the same time averaging period, routine environmental evaluation is required if the formula in § 1.1307(b)(3)(ii)(B) of this chapter is applied to determine the exemption ratio and the result is greater than 1.

4.1.3 § 1.1307(b)(3)(ii)(B)

in the case of fixed RF sources operating in the same time-averaging period, or of multiple mobile or portable RF sources within a device operating in the same time averaging period, if the sum of the fractional contributions to the applicable thresholds is less than or equal to 1 as indicated in the following equation.

$$\sum_{i=1}^a \frac{P_i}{P_{th,i}} + \sum_{j=1}^b \frac{ERP_j}{ERP_{th,j}} + \sum_{k=1}^c \frac{Evaluated_k}{Exposure\ Limit_k} \leq 1$$

Conclusion:

- The maximum RF emissions from this equipment fulfill the RF exclusion threshold limits for separation distance between the antenna and the human body greater than 20 cm. No RF Exposure evaluation is required.

5.2 RF Exposure Test Exemptions for Simultaneous Transmission Sources

- Theoretically, the worst case of simultaneous transmission operating at the highest output power mode, within the nearest frequency bands.
- The worst case of simultaneous transmission calculation :
 LTE Band 12 + WLAN 802.11b (2.45 GHz)
 $(246.04/1436.16) + (59.98/3060) = 0.191$

Applicable Simultaneous Transmission Sources	Sum of the ratios of the applicable terms	Limit	RF Exclusion No evaluation required
LTE Band 12 + Wi-Fi 2.4GHz	$0.171 + 0.020 = 0.191$	≤ 1	Yes

Conclusion:

- The sum of the fractional contributions to the applicable thresholds is less than or equal to 1, hence the multiple RF sources are exempt
