



Due to the tiny dimensions of product label (rectangle of 24 (L) x 6,5 (H) mm), and lack of space, FCC ID is indicated as an “**e-label**” within the smartphone app.

e-labeling eligibility (47 CFR § 2.935 compliance):

- * a) Product is a radiofrequency device without an integrated screen that can only operate in conjunction with a smartphone.
- * b) FCC ID is readily accessible at each usage (printed on login screen on the free app). App installation is described in user manual.
- * c) FCC ID is accessible without access codes, and with less than 3 steps (login screen on the free app).
- * d) FCC ID text size is large even on small screens
- * e) Information is hard coded, so it cannot be changed
- * f) FCC ID is also printed in user manual and packaging
