The sample was placed 0.8m & 1.5m for the measurement below & above 1GHz above the ground plane of 3m chamber. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case( Z axis) are shown in Test Results of the following pages.

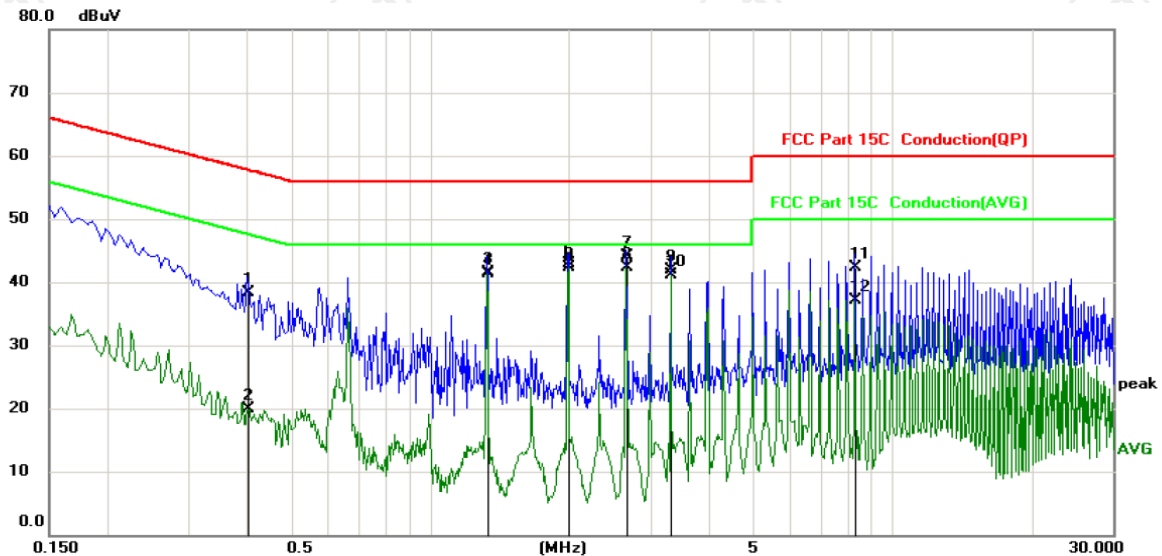

- For the radiated emission test below 1GHz:  
The EUT was placed on a turntable with 0.8 meter above ground. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
