## **5 Technical Requirements Specification in FCC CFR Title 47 Part 2.1093**

### **5.1 Limits**

According to 447498 D01 General RF Exposure Guidance v06 Mobile and Portable Devices RF Exposure Procedures and Equipment Authorization Policies.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$$
 for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

### **5.2 Result**

Worse case for BLE as below:

[2402MHz: -0.434dBm (0.905 mW) output power]  
(0.905 mW /5mm)  $\cdot [\sqrt{2.402(\text{GHz})}] = 0.279 < 7.5$  for 10-g SAR

Worse case for BT as below:

[2402MHz: 2.507dBm (1.78 mW) output power]  
(1.78 mW /5mm)  $\cdot [\sqrt{2.441(\text{GHz})}] = 0.55 < 7.5$  for 10-g SAR

### **5.3 Conclusion**

The device is exempt from the SAR test and satisfies RF exposure evaluation.
