## 2.2 MPE Calculation Formula

 $Pd = (Pout*G) / (4*pi*r^2)$ 

Where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

## 2.3 Classification

The antenna of this product, under normal use condition, is at least 20cm away from the body of the user. So, this device is classified as Mobile Device.

#### 2.4 Antenna Gain

The antenna type is Chip antenna with 3.46 dBi gain.
