Standalone SAR test exclusion considerations: | <p>During normal operation, user extremities can come within 20 cm of the internal antenna and therefore product is considered as "Portable".</p> <p>The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at Test separation distances <math>\leq 50</math> mm are determined by:</p> $[(\text{max. power of channel, including tune-up tolerance, mW}) \div (\text{min. test separation distance, mm})] \times [\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$ <p>f(GHz) is the RF channel transmit frequency in GHz<br/> Power and distance are rounded to the nearest mW and mm before calculation<br/> The result is rounded to one decimal place for comparison</p> <p>The test exclusions are applicable only when the minimum test separation distance is <math>\leq 50</math> mm and for transmission frequencies between 100 MHz and 6 GHz.
