2. PORTABLE DEVICE EVALUATION METHOD AND LIMIT

According to §15.247(i) and §1.1307b(1), systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines. See KDB 447498 D01 General RF Exposure Guidance v05, section 4.3.1.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, 16 where

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation 17
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

3. MOBILE DEVICE EVALUATION METHOD AND LIMIT

Human exposure to RF emissions from mobile devices (47 CFR §2.1091) may be evaluated based on the MPE limits adopted by the FCC for electric and magnetic field strength and/or power density, as appropriate, since exposures are assumed to occur at distances of 20 cm or more from persons.

S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator R=distance to the center of radiation of the antenna

Note 1: Calculation Value =[(max. power of channel, mW)/(min. test separation distance, mm)] $\cdot [\sqrt{f(\text{GHz})}]$.

For example: $0.1413/5 \cdot \sqrt{2.402} = 0.0438 \leq 3.0$

Note 2: Max Power (dBm)=Field Strength of Fundamental (dB μ V/m@3m)-95.23

Note 3: Max Power (mW)= $10^{(\text{Max power (dBm)}/10)}$

According to KDB447498 D01 V06, threshold at which no SAR required is ≤ 3.0 for 1-g SAR, separation distance is 5mm, and no simultaneous SAR measurement is required.

5. CONCLUSION

Since Source-base time average power is below SAR test exclusion power thresholds, the SAR evaluation is not required.
