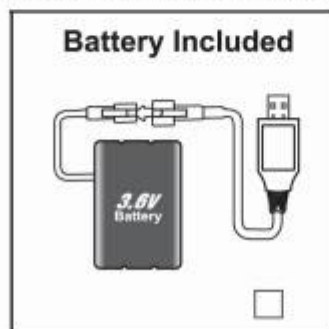

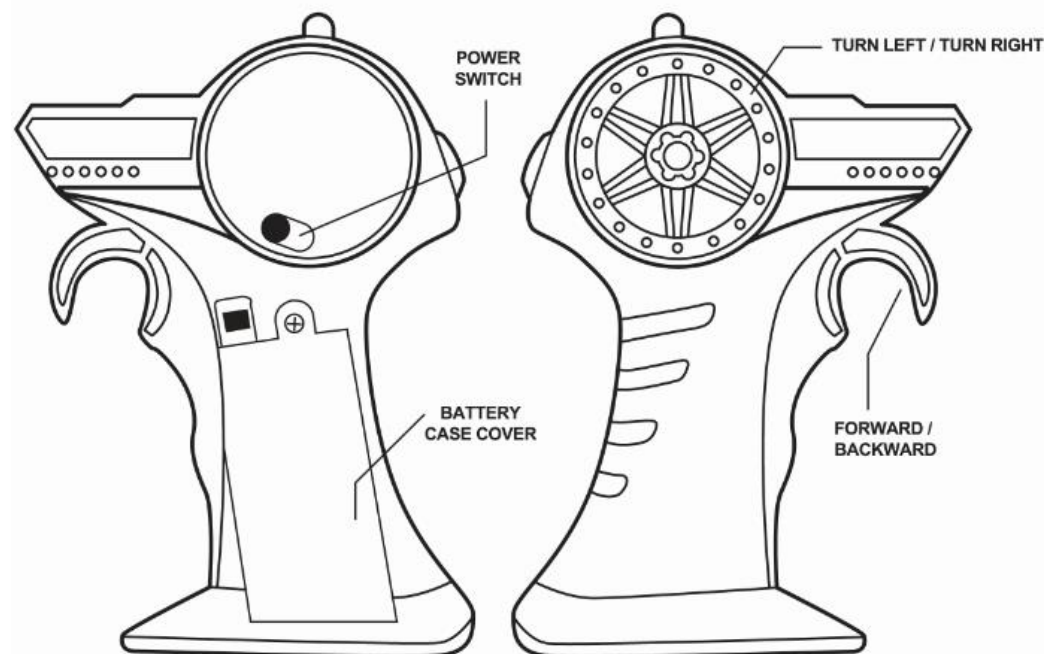
- Non-rechargeable batteries are not to be recharged.
