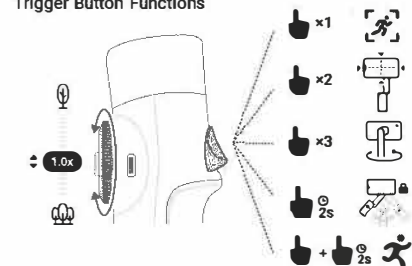

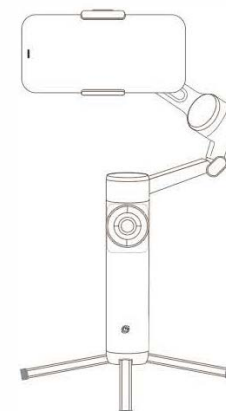

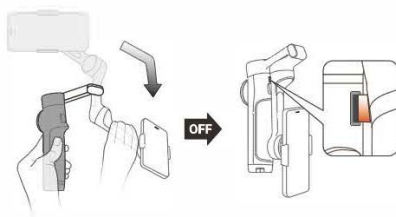

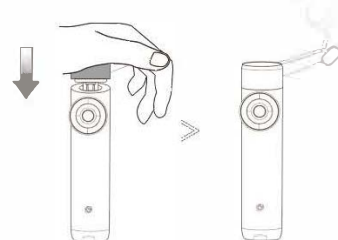

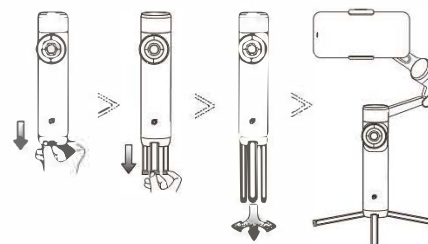

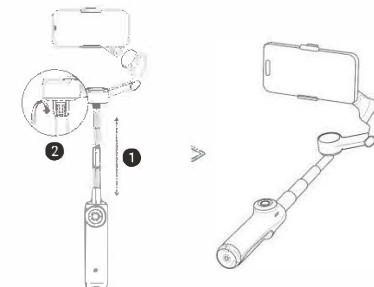

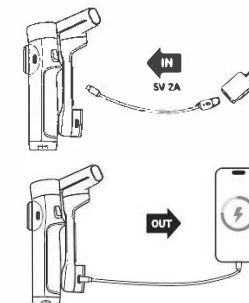

Warning

- The Magnetic Phone Clamp attaches to Flow 2 **pro** through magnets. Do not move it too fast or make any sudden movements.
- Deploy and use the tripod on flat ground without excessive wind, otherwise there is a risk of the gimbal tipping over.
- After use, please collapse the extension rod and store the product safely.
