Due to the differences between Motherboard 1 and Motherboard 2, both of these boards were tested in this experiment. Among them, the data of Motherboard 1 was the worst, so the report only presented all the test data of Motherboard 1 and the interference emission test data of Motherboard 2. (The battery used for the installation of Motherboard 1 this time was 2000mAh).

3.3 DESCRIPTION OF TEST MODES

The EUT has been tested under its typical operating condition.

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Those data rates (1Mbps for Bluetooth V5.2 GFSK modulation) were used for all test.

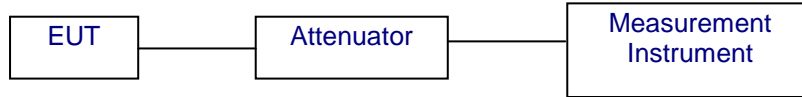

6 SETUP OF EQUIPMENT UNDER TEST

6.1 RADIO FREQUENCY TEST SETUP 1

The Bluetooth V5.2 component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



6.2 RADIO FREQUENCY TEST SETUP 2

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m. The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 32.

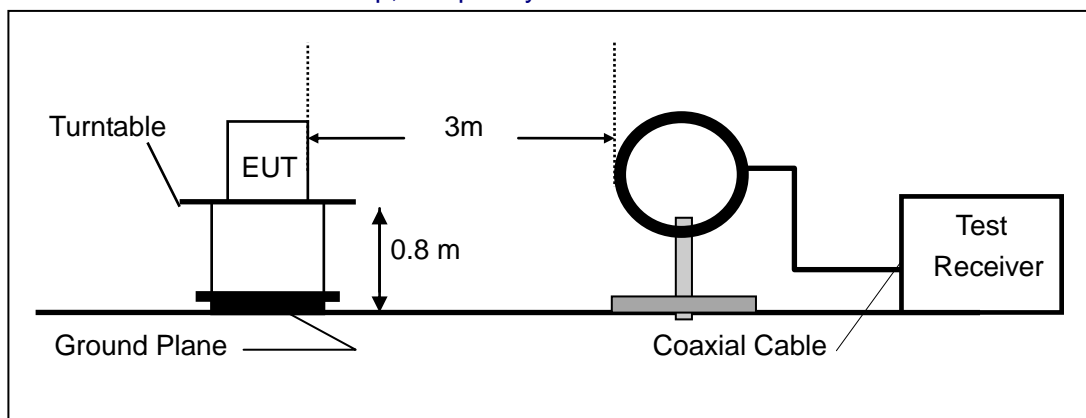

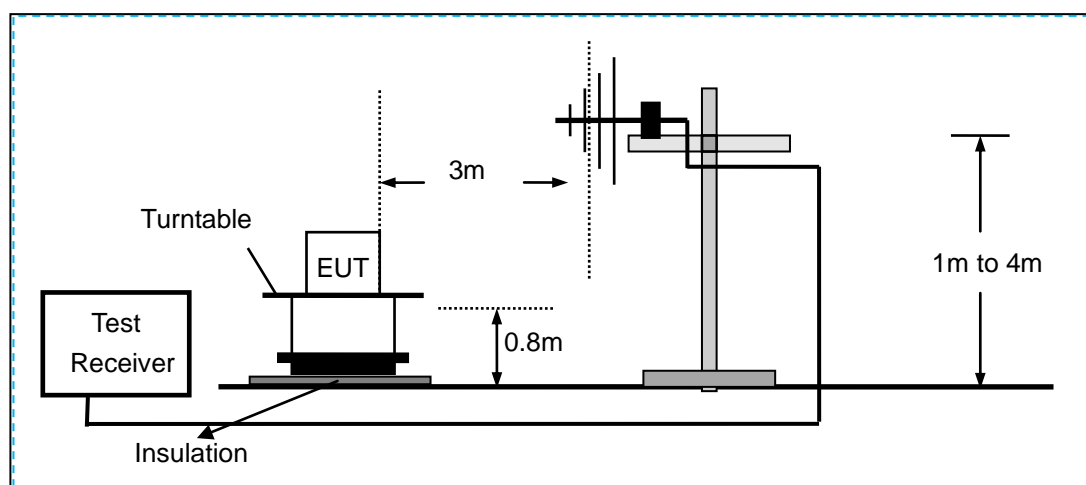

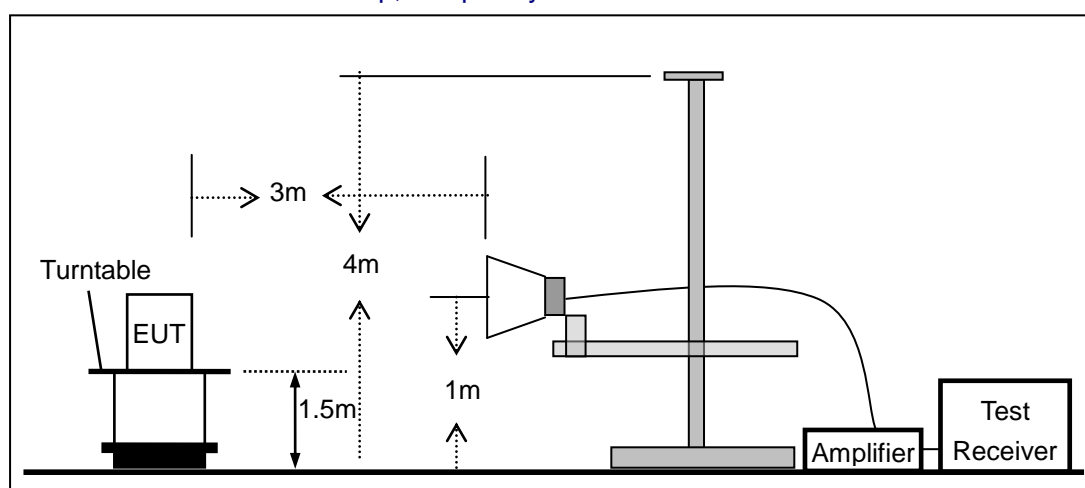
(a) Radiated Emission Test Set-Up, Frequency Below 30MHz

(c) Radiated Emission Test Set-Up, Frequency above 1000MHz

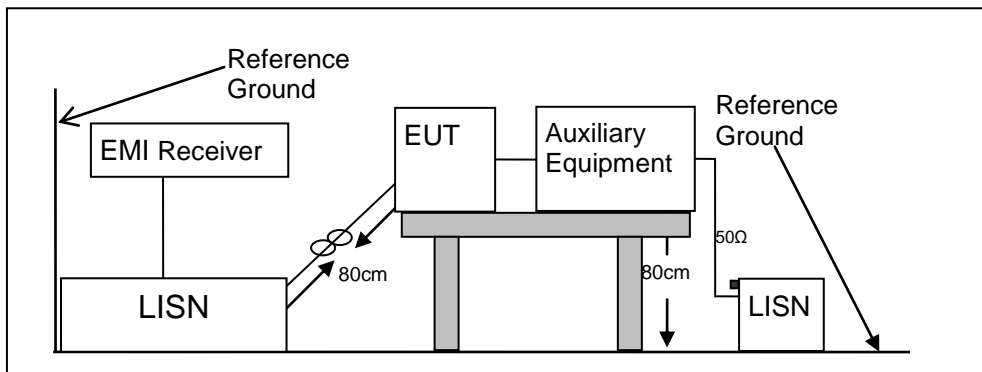


6.3 CONDUCTED EMISSION TEST SETUP

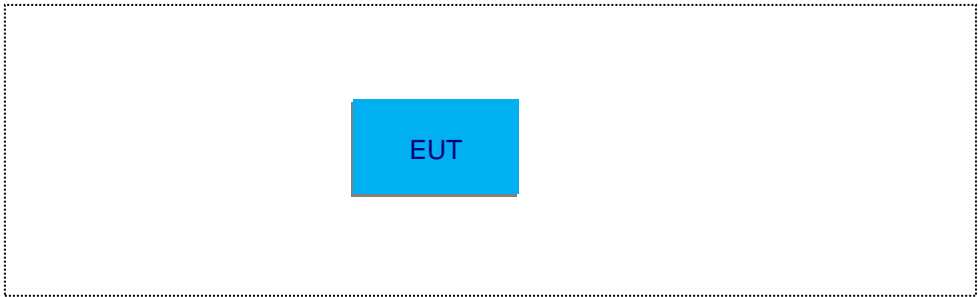
The mains cable of the EUT (Perfect Share Mini) must be connected to LISN. The LISN shall be placed 0.8m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.

Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.8m.

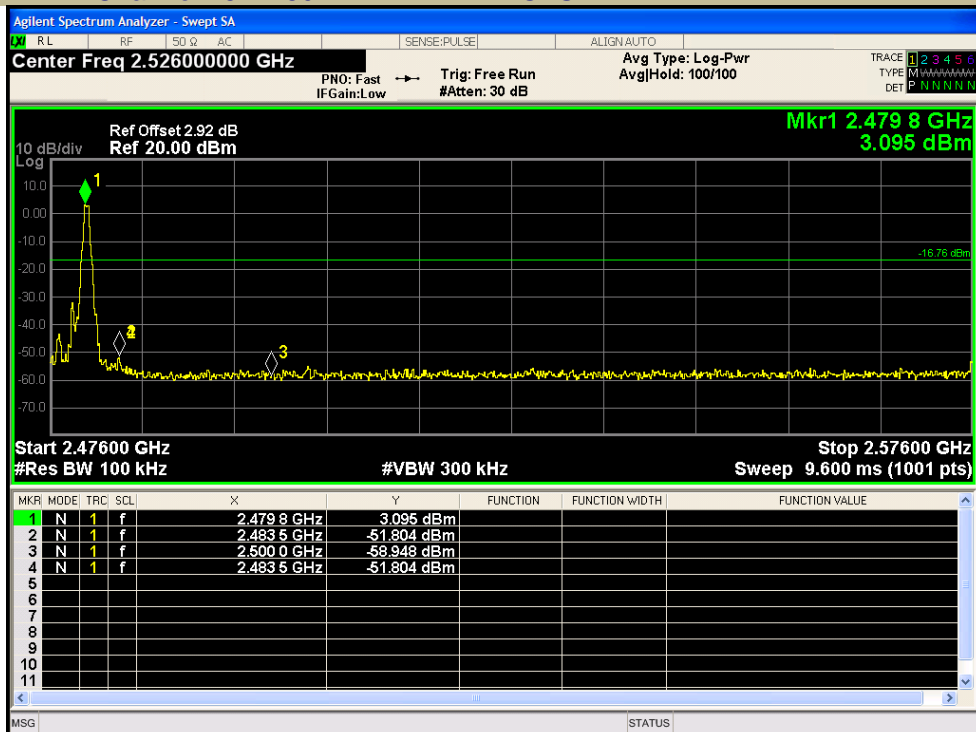
