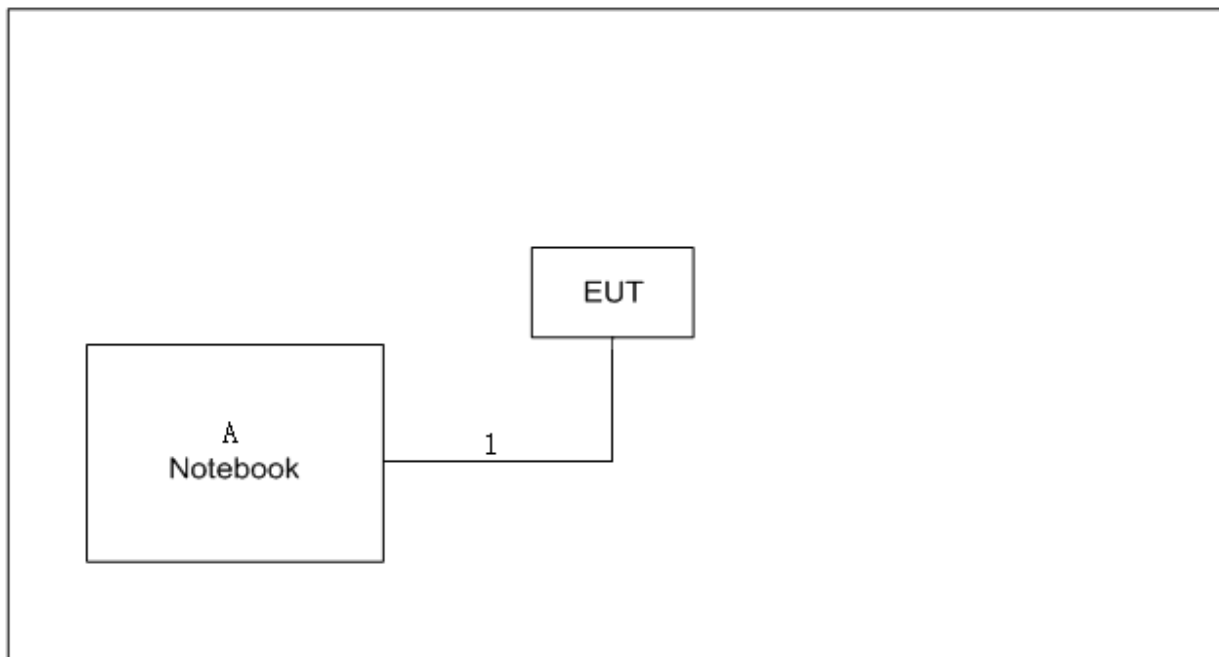

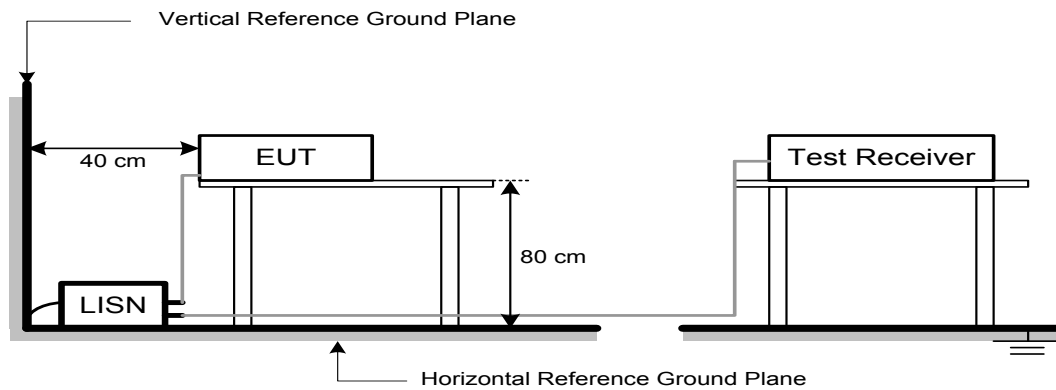
#### 3.2 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipment powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item –EUT Test Photos.

## **4.2 TEST PROCEDURE**

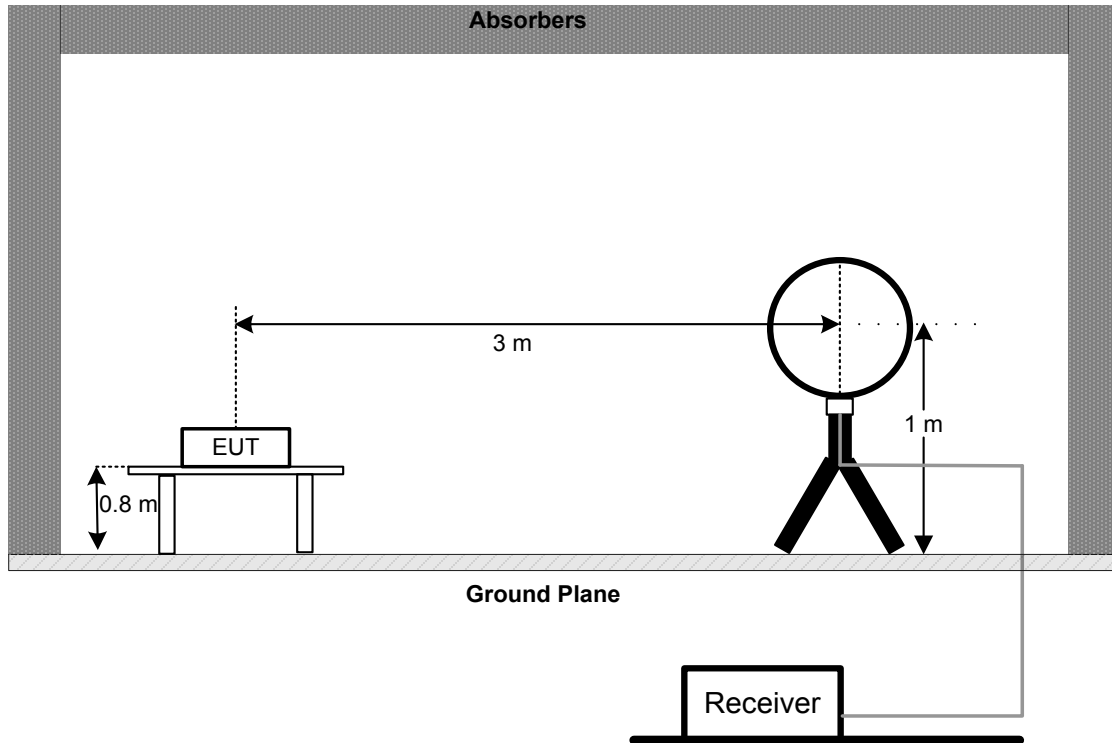
- a. The measuring distance of 3 m shall be used for measurements. The EUT was placed on the top of a rotating table 0.8 meter above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(below 1 GHz)
- b. The measuring distance of 3 m shall be used for measurements. The EUT was placed on the top of a rotating table 1.5 meter above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(above 1 GHz)
- c. The height of the equipment or of the substitution antenna shall be 0.8m or 1.5m; the height of the test antenna shall vary between 1 m to 4 m. Both horizontal and vertical polarizations of the antenna are set to make the measurement.

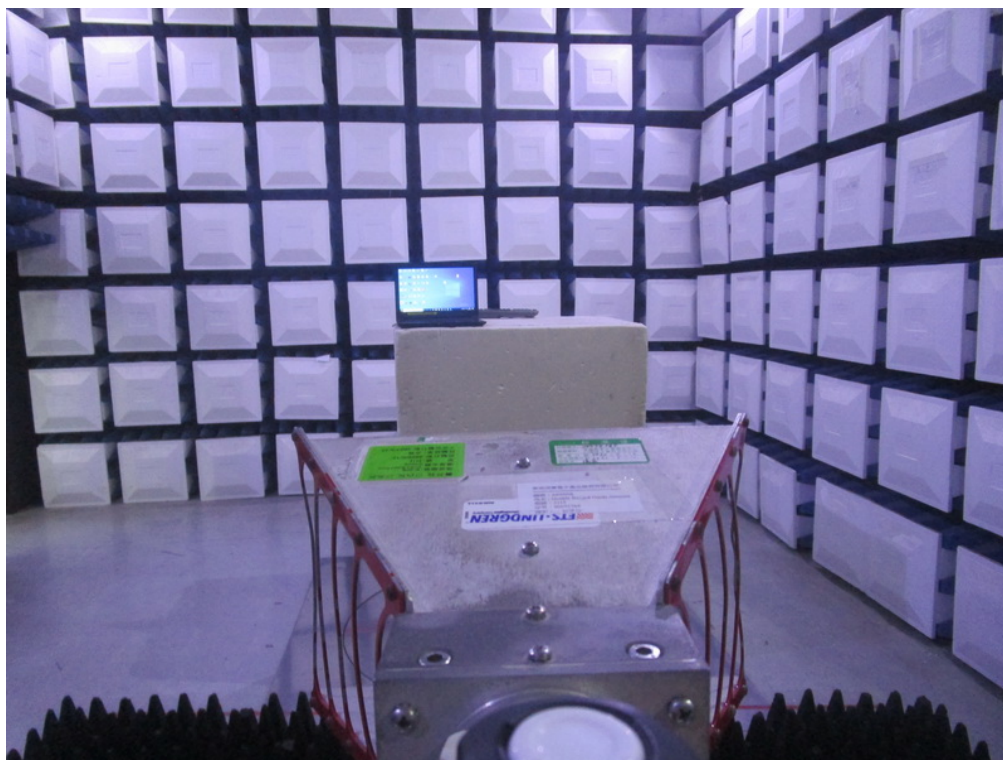

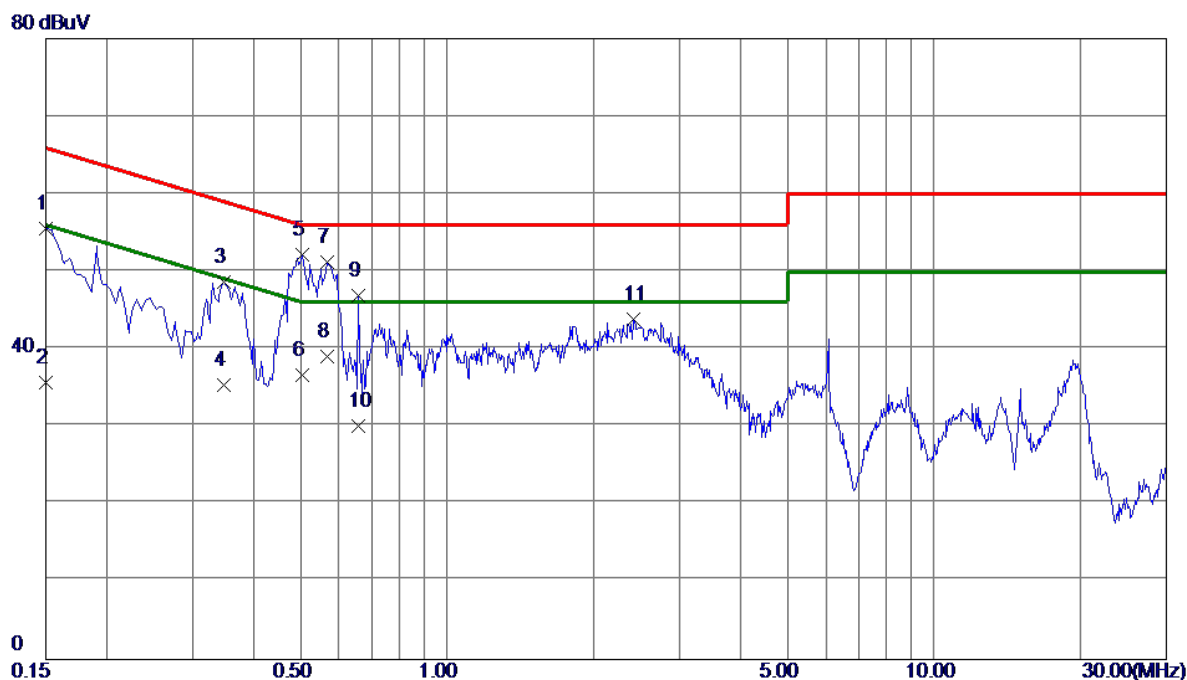

## Bandedge CH00 (Lower)



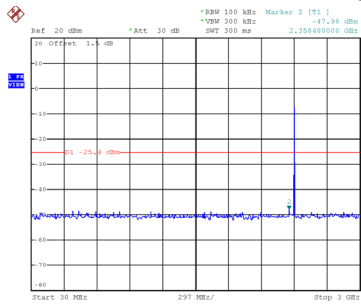

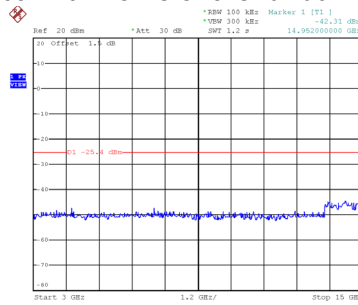

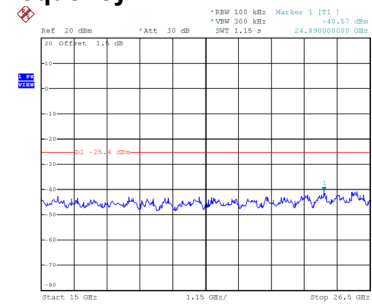
## CH00 – 10th Harmonic of the fundamental frequency

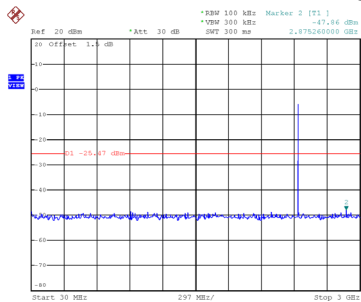

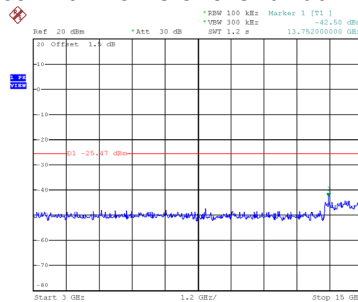

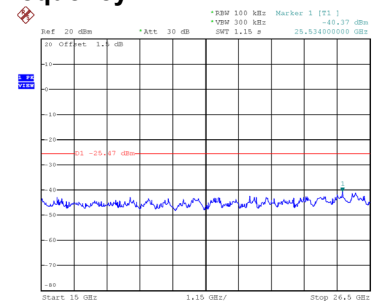
## CH38 – 10th Harmonic of the fundamental frequency

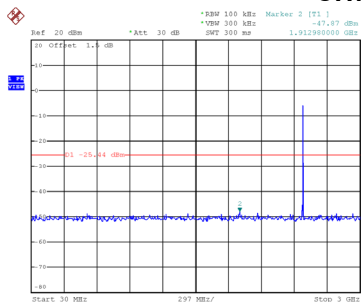

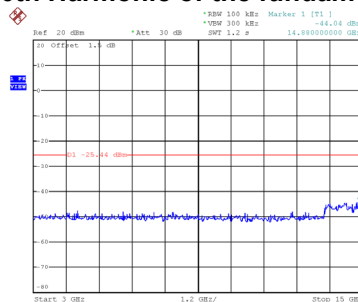

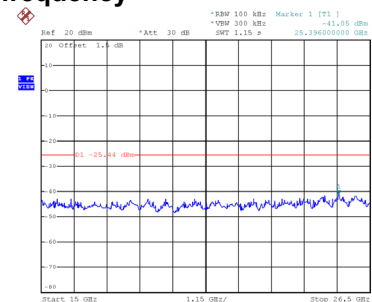
## CH78 – 10th Harmonic of the fundamental frequency

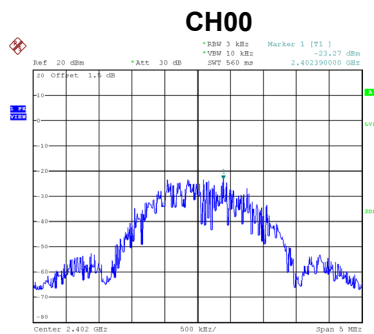

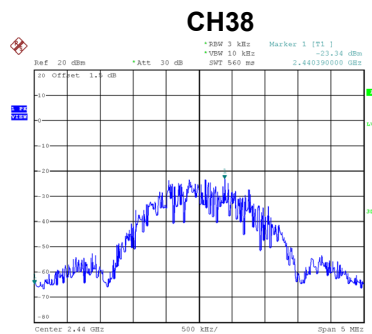

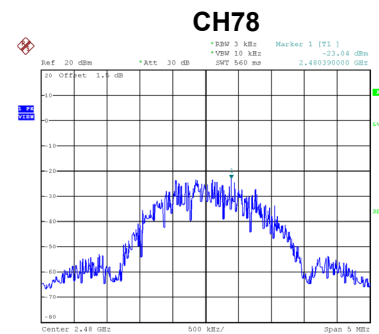
