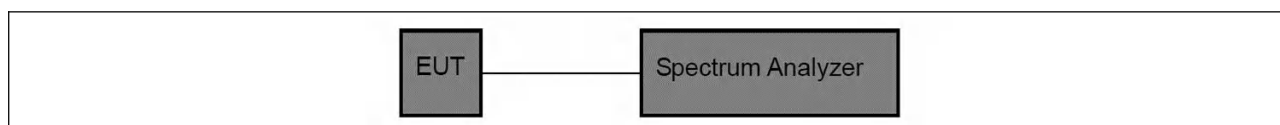
5. Channel Separation

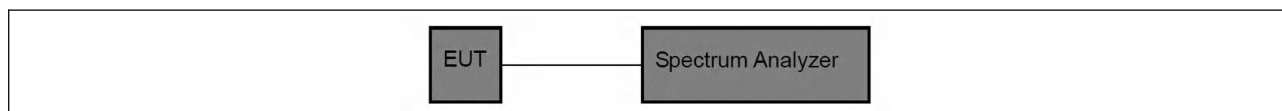
6. Number of Hopping Frequencies
