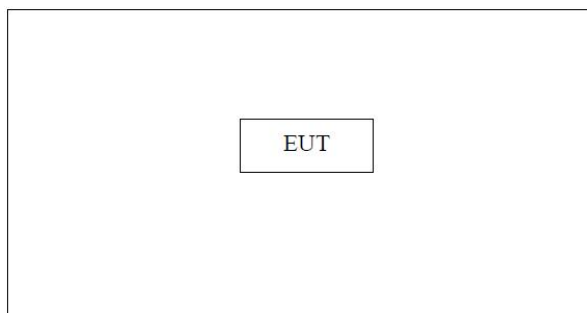

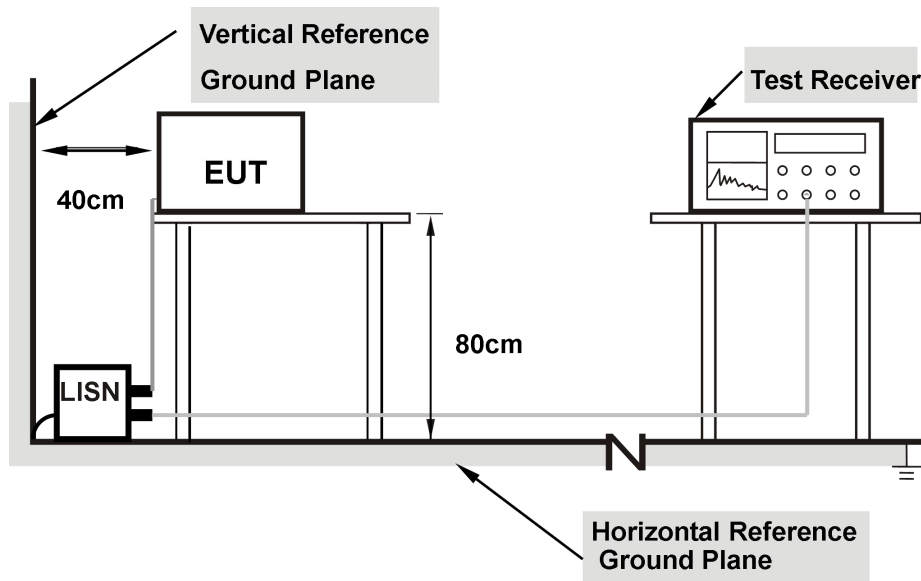

- a. The EUT was 0.8 meters from the horizontal ground plane and 0.4 meters from the vertical ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.

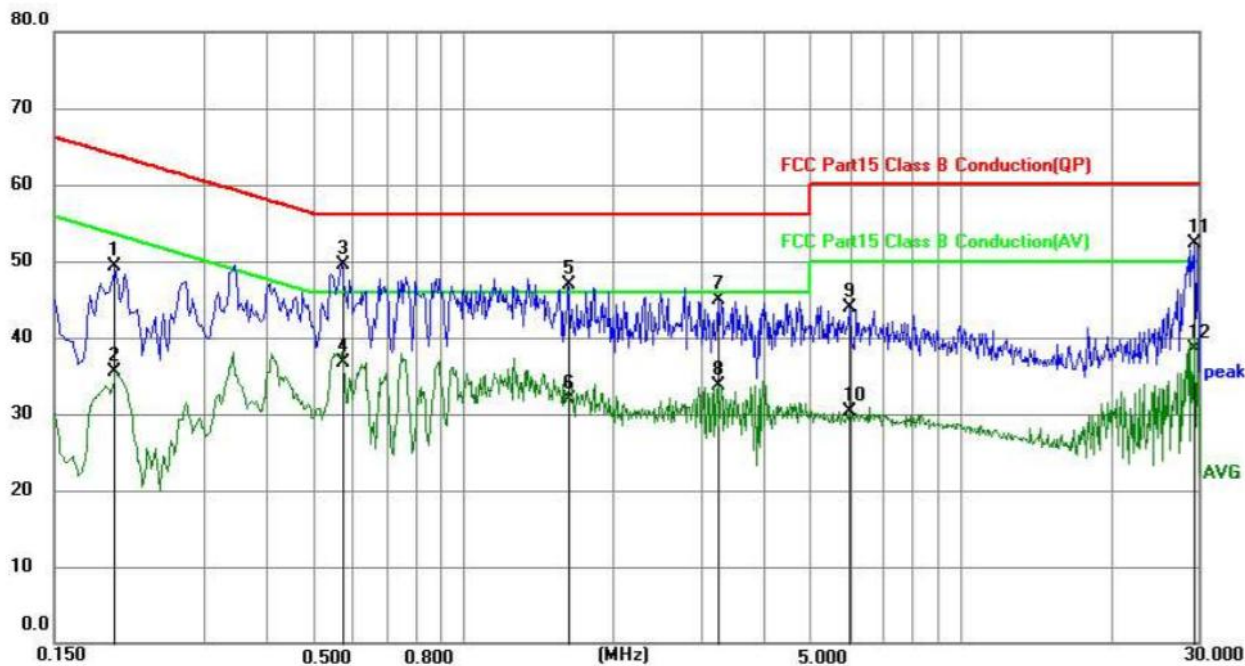

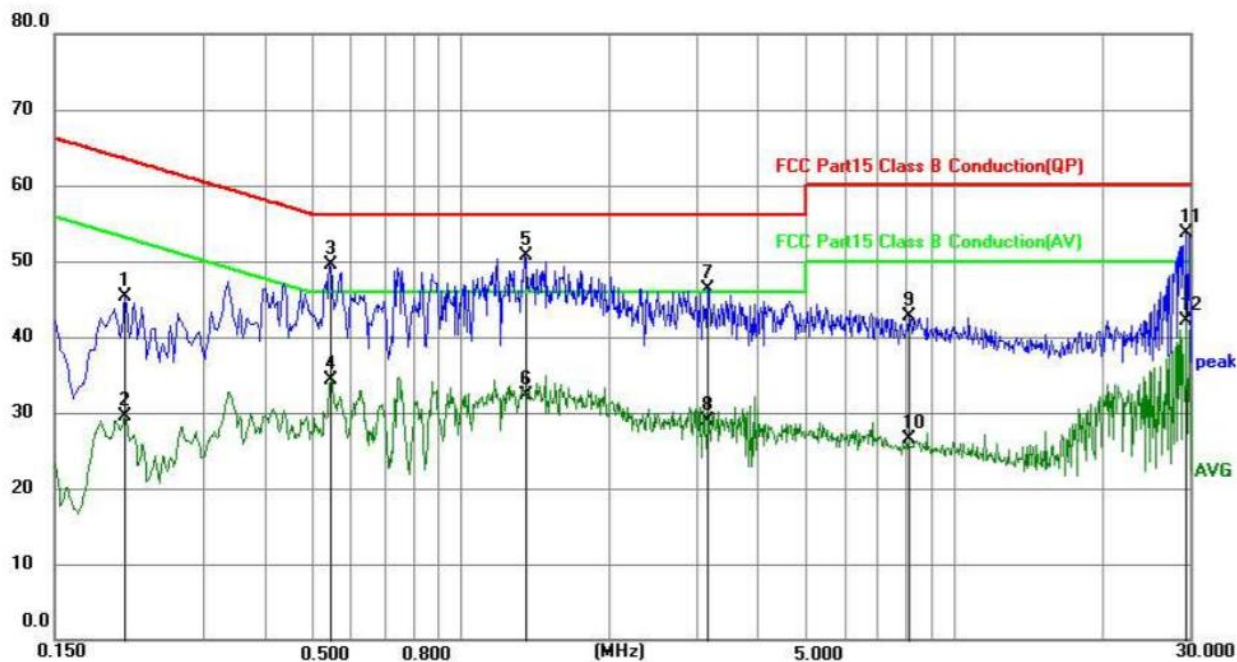

According to FCC section 15.225, for <30 MHz, Radiated emissions were measured according to ANSI C63.4. The EUT was set to transmit at the highest output power. The EUT was set 10 meter away from the measuring antenna. The loop antenna was positioned 1 meter above the ground from the center of the loop. The measuring bandwidth was set to 10 KHz. (Note: During testing the receive antenna was rotated about its axis to maximize the emission from the EUT) There was no detected Restricted bands and Radiated suprious emission below 30MHz. The 30m limit was converted to 3m Limit using square factor(x) as it was found by measurements as follows; 3 m Limit(dBuV/m) =20log(X)+40log(30/3)=20log(15848)+40log(30/3) = 124dBuV

#### 4.2 TEST PROCEDURE

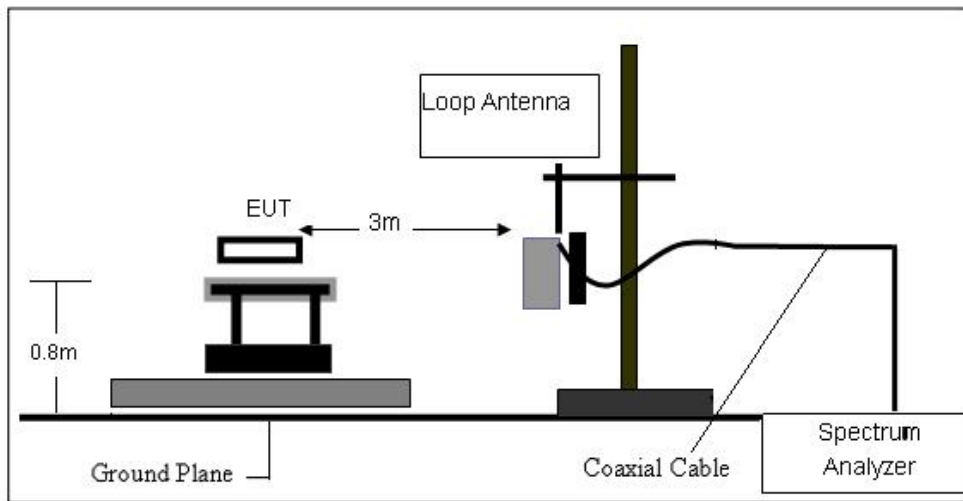
- a. The measuring distance of at 3 m shall be used for measurements at frequency 0.009MHz up to 1GHz,and above 1GHz.
- b. The EUT was placed on the top of a rotating table 0.8 meters (above 1GHz is 1.5 m) above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- c. The height of the equipment shall be 0.8 m(above 1GHz is 1.5 m); the height of the test antenna shall vary between 1 m to 4 m. horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then QuasiPeak detector mode re-measured.
- e. If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed.
- f. For the actual test configuration, please refer to the related Item –EUT TestPhotos.

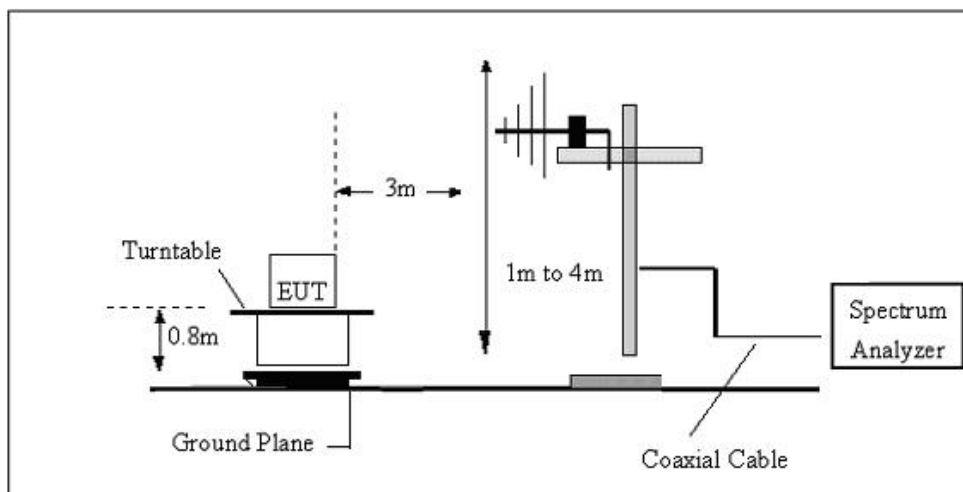

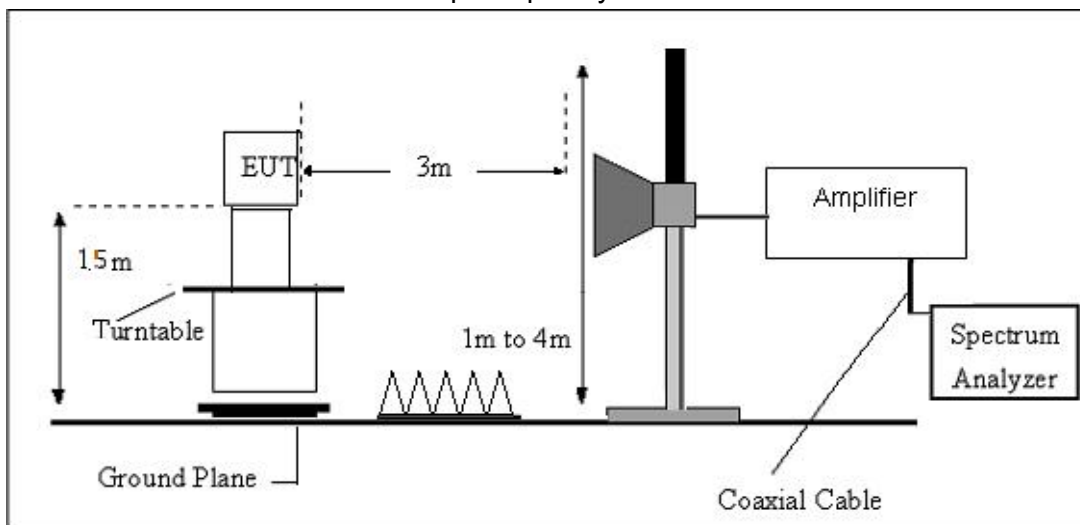
#### (A) Radiated Emission Test-Up Frequency Below 30MHz



#### (B) Radiated Emission Test-Up Frequency 30MHz~1GHz



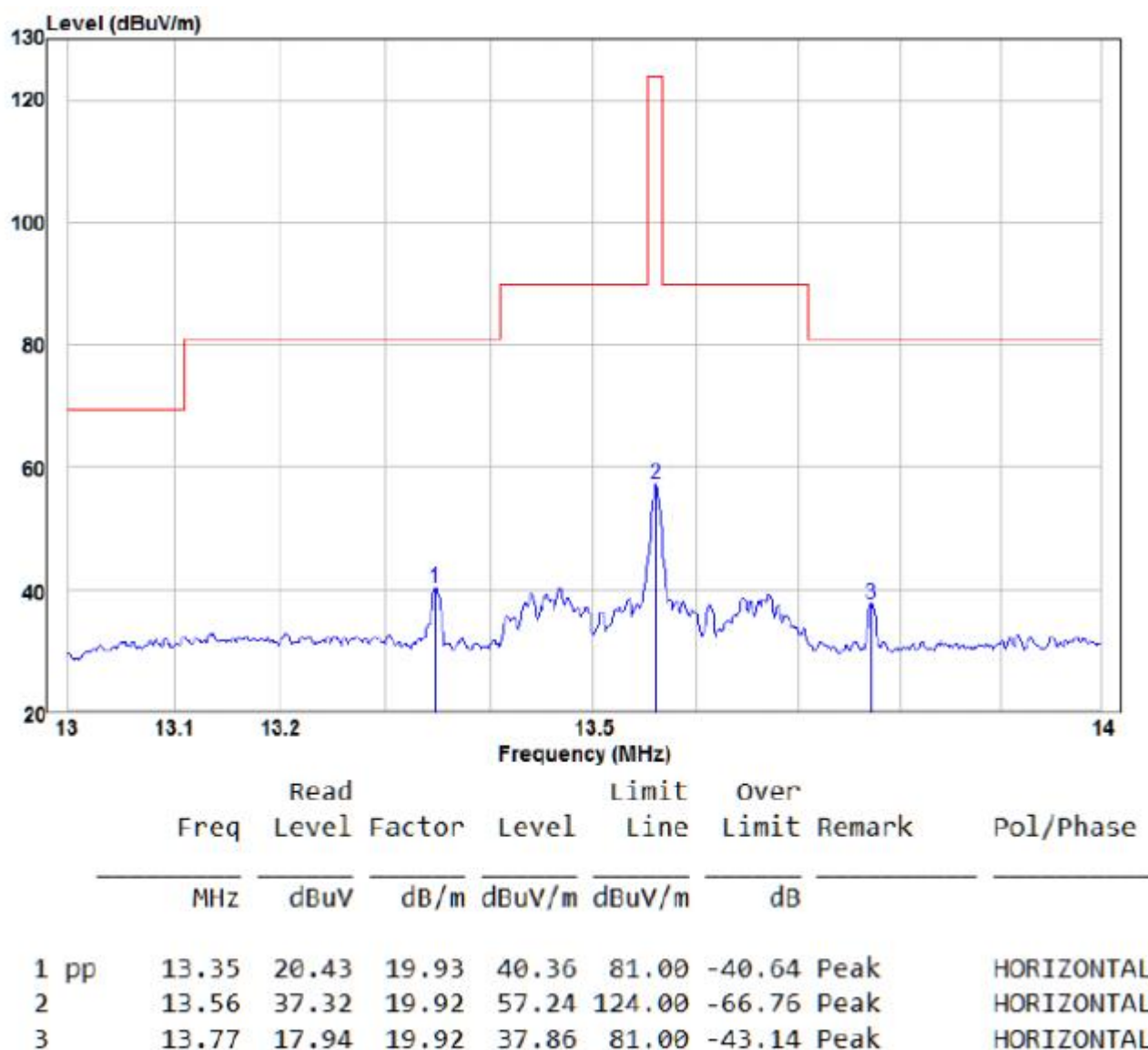
#### (C) Radiated Emission Test-Up Frequency Above 1GHz

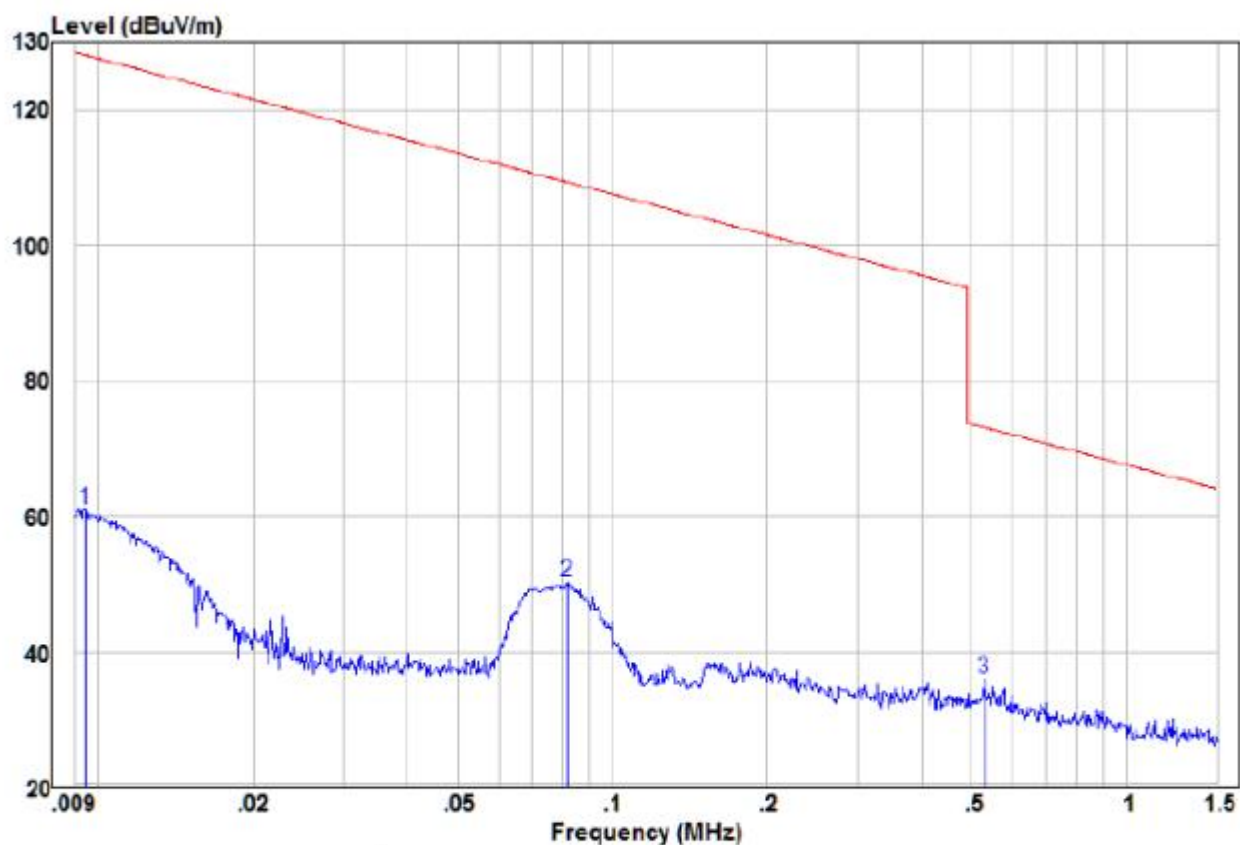

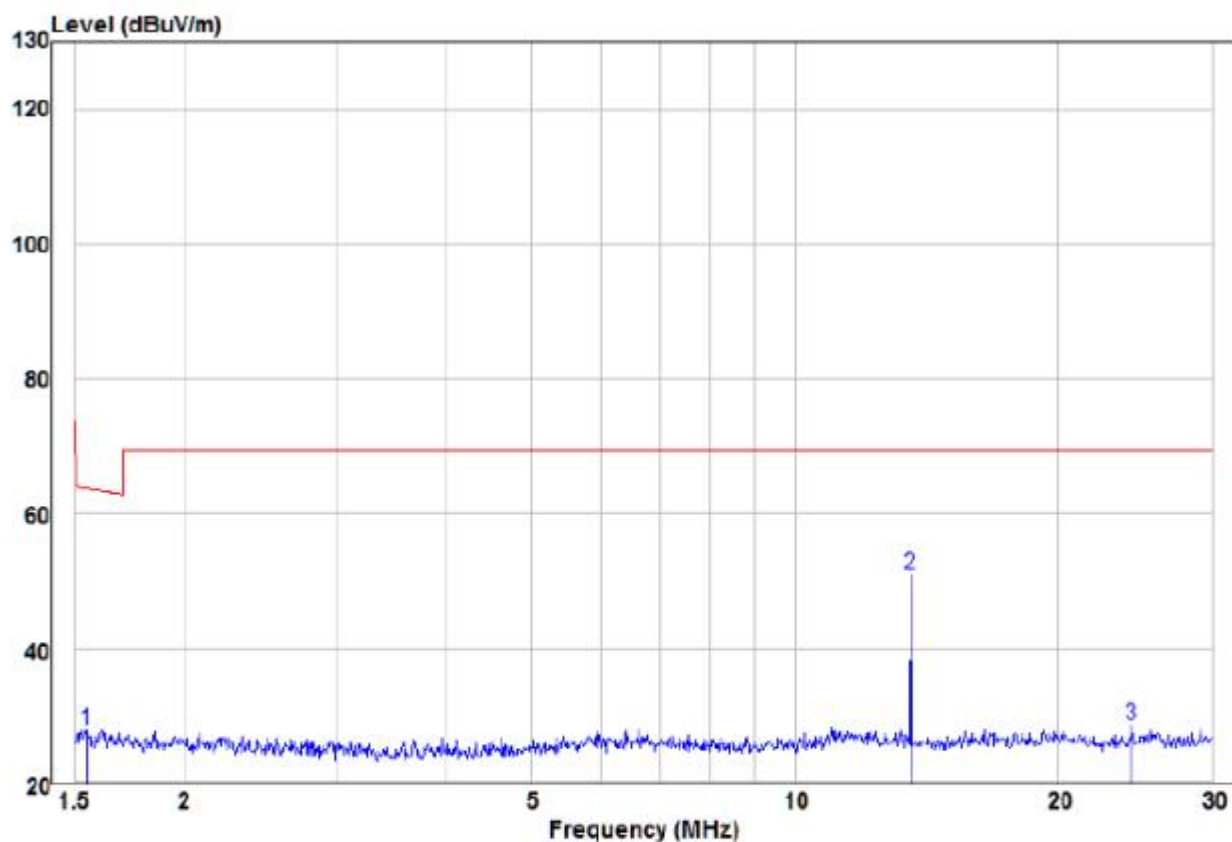

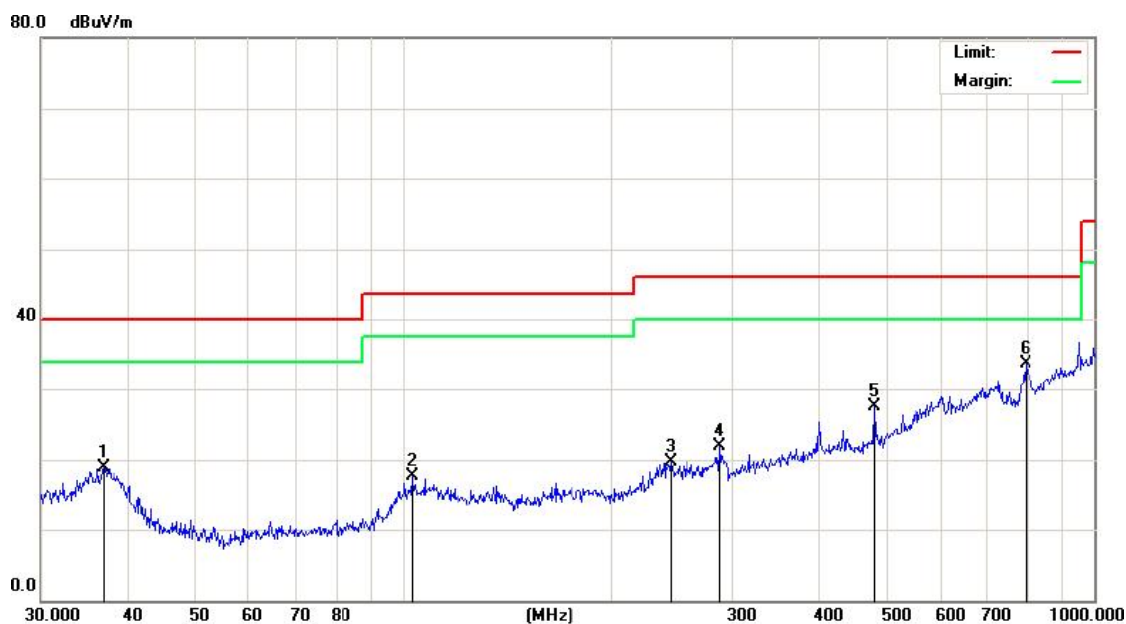

## 5.20 DB BANDWIDTH TEST

### 5.1 TEST PROCEDURE

FCC §2.1049&15.215(C)

Emissions from the intentional radiator shall be confined within a band 200 kHz wide centered on the operating frequency.

The 20dB bandwidth is measured with a spectrum analyzer connected via a receiver antenna placed near the EUT

while the EUT is operating in transmission mode.

Use the following spectrum analyzer settings:

Span = approximately 2 to 3 times the 20 dB bandwidth

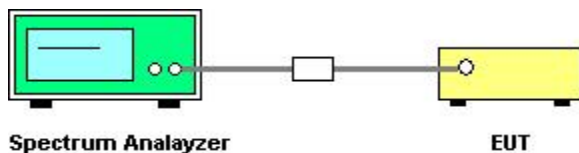

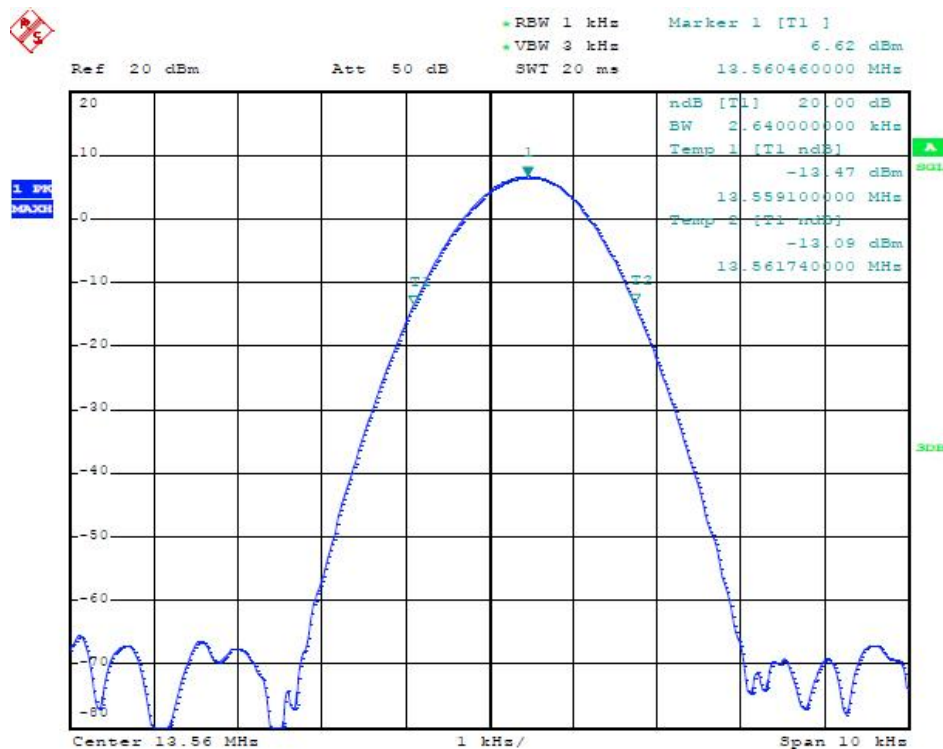

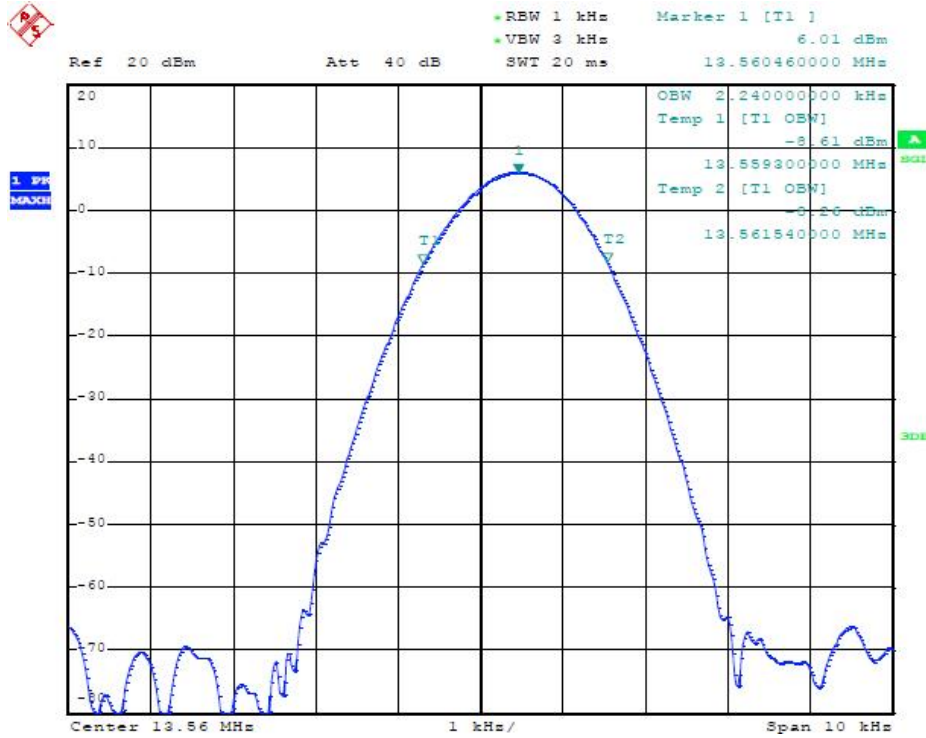

## 6 FREQUENCY STABILITY MEASUREMENT

### 6.1 LIMIT

The frequency tolerance of the carrier signal shall be maintained within  $\pm 0.01\%$  (100ppm) of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery

### 6.2 TEST PROCEDURE

1. The transmitter output (antenna port) was connected to the spectrum analyzer.
2. EUT have transmitted signal and fixed channelize.
3. Set the spectrum analyzer span to view the entire emissions bandwidth.
4. Set RBW = 1 kHz, VBW = 3 kHz with peak detector and maxhold settings.
5. The  $f_c$  is declaring of channel frequency. Then the frequency error formula is  $(f_c - f)/f_c \times 10^6$  ppm and the limit is less than  $\pm 100$ ppm.
6. Extreme temperature rule is -20°C~50°C.
