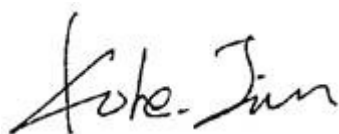

5.1 RF Exposure

5.1.1 Test Requirement:

CFR 47 Part 2.1093

Limit:

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$$\left[\frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \cdot \sqrt{f(\text{GHz})} \right] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

$f(\text{GHz})$ is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation¹⁷

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

5.1.2 Conclusion

The Mas Conducted Peak Output power is -1.48 dBm on the lowest channel 2.440GHz

-1.48 dBm logarithmic terms convert to numeric result is nearly 0.71 mW

According to the formula. calculate the test exclusion thresholds:

$$\left[\frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})}$$

General RF Exposure = $(0.71 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.44 \text{ GHz}} = 0.22$ (1)

SAR requirement:

$S = 3.0$ (2)

$(1) < (2)$

So the SAR report is not required.
