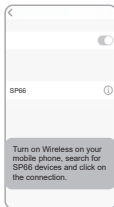
Read the manual before use

Important: Plug in the charging wire for charging at the first time after receiving the goods, and use it after fully charging, which can make the Wireless earphone last longer

Important: Do not use super fast charging with current above 2A to avoid damaging the circuit chip due to excessive current



TWS connection, remove the earpiece from the charging bin automatically turn on and automatically pair.
(The red and blue lights flash alternately when the TWS is turned on. When the TWS is successfully paired, the red and blue lights of one earphone flash alternately, and the lights of the other earphone go out. After the phone is connected, the lights of the earphone go out.)



Turn on Wireless on your mobile phone, search for SP66 devices and click on the connection.



Press and hold for about 5 seconds to turn on/off.



the earphone touch control is marked in red circle

If only one earphone has sound, please delete the connected "SP66" first, turn off the wireless function of the phone, the earphone needs to be paired once, enter the tws mode, and then return to the first step

The connection steps are as follows:

TWS connection, remove the earpiece from the charging bin automatically turn on and automatically pair.
(The red and blue lights flash alternately when the TWS is turned on. When the TWS is successfully paired, the red and blue lights of one earphone flash alternately, and the lights of the other earphone go out. After the phone is connected, the lights of the earphone go out.)

Touch function

1. Short press play, pause, answer, hang up.
2. Press and hold to reject the call.
3. Double click left/right earphone: Previous song/next song.
4. Three clicks left/right headphones: Volume +/ Volume -.
5. Hold and hold for 1.5 seconds to activate Siri. Tap to exit.

The power delivered by the charger must be between min 2.5 Watts required by the radio equipment, and max 10 Watts in order to achieve the maximum charging speed.
