

## 2. Antenna requirement

Test Requirement:

The antenna is a Ceramic antenna which permanently attached, and the best case gain of the antenna is 4.08dBi. It complies with the standard requirement.



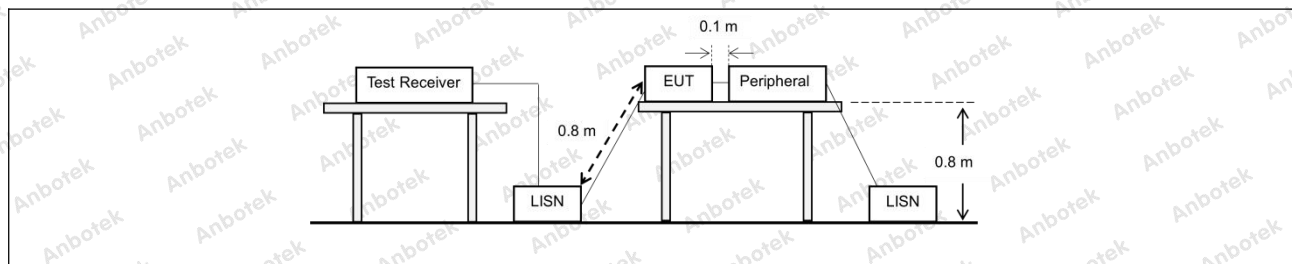
