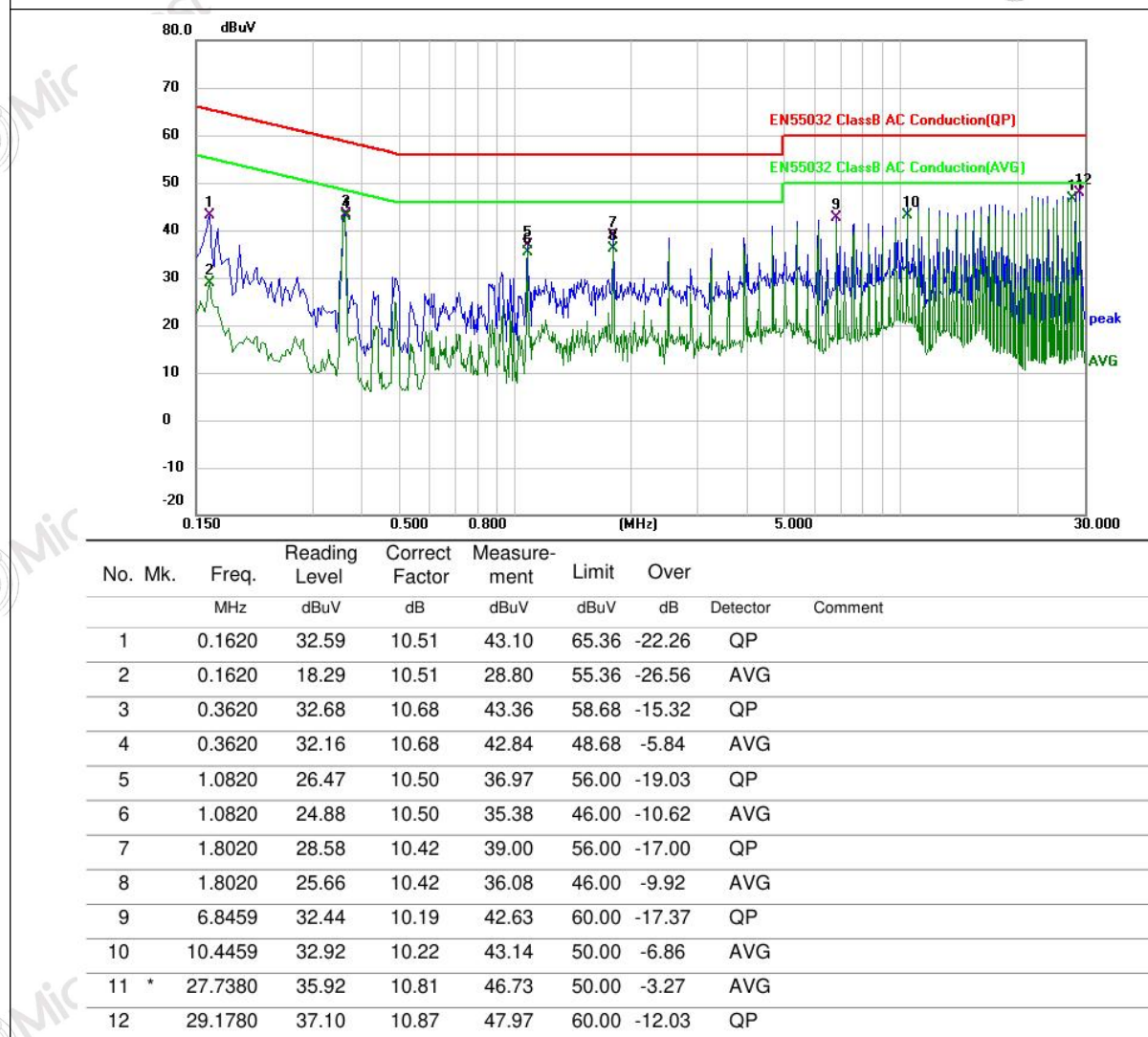

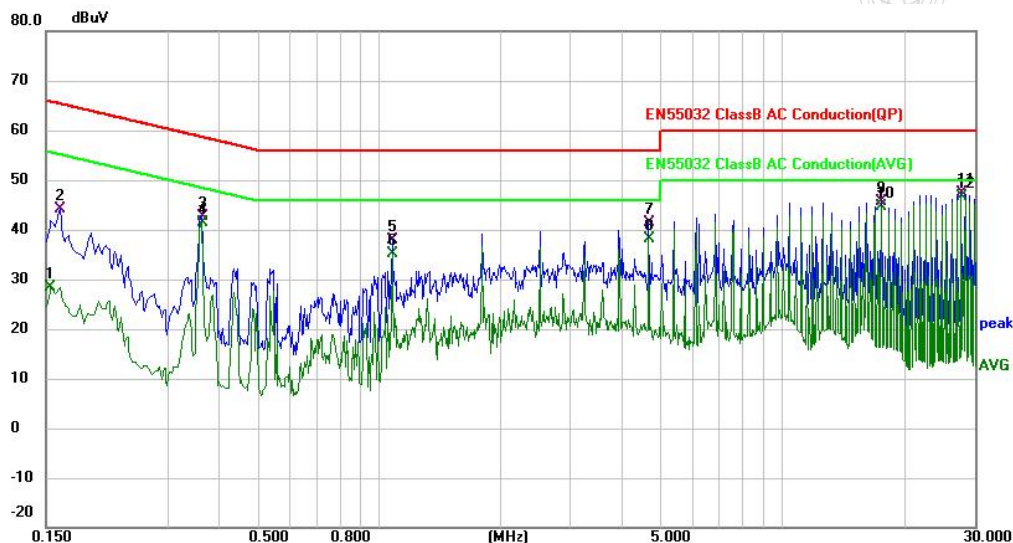

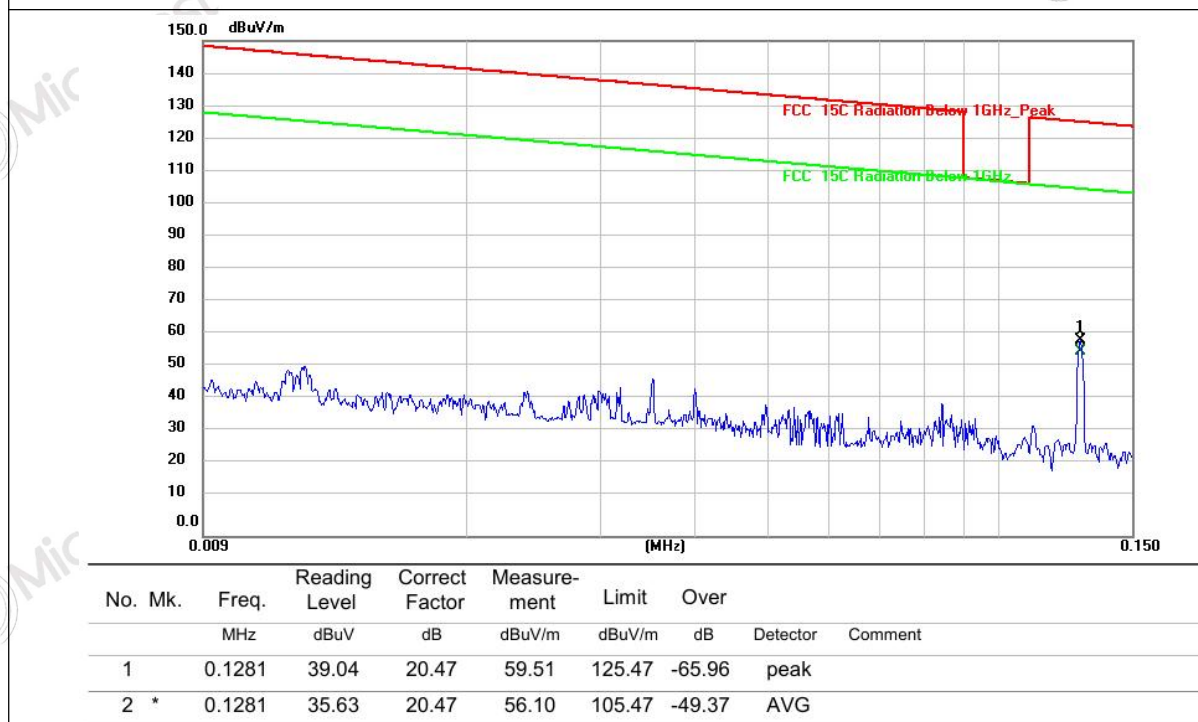

Mode3 / EUT direction: X axis

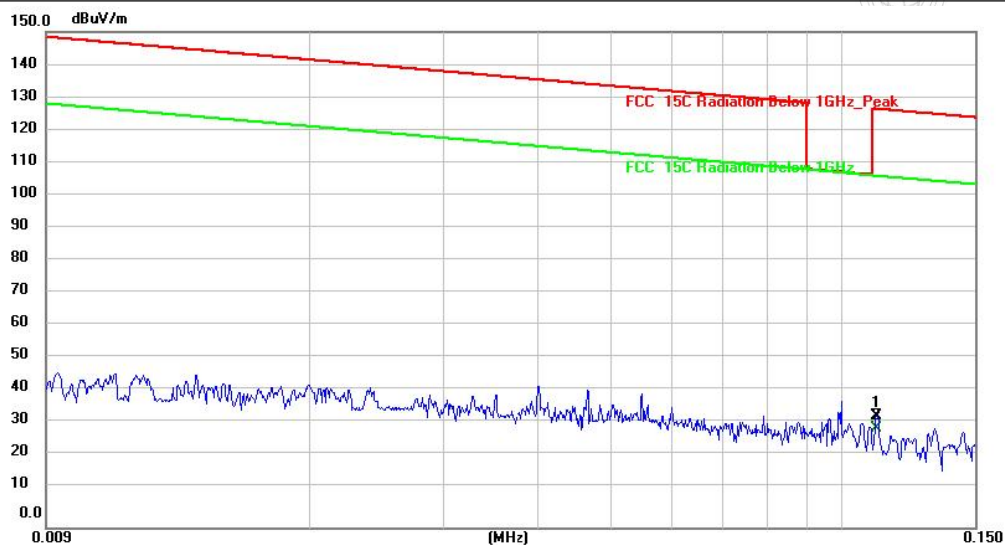

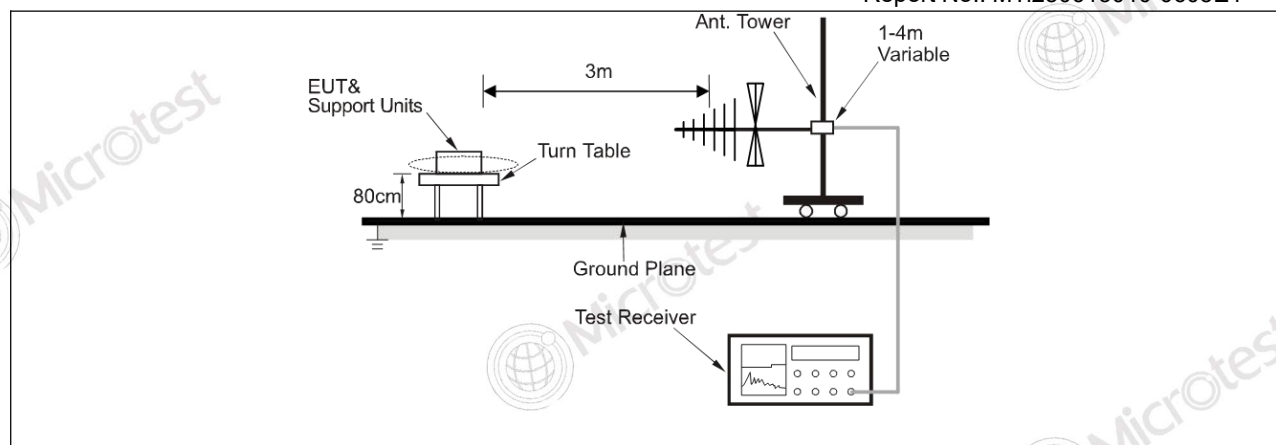

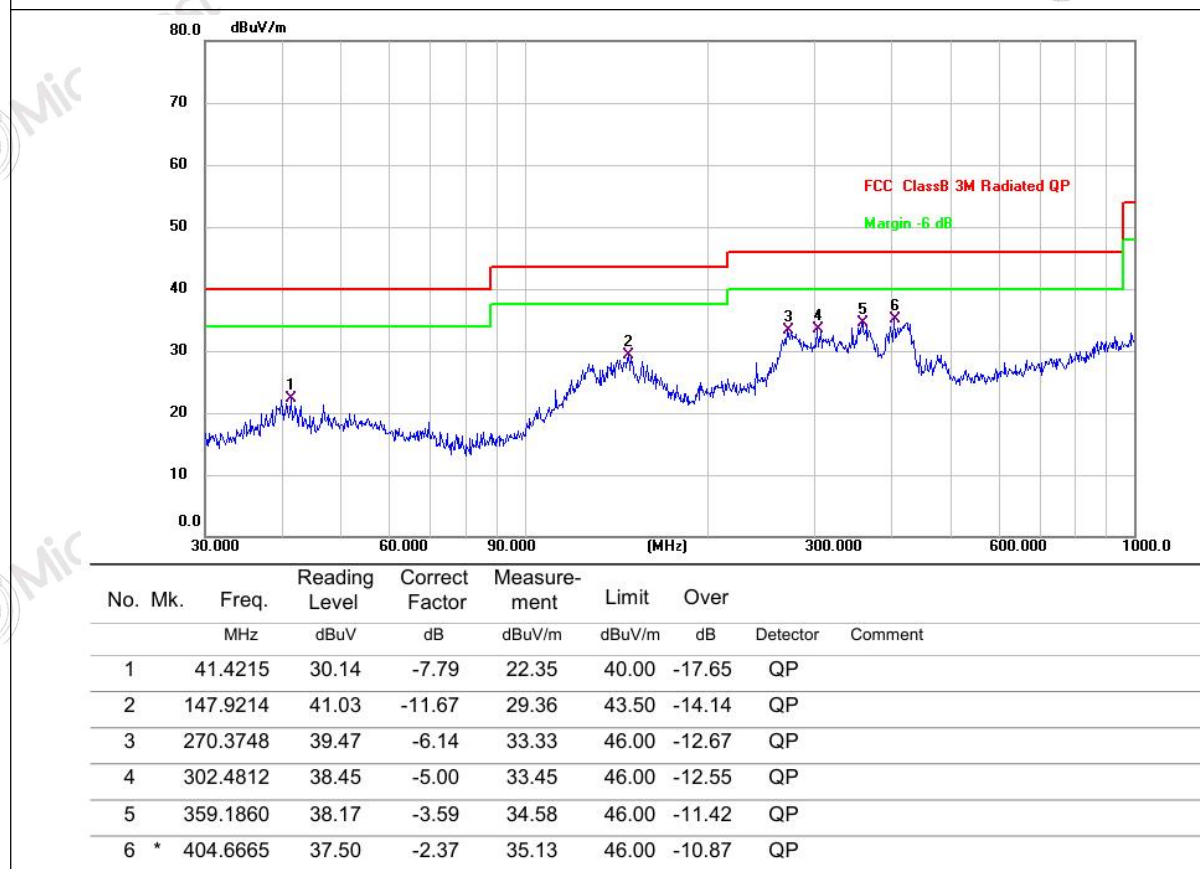
