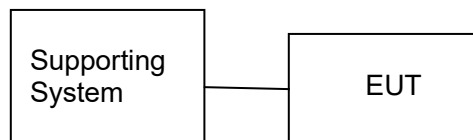

The measuring distance of 3m shall be used for measurements at frequency up to 1GHz and above 1GHz, The EUT was placed on a rotating 0.8 m high above ground for below 1GHz and 1.5m high for above1GHz testing, The table was rotated 360 degrees to determine the position of the highest radiation

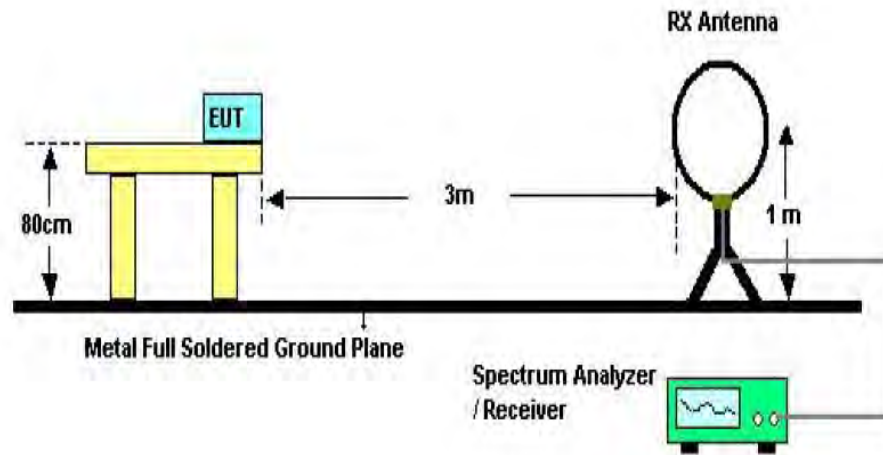

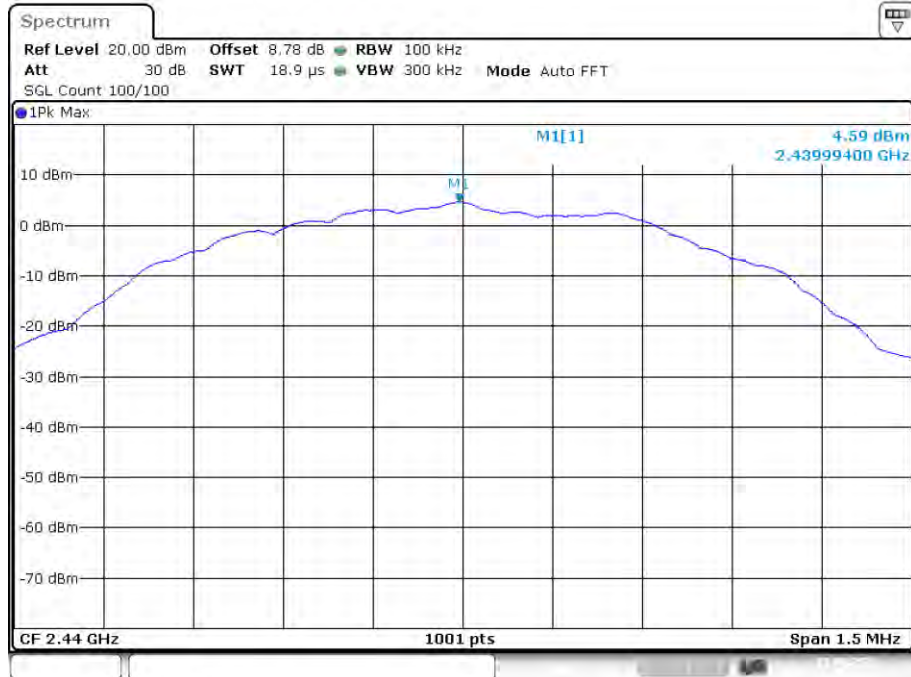
Tx. Spurious NVNT BLE 1M 2402MHz Ant1 Emission

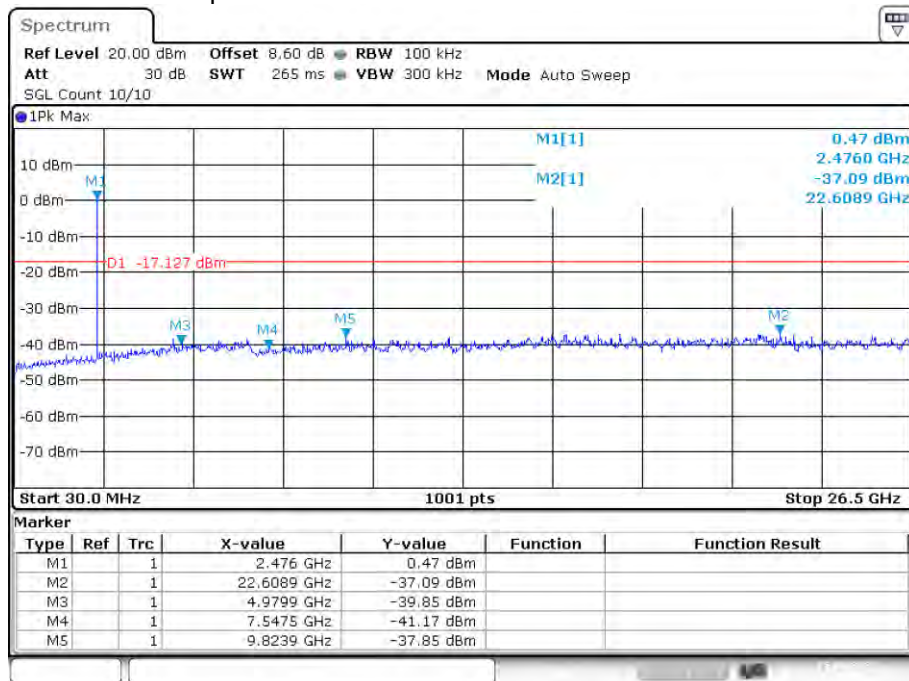

### 4.2. Test Procedure

The EUT is put on the plane 0.8m high above the ground by insulating support and is connected to the power mains through a line impedance stabilization network (L.I.S.N.). This provides a 50ohm coupling impedance for the EUT system. Please refer the block diagram of the test setup and photographs. Both sides of AC lines are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10:2013 on Conducted Emission Measurement.

The bandwidth of test receiver is set at 9 kHz.

The reference level is the level of the highest amplitude signal observed from the transmitter at the fundamental frequency. Once the reference level is established, the equipment is conditioned with typical modulating signal to produce the worst-case (i.e. the widest) bandwidth.

b) The test receiver set RBW = 100kHz, VBW $\geq$ 3\*RBW =300kHz, sweep time set auto, detail see the test plot.

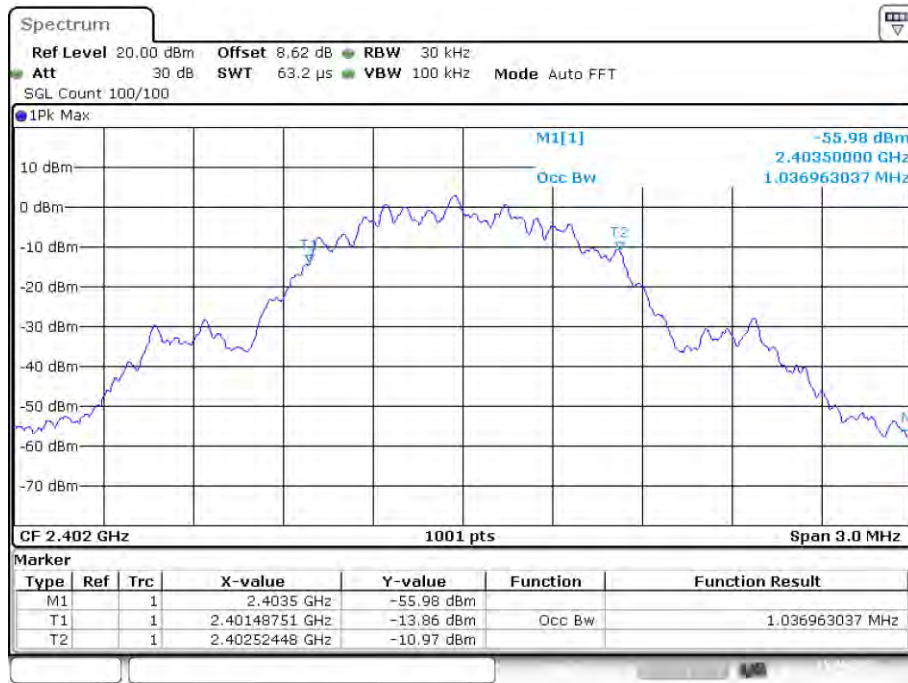

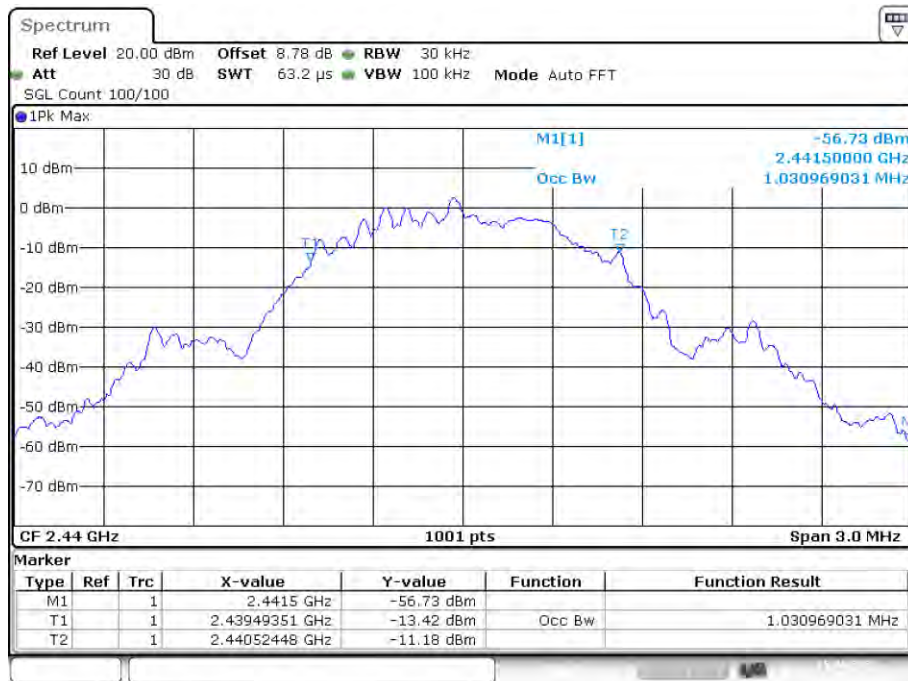


## OBW NVNT BLE 1M 2402MHz Ant1



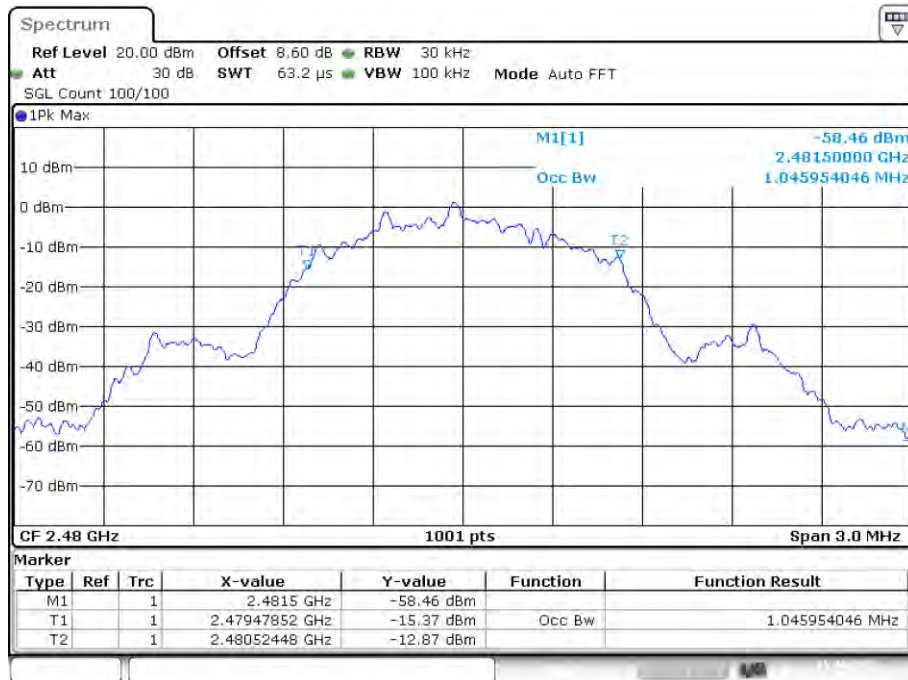

## Band Edge NVNT BLE 1M 2480MHz Ant1 Emission

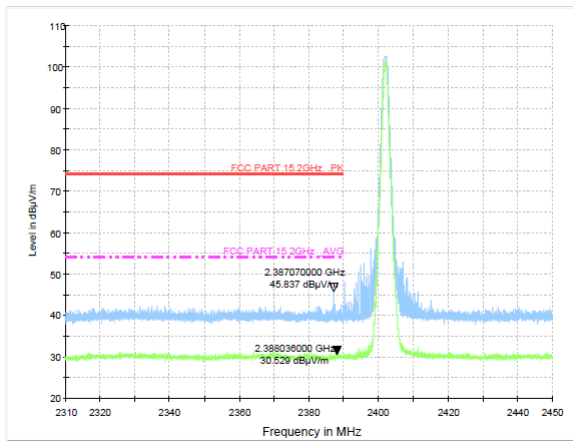

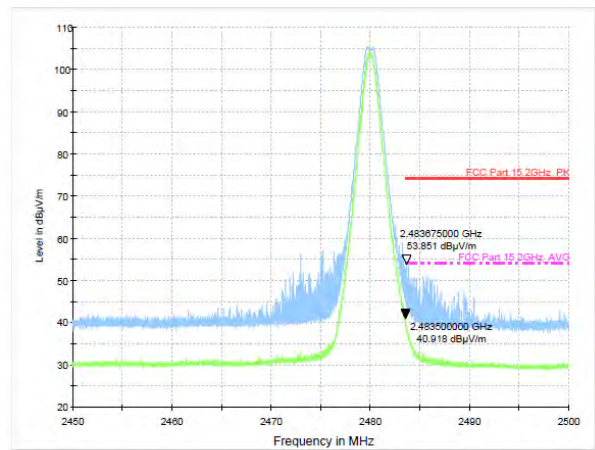

## **9. ANTENNA REQUIREMENT**

### **9.1. Standard Requirement**

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

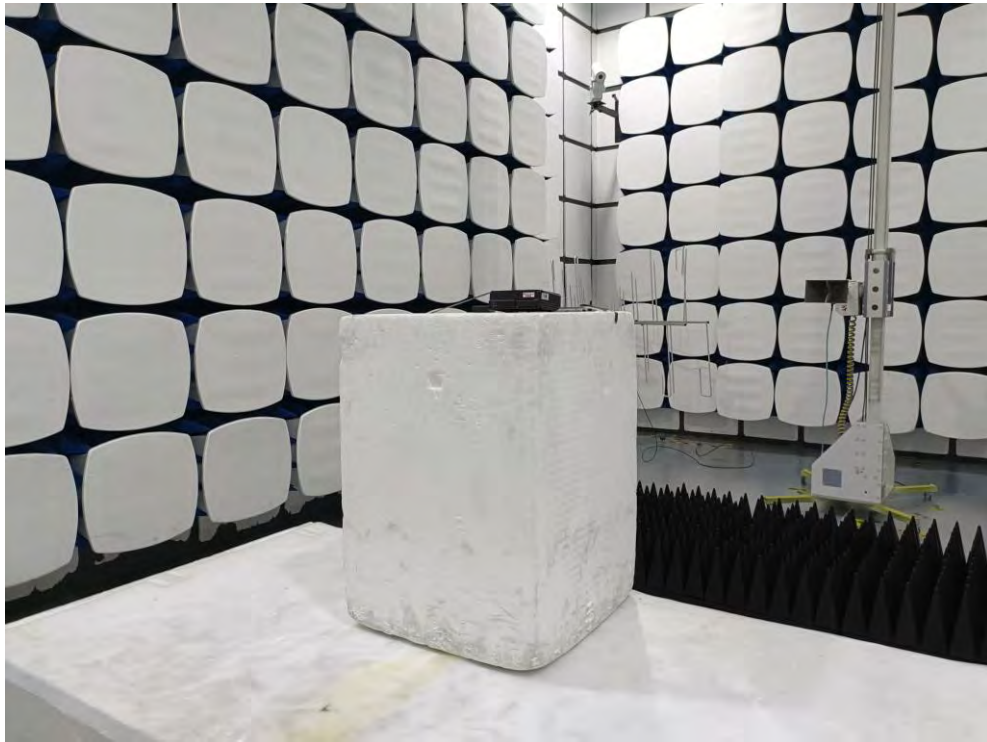
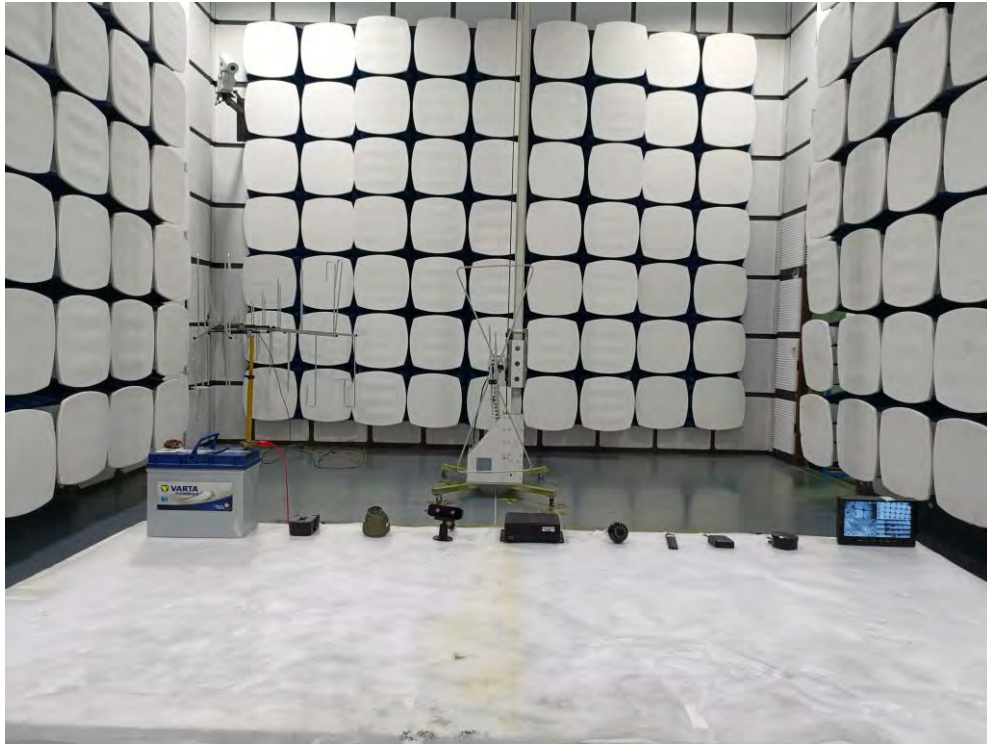
