Friendly reminder

B Chat is semiconductor sensor measurement device. Due to the duration of body system reflection after consumption of alcohol, performing a breath test less than 30 minutes after drinking will cause inaccurate test result. For best result B Chat suggest performing breath test at least 30 minutes after alcohol consumption.

- Spit into blow hole could cause damage to sensor.
- Perform test earlier than 10 minutes after alcohol consumption could cause permanent damage to sensor.

What is breathalyzer?

A breathalyzer measures the amount of alcohol in your lungs. If you had taken a single swallow of beer right before the breathalyzer test, your breath might smell of alcohol, but the test would indicate that you were not intoxicated. This is because the breath you would bring up from your lungs would not have any alcohol in it, even though the breath in your mouth might.

Because the alcohol content of air in your lungs accurately reflects the alcohol content in the blood stream, law enforcement officers can use this information to know whether or not to take the keys from a driver who seems to be intoxicated.

Appropriate use of B Chat

- Read the instruction before attempting to use B Chat
- Check if the Device contain require battery level to operate
- Download the mobile apps
- Use breathalyzer 30 minute after consumption of alcohol.
- Email us if you experience any problem service@kiot.com.hk
- Recommend a drink of water before using the breathalyzer to avoid any contaminant into the B Chat when breathalyzing
- Perform the ASC before and after use

Inappropriate use of B Chat

- Blow with contaminant in the mouth
- Use the breathalyzer 30 minutes before after drinking alcohol(we recommend using it the morning after)
- Use the breathalyzer 30 minutes before after using mouthwash, breath spray, cough medicine or anything else that may contain alcohol.
- Perform a test in contaminate environment
- Use the breathalyzer if you have shortness of breath, after excising. Wait until you are comfortable in perform the test.



GETTING STARTED



Step by Step to guide you through the B Chat journey

1. Unpacking the box
2. You may need to charge battery using the USB cord, however new battery usually has residual enough to operate for the first time.
3. This step might be needed if you have left B Chat idle for more than 3 month
4. Preparing it for use for the first time:
 - a. Activating the sensor
 - b. Performing an Auto Sensor Clean(ASC)
5. Download and install the (B Chat) breathalyzer application from Play Store on your android phone
6. Slide the side switch toward the Bluetooth sign to activate Bluetooth mode
7. Connect the Breathalyzer (B Chat) and the application using Bluetooth BLE.
8. Learn how to perform a breath test and understanding the results using the App in connection with B Chat VIA BLE

Unpacking the Box (Box Content)

In the box you will have the following components:

- "B Chat" smart phone Breathalyzer
- 10 cm length - Micro USB Cable for charging use
- 5X detachable mouthpiece "Optional For hygienic purposes"
- User menu



Bluetooth Connection

1. To enable BLE mode, slide the BT Slide Switch to on.
2. When BLE mode enabled, you can connect to the Breathalyzer using the Breathalyzer app on your android phone.
3. Purple LED flashes indicate device not connected.
4. Blue LED flashes indicate device is connected.

Perform Breath Test

The device is a sensitive measurement device. You must wait at least 30 minutes after drinking or smoking before performing a breath test, performing a breath test before this time may permanently damage the sensor and cause device to read inaccurately.

There are two methods to trigger Breath Test:

1. BLE Mode: Control device to enter Breath Test using the android application. Follow the instruction on the application for Breath Test.
2. Standalone mode: Perform the test directly without android application. To Perform Breath Test in standalone mode, hold the ON/OFF key for 3 seconds, breath test will be initiated

Note: For the first time usage of the Breathalyzer, it is suggested to use under BLE mode, such that the application can set the BAC limit and time to the breathalyzer unit.

Breathe Test Procedures

After breath test is initiated, the device will proceed with the follow test procedures:

1. Blue LED flashes for 17 seconds to indicate Pre-heat in process. (Note: Pre-heat process takes 19 seconds, LED stop flashing 2 seconds in advance by the assumption that user takes 2 seconds to response LED changes)
2. Blue LED on for 6 seconds and a "buzz" sound to indicate user can start blowing to the blow tube.
3. LED changes color based on the result and two buzz sounds to indicate result ready.

PASS > "Green"

FAIL > "Red"

ERROR > "Purple"

LED color will keep for 30 seconds

Note:

The pass criteria are based on a default value of 0.2 Per-mille (‰) if the device is never connected to the android application. If the device has been connected the android application before, the pass criteria is based on the BAC limit set by user.

Sleep Mode

1. Under Standalone mode, the device will enter sleep mode after breath test
2. To enter sleep mode from BLE mode, slide the BT Slide Switch to OFF.

Low Battery and Charging

Battery status will be sent to the B Chat mobile application, when battery level is low, please charge the unit. When charging, RED LED will be on until USB cable is removed or if the device is fully charged, the LED will turn green. You cannot perform any operation when device is charging.

Others

1. Time

On every connection from the mobile phone to the alcohol checker, the time of the mobile phone will be set to the device. If the battery of the device is completely drained, the time information will be invalid. In order to resume time record function, you will need to connect to the mobile to get the most update time.

2. BAC reading record

The device will save up to 10 BAC records in device. The oldest record will be removed if it is more than 10 records. The records are cleared after retrieved by the mobile application.

Trouble Shooting

1. The time of the BAC result is not valid

The Breathalyzer uses the mobile phone time, for the first time usage after battery drain, please connect the android application using BLE to obtain the time from the mobile phone.

2. The BAC Limit is suitable in my region or is not suitable for me

Please set the BAC limit on the mobile phone and connect the breathalyzer to the mobile application using BLE. The BAC limit will be set to the breathalyzer once connection is from.

Auto Sensor Clean

Please follow the instruction on the mobile application to perform Auto Sensor Clean.

Firmware Upgrade

Please follow the instruction on the mobile application to perform Firmware Upgrade.

Activating the Sensor

You will need an alcoholic liquid of 5-7%Vol

To make this liquid please do the following using normal white wine. Mix a small amount of white wine and water in a ratio of 1 part wine to 15 parts of water. This reduces the wine's alcohol %_o volume from approx 12-14%_o to 5-7%_o and provides a very pure liquid which is ideal.

- 1) Following the diagram below, turn the B Chat over so that the back of the unit is facing you. On the bottom right hand corner of the B Chat breathalyzer you will find a small cap which you can remove.
- 2) Dip this cap in your pre-prepared alcohol of 5-7%_o Volume, ensuring that the sponge section is now wet. Wipe off any excess liquid.
- 3) Insert the cap in to the ventilation hole on the back of the breathalyzer (do not press the cap in more than 1/2 way otherwise it may be difficult to remove it).
- 4) Turn the B Chat over so that it is facing you and slide the unit opens as if you were to perform a breath test. DO NOT BLOW INTO THE UNIT VIA BLOW TUBE
- 5) Remove the cap from the ventilation hole and place it back in its normal position. Perform an ASC(see page 6)
- 6) When ASC finish after 10 mins, remove the cap
- 7) Performs blow test using clean air (Blow with no alcohol) if the result read "LO" then Active sensor complete.
- 8) If not "LO" wait two hours then repeat step 7 again.

Automatic Sensor Clean (ASC) Function

The first time you use your B Chat breathalyzer you will need to perform an ASC. The ASC Function cleans the sensor inside the system and removes any contaminants. For example, oxidization if it has not been used for a period of time or residue left from contaminant in wine etc) To ensure high precision readings, we recommend performing an ASC regularly and ideally once every 2-4 weeks.

To Active ASC

1. Connect B Chat via Bluetooth with Smart phone
2. Turn on B Chat app
3. In the setting "click Auto Sensor Clean"
4. Press "OK"
5. Wait 10 minute. ASC complete

Maintaining your B Chat Breathalyzer

B Chat Maintenance

To keep your B Chat in top condition we recommend cleaning it regularly using a soft damp cloth.

After every breath test the B Chat automatically cleans the sensor but we recommend you should perform an ASC regularly to remove any contaminants from the sensor. You can find instructions for doing this on ASC

Be Careful

Take care not to drop the B Chat breathalyzer as sudden knocks can affect the unit's accuracy. If you have dropped your B Chat and feel that it is not reading correctly please contact us to arrange to have the unit services.

Re-Calibration

Like any sensitive instrument ,your B Chat breathalyzer may require re-calibration after a period of use. We recommend your B Chat breathalyzer should be re-calibrated once a year or more often if you use it frequently or you suspect it may not be reading correctly. 1) Re-Calibration

2) Full Service

This service completely re-works your breathalyzer, including cleaning sterilization, re-calibration and replacing any parts that may be required. ("KIOT") warrants to you that the B Chat device ("Hardware") will be free from defects in workmanship and materials under normal use including Appropriate use of B Chat ("Defects") for a period or one (1) year (unless the country of purchase requires a longer period under local legislation) from the date that the Hardware was first purchased by you from an authorized KIOT dealer ("Warranty Period"). During the Warranty Period, the Hardware will be repaired or replaced at KIOT's choice ("Limited Warranty") without charge to you for either parts or labor. This Limited Warranty covers the replacement of the Hardware only.
