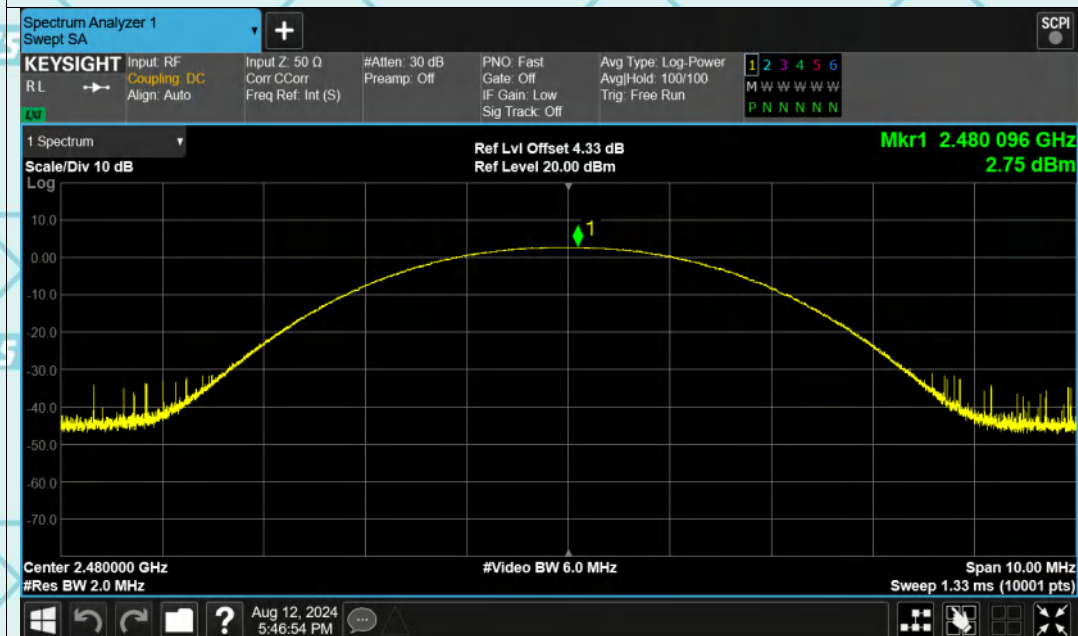

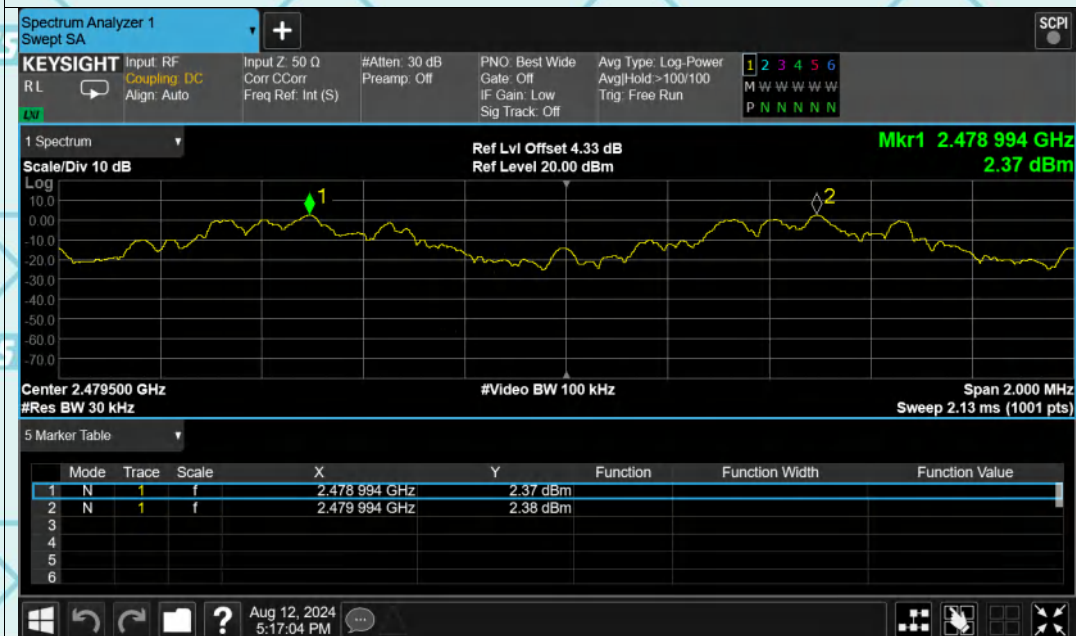

### Dwell NVNT 1-DH1 2402MHz Ant1 One Burst

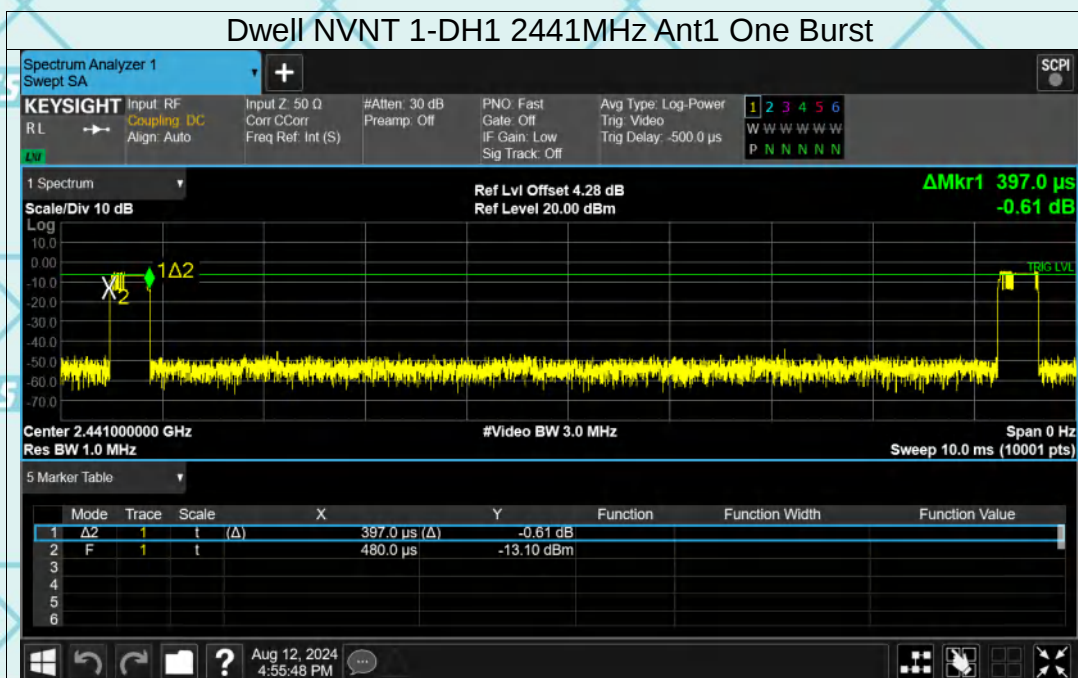


### Dwell NVNT 1-DH1 2402MHz Ant1 Accumulated

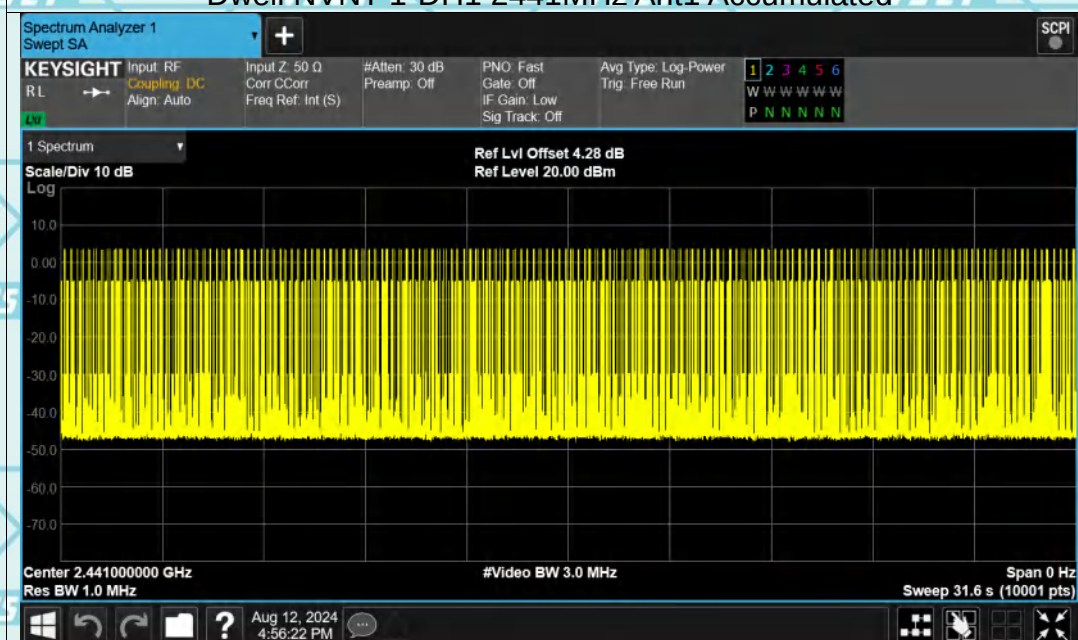

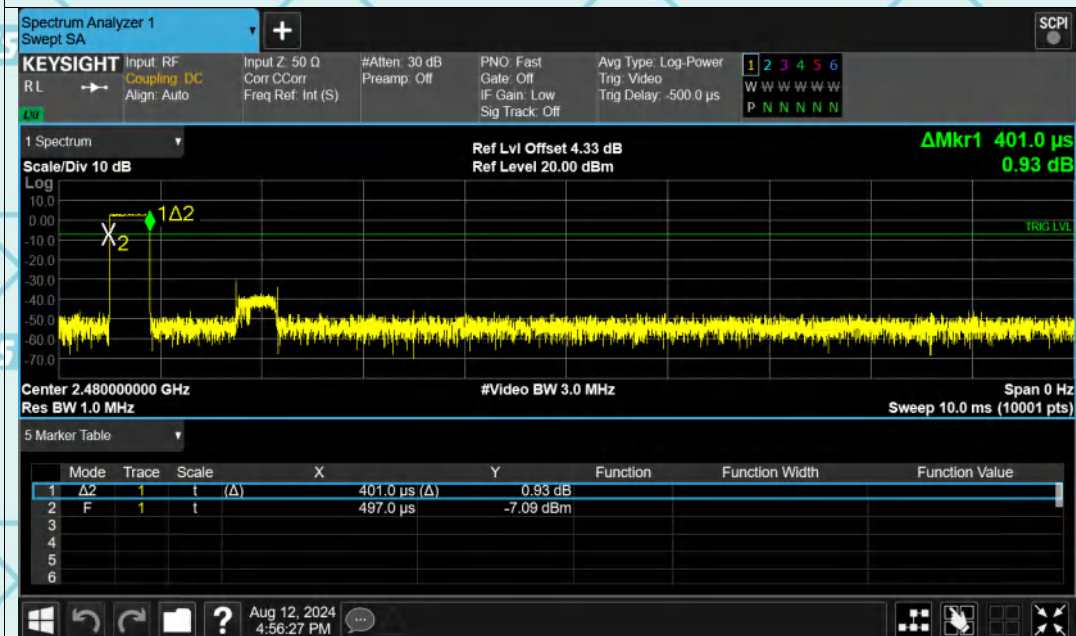

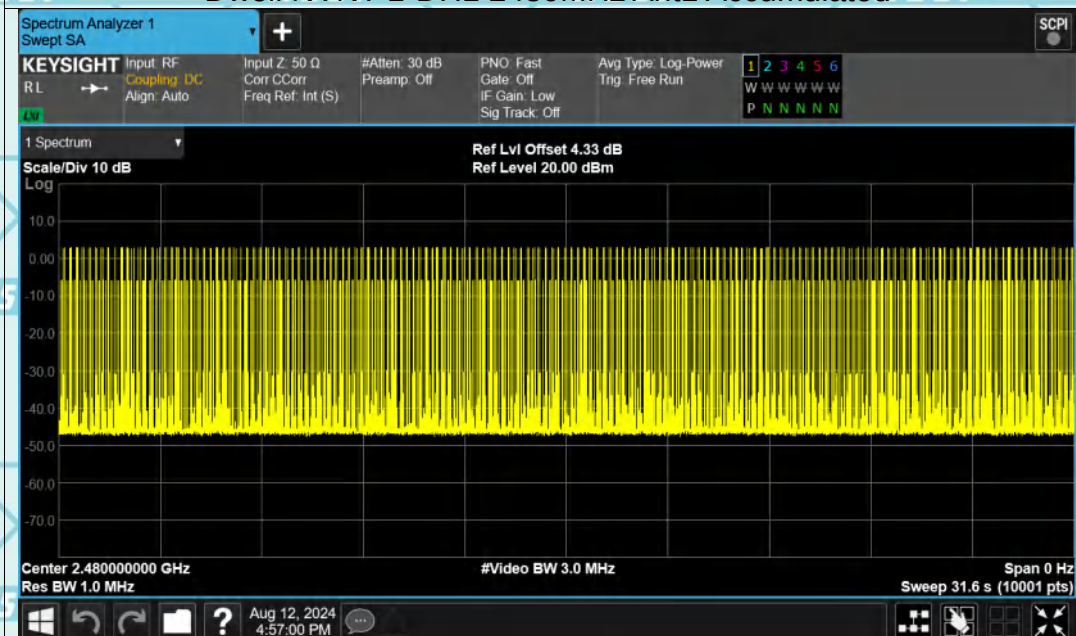

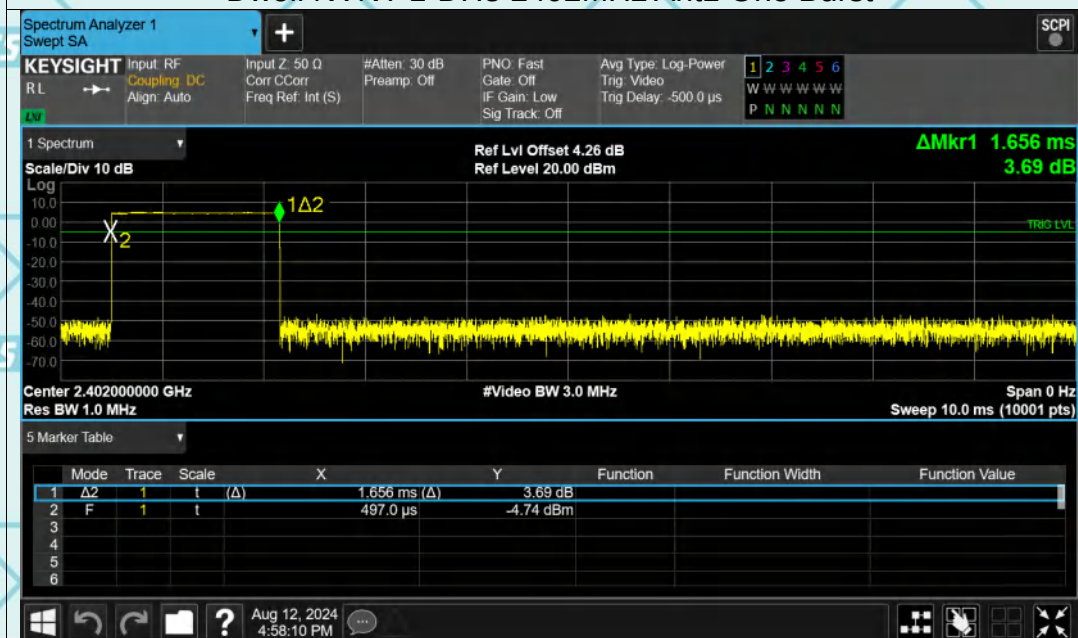

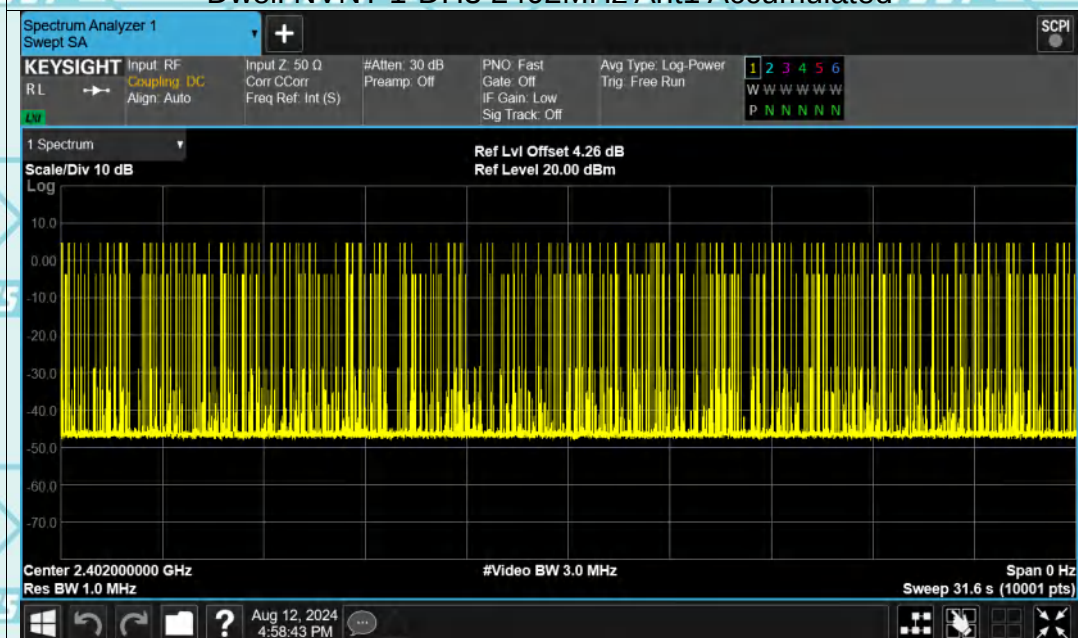

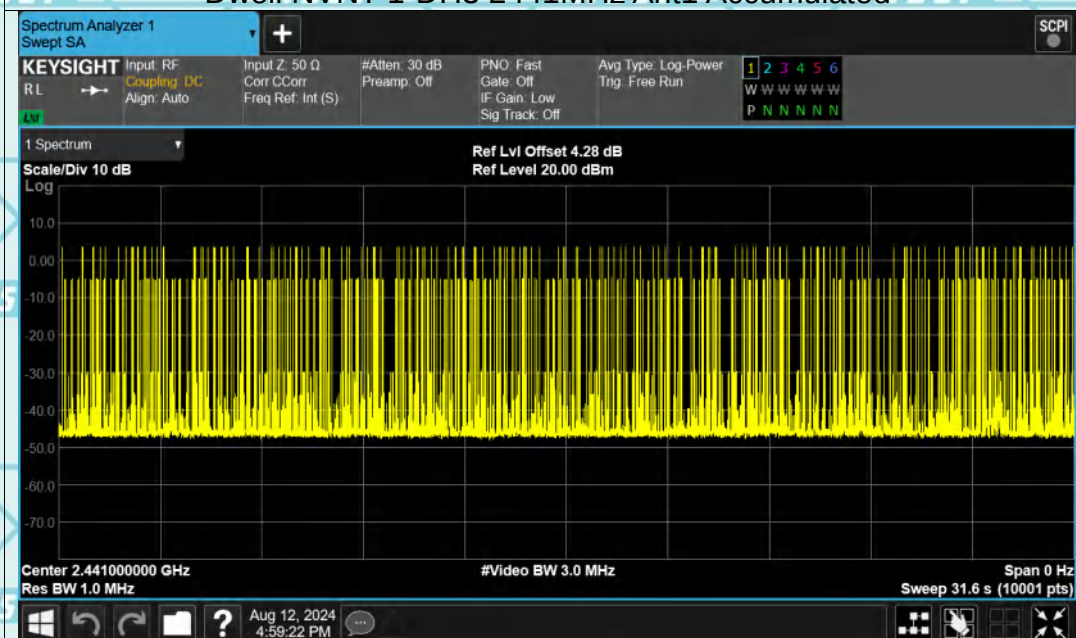

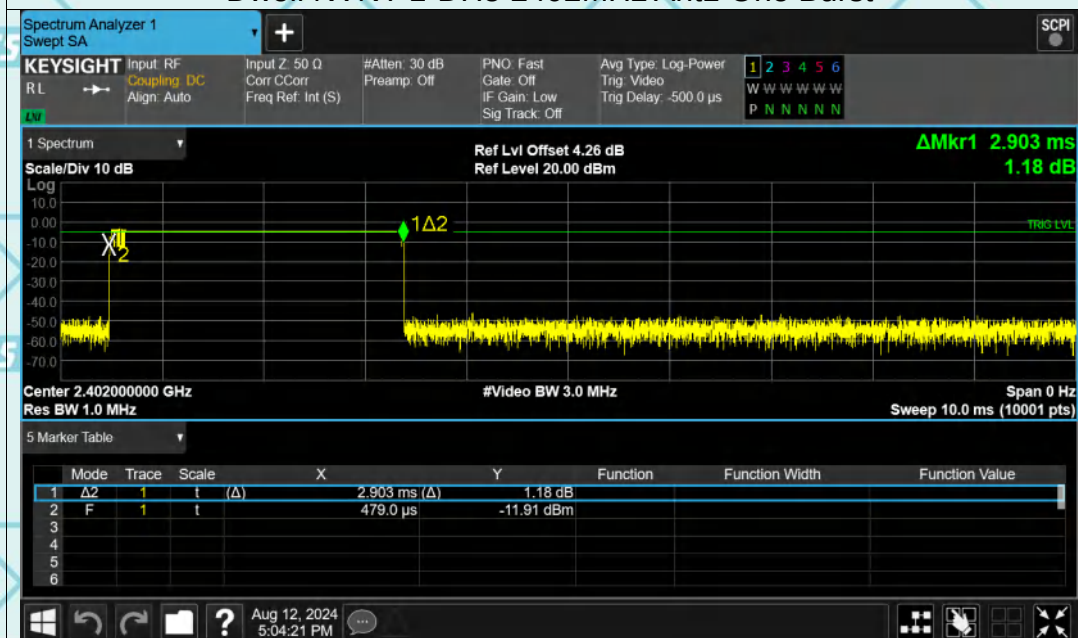

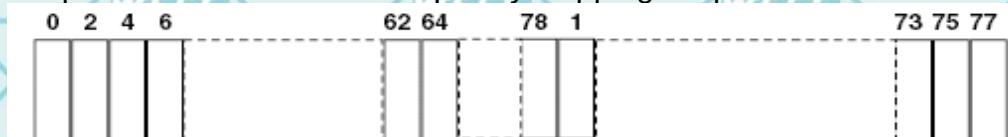
The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first one of 9 consecutive ones; i.e. the shift register is initialized with nine ones.

- Number of shift register stages: 9
- Length of pseudo-random sequence:  $2^9 - 1 = 511$  bits
- Longest sequence of zeros: 8 (non-inverted signal)

Each frequency used equally on the average by each transmitter. The system receivers have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shift frequencies in synchronization with the transmitted signals.

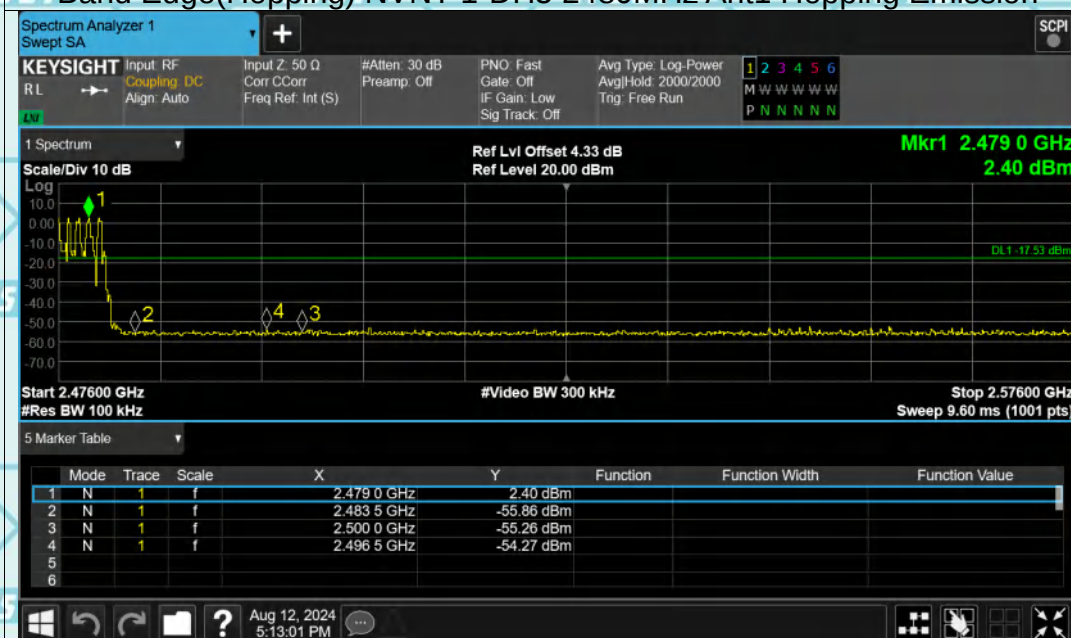

## Band Edge(Hopping) NVNT 1-DH5 2480MHz Ant1 Hopping Ref



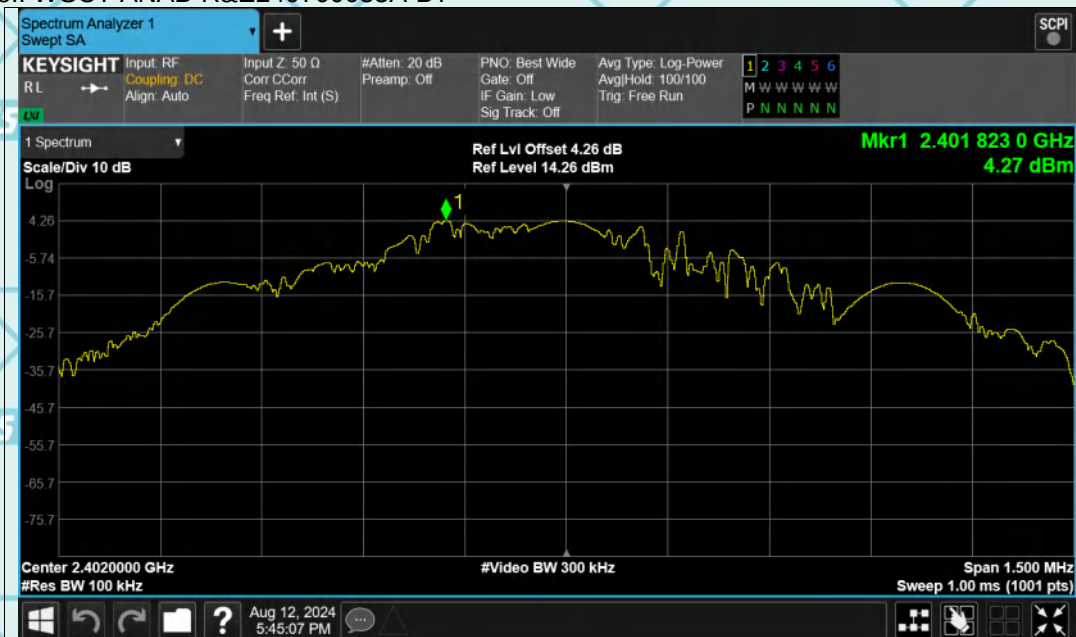
## Band Edge(Hopping) NVNT 1-DH5 2480MHz Ant1 Hopping Emission



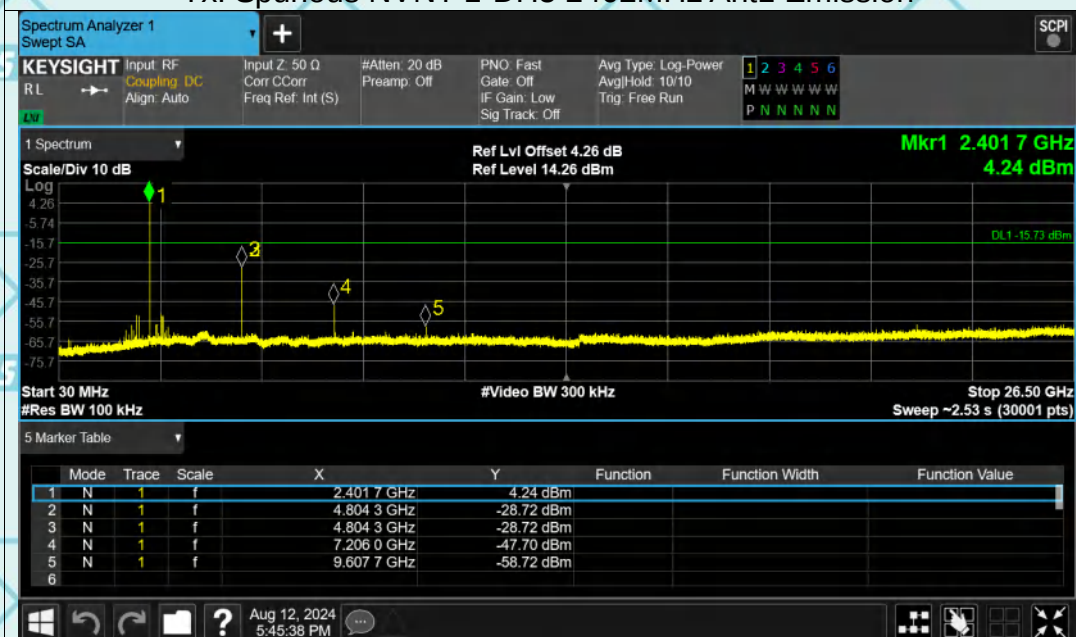

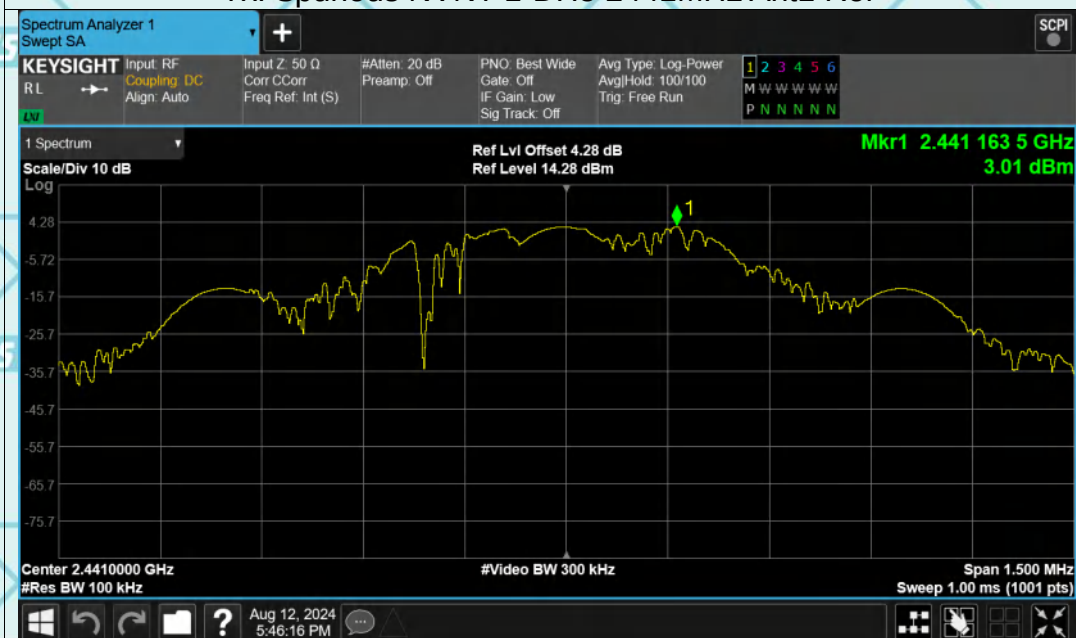


### Tx. Spurious NVNT 1-DH5 2402MHz Ant1 Emission

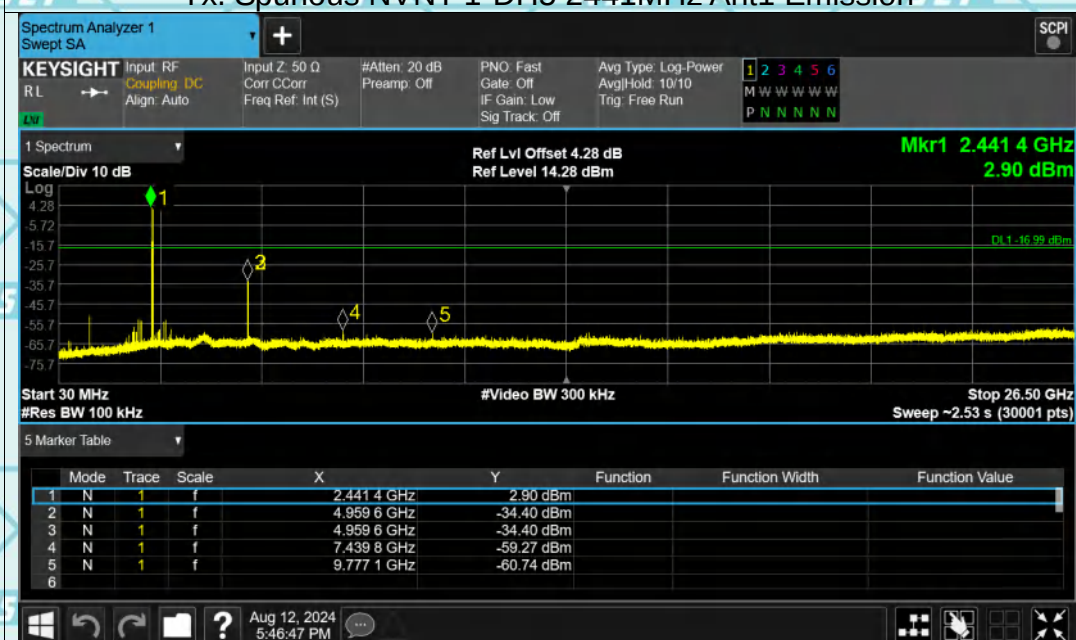
