This application is for a Change in the FCC ID, according to the KDB 388624, because the original equipment was certified using PAG mode, the New grantee and the TCB are different from the original one, New PAG must be open.

The original FCC ID is 2A7RF-LT102XK, granted on 01/30/2023. The certification is for a modular approval for a device using Ultra Wide Band (Grant UWB part 15F)

According to the KDB 388624 D02, we summarize next the checklist for PAG UWB15F:

Original UWB Module was granted under the requirements specified in 15.519 and 15.521.

6. Verify that grant restrictions and notices are in accordance with specific rule part

Special notes are implemented in the user manual and in the Grant notes.

7. Verify requirements and restrictions for UWB modular approvals

Yes the module has the requirement restriction for the UWB modules, see document "Modular Approval Letter - FCC"

8. TCB to include §15.521(a) statement on Grant Restrictions and verify the required device/user manual for all UWB modes of operation

The statement are present in the user manual and in the grant notes.

As the product is the same certificated with FCC ID: 2A7RF-LT102XX, and this was done by PAG process, we request the permission to realize the change to a new grantee

"Antennas mounted on the outdoor structures such, as antennas mounted on the outside of a building or on a telephone pole, or any fixed outdoors infrastructure are prohibited for use with this device.
